

# UNKNOWN CEMETERY, 83 -1

## Summary Report

This cemetery is in a wooded area between Igloos 8307 and 8308, west of McAlpine Road and south of Bayberry Road. It is located in the Northeast Quarter of Section 32, Township 5, Range 1 West.

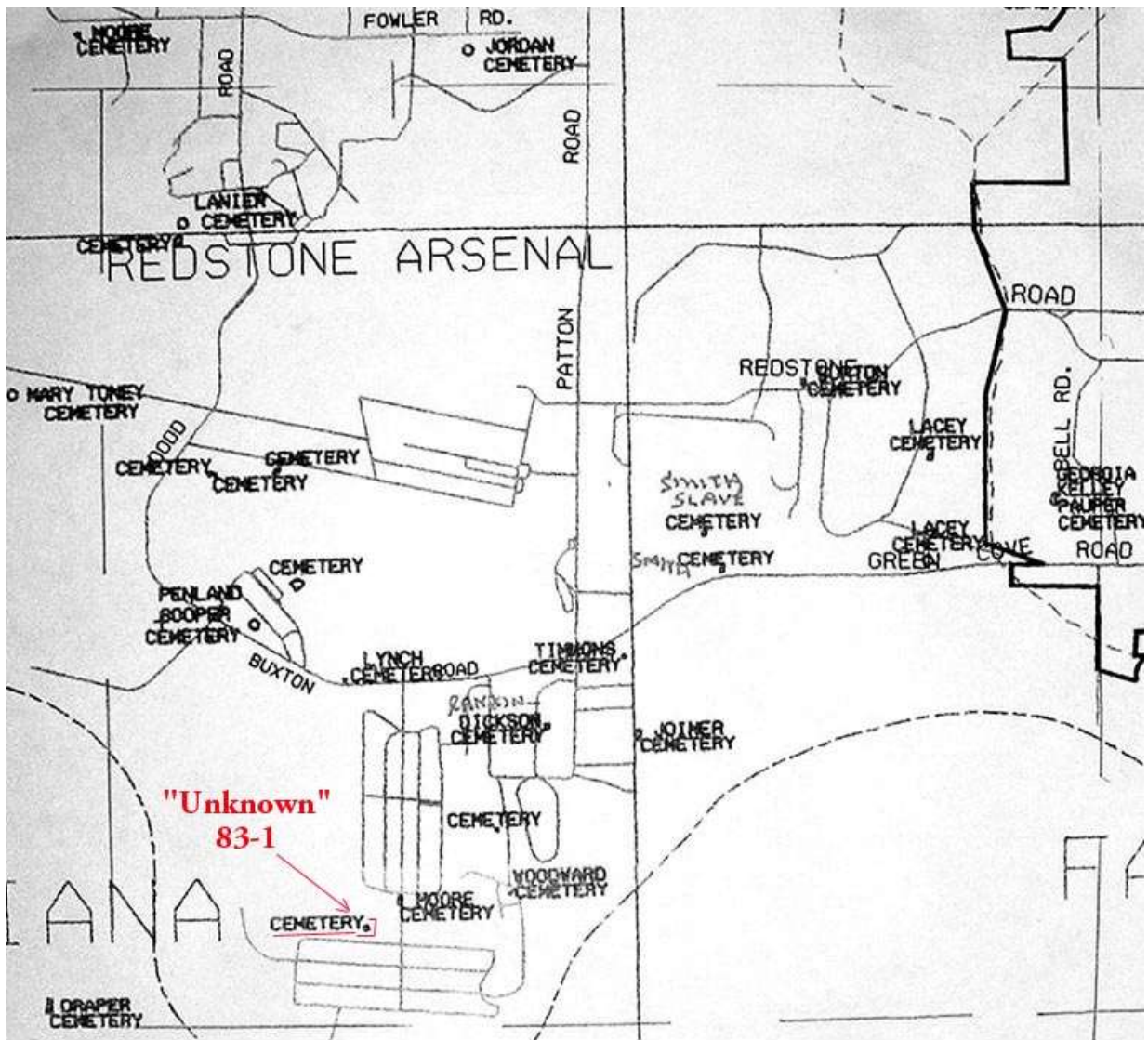

A pedestrian entrance gate is located in the southeastern corner of the cemetery fence. The large split-trunk tree appeared to be quite old, and apparently had died some years before 2003. It may not still be standing today. There was also some evidence of several large, very old stumps in the cemetery, indicating that the age of the cemetery would be rather advanced. Large trees grew and then died and were cut away from within the cemetery. Probably the cemetery was cleared of trees when it was first used, because it is difficult to manually dig graves through tree roots. Generally, the older cemeteries had few living trees in them when they were first utilized. That suggests that these stumps represent trees that grew after the cemetery was no longer in use, then the trees died of “old age” after reaching maturity, and now even the stumps are old and disappearing. The suggestion is that use of the cemetery was discontinued after about 100 years ago, as a minimum age.



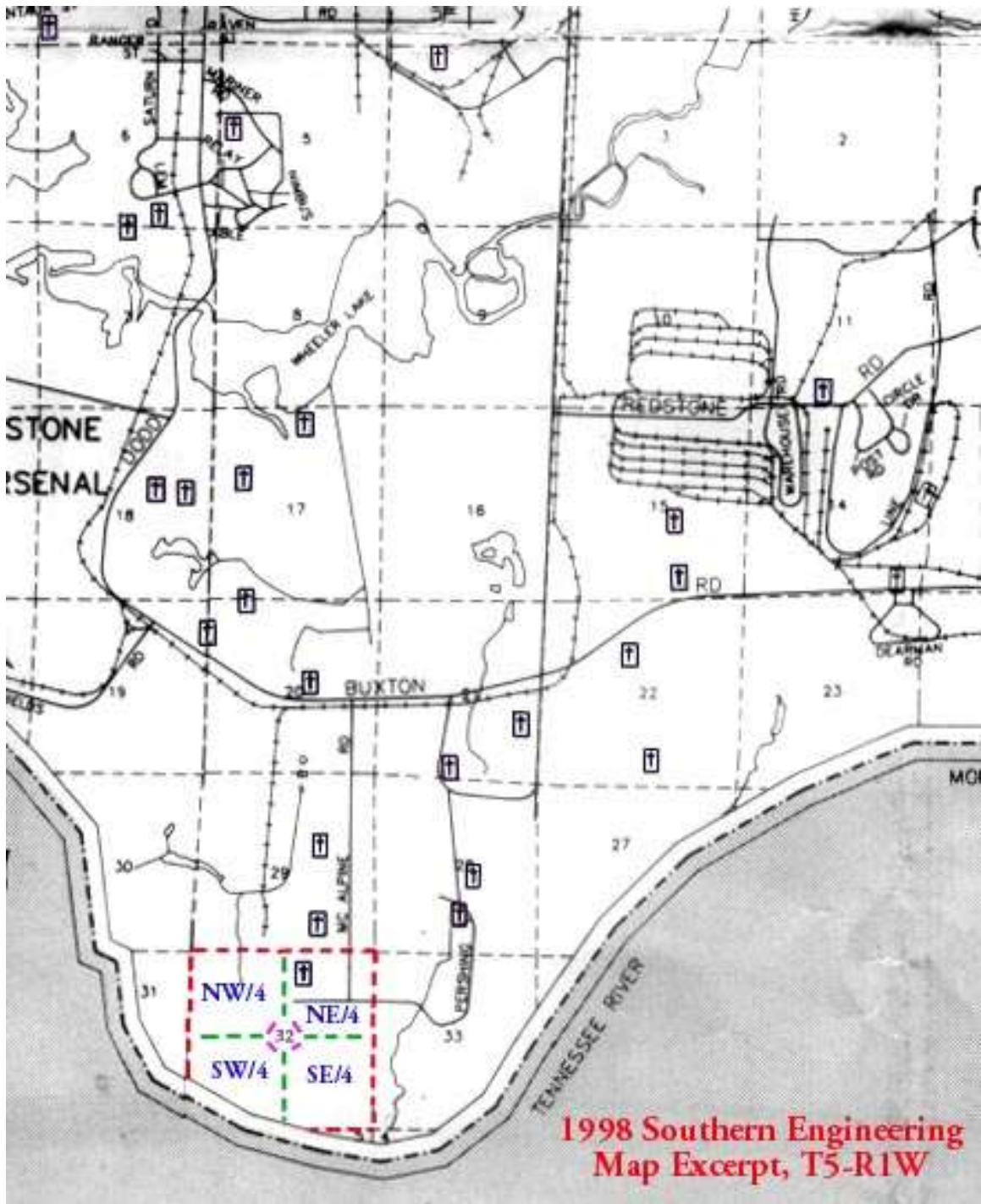
**UNKNOWN CEMETERY 83-1, evidence of about 8 graves per rectangular depressions, 12/8/03.**

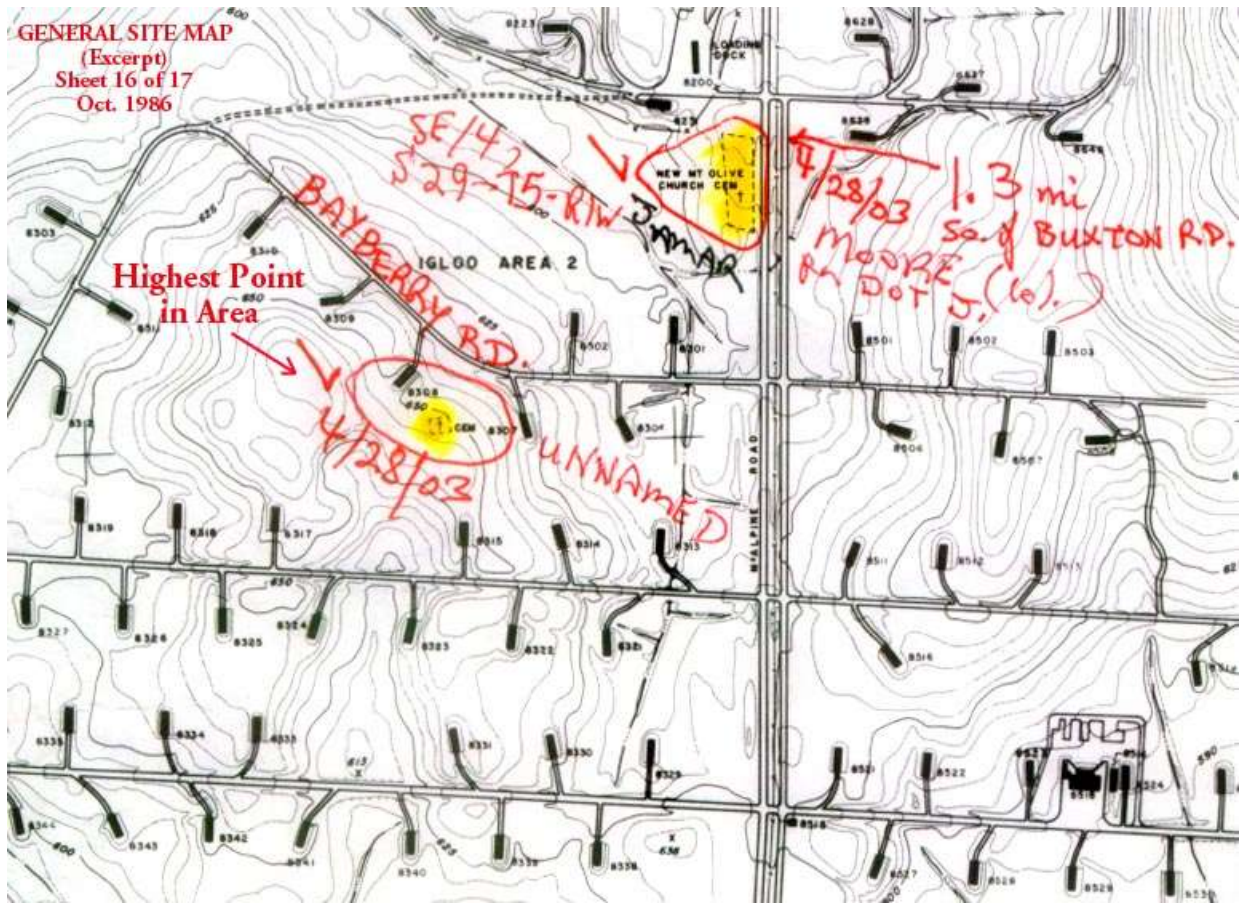
### **Cemetery Map, South Central Madison County AL, T5S-R1W**

(Note that this map, prepared for the Southern By-Pass survey in 2001 by unknown parties, labels the nearby New Mount Hope Church / Jamar 82-1 Cemetery as the Moore Cemetery – basis unknown.)



This map shows the Unknown 83-1 cemetery in the northwest corner of Northeast Quarter of Section 32, Township 5, Range 1 West.

The map excerpt below shows the cemetery near the highest point of land in the area:



There are few distinct grave depressions remaining in the cemetery, but the above photo shows one of the more pronounced to be found here. It lies just to the right of an imaginary line that could be drawn between the hoe handle (leaned against the left foreground tree trunk) and the base of the cedar tree within the fence of the background. The rectangular depression is not deep, and it is filled with leaves, producing only a faint outline against the green grass. The grave is adult-sized.

Since there are no tombstones to be found here, the land records provide clues to those who may be buried in the cemetery. Below is the page from Margaret Matthews Cowart's book **OLD LAND RECORDS OF MADISON COUNTY, ALABAMA** for Section 32 (and others), where the cemetery is located.

The **INDEX TO LANDS** for Section 32 shows that the first several transactions treated the entire section, rather than dealing in quarters. The land transitioned from Austin L. Sands to Francis Phillipon (Phillipson?) in 1846, then to Joachin Heydecker in 1847. Four years later (1851), the land is recorded in the name of Richard Jamar, with some portion going to Thomas J. Owen. These two families were closely intermarried, and they maintained possession of the land by one or more members of their families until 1893, when William G. Jamar and others began to mortgage land, including the NE/4 at times, to George M. Harris and others. By 1912, some of it had been sold to George and Lillie (Jamar) Darwin. By 1917, the SW/4, of Section 32 was in the hands of Moses and Beulah Love. Beulah has a tombstone in the Jordan Cemetery, 45-1, in the NASA area of arsenal property. George Darwin married Lillie Jamar in Madison County in 1897.

The marriage of George Darwin to Lilly Belle **Jamar** indicates that the land was in fact still remaining in the Jamar family after 1912. Furthermore, a check of the census records shows that George was a son of Sydney S. Darwin, whose wife was **Mary Dickson Lanier**. Thereby, it is seen that the land was still in the hands of several prominent pioneer families, tied together in George Darwin and his wife. The above 1880 census record shows George at age 10 in the household of his father Sydney, with his mother, Mary Dickson Lanier Darwin. The Darwin family always was enumerated in Huntsville, for both George and his father. However, George invested in land of historical family interest by his first wife (a Jamar). This land was in the southern portion of the county, near Leeman's Ferry and destined to become a part of Redstone Arsenal. Since the NE/4 of Section 32 in Township 5, Range 1 West included one of the highest points of elevation in the area, it is likely that it held the historical location of the Jamar family mansion, as well as the family cemetery. Normally, family cemeteries in the early 1800s were located within about 150 to 300 yards of the family house. If such is the case here, **then the "Unknown" Cemetery of 83 – 1 is very likely the old Jamar family burying ground.** It of course would be associated with the other Jamar Cemetery that is outside of the arsenal boundary on the west side, near the junction of Martin Road with Zierdt Road. Most of the data collected in research of the Jamar family in Madison County is filed under the Jamar – Owen Cemetery name (with no numerical designation, since it is not on the arsenal). That data is still in process, as it includes many "raw" digital camera images that have not yet been enhanced or trimmed. Most of those images are of old land records (deeds) that were photographed in hopes of finding clues to the cemetery in the NE/4 of S32-T5-R1W mentioned in the descriptions of lands. If such a reference is found in the future processing of these images, this Summary Report will be updated accordingly. For now, it seems quite logical that the Unknown Cemetery 83 – 1 is in fact the cemetery of the Owen and the Jamar family, and that the mansion would have been just up the hill to the northwest of the cemetery and behind the present site of Igloo 8309. It may be appropriate to consider renaming this cemetery to the **Jamar – Owen Plantation Family Cemetery, 83 – 1.**
