

DeYOUNG (715 School Ave. N. E., Huntsville, Ala. 35801) is well-qualified to undertake this work. She will NOT read microfilm but will do other library and courthouse work for a fee. We suggest that she be contacted for searching and photocopying records.

QUERIES - Free to members; \$2.00 for non-members. Please include enough information - names, dates, places - about your line that other readers may readily understand the query. Concise, well-stated queries about Tennessee River Valley (Ala.) families are suggested. We do reserve the right to edit.

CONTRIBUTIONS - TVGS does not pay for contributions but welcomes genealogical material pertaining to our Valley counties (See front cover). Occasional articles concerning neighboring counties will be used. To be considered for publication an item submitted must have a reliable reference - not be based entirely on 'tradition'. We do not want items copied from books now in print; however, such book-references may be used as footnotes to clarify items. Valley Leaves is most interested in securing for publication the following types of items - send photocopy of original where possible please: Family Bible records (please include title page with date if it exists), diaries, church records, military records, cemetery readings (locate cemetery and state if partial or complete reading is given), courthouse records, old newspaper items, minister's records, etc. Families living in our counties PRIOR to 1900 are of the most interest, genealogically speaking; so please do not send recent items.

BOOKS - Books will be reviewed in <u>Valley Leaves</u> only upon receiving a gift copy from the author; afterwards the book is given to the Huntsville Public Library. We do not accept paid advertisement.

DUES - Dues received after 1 May apply to the following year.

MAILING ADDRESS - Please inform TVGS immediately of a change of address. We will charge 50¢ to redeem an issue undelivered at the last address in our files.

SUGGESTIONS - TVGS welcomes any suggestions for improving our publication. Help us keep our standards high; please re-check for accuracy any item you send to us. Notify us of unusual sources of material we might be permitted to publish in future issues of <u>Valley Leaves</u>.

Items of interest to TVGS members in the July 1972 issue of Venture, Huntsville Library's newsletter:1) Catherine Gilliam has microfilmed the Mt. Tabor, Marshall Co. 1860-1941, and Salem, Morgan Co. 1825-Baptist Church Minute Books, brought in by TVGS member Mrs. David Allen. Thanks, Magdalene!! Who will be next??? 2) Two of our Huntsville Heritage Room librarians recently attended the Institute Of Genealogy and Historical Research at Samford University (Birmingham, Ala.). Gerlinda Talbot and Margaret Henson, the recipients of scholarships to the Institute, along with Mrs. Bessie Russell, continually give the public a friendly reception in the Heritage Room. Such genealogical training will result in even better service to researchers. TVGS is constantly adding to the library's supply of genealogical books; authors' gifts of historical and genealogical books, as well as memorial gifts, are making the department increasingly valuable. (Open 9-9 M-F; 9-6 on Sat. During the school year, open 2-5 Sun.) Do come by! You might be surprised to learn how many out-of-staters stop in Huntsville and use our library. As Mrs. Russell says, "Madison County must have been the Garden of Eden; everybody's family seems to have started here."

The Daily Sentinel of Scottsboro, Ala., had many kind words for Valley Leaves in their May 25, 1972, issue. Our research chairman, Ann Cochran, and Mary Fran Moore had just stopped by to present the Scottsboro Library with 1971-72 copies of Valley Leaves. (TVGS donates Valley Leaves to our Valley counties' public libraries to stimulate interest in local genealogical research.) Mrs. H. P. Blanks, Scottsboro's head librarian, welcomed the ladies to the local history room. Ann and Mary Fran, with the assistance of Christine Sumner, also did some 'courthousing'. Our talented past-editor Catherine Gilliam, who is TVGS's representative on the Alabama Historical Commission's Board of Advisors, was in Montgomery in July for the 5th Annual Preservation Conference. Her dedicated research (and writing ability) have resulted in the listing of Huntsville's old Railway Depot on the National Register of Historic Places. The depot has also been picked by Ala. for National Landmark status due to its significance in our country's history during the Civil War. And believe me, Catherine is NOT finished yet! Her ability and energy are ceaseless!

MARRIAGE CONTRACTS LAUDERDALE COUNTY, ALABAMA

The Gabriel Bumpass-Mary Stribling marriage contract dated 30 December 1839 and recorded in Deed Book 10, page 21 was published in <u>Valley Leaves</u>, Vol. 5, No. 4, pages 165-166. A further search of the deed index uncovered twenty-two other marriage contracts; another was located in Will Record 4. Abstracted from records in the Lauderdale County Courthouse, Florence, Alabama by Mrs. Roy J. Cochran, June 1972.

JESSEE EVANS & AMY PETTY MARRIAGE CONTRACT, 10 Apr 1821.

Amy Petty, late Amy Temple, formerly Amy Briggs

For the "benefit and advantage of our children".....

She relinquishes her dower and retains her property which shall be used for their common benefit while living together.

Witnesses: Hugh McVay and Gabl. Bumpass

Proven: 10 Aug 1825 by Hugh McVay

Recorded: 20 Sep 1825, Will Record 4, p. 154-158, W. W. Garrard, Clk. (Will Records 3 & 4 are laminated and bound together in one volume.) (10 Apr 1821, Jessee Evans m. Amai Petty, Marriage Bk 1, Sec 1, p 21.)

EDWARD YORK & SARAH HANNA MARRIAGE CONTRACT, 20 June 1831.

Sarah Hanna, mother of Sarah Hanna, will hold \$8000 cash, paying interest and investing it for her daughter.

Neither will claim interest in the property of the other.

She has interest in the estate of her deceased husband, not named.

She retains property of the estate of deceased husband, Young A. Grey. He settles upon her a child's part of his estate.

JOSHUA S. HAYLE & MARY HOUGH MARRIAGE CONTRACT, 12 June 1838.

Both shall enjoy their separate estates but each shall hold entire estate until the death of both.

She has estates by her dec'd father, not named, and dec'd husband, William Hough. His heirs by his first wife shall not be heirs of her estate. She signed (X). Witnesses: Alfred (X) Rice, Robt. (X) Kirkland

One-half of her property shall be her separate estate; after her death, she will deed it to him.

RICHARD FARIS (FAIRIS) & MARGARET FARIS MARRIAGE CONTRACT, 20 Sep 1842.

Each retains separate ownership of all property.

She can't sell or give away without husband's written consent.

Fayette County, Tennessee, 12 Oct 1848, W. C. Dunlap, Judge Circuit Court, swears to Burton being Chf. Clk. and in lawful office.

JOHN CAIN & MARGARET LUCINDA MIDDLETON MARRIAGE CONTRACT, 19 Jan 1846.

Margaret Lucinda Middleton of Franklin County, Alabama.

She is making provision for her children now living.

The entire estate of John worth ca \$2250 to descend to the children of said John now living or survivors living at his death or disposed of by will or otherwise. Margaret relinquishes all dower to aforementioned property. Property is to go to their issue, if any, distributed equally and if no children, Margaret is to have, in lieu of dower, one-third of all property accumulated after marriage. If John survives Margaret, at his death, two-thirds to children of said John and one-third to Margaret or legatees.

BOOKER SHAPARD & ANN LEFTWICH MARRIAGE CONTRACT, 8 Feb 1855.

Both create separate estates.

He has property in town of Pulaski, Giles Co., Tenn. where he now resides; money invested in mercantile business.

She has property in town of Florence, Lauderdale Co., Ala. where she resides.

Witnesses: Wm. B. Wood, S. A. M. Wood

Proven: 8 Feb 1855 by both parties, Sterling A. M. Wood, J. P.

DAVID ROBINSON & ELIZABETH SHELTON MARRIAGE CONTRACT, 10 Oct 1858.

David Robinson of Giles County, Tennessee.

The property of each remains their own.

Her property where she now resides (Lauderdale Co., Ala.), at her death,

belongs to her bodily heirs. She signed (X). Witnesses: Stephen Shelton, William Hammonds

Proven: 12 Sep 1859 by both parties, Thomas Stone, J. P.

JOHN W. TAPP & HARRIET MARKS MARRIAGE CONTRACT, 30 Nov 1859.

Each has estate in own right. She is to have dower, etc.

Negro slaves which were conveyed by William H. Crittenden & Benjamin F.(?) Crittenden by deed 15 Dec 1842 in trust for her use. Same slaves conveyed 23 Jan 1859 to Julian Marks in trust and upon her death to her children.

She now conveys said slaves to John W. Tapp.

Proven: 30 Jan 1860 by both parties, W. T. Hawkins, J. Probate.

JOHN ETHRIDGE & MARY JANE WILLIAMS MARRIAGE CONTRACT, 21 Sep 1859.

Both of Chaltocoge County, Georgia. Both signed (X).

Her property to remain hers to dispose of as she pleases.

Witnesses: Allan & Ervin, Jeremiah Murphy, J. P.

Recorded: Deed Record 16, p. 572, Lauderdale County, Ala.

OCTAVIO CRITTENDEN-CRITTENDEN CHILDREN MARRIAGE CONTRACT, 30 Apr 1860.

Octavio Crittenden, widow of William H. Crittenden, late of Lauderdale Co., is about to contract a second marriage and enters into the following agreement with Benjamin F. Crittenden, William H. Crittenden and Doctor Moses Hargraves Crittenden, minor children of said Octavio. The children shall continue to possess all of the interest which she has in law and equity in the estate of William H. Crittenden, Deceased, for her use during her life and after her death, to the children and any children which may be her issue by a future marriage as tenants-in-common and not as joint-tenants. Acknowledged before John S. Simpson, J. P., 30 Apr 1860 Recorded: Deed Record 16, p. 609

THOMAS J. CRITTENDEN & OCTAVIA CRITTENDEN MARRIAGE CONTRACT, 2 May 1860.

She disposes of her interest in her first husband's estate at her own pleasure and relinquishes all claims on his property unless it is in accordance with his will duly executed. This is viewed as an act of justice due to the said T. J. Crittenden and his children.

Acknowledged 2 May 1860 before John S. Simpson, J. P.

Recorded: Deed Record 16, p. 626.

(27 June 1843, William H. Crittenden m. Octavia Ingram, Marriage Bk 2, Vol 5, p. 113.)

SOME BOLLING FAMILIES IN ALABAMA WITH VIRGINIA CONNECTIONS
Abstracted and compiled by Helen Bowling McKnight

The wills of Stith and Charlotte (Edmunds) Bolling, recorded in Nottoway County, Virginia, will be of interest to our readers because some named descendants settled in this area. Alexander Bolling - born March 12, 1721, (Old Style), died June 11, 1767 - and his wife Susanna Bolling - born June 16, 1728, O.S. - were the parents of Stith Bolling born May 11, 1753, who married Charlotte Edmunds. The "Bolling Family Bible" (Susanna Bolling's) has been published in The Virginia Magazine of History and Biography, Vol. 23, pp. 422, 423; National Genealogical Society Quarterly, Vol. 57, pp. 41, 12; and The Virginia Genealogist, Vol. 12, pp. 33, 34. Those articles give two children for Stith and Charlotte Bolling; Rebecca B. Bolling - who married Melchijah Spragins and, later as a widow with two sons, settled near Huntsville, Alabama - and a son Alex Bolling (untraced).

The Bible was published by the American Bible Society in 1867; all entries are in the same handwriting and all were probably made at the same time—much later than occurrence. The record pages have been laminated for better preservation. Davis Moore was a physician; the family lived at New Hope (Madison Co.), Ala. Transcribed at Mexia, Texas, November 18, 1971, and submitted by TVGS member Miss Dorothy Rushing, P. O. Box 326, Lott, Texas 76656.

LARKIN CEMETERY - Huntland, Franklin County, Tennessee

This old cemetery, surrounded by trees and located about $1\frac{1}{2}$ miles south of Huntland on Tennessee Highway 97, was copied by Mrs. Ben Hunt and Mrs. Christine P. Sumner of Scottsboro, Alabama. Mrs. Sumner visited the cemetery in February, 1970. She stated that it could not be seen from the road. 



THE CEMETERY AT LaGRANGE, ALABAMA'S FIRST CHARTERED COLLEGE

LaGRANGE MONUMENT: "This is the site of/LAGRANGE CCLLEGE/Chartered in 1830 by act of/the legislature of Alabama/An institution of high order for men/attended chiefly by students/from the southern states/

The College was burned April 28, 1863/by Federal Cavalry commanded by/Colonel Florence M. Cornyn/under General Granville Dodge/PRESIDENTS/

The site of LaGrange College atop "Lawrence Hill," Franklin County (now Colbert County), Alabama is commemorated by this marker and a shedded park area. On Highway 157, approximately three miles Southwest of Leighton, a sign directs a visitor to the gravel road leading up the mountain.

Initiated by the Tennessee and Mississippi Conferences of the Methodist Church, Alabama's first college was chartered in 1830. Earlier, in January 1826, LaFayette Academy, an educational institution had opened and proven successful. In 1855 after the school removed to Florence as Florence Wesleyan University, the name at LaGrange was changed to LaGrange College & Polytechnic Institute. LaGrange College & Military Academy was established in 1858, then LaGrange Military Academy in 1860. The school was suspended in March 1862, prior to the April 1863 burning by the "Destroying Angels" of the Union Army.

The roll of teachers and students, benefactors and trustees, cadets and local citizens can be found in a number of volumes relating the history of this institution but the names of some citizens are carved in stones which mark their final resting places in LaGrange Cemetery, about a mile up the mountain past the park area. Most stones are becoming the worse from wear due to age, weather and careless visitors. The area nearest the end of the drive remains clear but paths wind round trees and rocks, past thorns and fallen trees, in the now wooded grounds of LaGrange Cemetery. When one first arrives, the towering monument to Abraham Ricks cannot be seen, but the "big path" leads to an enormous monument over twenty feet high which it took "eight yoke of oxen" to pull up the mountain in the early 1900's. In marked contrast are the graves marked only by fieldstone and hand-carved stones. Vandals have done their work well; many stones are broken and pieces are scattered.

The TVGS Research Committee, determined to capture as much as remained of the inscriptions on the stones in the cemetery, organized a party which drove seventy miles from Huntsville to the site in November 1971. With research, a list has been compiled to include the names of some for whom no stones remain. The inscriptions are presented here in alphabetical order by surname. Starred references (*, **) are annotated on the last page of this article. The TVGS party consisted of Mrs. Roy J. Cochran, Dr. and Mrs. A. Ezell Terry, Miss Lois Robertson, Mrs. K. K. Spooner, Mrs. Thomas W. Moore and her guest, Mr. A. J. Frazier, Miss Laura Cochran, and Mr. Chester H. Ingram, Jr. Mrs. V. W. Hamner, Jr. provided additional research.

GENERAL HISTORY OF MARSHALL COUNTY, ALABAMA by James Arthur Thomason

(As published in the 1945 and 1946 issues of <u>The Guntersville Advertiser and Democrat</u>. This series began in <u>Valley Leaves</u> Vol. 4, No. 1, <u>Sept. 1969</u>).

Chapter 51 "TWO THOMAS COXES BURIED THE SAME DAY" (March 6, 1946)

R J Riddle settled on the place where Carl Wright lives. They lived there till 1890, when he built a house on a lot where Isaiah Maze lives in Arab. He and Jasper Smith ran a store on the lot where the Stamps Hardware Store stands.

In the 90's J W Powell came in from Georgia and the store was run in the name of Riddle and Powell.

Dr. M L Hinds resigned as post master at Arab and R J Riddle was appointed in his place. Mr Riddle ran a store in the name of Riddle and son.

He was married to Miss Julia Cox in the standing Springs Baptist church. She was a daughter of Thomas Manley Cox and Lyda Dacus Cox. She died and was laid to rest at Brashier's Chapel. He married a widow. He is dead. She is still living at Arab.

Mr Riddle was a deacon of the Baptist church and Sunday school superintendent for years. He moved from the Maze place to the Carver, the forks of the road, where the road leaves the Birmingham-Huntsville highway going to Guntersville. It was first owned by Theodore Westbrook and William Camp, who came from Georgia. Mr Riddle bought it from Camp. I don't know who owns it now.

In the 80's Mrs Lyd a Cox and sons, the late Dock and M L Cox, moved on the place where R J Riddle first settled. Dock Cox married Miss Rebecca Cobb, a daughter of Robert Cobb and Mrs Mary Jane Griffith Cobb.

Augustus Cox, a son of Mrs Lyda Cox, came from Greenville county, S C He married Mrs Amanda Cox, a sister of the late J W Cox. He settled on a place near where Mrs Eliza Jarrett lives and moved to the Riddle place where Carl Wright lives now. He and wife are buried at Brashier's Chapel.

- M L Cox married Miss Florence Bagwell, a daughter of Rev J E Bagwell and Mrs. Everline Williams-Bagwell.
- J W Cox came from Greenville County, S C, settled where Mr. Atchley lives now not far from J. T. Ellenburg's machinery.

His first marriage was to Miss Nannie Cox. After she died in 1889, he was married to Miss Sallie Lee, then to the widow Galloway and the last time to Mrs Geromia Lee-Dunn. Miss Lee (the second marriage) was a daughter of Mr. & Mrs A M Lee and his last wefe was a half sister to his second wife. His last wife married D E Bryant and lives near the Aubudon school site.

Let me tell of an inciddent that happened. Mrs Lyda Cox's husband was named Thomas Manley Cox. He and a young man named Thomas Cox were buried at Standing Springs Baptist church the same day. Mrs Lyda Cox and Miss Lyda Thompson were buried the same day at Brashier'c Chapel cemetery.

There were four or five families of Cox's that lived around Standing Springs but weren't related.

(History of Marshall Co., Ala. cont'd)

Chapter 52 History of Fry (March 13, 1946)

J M Thomason came to Marshall county in 1888, coming from Chattanooga to Guntersville by boat. His family came in a wagon. He had served on a railroad during the Civil war and he and his wife had been married aboard a train by the famous Baptist preacher, Rev John A Broadus, in the presence of the traincrew.

Arriving in Marshall county, he settled on Brindlee mountain. He bought a claim on 152 acres where Fry postoffice was later built. He bought it from H. B Bodine for \$400 and entered the place. He got his deed or patent on a sheep skin with a seal on it.

After his death all the heirs signed a deed to J A Thomason for the place. He and his wife made a deed to Mr & Mrs S A Thomason for 71 acres about 1932. He sold his part to the Bank of Arab and the bank put it up and sold it in lots.

Luther Leak bought 60 acres and J E Bryant 20 acres. Luther Leak sold 20 acres to Robert Martin and 40 acres to Boyd Cox and he holds the sheep skin that was given to J M Thomason.

Later years, S A Thomason sold the 71 acres to R A Brown of Guntersville. He traded it to Robert Martin and Mrs. Sallie Lafarlett. J E Bryant sold an acre off his 20 to J E Coker for a store house and mill.

Herschel Bryant, bought the 19 acres from his father. J. E. Coker swapped his acre to A. J. Maze for a 20 acre block on the L. R. Hill place.

Let me go back to the history of the J M Thomason place.

A man name of Purvin traded his claim, for a double barrelled shotgun. S D Murphree owned the claim. He sold to B V Alexander and he to H B Bodine. There was a log house on it when J M Thomason bought it with a side room. It was built in 1883 and was torn down about 1924.

J. M. Thomason had farmed on a big scale in S. C. He would make 150 to 200 bales of cotton a year. He worked land on the S. F. Dacus place; the Jeremiah Leak place, the Bailey Murphree place and the John Norman place. Made 5 bales of cotton.

He got up a peddling wagon and would gather up chickens and eggs, carry them to Birmingham. He drove cattle, sheep, hogs, etc., to Birmingham.

About 1900 or 1901 he put up a store and got the Fry post office established in 1901. He did a big business hauled freight from Guntersville with a four horse team.

Linn and Copeland operated a saw mill and grist mill at Fry in 1901.

In 1898 J M Thomason ran on the populite ticket for County Superintendent of Education. His opponent Joe Cartee of Douglas, was elected.

J M Thomason was worshipful master of the Warrenton Masonic Lodge No. 320. He died Sept. 10, 1915 on his birthday.

The Fry postoffice was supplied from Red Hill. The carrier was J. A. Johnson. He went on foot sometimes. Red Hill is 5 miles Southwest of Fry. This scribe was assistant post master and J. M. Thomason [was] post master.

Chapter 53 Made Their Own Hats, Collars, Rope (March 20, 1946)

I told you who were our nearest neighbors when we came to Alabama.

John Barton Billingsley was born in Morgan County, Ala., or it might have been Cataco County. There was a county by that name.

M. A Peck, Arab 3, told me he married James Wheeler's daughter. Mr Wheeler's mother was a widow and she bought a place in Cotaco valley from Barton Billingsley in 1863 for \$1700. The deed was headed Confederate states. He moved later to Marshall county in Brown's Valley, on part of the Cobb quarters.

It belonged to Thomas Aldrege when we came to Alabama. He moved to Brindlee mountain in the early 80's and settled on a 40 acre farm near the top of the Fry Gap. It was railroad land bought from Hugh Carlisle of Guntersville.

(History of Marshall Co., Ala. cont'd)

I don't know what Barton Billingsley married the first time. They had two sons, James and Clem. Clem was never married. He is dead. James married Miss Mattie Brookshire, the daughter of Manning Brookshire at Red Hill and moved to Arkansas.

- J B Billingsley married the second time to Miss Jane Johnson. There were two girls, Mary and Sallie. Mary married Rev E T Pesnell, died 1917 and Sallie married Dr J H Maples. He is dead, Mrs Maples lives on the place he bought on Brindlee Mountain. She lives with her nephew E T Pesnell.
- J B Billingsley died 1894 and was buried at Brookshire-Berry cemetery near Red Hill. Mrs Billingsley died years later and was buried where her husband was.

Another neighbor, L R Hill, lived on the place George Feemster settled on. There was a homestead, 160 acres. Mr Hill married Miss Mattie Brown, daughter of Mrs Sarah Ann Brown. Mr Hill came from Sand mountain near Brasher's Chapel, to Brindlee mountain. His father came from S C to Sand mountain.

Once he visited his son, L R Hill. He wanted same biscuit cooked and he went to get some bark to make coals to put on the oven bed. He fell dead and they found him in the fence corner.

Mrs Hill had a loom and a spinning wheel, spun her thread and wove her cloth. They would sow rye and get straw and plait it and make straw hats, collars out of corn shucks and make their own ropes. Both are dead.

There are five houses on the tract now, J E Coker, Lionell Leak, Mrs Alma Noble, H E Hill and W G Roan.

Chapter 54 - How The Railroad Came To Guntersville - (Wednesday, March 27, 1946)

The railroad that runs to Guntersville started by Hugh Carlisle of Guntersville before the Civil War.

The government gave him all odd sections of land adjoining the right of way to build the road. Some of the land was in Marshall, some in other counties.

The road had to be completed by a certain time. It was named the Tennessee and Coosa Division, being named after the Tennessee and Coosa rivers. Mr Carlisl sold out to the N C and St. L. railroad.

A C Roan, who lives at Fry on Guntersville Rt. 1, worked for Hugh Carlisle. The hands received 75¢ per day for their labor. Later they gave them \$1 per day.

They got the road built to Boaz in 1892 and later to Guntersville. When the road was completed to Guntersville, they gave a free excursion to the citizens of Guntersville to ride.

I have written about a regular passenger train coming from Gadsden in the morning and going back in the evening. A mixed train would leave Guntersville in the morning for Gadsden and come back in the evening. Mr Tucker was the conductor and Mr Lane the engineer.

I remember riding the morning train. A locomotive helped push the train up the mountain. I came on the mixed train one night from Attalla. The train was late. It was about midnight. They came down Sand Mountain running at a pretty good rate, the cars were swaying to and fro. It was raining. I sure was glad when we arrived at Guntersville.

In 1909 when I was on my honeymoon, the train from Birmingham to Chattanooga on the A G S railroad was late. We missed the train for Guntersville and had to wait for the evening train. It was late and arrived in Guntersville in the night and we had to go out in a buggy to Fry about 15 miles. S N Moore was one of the first depot agents.

There were some old folks who lived in Marshall county who had never seen a train till the railroad ran into Guntersville. Before the road was built the people had to go to Cullman, Attalla and Gadsden.

The steamboat was the only way the people had to get feight. When the river was low and the boats couldn't run, the people were handicapped. It meant a big asset to the people when the road ran into Guntersville.

COTACO (Morgan) COUNTY, ALA. ORPHANS COURT REGISTER 2, 1818-1827

Established February 6, 1818, Cotaco County, Alabama Territory, was bounded on the North by the Tennessee River, on the West by the western boundary line of Range 5 West, on the East by the Cherokee boundary line, and on the South by the southern line of Township 8 South. Both the northern and the western boundaries are the same today.

The first Cotaco County Court (June 1818) was to be held at William Vaughn's house. Beginning with the September 14, 1818 session, Court was moved to Somerville. On June 14, 1821, the county's name was changed to Morgan County; Decatur became the county seat in 1891. (Acts of Alabama)

Orphans Court Register 2, 1818-1827, contains many bonds, inventories, and estate sales. This 171-page book, a photocopy of an earlier book, is in the Probate Judge's Office in Decatur. Parts of some pages in the older book had been destroyed. These articles will continue in Valley Leaves until all entries in Register 2 have been presented. Abstracted by Helen Bowling McKnight in July and August, 1972.

She removed to Greensboro, N.C. "with her own children," to be more convenient to schools. Remained there but a short time and then returned to her home, "The Hermitage." Through the courtesy of our townsman, Mr. T. P. Houston, and his friend, Mr. A. M. Hill, of Texas, we are able to present our readers with a partial list of old Co. "B", 16th Alabama regiment which was mustered into service at Courtland, August 15, 1861, and served the Confederacy bravely until the close of the war. Col. W. B. Wood, of Florence, commanded the regiment to which the company belonged. It was a part of the army of the Tennessee. Co. B left Courtland for Knoxville on the 18th of August, 1861, and saw hard service and was distinguished for many acts of bravery at Fishing Creek, Ky., Shiloh, Perryville, Ky., Murfreesboro, Chickamauga, Missianery Ridge, Ringgold, Ga., and around Nashville and Franklin, Tenn., and finally surrendered in South Carolina at the close of the war.

Please note that all county lines on the Alabama Territory Map in Valley Leaves, Vol. 6, No. 4, page 166, were not drawn to scale. The Cotaco Co.-Lawrence Co. line is placed too far Fast. That county line was the western boundary of Range 5 West; it is the present Morgan Co.-Lawrence Co. line.

The Lauderdale Co.-Limestone Co. line appears too far West. That county line was the western boundary of Range 6 West. Except for the extension of Limestone Co. in 1821 to include certain land originally in Lauderdale Co. and lying between the forks of the Elk and the Tennessee Rivers, the county line remains the same. (Acts of Alabama)
