

On September 28th Dr. Richard W. Iobst, archivist at Western Carolina University at Cullowhee, N. C., spoke to TVGS members about William Holland Thomas of Haywood Co., N. C. A champion of the rights of the Cherokee Indians, Mr. Thomas spent many years working with the Eastern Cherokee's claims. In a lively question period following his talk Dr. Iobst discussed specific items concerning the Cherokees, mentioning Indian records that are available including an Indian Collection at his University.

"No return" following the issuance date of a marriage license means that the person performing the ceremony did not return the courthouse form giving the date the marriage was solemnized. Occasionally the marriage did not take place but more often it did. See the marriage announcement on page 58 and the marriage license on page 61 of this issue as one example of "No return".

#### HOW TO READ A TOMBSTONE

#### By Dorothy Scott Johnson

When I canvass a cemetery I take with me certain Standard Operating Equipment. This includes: (1) Pencil and paper; (2) Lots and lots of chalk; (3) A plain ole' kitchen scouring brush; (4) Machetti.

Number 4 has probably raised some eyebrows so I'll explain it first. I've used it for: (a) Digging tombstones out of the earth; (b) Whacking my way into cemeteries since Alabama seems blessed with an abundance of foliage; (c) Killing snakes (in case I'm not up to out-running them); (d) Discouraging unwanted suitors while working in the hinterlands (which does happen - even at my age!). Warning: Keep it sharp.

Number 1 above hardly needs explaining but do take plenty of paper along in case the cemetery is much larger than you anticipated. If you use ballpoints take a spare along in case one runs out of ink; if you use pencils take several along and also have a small sharpener handy.

NEVER, NEVER try to canvass a cemetery without several boxes of chalk in your purse. And NEVER use anything but chalk. I've heard of people using everything from flour to stones to rub the face of a tombstone in order to make the lettering clearer, but I've never found anything as efficient, harmless, or easy to use as chalk. Don't use anything that will scratch the face of the marker; a clumsy scratch across a tombstone can change a "1" to appear a "4", a "c" to appear as an "e" and so on. Some tombstones have been so defaced by unthinking clods using abrasives that they are impossible to read today.

How to chalk a stone: Rub the chalk over the entire face of the stone. (It takes more chalk but you don't miss anything if you chalk it all). Then rub the face of the stone gently with the palm of your hand (it's hard on hands but they'll mend and a cloth or brush just isn't as efficient). THEN (and this is my trade secret) blow on the stone. You blow the chalk out of the lettering but it stays on the rest of the stone and don't ask why it works but it does. You'll be amazed at how sharp the lettering stands out. Try it.

More often than not you will find moss has covered the face of a tombstone. This is where your kitchen brush comes in. Just brush off the moss. Don't use a steel brush as that scratches the stone and is no more efficient that a bristle brush. I buy mine at the dime store or grocery store. I've heard of people hiring someone to clean their family tombstones chemically. That's a waste of money – and time. Some of the fungi found on tombstones thrive on certain chemicals, particularly those used to polish stone.

In reading weathered dates there are some things to watch for. Often we mis-read a "4" as a "1" due to weathering. If chalking (and blowing) doesn't bring out the cross-bar in the "4" then try my measure system: A "4" takes more space than a "1" so if the "1" appears a little too far from the other characters it's probably a "4". Another number that gives us headaches is a thinly carved "3" on a sandstone marker; they often weather out leaving a dot at the bottom point of the number where the stonecutter actually used a drill to start the number. So if you see something that looks like "18.8" you can pretty well judge it to be "1838".

By the way, if you find a sandstone marker lying on the ground, or worse yet, one under the ground, by all means clean it off and prop it against something. Sandstone will actually turn back to sand and dust if exposed to the minerals and acid in the earth for any length of time.

After copying a cemetery don't make the same mistake I did and put it in alphabetical order. It's a lot of extra work and serves no valid purpose if your work is indexed (as it should be). Leaving names in their natural order may give someone a clue to another branch of the family, a branch with a different name or an inlaw.

And last but not least: accuracy. I've very carefully copied large cemeteries, typed my notes feeling very smug at how careful I was-only to take my typed copy back to the cemetery for a double check and find several errors. I actually canvass every cemetery twice, once to copy and once to check my work; but it pays off! Have fun!!

# GENERAL HISTORY OF MARSHALL COUNTY, ALABAMA by James Arthur Thomason

(As published in the 1945 and 1946 issues of <u>The Guntersville Advertiser and Democrat.</u> This series began in <u>Valley Leaves Vol. 4</u>, No. 1, Sept. 1969).

Chapter 55 "Sarah Ann Brown And Her 7 Children" (April 3, 1946)

Mrs Sarah Ann Brown and her three sons and four daughters moved from North Carolina to Arkansas, and moved to Marshall county above Guntersville, now Lane's Switch on the N C & St. L.

They moved to Brindlee Mountain in the early 80's, settled on Garrison Feemster's place near where Maze's store is now.

Joseph Brown was never married. He had typhoid fever and died. Robert Brown married Miss Belle Peters, lived on the road from Shoal Creek church to Arab. C W Hewett owns the place now. Mr Brown is dead and his widow married a Mr Hornsby and moved to Lawrence county, Ala. She is dead now.

Mattie Brown married L R Hill. They are buried at Brashier's Chapel. Bettie Brown married Henry Lusk and lived a mile from Joppa, just across the line of Cullman county. The land joins Samuel Hyatt's place. Mr Lusk was a brother of Col. J A Lusk of Guntersville.

Alice Brown married Martin Wilks. She is buried on the place where Mr Wilks lived. It joins the place where S F Collins now lives on the line between Marshall and Cullman county. Mr Wilks was married the second time to Miss Martha Hall, a daughter of the late Robert Hall, and they moved to Tennessee.

Mollie Brown married Mack Mitchell. They lived on the Mrs Sarah Ann Brown place. 1896. Mr. Mitchell rented some corn land on the G W Thomason place and planted corn in February. There came a snow and it lay for 6 weeks. They moved beyond Union Grove not far from Flat Rock.

J W Brown and his mother lived in Brown's Valley at the Hall grist mill and moved back to Brindlee mountain about 1896, to the J B Billingsley place at the top of Fry gap.

Mr Brown married Miss Rachel Westbrook and they moved back to the old homestead, lived a few years. He traded 80 acres of the homestead to J M Westbrook, his father-in-law, near Shoal Creek and sold 80 acres of the old homestead to T P Fielding.

Mr Brown sold out to Radford Mitchell, a nephew, moved to Arab and went into the mercantile business. He lives not far from the Baptist church at Arab. His mother is buried at Brashier's Chapel.

J W. Brown is the only one of the family living.

T P Fielding sold out to Asa Phillips, he sold to S L Leak, he sold to J. B Kelly and he sold to Coe Allen.

The Westbrook part, J M Westbrook sold 20 acres to his son T M Westbrook, and he sold to J B Kelly. Mr Westbrook is buried at the old cemetery at Arab.

Mrs Westbrook deeded 60 acres to B  $\,$  L  $\,$  Brown to take care of her during her life time. She is dead. B  $\,$  L  $\,$  Brown sold it to D  $\,$  L  $\,$  Bales.

Chapter 56 "Married for a Dime - But No Bargain" (April 10, 1946)

I will give some experiences I have had marrying couples. In 1906 I was pastor on the New Hope Methodist circuit. I wasn't ordained. The General Conference met at Birming gham that year and passed a law giving pastors a right to marry folks and baptize.

That was when I married the first couple. I thought I could perform the ceremony and it wouldn't dash me, but my voice got pretty weak.

The next couple I married at the church and I forgot to have them join hands. The next couple the same thing happened. A Justice of the Peace called my attention.

Another couple I married, the man asked me "what do you charge?" I said, "I don't make charge. I leave it to you." He said, "Will a dime do?" This couple parted over a plate of fried chicken.

I married a couple and it came time for the woman to answer, "I will," she said, "I reckon so." She had a dip of snuff in her mouth and she had to spit before she answered.

I married them on the credit, but they never did pay.

One couple that I married was to pay when they sold their cotton. I reckon they never did sell their cotton. Another couple said, "I will pay you tomorrow." Tomorrow hasn't come yet.

A couple drove up to my home one night and hollered "Hello!" I got out of bed and put my pants on backwards. I asked my wife "You reckon they will notice me?" She said, "You change your pants." I asked them if they had run away. They said, "No, we started late."

One couple came and they had lost the marriage license and they had to go back and but it.

There are times it doesn't bother me so had and others it does. I married a runaway couple and they hurried me. I married the woman first.

There are some funny things that happen and there are some serious thing that happen too. (To be continued)

Wm. H. Newsom and Olive Gray, parents of Prudence Newsom, were married in Columbia Co., Ga. (Marriage is recorded there.) Wm. H. Newsom died about 1867 in Edgefield Co., S. C., according to a deed of Thos. H. Williams located in the Marshall Co., Ala., courthouse.

Of the ten children of Thomas H. Williams, Sr. and Prudence B. Newsom, the four oldest, listed on the 2nd page of the family records, were born in S.C.; the six listed on the 3rd page were born in Marshall Co., Alabama.

Thomas H. and John H. Williams were the only children of Osbern(Ausbern) Williams and wife Martha Findley. Ausbern Williams died about 1836 (Estate Settlement - Edgefield Co., S. C.) Widow Martha married William A. Halbert Howle; and they moved to Blount Co., Alabama, about 1845.

John H. Williams was a Confederate soldier, killed in battle at Chickamauga. Wm. A. Howl, son of Martha 'Patsy' (Williams) and Thomas Howle of Edgefield Co., S. C., was first cousin of Thos. H. Williams. He is listed in 1860 Marshall Co., Ala., Census in the household of Thomas H. Williams.

#### ABSTRACTS OF WILLS, LAUDERDALE COUNTY, ALABAMA

"Inventory A-1" (1818-1822), 140 pages, laminated and rebound, is the earliest book in the Lauderdale County Courthouse, Florence, Alabama which contains estate records. This book is not indexed and, although it has an assortment of deeds, bonds, stock marks, estate inventories and sales, etc., it has no wills.

"Will Record 3 & 4" (1821-1825), 166 pages and 161 pages in the respective books which are indexed separately, laminated and bound together, is the earliest volume which we could locate containing wills. We have abstracted the twenty wills in this volume which also contains estate records, bonds, etc. Exact land locations have not always been abstracted here. Primary emphasis has been placed on names, relationships, dates and state-county locations. Abstracted by Mrs. Roy J. Cochran, June 1972.

Her certified copy lists an additional child - "Polly Grayson, born October 8, 1795, died about 1845, and married Bryant Cobb in 1813." Thank you for this addition, Mrs. Underwood.

#### DEEDS, LAWRENCE COUNTY, ALABAMA

Compiled by Mrs. Roy J. Cochran in September 1972, Moulton, Alabama. These records are in the Probate Record Room in the Lawrence County Courthouse.

Direct Index to Deeds 1, Reverse Index to Deeds 1, Direct Index to Mortgages and Deeds of Trust 1, and Reverse Index to Mortgages and Deeds of Trust 1 are the general indexes to instruments recorded in the deed books of Lawrence County in its early years. The deeds prior to the formation of the Probate Court (in 1850) are indexed as "Orphan's Court" (deed books); the later ones are indexed as "Probate Court" (deed books). A complete search should include indexes of the individual deed books since some entries appear to have been omitted from the general indexes.

The "Orphan's Court" Deed Records now located in the Probate Office are: C. Sept 1824-Feb 1829, D. Dec 1828-July 1831, E. July 1831-Sept 1833, F. Sept 1833-Jan 1835, H. Apr 1838-Aug 1839, I. July 1839-Nov 1841, K. Sept 1841-July 1844, L. Aug 1844-Sept 1847, and M. Sept 1847-June 1850.

The "Probate Court" Deed Records now located in this office are in Books A-Z and Books AA-ZZ and numbered volumes thereafter.

"Orphan's Court" Deed Records "A" and "B" and "G" are missing, apparently there was no "J." We have copied references to these books from the general indexes. There were no references in these indexes for "G," obviously it was missing when the indexes were prepared. It is evident that many entries were omitted and some in the direct are not in the reverse, and vice versa.

NONE of the deeds listed in the indexes following can be obtained by writing to the courthouse since the deed books are missing. A few original papers of instruments recorded in these missing deed books have been uncovered and Valley Leaves will publish them in future issues.

# HOW TO PAY TAXES WHEN THE WOLF IS AT YOUR DOOR Franklin and Lawrence Counties, Alabama

After passage of this Act, it shall be lawful for tax collectors of Franklin and Lawrence Counties to receive all wolf scalps in payment of any county tax due from any person in the county, on prior affidavit made before an acting Justice of the Peace that the wolves were killed in Franklin or Lawrence County, as the case may be - Scalps received at the following rate; all scalps under one year \$1; all scalps one year and upward \$1.50. Tax collector of each county to return affidavits with scalps to the county treasurer as money for any county tax due from them as tax collectors - no money to be paid out for scalps; only receive scalps in payment of taxes. (Act passed Jan. 9, 1835(?6?)

# 1808 DEED - ZACHARIAH COX to MARTIN BEATY (Madison County), Mississippi Territory

The earliest deed we find recorded for Madison County, M. T. (now Alabama) is the one transcribed below - bound in the front of <u>Deed Book EE</u>, pages 1 and 2. Page '3' has a deed recorded June 1863, and the last deed in EE was recorded June 1866.

Zachariah Cox, the grantor, was the head of 'The Tennessee (Land) Company', which in 1789 and again in 1795 procured extensive grants from the State of Georgia for land in what is now the Tennessee Valley area of North Alabama. (See Valley Leaves, Vol. 6, no. 1, pp. 15-16).

The oldest deed book in Madison Co., Ala., Probate Record Room, Deeds A & B,1810-1816, begins with page 3. A note on the inside cover reads, "See 1st page in Book EE - earlier Cox deed".

A note at the top of <u>Deed Book EE</u>, page 1, reads, "A <u>copy</u> of 1st Deed in Book A". Page 1

#### - Twickenham 1810 -

- Paid. This Indenture Witnesseth that Zachariah Cox, one of the grantees of the Tennessee Company by his Attorney in fact Michael Harrison formerly of Washington County and State of Tennessee, but now of the great bend of the Tennessee River within the bounds of the Mississippi Territory, for and in consideration of One thousand Dollars lawful money of the United States to him in hand paid by Martin Beaty of the County of Lee, and State of Virginia before the sealing and delivery of these presents, the Receipt whereof is hereby acknowledged, hath granted bargained sold delivered and confirmed and by these presents doth grant bargain and sell unto the said Martin Beaty his heirs and assigns, one certain tract or parcell of land containing One Thousand acres, situated lying and being in the great bend of the Tennessee River on the Waters of Indian Creek a Branch of said River it being part of a Territory or tract of county granted to Zachariah Cox, Matthew Mahoe, and their associates from the State of Georgia, by a grant bearing date in the year of our lord one thousand seven hundred and ninety five and bounded as follows, (to wit) beginning at the mouth of the first branch from the head of the large spring, known by the name of Hunts Spring which branch empties into the said Hunts Spring branch, on the west side, thence west eight poles (turn over)
- P.2. thence North four hundred poles thence East four hundred poles thence South four hundred poles, thence a straight line to the beginning, including the head of the before mentioned <u>Hunts big Spring</u> together with all and singular the appurtenances thereunto belonging to have and to hold the said One thousand

acres of land, to him the said Martin Beaty his heirs and assigns to the sole use and behoff of him the said Martin Beaty, his heirs and assigns forever, against the claim or claims of the aforesaid Zachariah Cox, Matthew Maher and their associates or either of them, their heirs and assigns, as also against the claim or claims, of all and every person claiming by through or under them the said Zachariah Cox, or Matthias Maher or their associates, as likewise against the claim of all and every person whatsoever, will warrant and forever defend in fee simple. In witness whereof the said Zachariah Cox by his said attorney in fact hereunto set his name and affixed his seal the Eleventh day of July in the year of our Lord one Thousand eight hundred and eight. —

### Book review

BLEVINS ANCESTRY, Volume I, compiled and published by Bill D. Blevins, 716 East Sixth Street, Mountain Home, Arkansas 72653; published August 1972; 8 1/2 x 11, 144 pages, spiral binding. Copies are available from the compiler at \$15.00.

This volume is subtitled "A historical and genealogical record of the descendants of Richard Blevins and Rhoda Scott" and is ostensibly the first of several planned volumes. Richard Blevins was born circa 1800 in Tennessee, and his wife Rhoda Scott was born ca. 1798 in Ohio; they were the parents of nine children, and both Richard and Rhoda died in DeKalb County, Alabama.

The present volume gives a brief description of the Blevins Coat of Arms, the origin of the Blevins name, and a few Blevins family locations from 18th century records. Also presented is a section on the Richard Blevins (wife Rhoda) family and several pages of family photographs.

The majority of Volume I is devoted to the family record of Jonathan Blevins and his wife Emily Maxwell. Jonathan was born 17 July 1817 in Kentucky, possibly Wayne County, and was the first child of Richard Blevins and his wife Rhoda. Jonathan and Emily (Maxwell) Blevins were married 27 August 1837, possibly in Marion County, Tennessee, and lived their married life in DeKalb County, Alabama, Dade County, Georgia, and, in 1873, emigrated to Grapevine, Texas. They were the parents of thirteen children.

Volume I of the <u>BLEVINS ANCESTRY</u> is a well-arranged family record, with each member given a relationship code from a chart in the front of the book. The source for information on each family member is provided in a bibliography, and it is evident that the research has been carefully done. There is no index.

One of the contributors to this volume was local TVGS member Harold R. Blevins, who presented the volume. Mr. Harold Blevins points out that additional volumes are contemplated and Blevins families are invited to submit family data to the compiler or to himself at 514 Jeffrey Drive, NW, Huntsville, Alabama. 35806. ## Book reviews

Madison County, Alabama Orphans Court Minutes, 1810-1817 compiled by Dorothy Scott Johnson (1972). Red cardstock cover, 56 pages, full name index, 8½x11, \$3.50. Available from Johnson Historical Publications, 2409 Gaboury Lane, Huntsville, Alabama, 35811.

Orphans Court, the forerunner of Probate Court, dealt with matters concerning the settlement of estates, guardianships, care of the poor, laying out of roads, licensing of ministers and other cases. The first session of Madison County, Mississippi Territory (later Alabama), Orphans Court was held on 4 January 1810; the last session covered in this volume was held in July 1817. The names of men, women, children, friends, relatives and many early settlers of North Alabama appear. The fact that the volume is transcribed in its entirety is especially important since the original of this book is no longer in the Madison County Courthouse in Huntsville and has been virtually unavailable to researchers in this area. Mrs. Johnson has done an excellent job of deciphering the early handwriting from xerox copies of the original book now in the Alabama Archives.

Dorothy Scott Johnson, the author of <u>Cemeteries of Madison County</u>, <u>Volume 1</u> (reviewed in <u>Valley Leaves</u>, September 1971, \$13.00), and several other books relating to local history, is becoming a major contributor to the libraries of genealogists and historians in North Alabama.

A Souvenir of FIRST MONDAY TRADE DAY (Way Down Yonner in Scottsboro Alabammy!) by Chris Sumner. White soft cover (5½ by 8½) 75 pages. Copies of this book may be ordered from the author at Route 5, Box 123, Scottsboro, Ala. 35768. No price listed.

This rollicking fun-filled souvenir booklet is completely written in country folks dialect (\*better no'd as hillbillies\*), and it attempts to explain First Monday in Scottsboro - started in 1900 and still going strong. This unique festivity takes place on the first Monday of each month; and the town square of Scottsboro is turned into a horse-swapping, chicken-clucking, duck-quacking, hot-peanut, cold-coke, bonnet-selling, antique-heaven, tobaccochewing flea market! It's great fun with everyone getting into the act. Some very persuasive person talked the most important men in Scottsboro (Doctor, Lawyer, Merchant, Chief) into posing for pictures in rumpled snap overalls (sans shirt and shoes in some instances) looking like the world's worst country bumpkins and then captioned each picture hillbillyese. I can't help wondering what the U.S. House of Representatives would think if they could see Mr. Bob Jones "takin' time offen his plowin" or our own TVGS member Wendall Page, Scottsboro Jr. High Principal, with mop and bucket "takin' his janitorin' day". Even Chris Sumner in "poke bonnet" is in the book. Lots of First Monday snaps of local characters who compare favorably to the town fathers. This would be a great booklet to own for blackmailing purposes or if you just want to see. feel, and smell First Monday.
