

TVGS members are hard workers!!! When volumes such as those listed above appear on the library's shelves, we know our hours have been well-spent.

Our guest speaker for the January 25 TVGS meeting was Harvie Jones, local architect, who discussed the Twickenham Historical District, the oldest residential area in Huntsville. There are houses in this District that were built in each decade since 1810 - about 160 years of architecture in one small area. Mr. Jones said that a town needs to keep its memory, and the study of its architecture is one way of knowing its history. Slides were shown pointing out various architectural details in local homes and buildings.

Mr. Jones' mother, the late Mrs. Howard Jones, was a nationally-known Alabama genealogist.Mr. Jones mentioned that genealogists are interested in WHO and WHEN while architects want to know WHAT and WHY. Genealogists are discovering daily that their enormous curiosity is seldom satisfied with "who" and "when"; almost immediately we add WHERE and WHY, with WHAT naturally following. Beginning as genealogists, we soon become students of history, geography, law, religion, architecture, and who knows what else! Thank you, Mr. Jones; and thanks to Lois Robertson for the interesting programs being presented to us.

JACKSON COUNTY, ALABAMA CONFEDERATE VOLUNTEER SOLDIERS



"Commissioners Court Road Book No. 3 from Feby. 1853 to April 2nd 1866" is located in the Jackson County Courthouse, Scotts-boro, Alabama. This volume is in poor condition and some pages are loose. The title and dates quoted are found on the inside front cover of the book which seems to contain Commissioners Court Minutes. Among its predominately unnumbered pages were found the following lists of Confederate volunteer soldiers whose families were indigent or destitute and received assistance. Only those families who received aid were listed for many were not in need. All information on the lists is included (though children are rearranged) except the article(s) of supply bought and the amount paid for the article(s). Among the items purchased were bacon, meal, flour, tobacco, pork, cotton, salt, molasses, spelling books, beef, corn, domestic, potatoes, spinning wheel, shoes, sweet potatoes, "dry goods", "provisions", and "sundry Articles". These records were obtained through the efforts of TVGS researchers, Mrs. V. W. Hamner, Jr., Mrs. Roy J. Cochran, Mrs. T. W. Moore, Jr., and Mrs. Bill Sumner in May 1972. They were prepared for publication by Mrs. Eugene G. Cowart.

It is further ordered by the court that notice of the foregoing appointments be given for two successive weeks by publication in the Bellefonte Era a newspaper published in this county and copies of the same be forwarded by post to each of said agents the advertisement marked round in black lines and that said agents be required to make their several reports to this court by the 3rd Monday in January 1862.

State of Alabama January 20,1862 Jackson County

This being the day fixed by a former order of this court for hearing, examining and determining upon, and condensing for record the reports of the district agents appointed to report the destitute families of Absent Volunteers, in the Confederate State's Service, the Commissioners R. C. Austin & William McMahan having arrived. Court was opened for its appropriate business, and adopt ed the following table as the condensed statement which is to coinstitute the record required under this act.

PRINCIPAL STAGE ROUTES in Our VALLEY COUNTIES-1830's



The Ranges are numbered East and West from the Huntsville Meridian. The Range numbers are given in Roman numerals across the top of this map.

The Townships in this, the northern surveyors district, are numbered South from the Base Line, which is also the Tennessee-Alabama State line. Examples: Russellville is in Township 6 South, Range 11 West (written T6S, R11W, for brevity)

Bellefonte is in Township 4 South, Range 6 East (T4S, R6E).

Each square on the map represents a Township, which contains 36 Sections.

This map is too small to show sections, but sections within each Township are numbered as shown in small print on page 38, Valley Leaves, Vol. 7,

No. 1, September 1972.

Concerning boundary lines of our Valley Counties, Mrs. Gilliam notes that in 1837 the western boundary line of that portion of Marshall County north of the Tennessee River was extended westward to the Paint Rock River, "Paint Rock C." on the above map. Orphans Court Regular Term July 1849

Personally appeared in open Court Mary E Blanton and Saundra M Norwood, witnesses of lawful age and after being duly sworn, declare that on Saturday Morning about 3 Oclock June the 9th 1849, they were at the house of Giles McBride in said County, sitting up with One Dennis Carroll who was very sick of Dropsy and in addition thereto had had a chill on Friday Evening the 8th June--

They further State that said Carroll about 3 Oclock on the morning aforesaid Called them together with one Joshva Mason to bear witness to what he should say. He then Called Mary Ann McBride wife of said Giles McBride to his bed side and remarked that he was dying, but that he was as well in his senses as any of them, that he did not think he would live to see the sun rise, and handed Mrs McBride his gold watch and told her it was hers, that he gave it to her, for her kindness to him since he had been at her house sick. He then remarked, addressing himself to said affiants and said Mason, and calling on them to take notice of what he said that he wanted all his just debts paid and after they were paid he wanted his friend Giles McBride to have all his property -- He said he did not owe any thing of Account that he knew of He further said that if Mr McBride had been at home, he would have had his will written out, but he said that what had been said to affiants and said Mason, would do as well as if he had written it on ninety nine sheets of paper. He also said that he wished said McBride to wind up his business for him - said affiants further states that said McBride was from home and that there was no person present that could write a Will and that said Carroll was in great agony and scarcely able to turn himself in his bed and totally unable to write. That said Carroll continued to grow weaker but retained his right mind till Monday the 11th June when he became senseless and remained so till he died at said McBride's house on Thursday the 14th day of June 1849

TVGS MEETING - "LIMESTONE CO., ALA., RECORDS"

Guest speaker for the TVCS November 1972 meeting was Mrs. Thomas Edwards, President of the Limestone County (Ala.) Historical Society. She described the Society's projects of recording and abstracting courthouse records, city hall records, church records, and cemeteries. The Society's Museum is located in Athens in the old home of Alabama's Governor George S. Houston. 1

Mrs. Edwards told us that although the courthouse in Athens burned during the Civil War destroying all records, the earlier Probate Court records (wills, marriages, deeds, Orphans Court Minutes) were saved because the Judge had sent a wagon load of the records to Georgia with his family for safe-keeping. The marriage records before 1832 are missing, and Will Books 1 & 2, if they ever existed, are missing. (Anyone in Georgia finding Limestone Co., Ala. marriage records before 1832 or Will Books 1 & 2 please notify Mrs. Edwards or TVGS.) Some wills before 1826 are recorded in Deed Books and Orphans Court Minutes.²

Mrs. Edwards pointed out that the Limestone County Tract Book, going back to 1809, may be of interest to those whose ancestors lived in the NW corner of what was then Madison Co., Mississippi Territory, and is now NE Limestone County, Alabama. Thank you, Mrs. Edwards, for a most informative evening!

The 1846 Lauderdale Co., Ala. marriage contracts of two of the Governor's sisters, Ann and Jane, were abstracted in Valley Leaves, Vol. 7, No. 1. His father's 1836 will has been abstracted by Mrs. Roy J. Cochran for our series of Lauderdale County wills which began in Vol. 7, No. 2. For more on the Governor, his ancestors, siblings, and descendants see Appendix A, Samuel Rutherford Houston's The Houston Family (1882), Thomas M. Owen's History of Alabama and Dictionary of Alabama Biography, Vol. III (1921), and The Story of Alabama, Vol. IV (1949).

MARRIAGE RECORDS LIMESTONE COUNTY, ALABAMA

One large volume marked outside "Marriage Records, 1832-1862" and located in the Record Room of the Probate Judge's Office is the first book of marriages to be found. Judging by the difference in size of the pages, several volumes were bound together, but the pages are now numbered consecutively throughout. The marriages begin with marriage number 1103 on page 1 of this volume. Obviously, 1102 marriages recorded prior to 1832, are unaccounted for at this time. The license information is written on forms printed on the pages within the book; the return is written below the license and the wording varies. Transcribed in the Limestone County Courthouse, Athens, Alabama by Mrs. Roy J. Cochran, September 1972.

RICHARD JOHNSON, REVOLUTIONARY WAR VETERAN

Madison County, Alabama

PENSION (W 11956, from National Archives, Washington, D.C.) (Abstract)
Richard Johnson enlisted in 1778 and served to the close of the war as
corporal in the 3rd troop of Cavalry in Lt. Col. Henry Lee's Partisan Legion.
Was allowed pension on his application executed April 22, 1829 at Abingdon,
Washington County, Virginia to which place he had gone to obtain evidence of
his military service. At that time his residence was in Madison Co., Ala. and
he then stated that he was formerly of Halifax Co., Va. He died Aug. 30, 1842.
The soldier married Sept. 15, 1784 in Halifax Co., Va. to Frances Phelps, who
was born Apr. 29, 1759. She was allowed pension on her application executed
May 10, 1844 while a resident of Madison Co., Ala. It was not stated whether
they had children.

LAST PAYMENT OF PENSION (From records of the Comptroller General, General Accounting Office, Washington, D. C.)

In the case of Richard Johnson, a persioner of the Revolutionary War, certificate No 9, Ala. Agency, the records show that it was certified by the clerk of the County Court of Madison Co., Ala. that satisfactory evidence had been exbited that the pensioner had died in Madison Co., Ala. on Aug. 30, 1842 leaving surviving him a widow, Frances Johnson. The arrears of pension due the decedent covering the period from Mar. 4, 1842 to Aug. 30, 1842 were paid on Sept. 22, 1842 at Huntsville, Ala. to John Byrn, as attorney for the widow.

The records show that a pension was issued to Frances Johnson, widow of Richard Johnson, on Certificate No. 6240, Ala. Agency and that the clerk of the County Court of Madison Co., Ala. certified that satisfactory evidence had been exhibited showing that she died in Madison Co., Ala. on Nov. 2, 1846, leaving surviving her the following children: John P. Johnson; Sarah Sibley, wife of William A. Sibley; Elizabeth Sibley, wife of John S. Sibley; Martha Byrn, wife of John Byrn; and a granddaughter, Cisley Johnson, the only child of Mary Johnson, who is now dead and was one of the children of the pensioner. The arrears of pension due the decedent, covering the period from Sept. 4, 1845 to Nov. 2, 1846 were paid on April 27, 1847 to Thomas A. McCalley, as attorney for the surviving heirs, at Huntsville, Ala.

GENERAL HISTORY OF MARSHALL COUNTY, ALABAMA by James Arthur Thomason

(As published in the 1945 and 1946 issues of The Guntersville Advertiser and Democrat. This series began in Valley Leaves, Vol. 4, No. 1, Sept., 1969.)

Chapter 57 "Some Brindlee Farms and Their Owners" (April 17, 1946)

In another chapter I wrote about T P Fielding buying part of the Brown place near where Maze's store is now. He was a merchant a while at Arab, then in Tennessee and later moved to Cordova, Ala., where he died. His remains were laid to rest at the old cemetery at Arab. His widow, Mrs Emma McWhorter Fielding still lives in Walker County.

Ada Phillips came from Sand Mountain when he moved to the Fielding place. When he sold out to S L Leak, he moved back near Boaz. They live near Arab now. He came from Georgia to Alabama.

J B Kelly was born in Cleburne County, Ala. He served as conductor on the railroad till he was put on a pension. He lived in Birmingham before he moved to Brindlee Mountain. He lives at Arab now.

Coe Allen, who owns the place I mentioned in the other chapter was born near Cotton-ville. He was married to Miss Ida Adridge. He moved to Diamond on the Washington Griffen place. He sold out to TVA.

W R Coker owned the place joining the Brown place. It was first owned by James Bramlett, from South Carolina. W R Coker was the son of Yancy and Mrs Sarah Ann Brasher Coker. He was married to Miss Roxie Bodine. They had two children, Houston Coker and Mrs Demetry Coker Westbrook.

Mrs Roxie Coker died around 1890. Her husband was married the second time to Miss Sallie Patrick. She lives with her son Johnny and Mrs Roxie Coker Leak on the William Hanson place. Mrs Coker was the daughter of Mr & Mrs Berry Patrick of Ryan's Cross Roads.

- H L Forrester built a house where General Hill lives now. James Davenport bought the place from Forrester, and he sold to William Boling. Mrs. Ike Collins fell heir and Virgil Moon owned it. Frank Hill of Warrenton owns it now.
- J H Green bought out I R Forrester and they moved to Cullman County, lived there till his death.

H L Forrester moved above Oleander from there to where J O Spann lives, then to where Arless Spann and his wife Mrs Margaret Ellenburg inherited a place from the estate of her father, J T Ellenburg, Sr. Mrs Forrester's daughter Miss Flora and son Leman live at her place. It is south of the Albert Brock mill site.

Rev W J Wright came from Clay County, Ala., to Sand Mountain in the early 80's. In 1883 he moved to the place fronting J H Green. He got a loan on his place and lost it in the 90's. J H Green, Mr. Holcomb and Oran Benson own 20, C M Green a 20, G G Hill a 20, J D Crow a 20. Rev Wright and children lived on the place a few years and he broke up housekeeping and went to Texas and died. He was a son of Flem Cox of Big Spring Valley and his wife was the daughter of Manning Brookshire near Red Hill.

W D Deerman owns part of the place, W C Pesnell and others. Chapter 58 "History of Diamond" (April 24, 1946)

The post office was established the year 1889. It was supplied from Red Hill. The late J W Sinquefield was the first postmaster. He ran a store in connection.

What gave rise to its name, there were diamond pebbles at an oil well drilled on the Washington W Griffen place. It was owned then by the late Seaborn Thomas Smith. Mr Smith furnished the engine and a northern company furnished the well drill.

The work began in 1889 and stayed till 1891. The well was sunk 1105 feet and when they quit they put a steel ball in the casing so no one else could go any deeper.

Samuel Henry bought the place and hired someone to go there and see if they could move the steel ball, but they failed. The water ran out of the top of the well and you could see the sign of oil.

Coe Allen bought the place and the TVA took over. The well is covered with back water. W W Griffen operated the first horse power gin in that community. W W and Billy Griffen came from Tuscaloosa, capital of Alabama at that time. They both owned property at Tuscaloosa. They sold out and came to Marshall in 1844 and bought land. Billy Griffen owned where H M McGee lives.

Thomas J Anderson married a daughter of Billy Griffen. They didn't have any children. Mr Anderson willed the place to H M McGee, a relative of his.

Uncle Tom as he was known, was a Presbyterian but worshipped with other churches. His home was the preacher's home. He went to church in a buggy and had a certain pine tree he hitched his horse to. Some one cut the tree and it hurt the old man.

He was a son of the late William (Uncle "Billy") Anderson of Warrenton that belonged to the historic family of Greenville, S.C. He and David Anderson came from South Carolina before the Civil War. (Continued on page 146)

Samuel Griffen a slave of W W Griffen killed a slave, Berry Griffen, belonging to William Griffen, by knocking him in the head with a maul. William Griffen sued W W Griffen for damages. They valued a slave at \$500. The case was still pending in court when the Griffen brothers died.

Dr Dean Griffen was in the cavalry in the Civil War. Sanders Griffin owned an interest in the Daniel Pratt Gin Company.

We are always happy to find our members are publishing and it is a pleasure to review their books. This book reminds the reviewer of a "Quarterly" in that Mrs. Sumner has included a variety of records. Some records are continued from Volume 1 and will be continued in Volume 3. To my knowledge there is not a quarterly published in Jackson County, so this book fills a gap for badly needed Jackson County records. Editor's notes are added in the form of footnotes to clarify marriages, deaths, etc., concerning names mentioned in the text.

Contents include Early Land Entries, Wills & Estates, 1907 Confederate Soldier Census, John Smith Family Bible, Harris Family Records, Masonic Records, Woosley Family Records, Cotton-Lewis Family Records, David Hunt Bible Record, Larkin Cemetery, Caperton Family Bible, Marriage Records, Dodson Cemetery, Civil Court Docket, Newspaper Clippings and excerpts of letters to the compiler.

Crittenden County, Arkansas Marriage Records, Volume A 1813-1859 compiled and published by Pat Isabell Brown. Beckett Antique cover, 40 pages, stapled and tapebound, $8\frac{1}{2} \times 11$, \$3.00. Order from Mrs. Pat Isabell Brown, 2013 Park Street SE, Decatur, Ala. 35601.

A well organized book containing 430 marriages with grooms listed alphabetically and a bride's index. The age and county of residence is given in most cases as well as the person performing the ceremony and the date of the ceremony. A short history of Crittenden County is included, also a county-township map. All persons performing marriages are listed alphabetically and ordination entries for ministers are given. In twenty percent of these marriages, the couples lived outside of Crittenden County with twelve percent coming across the river from Shelby County, Tenn.

The author includes charts on her family in the hope that others may be working on the same lines of Isabell, Robertson, Mason, Carter, Farmer, Hood, Glover, McCorkhill, Fuller, Hostetter, Combs, Lyles, Richards, Holmes.

Do you love cemeteries? Have you tramped all day through high grass to find the tombstone? Then scraped, brushed or scrubbed it to take a picture? Have I got a treat for you! Edward Moore, Jr. has photographed tombstones, copied epitaphs, written haunting poetry, and produced a very unusual book. The author was born in Clarksdale, Mississippi and is currently News Editor in the Office of Public Information at the University of Mississippi.

Be prepared for Mr. Moore to play on your emotions; the inscriptions are tender, whimsical, sad and humorous, but when the words become too sad, you find yourself chuckling over the next epitaph.

This handsome book has on its cover a striking original watercolor of a tiny cemetery in Coahoma County, Miss. The Artist is Marshall Bouldin, III, also of Clarksdale.
