



The Huntsville Public Library has been the recipient of two special collecttions recently. Donations of personal collections are valuable additions to the library holdings. The library will evaluate gifts of this nature and you may use this as an income tax deduction.

The Clay Collection, donated by Dr. Clement C. Clay of Durham, N.C. and his two sisters, Misses Mary & Emily Clay, descendants of Gov. Clement Comer Clay. This collection consists primarily of books, portraits, etc. of an historical nature with some items of genealogical interest, such as: an 1881 autograph album belonging to Carrie A. Saunders (mother of Clement Clay); a receipt book belonging to Mr. John W. Clay (1856); a genealogy of the Clay family and one of the mother of Henry Clay; a series of articles from The Huntsville Democrat; a scrapbook containing newspaper articles, family pictures, letters, etc..

The McEntire Collection was contributed by Mrs. Clyde McEntire of Decatur, Alabama and consists of a lifetime of genealogical research and a large number of books and quarterlies. People's Standard Edition of the Holy Bible, entered according to Act of Congress, in the year 1872, by Ziegler & McCurdy, in the office of the Librarian of Congress, at Washington, District of Columbia.

This certifies that the Marriage Contract between Peter G. Hasten of Giles County, Tennessee and Elizabeth A. Philips of Madison County, Alabama was duly solemnized by me at her Fathers on this 29th day of April One Thousand Eight hundred and Sixty nine. (No signatures.)

Expanded information on some of the persons listed in this Bible:

Peter Green Hasten is buried in Potts Cemetery, Aspen Hill , Giles Co., Tennessee, next to his parents, Joseph Hasten and Sarah Ann Dunnavant. He was the grandson of James Hasten of Giles Co., Tenn. and of Abel Burton Dunnavant and Sarah Marriott Mitchell of Limestone Co., Ala.

Elizabeth Alcena Phillips married (1) Peter Green Hasten, and (2) Edward Lafate Tate. She was the youngest of seven children and the only daughter of Thomas A. Phillips and Elizabeth Loveless. The mother died at the birth of the daughter and Thomas later married Permelia Coile. They also had seven children. Many of Thomas' children and grandchildren moved to Pecan Gap, Delta Co., Texas. Four of his sons by the first marriage died in service during the Civil War. Thomas, Permelia and Elizabeth Alcena are buried in Washburne Cemetery, Madison Co., Ala. "Fate" Tate, being ten years younger than his wife (Elizabeth Alcena) married again and several children were born of that marriage.

Tommie A. Hasten died 1 December 1917. Her husband, Richard H. Parm, died 15 May 1916. Both are buried in State Line Cemetery (Old Section), Lincoln Co., Tenn.

Correct name for "Tennie", wife of William Jerome Hastings, is Melissa Tennessee Patterson. Elwood Lacy Hastings died 18 June 1963. These two brothers and their wives are buried in Pecan Gap Cemetery, Delta Co., Texas.

Children of William and Tennie Hastings:

Elwood P. died 1900.

Earl Ambrose married (1) Hester Huffer, (2) ____Woods, died 3 April 1962, buried Arkansas.

Annie Elizabeth married Leroy Abbott and died 31 Oct 1966, buried next to parents in Pecan Gap.

ORIGINAL ESTATE PAPERS - LAWRENCE COUNTY, ALABAMA

Part 3 of a series of loose original estate papers found in the Lawrence County Courthouse by Ann Cochran and transcribed by Ann Jenkins.

PERSONAL PROPERTY OF ELIZA T. TWEEDY

To C McDonald judge of Probate of Lawrence Cty.

This is to certify that Thos Ashford Jno(?) N Crow & Frs(?) W Sykes a majority of the commissioners appointed by said court, to value and divide certain negroes, named in the commission between Thos T Tweedy & his son Jos W Tweedy after being duly sworn proceeded to value & divide said negros as follows, Nancy a woman 60 years of age \$300.00 Lizzy 23 years old & child Robert 6 months old \$1225.00 Louisa 35 years old & child James 6 months old \$1025.00 Mary a girl 10 years old \$800.00, Jacob 14 years old \$1125.00. After valueing said negros they were divided into two lots as nearly equal in value as the said commissioners could divide them having due regard to law. One lot consisted of Lizzie & child \$1225.00 and the boy Jacob \$1125.00 making \$2350.00 & was marked No. 1. The other lot consisted of Nancy valued at \$300.00 Louisa & child James \$1025.00 & Mary \$800.00 making \$2125.00 & marked No 2. Two pieces of paper with Nos 1 & 2 were placed in a hat & Jos M Tweedy was appointed to draw from the hat a number for the minor which was done & he drew No 1. Now therefore our decision is that Lizzie & child Robert & Jacob be partition to J. W. Tweedy minor & that Nancy, Louisa & child & Mary be partitioned to T.T. Tweedy & that T.T. Tweedy having the least valuable lot by two hundred & twenty five dollars is intitled to that amount from the minor Jos W Tweedv. Done in Courtland (Frs W Sykes 22nd Dec 1856 (J. N. Crow

WILL OF THOMAS MCCRARY

I Thomas McCrary of the County of Lawrence and State of Alabama do this tenth day of June one thousand and eight hundred and thirty five make this my last Will and Testament in manner and form following.

First I give unto my youngest son Allen McCrary that part of my land whereon he now lives being in Lawrence County and known as the State SW qr of Section numbered 19 T5 R6 west which tract contains 40 Acres, and also the State SW qr S 19 T5 R6 west which tract contains 40 acres, being of the relinquished lands sold at Courtland To have and To hold in fee simple, after my decease which land and other things heretofore given him will make him equal to what I have given

my other sons in times past. Then all the rest and residue of my estate both real and personal after payment of my just debts I want sold and the money equally divided among my children and that part of my estate that will fall to my daughter Charity's children (as her representatives) I wish to be equally divided among them. And better to provide for them, I hereby appoint my son Matthew McCrary to be their guardian, and as they become of age or marry my will is that he shall pay them their equal part. And finally I appoint my son Matthew McCrary and my son-in-law John Brown

administrators of this my last will and Testament this the day and year above written.

Orphans Court July Term 1835

On the application of John Brown and Matthew McCrary for the Probate of an Instrument of Writing purporting to be the last Will and Testament of Thomas McCrary late of said county deceased, and thereupon came Thomas G. Dobbins and John F. Hughston the subscribing witnesses to said Instrument of Writing who after being duly sworn depose and say that they saw the said Thomas McCrary sign seal and publish, said Instrument of Writing as his last Will and Testament and that they said deponents subscribed their names as witnesses to said Instrument at the request of the said Thomas McCrary in his presence and in the presence of each other and that they said deponents believed the said Thomas McCrary at the time of signing the same to be of sound mind and disposing memory.

It is therefore considered by the Court that said Instrument of Writing is fully proven so far as related to the personal property, as the last will and testament of the said Thomas McCrary and is ordered to be received and recorded as such. And the said John Brown and Matthew McCrary the persons named as Executors in said Will appeared and entered into bond as such executors, with Robert H. Hicks, Thomas G. Dobbins and Alexander G. Austin as their securities in the penal sum of ten thousand dollars which is approved by the Court and taken the oath prescribed by law. It is further ordered that Letters Testamentary issue to them accordingly.

WILL OF EDMUND MCALISTER

In the name of God Amen I, Edmund McKalister being of sound mind and memory though weak in body do make and ordain this my last Will and Testament revoaking all others.

Item 1st After discharging all of my Just debts I give and bequeath unto my appointed daughter Luisa Blankenship child of Margaret Blankenship all my estate real and personal on condition that she take name of MCKalister except two negroes Viz Evelina and child Mary Jane and their future increase and I desire that my Executor obtain the pasage of a law legitomating the said child and altering hir name to that of MCKallister.

Item 2d I give my two negroes above named Evelina and child Mary Jane and their future increase unto Sarah Legrand Pointer daughter of Thomas Pointer. Item 3d In the event of the death of my above named Daughter Luisa Blankenship before she marrys or becomes of age; then and in that case I wish my estate which is left to said child to be equally divided between my Brother Daniel McKalister and my nephews John McKalister and James McKalister and my nease Mary McKalister sons and daughter of my Brother William McKalister. Item 4th I wish my estate to be kept together for the benefit of my above named child and I appoint my friend Thomas Pointer guardian of the said child and Executor of this my last will and testament.

The undersigned commissioners appointed by the Orphan's Court of Lawrence County at the January Term thereof in the year of our Lord One Thousand eight hundred & thirty eight to sell the real estate of Robert Berry deceased beg leave to report that after having given due notice by advertisement of the time & place of sale and of the terms & conditions thereof they proceeded to expose the same to sale on the premises on the first day of March One thousand eight hundred and thirty eight and that the following tracts being offered for sale, to wit, the North West quarter of Section 36 Township three Range nine West and the West half of the North East quarter of the same section Township & Range. Vinson Dec. between Sarah Ann Vinson widow of said dec & John Emmett Vinson infant son of said dec; beg leave to report that they have in accordance thereto divided the same and have allotted to the widow the following slaves Viz: Wilson a negro man, Charity a woman, Sam a man, Grace a woman & her child Narcissa; Dionitia a girl, Indiana a girl, Kemp a man, Burrell a boy, Caroline a girl & Stephen a man (a Blacksmith) And to Jno Emmett Vinson infant son of said dec the following slaves Viz. Patrick a man, Louisa a woman & her child Jane, Daniel a boy, Adalade a girl, Martha a girl, Ben a man, Jack a boy, Henry a bey, Liza a woman & her child Amanda, & Matilda a girl.

The following information has been compiled as the result of an extensive search in both Alabama and Virginia to determine the Newby family genealogy. Born: 13 Oct 1788 Chesterfield Co., Va. Died: 22 Feb 1861 Madison Co., Ala.

Buried: Newby/Carter Cem. Mad. Co., Ala.

Sallie Haines Newby
Born: 4 Aug 1803 Virginia
Died: 26 Nov 1881 Madison Co., Ala.

Buried: Newby/Carter Cem., Mad. Co. Ala.

Chesterfield County Marriage Register, 1772-1853, page 162, notes the marriage bond for the intended marriage of Matthew Newby and Ann Brooks dated 28 Sep 1820. Martin Brooks, father.

Madison County, Ala., Marriage Bk. 3, James Newby married Sally Haines 26 Dec 1825.

1833 Chesterfield County Personal Property Tax List notes that on March 12 Matthew Newby declared his personal property. The 1834 list does not include Matthew, nor does subequent lists.

Chesterfield Co. Deed Bk 37, 1846-1848, pages 127-128. Matthew Newby and Ann, his wife, and James Newby and Sarah H., his wife, all of Alabama, to Newman Newby of Chesterfield County, 1847. (This deed includes a copy of the acknowledgements by the Newbys in Limestone County, Alabama, 8 Sep 1846.)

Chesterfield Co., Order Bk 31, page 80 notes that at the court session of May 12, 1845, James Cox gave oath that Thomas Newby, Sr., deceased, late a pensioner of the United States, died 24 Mar 1845. This was ordered to be certified to the War Department. Page 491 notes that at the court session of 8 Mar 1847, it was ordered to be certified that satisfactory evidence had been presented to the court to show that Thomas Newby, Sr., was a pensioner of the U.S. at a rate of \$100 per year, that he died 24 Mar 1845, did not leave a widow, but left the following children: Matthew and James Newby now living in the State of Alabama, and Abram Newby now residing in Virginia.

Chesterfield Co., Deed Bk 28, 1830-1832, page 579. Thomas Newby to son, Matthew, both of Chesterfield County, 63 acres for \$100, dated 1 Mar 1832 and recorded 5 Apr 1832.

Examination of the Revolutionary War Record shows the main record is an affidavit by Lt. Nathaniel Rice, 30 May 1783, that Thomas Newby enlisted as a soldier in the State Artillery 18 Aug 1777, for three years, which time he served. The Report of the Secretary of War, 1835, lists Thomas Newby, a resident of Chesterfield County, who was placed on the pension roll 21 November 1832, with a pension to commence as of 4 March 1841. Age was given as 74. See pension file S5812.

Chesterfield Co. Land Tax Records for 1816 cites "Anne Newby, wife of Thomas Newby, 100 acres, transferred from the estate of Phebe Atkins."

Chesterfield Co. Will Bk 8, 1813-1818, page 378-379. Will of Phobe Adkins dated 4 Mar 1814 and recorded 9 Oct 1815. There are references to daughter Anne Newby, wife of Thomas Newby, and the will refers to her grandson Matthew Newby who was the son of Anne and Thomas Newby.

Chesterfield Co. Deed Bk 29, 1832-1835, pages 349-350. Matthew Newby and Nanney, his wife, to Thomas Newby 1833. (Anne/Ann and Nan/Nannie/Nanney are synonymous.)

Federal Census 1850, Limestone Co., Ala. lists: Newby, Matthew, 56, Va.; Nannie, 52, Va.; George, 23, Va.; Patrick, 21, Va.; James 19, Va.; Susan, 16, Va.; Joseph, 14, Ala.; Isabella, 13, Ala.; Benjamin, 11, Ala.

Federal Census 1850, Madison Co., Ala. lists: Newby, James, 60, Va.; Sarah, 44, Va.; James (Jr.), 16, Ala.; Volentine, 14, Ala.; Henry, 12, Ala.; Elizabeth, 9, Ala.

GENERAL HISTORY OF MARSHALL COUNTY, ALABAMA

by James Arthur Thomason

(As published in the 1945 & 1946 issues of <u>The Guntersville Advertiser and Democrat</u>. This series began in <u>Valley Leaves</u>, Vol. 4, No. 1, September 1969.)

Chapter 78 - "Andrew Jackson Built County's First Road" (September 11, 1946)

The following is quoted from the late O. D. Street:

"Roads were usually the precursors of settlement in the early days. The Indians soon learned this, and bitterly opposed the building of highways through their country by the United States.

"The first wagon road in Marshall county was for military purposes and was opened by Gen. Andrew Jackson in 1813, during the Creek war.

"It was constructed by him for the passage of his troops and the transportation of their supplies from middle Tennessee to the scene of conflict in middle Alabama. It ran from Fayetteville, Tenn., via New Market and New Hope along the general course of the present public road to Fort Deposit on the Tennessee; thence via Beard's Bluff, Warrenton, Old Missionary, Weaver's, Cox's old stand, Dulin's and Jordan Gap to the Coosa river.

"The fact that this road after the lapse of more than 100 years is still used as a public road throughout a greater portion of its extent attests the skill and ability of the engineers who accompanied his army. The old road is still known as 'Jackson's Trail.'

"He crossed his army at Ditto's Landing (now Whitesburg) and marched across Brindlee mountain to Brown's Valley, where he camped for two days near Warrenton while he was establishing a depot for his supplies at Ft. Deposit (whence it received its name). His baggage and artillery here joined him and he proceeded to Coosa by the route above indicated. The signs of the old Jackson Trail cross the land of D. L. Bales, Mrs. Bettie Hartsfield and O. E. Bryant. The signs of the 'Trail' you can see going up Sand mountain. It leads by Boaz, Attalla, Gadsden, etc.

"The second road in the county was established by Federal authority under the provisions of the Cherokee treaty of 1816 and was and still is known as the 'Georgia Road'. It extended from Ft. Deposit (following Jackson's trail to Weavers) across Sand or Raccoon mountain by way of Albertville, Collinsville, and Center, Alabama and Cedartown and Dallas, Ga. The great importance of this road at that time lay in the fact that it opened a line of communication between the white settlers in Madison county, Alabama, and those in Georgia and also gave the latter access to transportation facilities of the Tennessee river."

The roads Mr. Street tells about were built in the days before railroads. The people that came to this country came in wagons. The wagon had a bow frame and it was covered with a sheet made of thick cloth.

In 1888 when we moved from South Carolina we had covered wagons. We would stop and camp at night, pick up wood and build a fire. I was 10 years old, I enjoyed camping.

In my piece about the steamboats, the place I mentioned called Hog Jaw was not the Hog Jaw beyond Rice school on Brindlee mountain, but a place in Jackson county that is also called Hog Jaw. It is near Long Island, P. O. Carpenter is the name of the depot, also known as Turnip Salad.

Killing of Joe Childress

... About forty-five years ago – as near as we can come at the date, in 1850 – one Jesse Lucy, at that time an influential citizen of this section, operated a business house at the foot of Lucy's Hill – the hill on which is now located the new cemetery. It was a general merchandise business that Mr. Lucy ran, and included a bar-room, where refreshments were served and where a quiet game of "Honest John" or "Seven Up" could be indulged in by the gentlemen who stopped with Mr. Lucy.

One winter evening in the year named, there occurred at Lucy's place of business an event that created great consternation among the people that lived here. It was the killing of Joe Childress by a man named Hutchinson. Both men were habitues of Lucy's place, and often enjoyed a quiet game of cards. They were each about thirty years of age, and were generally well liked by the people of the district.

On this occasion Childress and Hutchinson were having a game of "Seven Up" and fell out about some point in the game. It is said Childress accused his opponent of cheating, when the latter secured a single-barreled shotgun, and emptied the contents into the former's body. We are informed the same gun is still owned by a resident of the county and less than a year ago was instrumental in the killing of a young man not far from Waterloo.

Waterloo in 1850

At the time of the killing of Childress a portion of the original town of Waterloo had already been moved toward the high ground. Lucy and some others had settled at the foot of the hill above named and were doing business there. Sandy Simmons was a shoemaker and also a justice of the peace.

A man named Bishop lived on the brow of the hill and ran a blacksmith shop at the settlement below. He got \$1.50 for shoeing a horse and proportionately large pay for other work.

Others in business here then were Hargrave Barsew, Carter Madry, James Humphrey, West & Jones, Witherspoon & Harrison, all of whom had large business houses and plentiful stocks, and did good business.

Mr. John Till

who is well known to all our people, remembers those old days. He is a grandson of old Dr. Bumpas, one of the earliest settlers in this section. Mr. Till is an old

keelboat hand, having served in various capacities from cook to general superintendent. He says that Jesse Lucy's was a great resort for the men of that day. It was not often disorderly and the killing of Childress was an exceptional case. The boys could meet there, enjoy a quiet game, drink good whiskey at ten cents a quart and nobody was the worse for it. It was one of the old-time pleasure resorts of the first settlers.

Let this be added to the numerous other solemn admonitions against the use of those articles of dress, which in vain attempts to improve the comeliness of the person, so often destroy life or health.

ABOUT MORGAN CO., ALA., MARRIAGE RECORD B: (by Helen Bowling McKnight)
This book is obviously a copy of either an earlier book OR of the original
licenses and returns. The printed "license" and "return" forms in the book are
dated "186", indicating that the book was printed about 1860 and the copying
of the 1848-1860 marriages was done during the 1860's or later. The copyist's
letters are poorly formed, and there are indications that little attention was
given to the task. (Were the brides' names copied correctly on pages 316-319,
321 and 325? It is unusual for the same Christian names to be used in pairs
so frequently.)

There are indications that the copyist had difficulty reading the records he was copying. Some names are almost illegible making one question the copyist's familiarity with the names. The handwriting throughout the book - and in the groom's index in the front of the book - appears to be that of the same person. The spellings of names frequently differ on original bonds, licenses, and returns; but need they differ in this book and its index? Order from the Probate Judge's Office, for a fee, a copy of any marriage you find interesting. It is best to make your own interpretation of the handwriting whenever possible.

An interesting account of the way of life, events and travels of George Jackson, his family, friends and other Dallas Co., Texas pioneers, 1848-1908, who came from England and the U.S. Included are drawings, photographs, original poetry, and an extensive list of early Dallas County officials.

Some of the families named are: Amery, Bryan, Burford, Cochran, Cole, Furneaux, Huffhines, Kennedy, Knight, McCoy, Marsh, Miller, Morgan, Nash, Patterson, Perry, Rowe, Simpson, Smith, Warner, and West.

Some known errors in the first edition were corrected, others were not. A lengthy table of contents and alphabetical listing of over 1200 Dallas Co. pioneers is partial compensation for the missing index.



Alabama Territory Circa—1776

The earliest settlers to the land of Alabama began arriving in the eighteenth century. The French moved into Alabama from the Gulf and settled near the coast, later moving inland up the rivers from the Mobile area. From the north and northeast came hardy families that began trickling southward through gaps in the Appalachians, following paths that were beaten out by animals and blazed by fur-trappers and traders, into a land of rich soil and mild climate that was well-watered by a multiplicity of small rivers and creeks. The French settlers in southern Alabama were mainly genteel, gracious and courtly while those of the upper state were mainly Anglo-Saxon Protestants. As a group

they were semi-literate, proud, cantankerous and firm in their insistence about their own way of life.

These early settlers of Alabama produced families that were tough and persistent, who had to withstand disease, hunger, deprivation and occasional Indian raids. The material wealth and possessions of most families were practically nilconsisting mainly of an axe, a hunting knife, an auger, a rifle, one or two horses, a few cattle and pigs, a sack of seed corn and a sack of salt, maybe a cross-cut saw and a loom. But that which these people lacked materially they made up for in an iron-willed determination to settle and tame the new land. The new land offered them a

chance to be proud—a chance to make a new life.

Who occupied this land they wanted? Innumerable Indian tribes had roamed here for hundreds of years. Now they were being called upon to share this land of rest and richness.

There seemed to be plenty for all and for many years there was. According to Alabama historian, A. J. Pickett, the Pafallayayas or Choctaws inhabited the territory of the modern counties of Green, Marengo, Tuscaloosa, Sumter and Pickens; the Chickasaws settled upon the northwestern sources of the Tombigbee; while the Cherokees trickled in mainly from the north and east.

Naturally with the passing of time, they all infiltrated into a greater depth of settlement of Alabama. One of the main tribes found in the Piedmont regions of Alabama was the Creek or Muscogee. The Creek Indians received their name from early English explorers because of the many rivers and streams flowing through their Alabama area. As a race, the Creeks were haughty, proud, and arrogant, showing bravery, ambition and restlessness. Like all other known tribes they were fond of ornamentation.

William Bartram, son of America's first botanist John Bartram, travelled through Alabama during the prerevolutionary and revolutionary days and wrote vivid accounts of the Creeks. In 1777, Bartram found fifty towns in the Creek nation, with a populationof eleven thousand which lay upon the rivers Coosa, Tallapoosa, Alabama, Chattahoochie, Flint and the prominent creeks which flowed into them. Muscogee was the national language, but in some towns, variations of this language prevailed. William Bartram travelled from northern Alabama down through the Creek nation to Mobile and on to West Florida. He had become interested in the botanical richness of the area through his father and continued his botanical studies after the death of his father in 1777. In Mobile, Bartram found many vacant houses in the town that extended nearly half a mile from the river. The few good buildings remaining were occupied by French gentlemen and by refined emigrants from Ireland, Scotland, England and from the northern British colonies. The French houses were one story square brick that were large enough to encompass a courtyard in the rear. The lower class homes were made of strong cypress frames that were filled with plaster. Bartram travelled from Mobile through the Creek territory with a caravan of traders who were transporting their merchandise upon packhorses. The road upon which they travelled was much like others in Indian country in that it was narrow and well-beaten. On this journey, Bartram met a group from Georgia who were on their way to what is now Baldwin County. These people are believed to be the first Anglo-Americans to settle there at the confluence of the Tombigbee and Alabama rivers.

Conflicting New World land claims between the French and British seemed destined to bring war upon the continent of North America. There were several territorial disputes and some trading disagreements. These differences brought about a series of short wars and one major war between these powers. This main war was called the Seven-Years War in Europe, and it was called the French and Indian War in America and lasted for seven years from 1756 until 1763. The peace treaty which concluded the hostilities provided the Proclamation of 1763. In this single stroke, France lost all her land east of the Mississippi River to England. This Proclamation stated that all southern lands that made up what is now Alabama were now forbidden to settlers. It was designed to placate the Indians but served no useful purpose in the holding back of families determined to move south. Many fur trappers and traders who hunted in this territory had marked out claims for themselves and had every intention of rearing their families on this forbidden land. One such family was the McGillivrays. Lachlan McGillivray had come to the new world and married a Creek princess of the Tribe of the Wind, whose father had been the French Commandant at Fort Toulouse. This man was the ill-fated Marchand, and his daughter was Sehoy Marchand. McGillivray and Sehoy settled in the French town of Little Tallassee about four miles above what is now Wetumpka. From there he sent his son Alexander to Charles Town, South Carolina, to be educated by his cousin, a Presbyterian minister. The elder McGillivray had praised King George III so often that the state of Georgia fined him for being a Loyalist and confiscated over \$100,000 worth of McGillivray property. After this occurrence, Alexander left Charles Town and returned to his mother's people with an abiding hatred of Georgians. life peculiarly adapted to This was a driving force in making the Alabama—"the Land of Rest."

Creeks favorable to the Loyalists. The eldest daughter of the McGillivrays, also named Sehoy, married a trader named Charles Weatherford. Her first born child was the famed William Weatherford, the great military leader of the Creeks. Another daughter met LeClerc Milfort as he toured the Alabama region. Later they were married. Milfort was renowned in France as a military genius and a scholar. As he travelled through Creek territory he made many friends in the tribes and collected many Indian folk tales and legends. He led the Creeks in most of the battles that they fought during the Revolutionary War. After the war Milfort travelled back to France and was made a General of France by Napoleon. Using the notes he had compiled during his stay ir Alabama he wrote one of the most authoritative books available about the life of the Creek Indians and about his experiences while living with them.

According to early descriptions of the Alabama region, the terrain was varied from the beach to the mountains. Beautiful forests of pines and hardwood adorned the area. The trees were very tall, thick and lush. They enveloped a botanist's paradise due to the tremendous variety of plant life. Also abounding in this abundant land was a plentiful supply of animal life. Nature had blissfully smiled upon the region and afforded early settlers a wealth of life's sustenance.

Following the American Revolution there were many other settlers desiring to bring their families into the land of Alabama. In 1798 the United States organized the Mississippi Territory and Alabama remained a part of this territory until 1817 when the western half of the territory became admitted to the union as the state of Mississippi. The Alabama Territory lasted but a brief two years before it, too, was ready for statehood. Alabama became a state on December 14, 1819.

And so they continued to come-the young, the old, the trapper, the trader, the botanist, the farmer and the family. They came-they stayed. They built farms and started a new way of

JOHN McDOWELL, REVOLUTIONARY SOLDIER

John McDowel(1) was born in Ireland, 10 August 1758. (Name of parents unknown to writer). He was married by publication to Sarah Thomas, born 15 June 1772, daughter of Philemon Thomas, in Marlboro District, S.C. (actually Cheraws, until 1798), on 27 May 1790. John died near Oakville (Lawrence County), Alabama 1 January 1841. The writer has been told in interviews with senior citizens of that area that livestock have broken the tombstones down in the Oakville cemeteries until the exact location of the grave has not been determined.

John Knox states that:

John McDowell, a Scotch-Irish hatter, a fighting Gael, came from North Ireland in 1774, and apparently had hit the shore with his fists already doubled, eager for a chance to scrap with the British. He had joined up as a private in the Maryland Continental Line, and had fought through to the war's end, and had then come to Alabama—by way of Maryland, North Carolina, and Georgia. 1

In his pension paper, the veteran states that he enlisted in 1775, and served three months as Private in Capt. William Woodal's Co., Col. Guest's Maryland Regiment. He then enlisted and served as Private in Capt. James Fair's North Carolina Company. He was in the Battle of Germantown, the Battle on Drowning Creek, Beatie's Bridge, a branch of Peedee River in North Carolina, where he was taken prisoner and carried to Wilmington, North Carolina, and about two months later, he was taken to Charleston, S. C. About six months later, he was "discharged by parole".

Sarah McDowell, widow of John McDowell who served in the Revolutionary War as a Private, was inscribed on the Roll at the rate of \$36.66 per annum, to commence on the 4th day of March, 1848. Her certificate of Pension was issued on the 15th day of January, 1850. (B.L. Wt. 38502-160-55)

In March, 1855, Sarah (Thomas) McDowell was drawing a pension, age eightythree, and living in Lawrence County, Alabama. She died in Lawrence County, Alabama, 13 August 1856.

As stated in John McDowell's Military Record, deposition paper, and folder from GSA, National Archives, we know that he lived in Maryland; Richmond County, North Carolina; Marlboro District, South Carolina; Georgia (Census record shows that his son Miles McKinnis was born in Georgia, 1804, but county is not known at this time.)

In his pension papers, it states that John McDowell had resided in Lawrence County, Alabama six years prior to his death in 1841, and had previously lived in Madison and Morgan Counties, Alabama—and, before that, in the counties of Logan and Warren, Kentucky. Sarah (Thomas) McDowell is listed as a charter member in Hopewell Baptist Church, Morgan County, Alabama in 1824.3

John McDowell was a hatter by trade. In his book, Col. James Saunders wrote:

About 1828, three settlers lived on the south side of Warrior Mountain (or Sand Mountain) in Lawrence County, Alabama, near Moulton—Hansford Fears, John McDowell, and Gilbert C.K. Mitchell . . . he (John McDowell) was a hatter by trade . . . Indeed for the first ten years of the settlement he made most of the hats, and carried on an extensive trade with the negroes and boys of North Alabama for raccoon skins.

John and Sarah (Thomas) McDowell had the following children:5
