

1819 ORGANIZATION AND DISCIPLING OF THE ALABAMA MILITIA

> ACTS of the General Assembly of the STATE OF ALABAMA

Passed at its First Session, Which was begun and held in the town of Huntsville, on Monday, the twenty-fifth day of October, one thousand, eight hundred and nineteen, and ended the seventeenth day of December the same year. WILLIAM W. BIBB, Governor - THOMAS BIBB, President of the Senate -

AN ACT TO PROVIDE FOR THE ORGANIZATION AND DISCIPLINING OF THE MILITIA OF THE STATE OF ALABAMA (Approved December 17, 1819)

(Page 17) Section 1.all free white men and indented servants, between the ages of eighteen and forty-five years, shall compose the militia of this State, Judges of the Supreme, Chancery, Circuit Courts, Secretary of State, Treasurer, Comptroller, Attorney General, Solicitors to the different circuits, licensed Ministers of the Gospel of every denomination, public Ferrymen, Justices of the Peace, Postmasters who have the care of the mail of the United States, and Postriders shall be exempted from militia duty, except in cases of imminent danger, insurrection or invasion.

(Pages 17-18) Section 2.the militia of this State shall compose four Divisions

Ist Division - Jackson, Madison, Limestone and Lauderdale Counties; 2nd Division - Cotaco, Blount, St. Clair, Lawrence, Franklin, Marion,

Tuscaloosa, Shelby and Jefferson Counties;

3rd Division - Greene, Marengo, Perry, Cahawba, Autauga, Montgomery, Dallas and Wilcox Counties;

4th Division - Monroe, Conecuh, Henry, Butler, Clarke, Washington, Baldwin and Mobile Counties;

which divisions shall form nine Brigades,

Jackson and Madison Counties, Brigade 1.

Limestone and Lauderdale Counties, Brigade 2.

Brigade 3. Cotaco, Blount and St. Clair Counties,

Brigade 4. Lawrence, Franklin and Marion Counties,

Brigade 5. Tuscaloosa, Jefferson and Shelby Counties,

Brigade 6. Greene, Marengo, Perry and Cahawba Counties,

Brigade 7. Autauga, Montgomery, Dallas and Wilcox Counties,

Brigade 8. Monroe, Conecuh, Henry and Butler Counties,

Brigade 9. Clarke, Washington, Baldwin and Mobile Counties, each of which shall be commanded by a Brigadier-General; each brigade shall consist of not less than two, nor more than five Regiments,

(Pages 18-19) Section 3. The regiments of the Militia of this State shall be designated and numbered as follows, viz

Jackson County - Regiment No. 1,

Madison County - Pegiment No. 2, northern regiment to be the second,

Madison County - Regiment No. 3, southern regiment to be the third, Limestone County - Regiment No. 4, eastern regiment to be the fourth, Limestone County - Regiment No. 5, western regiment to be the fifth, Cotaco County - Regiment No. 6, (Note: Now Morgan County.-Editor)
Lawrence County - Regiment No. 7, northern regiment to be the seventh,
Lawrence County - Regiment No. 8, southern regiment to be the eighth, and the line between the fifth and sixth townships shall be the dividing line of said regiments, Franklin County - Regiment No. 9,
Lauderdale County - Regiment No. 10, area east of Shoal Creek,
Lauderdale County - Regiment No. 11, area west of said creek,
St. Clair County - Regiment No. 12,
Shelby County - Regiment No. 13,
Blount County - Regiment No. 14,
Laffarana County - Regiment No. 14, Jefferson County - Regiment No. 15, Marion County - Regiment No. 16, Tuscaloosa County - Regiments No. 17 and No. 18,to divide the county of Tuscaloosa into two regiments.... Greene County - Regiment No. 19, Marengo County - Regiment No. 20, Cahawba County - Regiment No. 21, Dallas County - Regiment No. 22, Autauga County - Regiment No. 23, Montgomery County - Regiment No. 24, Henry County - Regiment No. 25, Monroe County - Regiment No. 26, area east of the Alabama River, Monroe County - Regiment No. 27, area west of the Alabama River, Co ecuh County - Regiment No. 28, Butler County - Regiment No. 29, Clarke County - Regiment No. 30, Washington County - Regiment No. 31, Perry County - Regiment No. 32. (Note: See Section 40 for the militia of Baldwin, Mobile, and Wilcox Counties.-Editor)

- (Page 18) Section 2. (continued: following the words "nor more than five Regiments") each regiment shall be commanded by a Colonel Commandant, and to be composed of two Battalions, the first of which shall be commanded by a Lieutenant-Colonel, the second battalion shall be commanded by a Major, each battalion shall consist of not less than two, nor more than five Companies, each company shall consist of not less than forty, nor more than one hundred and twenty privates, and shall be commanded by a Captain, First and Second* Lieutenants, one Ensign, five Sergeants, four Corporals and two Musicians, the non-commissioned officers to be appointed by the officers of their respective companies.
 - * (Page 34) Supplementary Militia Act... Sec. 2. That instead of first and second Lieutenants to each company, there shall be one Lieutenant,...
- (Page 22) Section 16. The Adjutant-General shall receive from the Assistant Adjutants General of Divisions, all returns of the strength and condition of the Militia of this State, and make out four fair copies thereof, annually, lay one copy of the same before each branch of the General Assembly, and retain one copy in his own office, for the information of the Governor.... He shall annually transmit to the Secretary of the War Department of the United States, a return of the strength and condition of the Militia of this State;
- (Page 23) Section 20. Each commandant of a regiment of Militia in this State shall hold a regimental muster annually and each Battalion shall hold one muster in each and every year, at such time and place, near the centre of the (continued)

Organization and Discipling of the Alabama Militia, 1819, continued bounds of the battalion....

(Pages 24-25) Section 25. It shall be the duty of Company officers, to hold Company musters, once in every two months, except the months of November, December, January, and February....

(Page 28) Section 29. The sheriff, or any constable, in each company, shall collect all fines assessed at courts martial.... pay over to regimental paymaster....

(Page 28) Section 30. No officer or private shall be arrested by any civil process, while going to, continuing at, or returning from...(musters)..... shall pass all ferries, bridges, and turnpikes free of expense.

(Page 28) Section 31. Officers may confine for the day bystanders that interrupt the muster.....

(Page 29) Section 34. All persons liable to do militia duty, moving into the bounds of a company, shall within thirty days, or at the next muster after his arrival in said bounds, report himself to the commanding officer of said Company....

(Page 31) Section 40. That the counties of Baldwin, Mobile and Wilcox shall each compose one Battalion....any of the counties above named...organize a regiment therein, so soon as the militia there of shall amount to five hundred effective men.**

** (Page 34) Supplementary Militia Act... Section 1. Counties of one battalion only to have a Major Commandant instead of a Lieutenant Colonel....

(Pages 32-33) Section 47.any person who....remove out of county in which a fine was assessed....amount of the fine forwarded to Sheriff of the county into which the delinquent moved.....for collection....

NORTH ALABAMA STATE MILITIA OFFICERS 1820

This information is taken from Military Register, State Militia, Vol. I, 1820, a book in the Military Room of the Alabama Archives, Montgomery, Alabama. The 1820 commissioned officers for all of the Alabama counties in existence at this time are in this register; however, only the North Alabama counties of Blount, Lauderdale, Cataco (Morgan), Madison, Lawrence, Limestone, Jackson and Franklin were copied for Valley Craves. Contributed by Mrs. Richard H. Gilliam, Jr., Huntsville, Alabama, the militia officers will be presented in two parts, concluding in the June issue of the quarterly.


