

APRIL SEMINAR - BILL LINDER

We are pleased to announce that our annual genealogical seminar will be held this year on April 9, 1983, at the Hilton Inn Hotel in Huntsville, Alabama. We have been very fortunate in obtaining Mr. Bill R. Linder of Washington, D. C. as our speaker. Those who have heard Mr. Linder speak have given him rave notices - he holds his audience's attention and his sense of humor is a delight. His credentials are staggering and we feel his topics will benefit beginners and advanced genealogists alike. Mr. Linder will lecture on record organization without computers and research in the National Archives.

Mr. Linder was born in Kenedy, Texas and is an archivist, author, lecturer and tour organizer. He obtained a BBA degree from the University of Texas and also studied at the American University in Washington D. C., the University of Utah, Brigham Young University, and Southwest Texas State University. Mr. Linder is past director, Central Reference Division, of the National Archives. He is Chairman of the Board of Trustees, International Society for British Genealogy and Family History; a council member in the Association for Genealogical Education; a member of the council of the National Genealogical Society; director, Annual British Genealogical Institute for U. S. Genealogists; member, Society of American Archivists; member, Texas State Genealogical Society; member, North Carolina Genealogical Society; and member, Southern Historical Association. In 1978 he received a Commendable Service Award from the National Archives and became a Fellow in the Arkansas-Louisiana-Texas Genealogical Society in 1979. He is the author of "How to Trace Your Family History," 1978 and is a contributor to "The Genealogist" and various other journals.

BOOK STALLS - AT SEMINAR

Book Reviews

GILES COUNTY LINEAGE BOOK, from the Giles County Historical Society (Pulaski, Tn.). 1982. Published by Margaret Matthews Cowart, 7801 Tea Garden Road, Huntsville, AL 35802. \$23.00. Soft cover, 747 pages, 8-1/2 x 11. Surname index.

The members of the Giles County, Tennessee Historical Society furnished their lineage charts for publication in this outstanding 747 page compilation. Lineage charts begin with the child and continue back to the emigrant ancestor if known. The first five-generation chart is presented in the usual form and information thereafter has been put on "continuation charts." Since many of the charts submitted had common ancestors a clever "master chart" system was worked out resulting in more than 30 master charts. These master charts were used to combine information for the members' common ancestors.

The format is easy to follow and the type is very clear. An added value of this book is the fact that Giles County is a "burned out" county with many of their earliest records missing. There is no index to many of the surviving early records which makes research in that county difficult and time-consuming. Because of this, we feel "Giles County Lineage Book" will be helpful in locating lost ancestors in Giles County.

TAYLOR-OWENS: THEIR TRAILS AND TIES by Thomas A. and Edna C. Taylor. 1981. 8-1/2 x 11. Full name index, 323 pages. Available from the authors: 1687 East 1460 North, Logan, Utah, 84321. \$25.00.

The Taylors have published this work about the ancestors and descendants of William Archer Taylor and his wife, Nancy Ellen Owens. The use of photographs and reproductions of newspaper articles, plus Bible records, makes this an attractive book. Names, dates, and places abound. Sources of much of the information are noted. Lineage charts provide a guide to the book.

Some other surnames in the work are Briscoe, Burner, Johnson, Keyser, and Wallace.

TRACES IN THE SAND, a quarterly, 8-1/2 x 11, 4 pages. \$2.00 from Vista A. Setters, 3545 Bear Hollow Road, Whites Creek, Tn. 37189.

The first two issues of this Allison Family newsletter contain data from the Bible of Richard B. and Sarah W. (Cobbs) Allison and a brief write up about each person listed.

WORTHINGTON DESCENDANTS, a newsletter, 8 pages, 8-1/2 x 11, from the Society, 6619 Pheasant Road, Route 16, Baltimore, Md. 21220

Our review issue contains queries and family information sketches. No indication is given as to the cost or frequency of the Newslatter.

REFLECTIONS, a quarterly, the Coastal Bend Genealogical Society, 8-1/2 x 11, 19 pages. \$8.00, from the Society, P. O. Box 2711, Corpus Christi, Texas 78403.

Volume 18, No. 2 (June, 1982) of Reflections contains a listing of Louisiana Revolutionary War Soldiers; cemeteries from Goliad, Grimes and Jim Wells Counties, Texas; and family records. Queries are free to members and nonmembers.

EAST TEXAS FAMILY RECORDS, a quarterly of the East Texas Genealogical Society. 8-1/2 x 11. 65 plus pages. \$10.00 from the Society, P. O. Box 6967, Tyler, Texas 75711.

The East Texas Genealogical Society was formed in April, 1977 and began publication of the quarterly which contains articles from Anderson, Gregg, Henderson, Panola, Rusk and Smith Counties.

Volume 6, Issue Number 3, includes an article about the Cherokees of Texas. Tax lists, cemetery records, maps, and census records are also in this issue. Queries are free to members.



Volume II, Number 4, of "Freestone Frontiers" contains a school census, marriages, jury lists, Bible records and a cemetery transcription. Included in this issue is a list of the members and the surnames that they are researching. The quarterly has a surname index in each issue. Queries are accepted free of charge from members and non-members.

GENEALOGICAL PERIODICAL ANNUAL INDEX (Vol. 18, 1979) ed. by Catherine M. Mayhew and Laird C. Towle. \$15.00. Order from: Heritage Books, Inc., Suite 301, 3602 Maureen, Boxie, Md. 20715.

The Genealogical Periodical Annual Index gives the researcher a guide to information in genealogical periodicals in the United States and Canada. Volume 18 includes 147 periodicals through 7,700 citations. The GPAI is based on surname, locality, and topical catagories. Entries provide some description of the scope of the articles indexed. Queries are not indexed. Use of the GPAI could simplify research—and help one find, for example, inscriptions from a DeKalb County cemetery published in a Texas quarterly.

The esact location of the Decatur/Jackson County line remains elusive but it was in trying to locate it that negative photostats of the township plats of the Decatur County area were ordered. The public surveys of this land were conducted in 1822 and 1823 but annotations as late as 1888 are included. Located and secured by Catherine Gilliam, this information was transcribed by Dorothy S. Johnson and Margaret M. Cowart. This series began in <u>Valley Leaves</u> Volume 16, Number 1, September 1981.





THE PROGRESSIVE AGE

Old newspapers are important to genealogists as they are contemporary accounts of our ancestors' place in history. "The Progressive Age" was a newspaper published in Scottsboro, Jackson County, Alabama. This particular issue, December 14, 1899, was found folded and placed between pages of the Stephens Bible now in the possession of TVGS member Margaret (Stephens) Gurganus of Ft. Lauderdale, Florida.

Since Jackson is a burned-out county there are no known early [pre-Civil War] extant newspapers from that county and comparatively few of pre-1900 vintage. ACTS OF ALABAMA

1856

The following Acts have been pulled from "Acts of the General Assembly of Alabama" which were the legislative acts passed by the Alabama State Legislature in Montgomery in various years. A complete set of these published Acts may be found in the Alabama Department of Archives and History. The date at the end of the Act is the date it was approved by the Legislature.

An Act to Authorize the Court of County Commissioners to pay certain persons for certain services therein mentioned:

That the Commissioners' Court of the county of Jackson be, and it is hereby authorized to extend similar compensation out of any funds in the County Treasury arising from fines and forfeitures, to Nathaniel Hillion of said county, for services rendered in arresting, guarding, victualing and ferriages of William Dukes, David Dukes and Henry Dukes, on a charge of murder, and Matthew Killingsworth on a charge of being accessory thereto, and also T. A. Ford and William Ford on a charge of murder: PROVIDED said Commissioners shall be satisfied, by proof, that the services were rendered and the charges reasonable. Approved February 13, 1856

An Act to Create additional Company Beat in Jackson County:

That an additional Captain's company beat of the following bounding, viz: beginning at the foot of the mountain in Mud Creek near the residence of George V. Houston, and including it thence north to the top of the mountain near by Coon Creek, thence with the top of the mountain to Geer's old place, thence meandering the top of said mountain to the narrows, between Guess' Creek and Box Cove, thence meandering said mountain eastwardly to the head of Manners' Cove, so as to include Nathan P. Brandens, thence northwardly to the beginning; be established in the county of Jackson, on what is called the Cumberland Mountain, to be known as the Mountain Beat, and be attached to the first Regiment of Alabama Militia, whether there be within said bounds, the requisite number of privates or not.

Be it further enacted that on the first Monday in March next, there shall be held an election at the residence of John Sanders, in said beat, for two Justices of the Peace, a constable, a captain and the requisite subaltern officers, who shall hold their offices for the term now prescribed by law, and a precinct for general elections, is established, at said John Sanders' until otherwise directed by the court of county commissioners.

Approved February 15, 1856.

An Act ordering that the following sums of money be, and the same are hereby appropriated to the payment of the following persons:

To Edmund Reeves for feeding prisoners confined in the jail of Jackson county in the year 1855, Seventy Three Dollars and Eighty Cents.

To Seaborn H. Jones, for arresting William Hanf, in Tennessee, on a requisition of the Governor of Alabama, and delivering him to the jailor in Jackson County, Seventy Dollars and Forty Cents. Approved February 11, 1856

Abstracts of wills of Lauderdale County, Alabama were first published in Valley Leaves in Volume 7 (December, 1972) and began with Will Record 3 (1821). Additional wills were published until that series concluded with the first fifty pages of Will Record "A" in Volume 7 (June, 1974). The current series began in Volume 14 (June, 1980).

Will Record "A" is a large red 316 page volume and is in the Lauderdale County Courthouse, in Florence, Alabama. All decedents were residents of Lauderdale County unless otherwise stated. B. W. Wood was the judge of the County Court and Wiley T. Hawkins was the judge of the Probate Court at the time these minutes were made. Abstracted from photocopies by Dorothy Scott Johnson.

Executor to retain funds of Mary, Sarah, and Harriet Stamps and manage same for their support until they come of age or marry. If executor unable to find a suitable family head for my children then he may sell real and personal property and divide proceeds among my children and the heirs of Lucinda Porter.

"My executor, on distribution of my estate, [to] pay the distributive share of my said son, P. R. Stamps, into the hands of my son John Stamps whom I wish to act as trustee for my said son Richard Stamps." [Note: It is unclear whether Pleasant R. Stamps is Pleasant Richard Stamps or not. The will indicated they are one and the same person but the Petition to Propound Will lists Pleasant R. and Richard as two separate people.]

PETITION to PROBATE MARY DUCKETT'S NUNCUPATIVE WILL

Petitioner: Jonathan Rhodes, for his wife Mary O. Rhodes, and his children Isabella Rhodes and Adaline Rhodes.

Mary Duckett, late of Lauderdale County, Alabama died July 31, 1852. During her last illness, at her habitation, when she was "in extremes but in her right mind" and memory she made her nuncupative Will and Testament in the presence of James D. Callicott and Deborah Duberry, witnesses of lawful age. Mary Duckett declared, in her nuncupative will, Mary O. Rhodes, Isabella Rhodes, and Adaline Rhodes to be the legatees of her entire estate. Mary Duckett left no children nor dependents of children surviving her. She has "one brother of the whole blood," John Odell, who resides in South Carolina and the children of Reynal Odell, decd., who was also her brother. Petitioner does not know the names of said children, all of whom live out of state. Petitioner does not believe Mary Duckett has any kin residing in Alabama who "stands in a nearer relation than Mary O. Rhodes or any other kin who would be entitled to" her estate.

Jonathan Rhodes, petitioner, asks that the witnesses to the will be summoned and the Will admitted to probate.

Pages 214-215 Recorded: 21 Jan 1854 MARY DUCKETT (Nuncupative Will)

Dated: 30 July 1852 Written: 13 Aug 1852

Will taken before Wiley T. Hawkins, judge of Probate, Lauderdale County, Ala. on 13 August 1852.

James D. Callicott statement: On July 30, 1852 Dr. Callicott was called as a physician to see Mary Duckett at her home in Lauderdale County, Ala. She seemed very concerned as to the dangers of her attack and stated she felt she would not recover. She stated she had just gotten a man "to take her unsettled business in South Carolina against her brother and wind it up and that she did not ever want him, her brother, to have any of her property for he had never done her justice." She wanted her friends who had attended to her to have it and that

"Mrs. Duberry had been a good friend of hers and that she wanted Mary Rhodes and her two daughters who had waited on her to have her property. He heard her speak to Mrs. Duberry in an undertone regarding her worldly goods but could not fully understand her. She died the next day, on July 31st 1852. At the time she spoke she was in sound mind and disposing memory.

Deborah Duberry statement: Deborah Duberry was present at the house of Mrs. Mary Duckett and was sitting on the side of the bed by Mrs. Duckett when "she threw her arms around my neck and said, 'My dear child, stick to me as you have always done. If it had not been for you and Polly Rhodes (meaning Mary Rhodes) and them two children, what would have become of me. I want them who have rendered me a service to reap the benefit of my labors and my little negroes. I never want my



brother, John Odell, to enjoy one cent of my property for he has treated me so ill.' Mrs. Duckett was taken [ill] about 10 o'clock on Friday, 30th day of July, 1852, and died the next day, Saturday, 31st July 1852 about 12 o'clock noon."

RICHARD RICE

Dated: 14 Jan 1853 Prob: 25 July 1853

... being of perfect health and of sound mind and memory ...
I have already given my daughters Sarah T. Thrasher and Mary E. Hogan their share of my estate and they are to have no more.

To my beloved wife, Elizabeth B. Rice, in lieu of dower, 1/6 of my real and personal estate and after her death it is to go to my children hereafter named.

To my daughter Rachel F. Casey, wife of Jacob Casey, and to my sons George R. Rice, James R. Rice, William P. Rice, and Solomon C. Rice, the balance of my estate to be equally divided amongst them. 

On October 18, 1852 Joseph S. Stephens and Thomas J. Bray stated they witnessed Edmund Larken's nuncupative will on October 11, 1852 during his last illness and a few days before

his death in his own flat boat then lying in the Tennessee River at Savannah Landing in Hardin County, Tennessee where he was confined by sickness but of sound mind.

He wished his property to go to his brother, Andrew Larken, who then resided in Louisville, Kentucky, because Andrew had always treated him better than any of his



other relatives; that he had never called on Andrew for a favor without receiving it.

Court Ruling

Edmund Larken died about October 12, 1852 in Harden County, Tennessee leaving no widow and his next of kin not a resident of said state. His verbal (nuncupative) was written out and witnessed within ten days of his death and that more than fourteen days have lapsed since his death. The Will is admitted to probate. Edmund Larken did not appoint an executor and James C. Green applied for Letters of Administration which were granted him after he gave \$2000. bond with W. Cheny and Joseph N. Baker as his securities.

TEXAS 1836 REVOLUTION Bounty Land due North Alabamians

The following letter was sent to the 'Moulton Advertiser' of Moulton, Lawrence County, Alabama and appeared in that newspaper on Thursday, November 17, 1898. The letter was dated November 5, 1898 at Austin, Texas, and was written by Mr. Edward W. Goff.

Nov. 5, 1898 Austin, Texas

Major D. C. White Moulton, Alabama

Dear Sir:

A copy of the Moulton Advertiser of March 24, 1887, has just been handed the writer containing an article entitled "Early Settlers of Lawrence Co., Ala." by Jas. E. Saunders, and giving a list of the members of Capt. Jack Shackelford's Alabama Volunteers who fought for the Texas Republic in the Texas Revolution of 1836; also some bits of Texas Revolutionary history. Among the members of Shackelford's company (The Red Rovers), Mr. Saunders mentions Harvey Cox, John Jackson, Wm. Quin, L. M. Brooks, J. G. Coe, John N. Jackson, F. T. Burts, G. W. Brooks, and L. M. Brooks as early settlers of Lawrence County, Alabama.

It may be of interest to your citizens and especially to the relatives of these nine men to know that the Republic of Texas issued to their heirs grants of land ranging from 1476 acres to 4,000 acres, which lands still await claim of the heirs and may bet be recovered for them by prompt action.

A recent investigation of these land grants has unearthed a large number of unclaimed estates in Texas in the hands of administrators, Land Sharks, squatters, and others, or unoccupied, and these lands, although acquired sixty years ago still await claim of the unknown heirs of the original grantees. The land ranges from 300 to 6,000 acres, are worth from two to ten dollars per acre, and were granted by the Republic of Texas to soldiers of the Texas Revolution and imigrants to Texas up to the year 1842.

Following is a list of such soldiers and immigrants whose lands still await claim of their unknown heirs. Many of the persons named were members of Shackelford's Red Rovers or formerly lived in Lawrence Count and counties in Alabama

and no doubt their relatives would welcome this intelligence. The list is as follows:



Adam Nichor died without a will. David Ricketts applied for and was granted

Letters of Administration after giving \$300 bond with James Birdwell and

William S. Johnson, his securities.

William M. Griffin, Richard Griffin, and John A. Mironey were appointed to appraise the personal estate which was ordered sold at public sale.

An inventory of the estate was taken 19 August 1837 and included "One Improvement in the Cherokee Nation" valued at \$20.00. Other items included carpenters' tools, miscellaneous wood cutting tools, and a bed and furniture.

A list of the purchasers of the estate, as certified on 21 Oct 1837, were: [Note: the sale was held 6 Oct 1837]

Estate settled 2 September 1839 before Washington T. May, Judge of the County Court.

Pages 100-106 Randolph Morgan Estate.

Randolph Morgan died without a will. China Derrick applied for Letters of Administration. The widow (not named) appeared in person and renounced her right to administer the estate, therefore, China Derrick was made administratrix after giving \$300 bond with Richard Griffin and Tobias Derrick, her securities. China Derrick made an inventory of the goods, rights, and chattled and made her return to the court within three months as prescribed by law, on 14 May 1838. [Note: China Derrick signed her name with an "X."]

China Derrick's Inventory, dated 5 Dec. 1838, stated: "There is no property on which I can administer after leaving to the widow of the decedent the following property, to wit: 9 head of hogs, 1 cow and calf, 1 mare, 1 bedstead, 1 chest, 1 table, 3 chairs, 1 oven, 1 pot, and 1 skillett. All I can say or do in said administration is to report the time of his service in the Florida Campaign, 3-3/4 months at \$22.50 - \$83.87-1/2, which money has never come to my hands and which has never been drawn from the department." She further states the estate is nearly \$500 in debt which renders the estate entirely insolvent.

After administration expenses were paid there was a balance of \$26.89-1/2 left

to distribute among three creditors:

- 1. Richard Griffin note and interest, \$134.20 paid \$17.46
- 2. White & Woodard judgment on debt plus interest, \$65.31 paid \$8.50
- 3. Alexander Derrick note and interest. \$7.00 paid 93¢.

The court appointed Louis Wyeth, Edmund A. Webster, and Thomas Barclay, Commissioners, to settle the estate. On 2 December 1839 they found the foregoing to be true and correct.

Note: At the beginning of this case Louis Wyeth was shown as Judge of the County Court; on 2 Dec. 1839 Washington T. May was shown as the Judge.

Pages 107-112 Reubin B. Tate Estate
Reubin B. Tate died without a will. On 30 April 1838 Isham H. Fennell applied for and received Letters of Administration after giving \$1200 bond with Benjamin Merrell and Richard Griffin, his securities.

> Andrew Ice, George Chenault, and Lawyer Simpson were appointed to appraise the estate. The personal estate was ordered sold to the highest bidder at public auction. The estate sale was held 11 June 1839 and was "bid off by the widow of said decedent, the whole amounting to" \$49.00. Items "sold" included:

This estate was insolvent with over \$355. in debts and only \$144.90 in assets. Debts were owing to the following:

INTRODUCTION TO GENEALOGY

UNDERSTANDING PROBATE RECORDS by Dorothy Scott Johnson

COURTS

The names of courts handling estates and other probate proceedings vary from state to state and even, sometimes, from county to county within a state. In Alabama it is called the Probate Court but before 1850 it was called the Orphans Court and is still called that in the state of Maryland. When writing for probate records in various states your request will be handled more expeditiously if you address your letter to the correct court. For instance, in New York it is called the Surrogate Court; in Alabama, South Carolina, and Arkansas it is the Probate Court; in Mississippi it is the Chancery Court; in Kentucky and West Virginia it is the County Court; in North Carolina it is the Superior Court and in Georgia it is the Ordinary Court. In Tennessee this court is called the County Court except in four counties; in Shelby and Davidson Counties it is the Probate Court; in Dyer County it is the Court of Common Law & Chancery, and in Hamilton County it is the Chancery Court. For a complete list of the names of the courts in various states I refer you to Val Greenwood's "The Researcher's Guide to American Genealogy," Chapter 13, Pages 234-238.

ORPHANS COURT -vs- PROBATE COURT

In 1850 the name of this court was changed to Probate Court in Alabama. It handled the same probate functions as the old Orphans Court, or County Court. A discussion of these changes will be carried in a later issue of "Valley Leaves." The term, "Orphans Court" is misleading and often confusing to beginners in genealogy because the name implies that it handles only the affairs of orphans. Originally, it was established to handle matters affecting children whose parent or parents had died, thus the name was exactly what it implied: a court which would protect the welfare of children who had lost at least one parent. The probate court still serves that function

the

today but the prime function is to handle estates of the deceased whether children are involved or not. As our social structure changed the work load handled by this court also changed, and it was for this reason that the name was changed to Probate Court.

TYPES OF RECORDS FOUND

Prior to 1900 you will find four main sources of estate information in the Probate Court:

- 1. Minutes ledger
- 2. Records ledger
- 3. Will books
- 4. Original files

Also handled by the Probate Court in Alabama are marriages, deeds, mortgages, and the Government Land Tract Book. Records kept after 1900 include the 1907 Confederate Census ledger, military discharge records, a register of physicians, a register of purchasers of land sold for back taxes, and other minor records. In time, each of these records will be explained in "Valley Leaves" but in this issue we are primarily concerned with Probate Minutes.

PROBATE MINUTES & ORPHANS COURT MINUTES

Probate Minutes are a brief statement of what transpired in court on any given day. Probate Records are a copy of the actual documents filed or acted upon and are of greater value than

Minutes because of the details they give, genealogically speaking. In the Minutes you will find a list of heirs only rarely whereas heirs may be listed in the Records in their entirety. This does not mean Minutes are without genealogical value. On the contrary! They are of immense value but you must know how to interpret them as some of the most important information to the researcher is assumed rather than implied or stated.

Minutes are especially important prior to 1850 as many counties did not start keeping Record ledgers until the name changed from Orphans to Probate.

Examples can best illustrate how to interpret the old Minutes. The first entry in the Minutes you will find concerning your ancestor's estate will be similar to the following abstract of an actual entry from the Madison County Orphans Court Minute Book No. 4, Pages 66-67:

William Mills died without a Will. The widow [not named] relinquished her right of administration in favor of John Maddox. Maddox applied for and received Letters of Administration after giving \$2000 bond with William Dottery and Joel Stone his securities.

If a man died with a will (testate) and named an executor, his widow did not have the privilege of administering his estate. Sometimes, as a courtesy, she gave her written concurrence with her husband's choice. If the executor chose not to act or if he was incompetent, ill, dead, or had moved from the area then the widow was given preference.

In the case of Williams Mills who died without a will (intestate) the widow chose not to administer the estate even though the privilege was offered her. Many pioneer women were illiterate and chose not to administer because of that handicap. Often, however, she was literate and wrote out and signed her request or consent for another person of her choosing to administer in her place. She did this because most women of that period were sheltered from "worldly" matters and she felt incapable of handling the tasks involved which must have seemed quite mysterious to her. Too, in certain socio-economic classes it was not "seemly" (proper) for a woman to involve herself in such worldly matters as estate legalities. Some women did assume the responsibility of administering an estate and she was called an "administratrix." Usually, she was a woman with children, well-educated, and of the more progressive upper-class of citizens. I have seen a few instances where illiterate ladies chose to administer their husbands' or sons' estates but they were the exception rather than the rule and could be easily termed courageous and progressive; they usually had a close relative or trusted attorney guide them through it, however.

If there was no widow the deceased's next of kin was offered the administratorship, usually the eldest son if he was of legal age (21 or over). If there was no relative living in the community who could or would act as administrator then the court usually appointed the local sheriff to serve in that capacity.

In the William Mills estate, above, the widow requested that John Maddox serve as the administrator in her place and the court issued him Letters of Administration. ['Letters of Administration'' is merely a sheet of paper, usually preprinted, giving the date, name of Administrator, his bondsmen's names, the name of the deceased, and the judge's signature; it is authorization for that person to act as Administrator.] As was usually the case, John Maddox may have been a relative, close friend, or neighbor.

The law required anyone handling an estate to post a bond before he could transact business of the estate. The amount of the bond was usually the approximate value of the estate he was to administer, therefore, we can assume that William Mills' estate was worth approximately \$2000 since that was the amount of the bond. Often it was discovered, after the estate had been appraised, that it was worth more than originally thought and the court would require that more bond be posted.

This bond was a surety bond and its purpose was to guarantee satisfactory performance in administering the estate. The securities were persons who could vouch for the administrator's integrity and whose combined assets had to be at least the amount of the bond since they would be held financially responsible for any loss sustained by the estate through negligence or misconduct of the administrator. These bondsmen were usually relatives or very close friends of the administrator.

On occasion, a bondsman was not happy with the way the estate was being handled and would ask the court to be relieved of his responsibility. This request was granted when he was replaced by another bondsman. Bondsmen were also replaced if they were leaving the county, if they became ill, died, etc.

The next entry you will probably find in the Minutes regarding your ancestor's estate is the order to sell perishable property. It will appear similar to the following abstract:

The perishable property of the estate of William Mills is to be exposed to public sale, slaves excepted. Samuel East, David Gray, Holloway Power, Thomas Power, and William Wells, or any three of them are ordered to appraise the perishable property of this estate and report same to the court.

First of all, it is most important that you understand that even though the entry will state that property is to be "... exposed to public sale, slaves excepted," it does not mean there actually were slaves belonging to the estate. The phrase was merely added by the court to cover all possibilities. Until the estate was appraised the court had no way of knowing whether there were slaves or not. Therefore, you must not assume there were slaves in your ancestor's estate based on this entry in the Minutes.

Few people in pioneer Alabama were completely free of debt. The aim was to get the estate into a debt-free position so the remainder could be distributed among the heirs. To do this, in most cases, property had to be sold to pay outstanding debts. The property the family could give up with the least hardship was the perishable property so it was ordered appraised and sold first. Perishable property was anything that would perish such as livestock, grain, fodder, and slaves, however, slaves were sold almost as a last resort.

If the proceeds of the sale of perishable property did not cover the outstanding debts then the personal property was appraised and sold at public auction. Personal property con-

sisted of household and kitchen furnishings, farming utensils (ploughs, hoes, etc.), and even clothing of the deceased. In many records of estate sales you will find the widow and children buying back beloved items they have lived with most of their lives. I find it particularly sad to see a poor widow purchasing her own family Bible or a set of dishes that were, perhaps, a wedding gift from her parents many years before.

Personal property sales are very revealing. Sometimes there are only a few items and sometimes the list covers many pages. The Minutes will not list the individual items sold; you must look in the Record ledger for that or go to the original file if one exists.



If the proceeds of the personal property still did not cover the debts of the estate the slaves, if there were any, were sold. Only approximately one-third of the families in Alabama owned slaves (the greatest concentration of them were living in south-central Alabama) so do not be surprised if your ancestor was not a slave owner.

The last thing to be sold to pay an estate's debts was the real estate. Everything possible was done to keep a roof over the heads of the family. Sometimes that was not possible and the widow and children had to live off the charity of relatives, go to a Poor House, or move to town and take in washings, ironings, and sewing.

In most cases it was not necessary to sell all the real estate. If possible, only a portion of the real estate was sold leaving that portion on which stood the "mansion house" free and clear of debt. Usually the "mansion house" was not a mansion as we think of it today. More often than not it was a log cabin but was called "mansion house" to differentiate it from other buildings on the place such as slave quarters (called "servants quarters"), smoke house, chicken house, barns, etc.

If it was necessary to sell all the real estate the court would appoint "commissioners" (usually the same persons appointed to appraise the property) to also sell it and an entry would appear in the Minutes stating this. After the "commissioners" sold the property (always at public auction after advertising the property for so many weeks in a local newspaper) they would report back to the court giving the judge a record of the sale. The entry in the Minute would appear something like this:

The commissioners appointed to sell the real estate made their report and the same was ordered to be recorded.

The actual deed given for the property would be recorded in the Deeds. The Minutes merely give a brief outline of what happened and did not go into any details

The next item you are likely to find in the Minutes is as follows:

John Maddox made final settlement of his administration on the estate of William Mills.

The word "final" is most misleading to the researcher as we tend to interpret it literally. The law required that each year the administrator give the court a list of expenditure and income of the estate which was called a "settlement." Therefore, these brief entries are final settlement for that particular year and does not mean it is the end of the estate proceedings. If Record ledgers are kept in the county in which you are researching, you will find these yearly "final" reports recorded there in their entirety. They are most interesting because they record every expenditure made by the family and every cent of income.

The next entry you will find in the Minutes regarding your ancestor's estate will be an entry similar to the following one from Page 3 of Book 2 of the Limestone County Orphans Court Minutes:

On this 20th day of December, 1824, John P. Hall, administrator of the Estate of Joseph Flournoy, decd., filed the accounts & vouchers of his administration on Said Estate with the Judge of the Court for final Settlement. It is therefore ordered that public notice be made in the Alabama Gazette for three weeks successively requiring all persons interested in the settlement of said accounts and vouchers to appear before the Judge of the Court at the Court house in the Town of Athens on the 3rd Monday in January next to show cause, if any they have, or cause why said account and vouchers should not be allowed and finally settled.

The last entry you will find in the Minutes regarding your ancestor's estate will be after the judge has gone over the administrator's accounts and vouchers, found them all in order, and no one has objected to the settlement. It will merely state that the administrator made his final settlement on such-and-such date and was ordered recorded.

PUBLISHED GENEALOGICAL REFERENCE MATERIAL COVERING THE ALABAMA TENNESSEE VALLEY.

During the last ten years many genealogical source books were published covering our nine North Alabama counties of interest. Unless members live in this immediate area they are probably unaware of these marvelous finding aids, therefore, we have compiled a list of all books presently available. This is not a complete list of all the material that is available in private collections such as manuscrips or rare books that are no longer in print. The books listed here are presently available from the various publishers.

ALABAMA

Alabama Soldiers (Revolution, War of 1812, & Indian Wars), Volumes A through Fl[7 volumes], by Pauline Jones Gandrud. Each book is from 90 to 151 pages. Through the years Mrs. Gandrud compiled over 45 loose-leaf notebooks of records relating to soldiers who served in the above wars and who, at one time or another, lived in Alabama. The notebooks are alphabetically arranged listing all records that could be found concerning each soldier: pensions, last payment, bounty land warrants, wills, lists of heirs, Bible records, tombstone inscriptions, obituaries, census, or anything of genealogical note including correspondence with descendants dating over the past thirty-plus years. This material has been edited by Mrs. Bobbie Jones McLane who has also included an index to each volume. These volumes range in price from \$8.00 to \$11.00 but please write to Mrs. McLane for her current price list.

Alabama, An Index to the 1830 United States Census, by Pauline Jones Gandrud. 392 pages, \$18.00. Anyone who has attempted to read the very poor 1830 microfilm census can appreciate Mrs. Gandrud's compilation. The index contains the names of all heads of household in 1830 and gives the county residence of each but, unfortunately, does not reference the original microfilm page numbers.

Alabama Records, by Pauline Jones Gandrud. 100 pages each plus index. \$10.00 per volume. Over a period of nearly fifty years Pauline Jones Gandrud compiled 245 volumes (100 pages each plus index) of genealogical information such as marriages, estates, deeds, law suits, obituaries, etc. Ninety five of these volumes cover our North Alabama counties as follows: 58 on Madison County, 13 on Limestone County; 2 on Lawrence County; 5 on Morgan County; 2 on Marshall County, 6 on Jackson County and 7 on Lauderdale plus one volume of land grants that cover some of these counties. Mrs. Gandrud died September 29, 1980 and her son made arrangements with the Rev. S. Emmett Lucas, Jr. of Southern Historical Press, Inc., (P. O. Box 738, Easley, S. C. 29640,) to publish all of these volumes. Most of the volumes have already been published at \$10.00 each and we suggest you write to Southern Historical Press for a catalogue and detailed information on this series of excellent books.

Marriage, Death and Legal Notices from Early Alabama Newspapers, 1819-1893, by Pauline Jones Gandrud. 615 pages, hard cover, \$40.00. Sometimes an estate is solvent and it is not necessary to sell any property to pay debts; either there are no debts or there is enough cash on hand to pay them. Such an entry in the Minutes will appear like the following abstracted entry on Frederick James' estate on Nov. 13, 1826 in the Madison County Orphans Court Minute Book 4, Page 69:

Frederick James estate is entirely solvent and not involved in debt so as to require the sale of any part thereof other than what has already taken place. Therefore, the court appointed William Weedon, Elbert H. Thompson, William E. Phillips, Eldred Rawlins, and Richard E. Mead to divide the real estate among the heirs at law but reserving the widow her dower in all cases.
