

CURRENT GENEALOGICAL PUBLICATIONS, Vol. 1. Edited by Claudette Maerz, P. O. Box 37010, Bloomington, Minnesota 55431 - cost not given - 100 entries - 8-1/2 x 11, soft cover. Index by surname and state.

Claudette Marez's "Current Genealogical Publications" provides researchers a listing of some of the genealogical works that are now available for purchase. Presented in questioaire format, Mrs. Maerz's book provides an overview (as provided by the author) and full order information for each work listed.

FOSTER: A FIRST FAMILY by Bettina Higdon - 8-1/2 x 11, hardbound, indexed. \$40.00 from The Gregarth Company, P. O. Box 1045, Cullman, Al 35056

Mrs. Higdon's "Foster: A First Family" was compiled for, and presented to, her aunt, Minnie Blanche Bradley Williams, on her 84th birthday. The work traces the descendants of William and Sabrina Roberts Foster (born 1795 Ga. and 1804 NC) especially the line of their sixth child, Joseph Archibald Foster.

Section II of the book contains collected data about Fosters who are not known to be related to Mrs. Higdon's line.

THE McCARLEY MEMORIES by Jane Berry McAfee. 8-1/2 x 11, velo-bind cover, indexed. 138 pages. \$15.00. Order from: Search-N-Print, P. O. Box 777, Farmersville, Texas 75031

"The McCarley Memories" by Jane B. McAfee traces the descendants of David McCarley of Spartanburgh District, South Carolina. Beginning with a chronological listing of pre-1790 McCarley records the book follows the family through Georgia, Alabama and Texas.

Reproductions of documents and pictures illustrate the text.

Some of the other surnames included are: Bomar, Chambers, Fowler, Heaton, Tapp, Richardson, Winne and Yeats. The book is indexed by surname with a full-name indexing of the McCarleys.

THE DEDMAN GENEALOGY WITH ALLIED FAMILIES by Wanda Williams Colvin. 1984. Hard bound, 8-1/2 x 11, 303 pages including a full-name index. \$35.00. May be purchased from author at 202 South Roosevelt, Cleveland, Texas 77327.

This book is well laid out and nicely arranged. Mrs. Colvin's Table of Contents enables one to easily locate a given family branch in the book and the full-name index is also very helpful.

Mrs. Colvin's research appears to be quite thorough and well thought out. She has included transcripts of wills and other records to document her work which is excellent especially since she traces this family from Virginia in 1646. In later generations the author has included a generous supply of family photographs and photocopies of actual documents which makes genealogies come alive.

OLD LAND RECORDS OF LIMESTONE COUNTY, ALABAMA. 1984. By Margaret Matthews Cowart, 7801 Tea Garden Road, Huntsville, Al 35802. 8-1/2 x 11, soft cover, 238 plages plus full name index. \$18.00

This meticulously compiled record of the purchasers of Government land in Limestone County is the fourth in a series of published land records by Mrs. Cowart. Others are on Madison (\$18.), Jackson (\$20.) and Morgan (\$17.) counties, Alabama.

This work is actually a transcription of the Government Land Tract Book which is a record of the first owners of all property purchased from the United States Government. Mrs. Cowart made her transcription from the tract book housed in the Limestone County Probate Judge's office then compared this copy with that in the Secretary of State's office in Montgomery since the two copies do not always agree. She has then noted the discrepancies. In many cases, the only record of a man being in Limestone County will be in this work.

In the front of the book is a page explaining the abbreviations used throughout the book—something more authors of genealogical books should provide.

Instead of an Introduction or Foreword, Mrs. Cowart has chosen the title, "Explanation of Some of the Terms Used in This Book." The information she gives in these few pages is invaluable to anyone attempting to locate ancestors in land records. She covers such items as "Public Domain" and "Old Indian Boundary Lines." She shows how your ancestor may have obtained land for military service in Limestone County. Some of the most importation information she gives you is a detailed explanation of how you can find original applicants when the land has been assigned to someone else, how to order a copy of a patent, and how to order land entry papers, plus much more.

This book is broken into chapters by townships and ranges with a map showing the location of each capter within the county. Not only does this show you at a glance where your ancestors lived in the county but Mrs. Cowart has gone a step farther and included a blank township plat in each chapter so you can actually plot your ancestor's land.

The information contained in the book consists of name of purchasers, date, acreage, location of land and the certificate number issued by the U. S. Government. [Reviewed by Dorothy Scott Johnson.]

The exact location of the Decatur/Jackson County line remains elusive but it was in trying to locate it that negative photostats of the township plats of the Decatur County area were ordered. The public surveys of this land were conducted in 1822 and 1823 but annotations as late as 1888 are included. Located and secured by Catherine Gilliam, this information was transcribed by Dorothy S. Johnson and Margaret M. Cowart. This series began in <u>Valley Leaves</u> Volume 16, Number 1, September 1981.

COLBERT COUNTY WILL BOOK "A" - 1869 - 1903 1st Installment

The earliest Will book in Colbert County is Book "A" which runs from July 22, 1867 to May 11, 1903. The first Judge of Probate was C. Womble. Colbert County was carved from Franklin County and became a full-fledged county in 1867. Many of the earliest wills were dated in Franklin County before it was split into two counties. Abstracted from photocopies by Dorothy Scott Johnson.

Pages 1-4

A. L. GARNER, Last Will & Testament.

Dated 4 March 1861, Franklin Co., Ala.

Codicil dated 12 April 1861

Probated 22 July 1867

I, A. L. Garner, of Franklin Co., Alabama being in good health and of sound mind ...

1st. Pay just and lawful debts.

2nd. To my dau. Sallie Bettie Garner, now an infant, all my property both real and personal.

3rd. In case Sallie Bettie dies without heirs of her body my slaves are to be kept together and worked on my land as though I was living and managing them myself.

4th. In case of the death of Sallie Bettie:

I give unto the present children of my brother, Sturdy F. Garner, \$100.00 each for ten years; to the children of my brother Daniel H. Garner, the sum of \$100.00 each for ten years.

5th. To the children of Alexander Malone, Goodloe W. Malone, and John S. Malone, equally, all the residue of the proceeds from my estate for 50 years. [Note: this is in case Sallie Bettie dies without issue.]

6th. At the end of 50 years each of my slaves to select their master and the master so chosen to pay the other heirs a fair valuation for them - it being my desire to keep them together as much as possible.

7th. My executors, A[lexander] Malone, G[oodloe] W. Malone, and J[ohn] S. Malone are empowered to make purchases and sales necessary to best serve the estate. At deaths of executors their oldest children to replace them as follows:

They shall write their names on slips of paper and put them in hats numbered 1, 2, and 3. The one drawing No. 1 shall have the management for the first four years, the one drawing No. 2 shall have the management for the next four years, and the one drawing No. 3 to have the management the next four years, then the rotation to begin over again until the expiration of 50 years.

8th. I appoint Alexander Malone, Goodloe W. Malone, and John S. Malone executors placing full confidence in their judgment and integrity.

Witness: Hector Atkisson John D. Inman J. H. Simpson.

Codicil

9th. I give full executor power to the children and their heirs and representatives.

10th. I wish to be distinctly understood as to raising and management of my daughter,
Sallie Bettie Garner: she is to be kept at home on my premises with a
competent lady employed to attend her. The same servants who now nurse
her shall continue as such as long as they live.

11th. The lady employed to attend my daughter to receive instructions on management of my child from my executors.

12th. None of my brothers or sister, nor their children, are to have anything to do with the management of my child whatever - nor are any of my wife's brothers or

sisters, nor their children, to have any control or management of my child.

I, William H. Person, of sound mind and memory ...

1st. To my son Alfred S. Person and my daughter Sarah J. Person, jointly, the following lands:

the W/2 Section 1-3-14W SW/4 Section 36-2-14W W/2 NE/4 Section 35-2-14W

Also all my household and kitchen furniture, stock of hogs, cattle, sheep, mules. horses, wagons, carts, harness, plough gear and farming implements.

2nd. To my son John A. Person, in trust, for the use and benefit of my grandson, William H. Person, the following land:

COLBERT COUNTY CEMETERIES

During the Great Depression days of the 1930's, one of the Colbert County WPA projects was to copy the cemeteries of the county. Since that time a copy of the work has been on deposit in the office of the Colbert County Commissoners' office and available only to those who knew it was in existence and who went to that office to see it. TVGS has Xeroxed the complete work, indexed it, and will carry some of the cemeteries in "Valley Leaves" from time to time beginning with the December issue.

In the 1930's genealogical research was not as exacting as it is today and a few words of caution must be said regarding these cemeteries. First of all, it is apparent the copyists did not use chalk on the faces of the stones to bring out the lettering to a more legible condition. For instance, a person's initials might be "M. R." on one inscription and "W.R." on another.

There is nothing on the work to indicate when these cemeteries were copied, however, it was probably between 1931 and 1935. Of course, no tombstones erected after that period are included. Too, there is no way we can guarantee their accuracy which depended entirely upon the copyist and the typist. The location of the individual cemeteries is given only roughly and even then in only a few cases. I have tried to correlate these cemeteries with the current Colbert County road map without success. I feel sure there are some that were copied that are no longer on the map and some on the map that were not copied.

The great thing about these cemeteries is that they were recorded. "Civilization," being what it is, has probably already destroyed a number of them and at the very least some of the individual markers have undoubtedly been obliterated by time and the elements.

We extend our heartfelt thanks to the Colbert County Commission for allowing us to copy these important genealogical documents and for sharing them with a hungry public.

AMNESTY AND PARDONS

On May 29, 1865, shortly after the end of the Civil War, President Andrew Johnson issued a Proclamation granting amnesty and pardon, with restoration of all property (except slaves) and rights of full citizenship, to those who would sign an oath and pledge their allegiance to the United States government. This 'blanket' pardon DID NOT include persons who fell into any of fourteen different categories, the most common one being, "All persons who have voluntarily participated in said rebellion and the estimated value of whose taxable property is over \$20,000."

A total of 1787 persons in Alabama applied to the provisional Alabama government for pardons. Of these, forty nine were from Franklin County and one was Dr. James M. Huston. Dr. Huston made a special application for pardon because his property was valued at more than \$20,000 and he was not covered by President Johnson's "blanket" pardon.

Dr. Huston's file was submitted by TVGS member Elizabeth Collins, genealogist, No. 604, 1300 Beacon Parkway East, Birmingham, Ala. 35209. It was photocopied from microfilm at Samford University in Birmingham.

That he is the owner of over twenty thousand dollar's worth of taxable property which alone places him in the excepted classes, as excluded from the general Amnesty extended in your Proclamation.

He further states that he voted for John Bell for the Presidency in 1860; that he honestly believed secession to be a reserved right of each State; that he was largely interested in slavery as a property owner; and that he believed the exercise of the right of secession would place this property on a firm and secure basis; & he was therefore in favor of the passage of the ordinance of secession on the 11th January 1861 by the Convention of Alabama.

He further states that he subscribed fifty bales of cotton to the so-called Confederate Cotton loan, all of which were burnt by Confederate authority.

Petitioner never belonged to the Confederate army, nor did he hold any State or Confederate office during the rebellion, but remained at home, a private citizen, superintending his planting interests & practising his profession.

No charges are preferred against petitioner in any tribunal of the United States, nor has any of his property been seized or in the possession of the United States as abandoned or otherwise.

Petitioner further states that he will in perfect truth & sincerety sustain the policy of your Excellency's administration in restoring the State of Alabama to her Federal duties & relations; that he accepts & recognizes the emancipation of the slaves in the Southern States as a fixed & accomplished fact; & that he will abide by & sustain the laws of the United States & the proclamations of the President thereof in respect to the emancipation of slaves since the rebellion; & that he will in future make a peaceful citizen, loyal to the United States.

Petitioner prays that your Excellency would restore him by a special pardon to his rights of citizenship & property.

- 10. He will be a peacable & loyal citizen in the future.
- 11. No proceedings have been instituted against his property under the confiscation act.
- 12. None of his property is in the possession of the United States as abandoned property or otherwise.

THE PARKS FAMILY

The following information on the Parks family was compiled and contributed by Christine Sumner of Jackson County. The notes and comments are also by Mrs. Sumner. This Parks family came to Jackson County from Blount County, Tennessee, and settled at a place near Scottsboro called "Parks Campground."

The following record is taken from the old Thomas B. Parks diary (son of John Parks). The diary is presently owned by Mr. Julian Clemons of Scottsboro.

Thomas B. Parks Diary

John Parks was born on January 14, 1782. He married Mary M. Dulaney on March 12, 1811. Mary M. Dulaney Parks died February 15, 1812. John Parks married 2nd, August 13, 1816, Ruth Brown (born October 18, 1796).

An Old and Esteemed Citizen Gone

Dr. Andrew Jackson Kirby died at his home three miles south of town, on the 4th of December and was buried at the Parks' graveyard on the Ridge. He was in his 82nd year and passed away tranquilly, expressing no fear of the dark river. Dr. Kirby's father was Joseph Kirby who came to this section from Tennessee in 1800. His brothers were Clinton and Richard Kirby. He was a soldier of the Florida Indian wars and drew a pension for that service. He practiced medicine in the county until enfeebled by age and was always held in high esteem and passed away without an enemy. He married Miss Jane Gossett, who survives him, with nine children and a large family connection. Mrs. J. D. Jordan of this place is a daughter; Mrs. T. D. Starnes is a niece, and W. D. Parks is a nephew.

The Parks Family (-continued-)

"The foregoing obituary is the only evidence we have found to date to prove that Joseph Kirby, one of the first county [Jackson] commissioners, was the father of Lucinda Kirby who married William Delaney Parks.

"When Andrew Jackson Kirby's widow applied for a widow's pension she gave the death of her husband as December 4, 1895 (General Services Commission, Washington, D. C.)

"These Kirbys are also from Blount County, Tennessee, and we believe they came down the river to Jackson County with the Parks family."

FROM THE CONFEDERACY

The following newspaper article, from the "Nashville Daily Times and True Union," was secured for and contributed to TVGS by member P. B. Keel. The newspaper was dated April 21, 1864.

"A mixed crowd of citizens and soldiers, nineteen in number, arrived at the picket line yesterday, direct from the nitre works near Paint Rock, (Ala.) and were sent to Captain Goodwin. Up to a short time since they had all been engaged in the nitre works. Their names are:

1921 CONFEDERATE CENSUS

The 1921 Alabama Legislature passed an Act requiring that a permanent roll of Civil War pensioners be prepared and kept by the Pension Commission. Questionnaires were prepared and sent to all known pensioners, both veterans and widows of veterans. The following is an abstract of some of those returned questionnaires. For a full explanation see the Morgan County chapter in this issue. Abstracted by Dorothy Scott Johnson.

James A. Duncan Route #4 Florence, Ala. James A. Duncan was born May 20, 1842 in Alabama and has never lived in any other state. His wife is now aged 65 and she was born in Lauderdale County. They were married in 1881 in Lauderdale County. He is a farmer.

Mr. Duncan entered service at Oakland near Florence in June 1861 as a private in Company 'D'' of the 9th Alabama Regiment of Infantry under Dr. Butler Houston, Captain, and Col. Wilcox. He was in the battles of Williamsburg, Seven Pines, Second Manassas, Gettysburg, Malvan Hill, Frasier's Farm, Salem Church, and the Wilderness in Virginia. He was wounded on May 6, 1864 in the Battle of The Wilderness but was not captured or imprisoned.

Mr. Duncan served three years and was discharged on account of wounds he received in the Battle of the Wilderness. He was paroled in May, 1865 at East Port, Mississippi.

James A. Duncan lives with his wife and daughter and is a registered voter in the Lauderdale County 12th precinct. The names, residences, and occupations of his living children are:

Mr. Smith entered service at Florence, Alabama in 1861 as a private in Company "C" of the 16th Alabama Regiment of Infantry under Capt. Cal Carson and Col. W. B. "Billie" Woods. He was in the battles of Fishing Creek, Chickamauga, and in the Battle of Perryville, Ky. He was never wounded, captured, or imprisoned. He was in service over four years and was discharged at the surrender in North Carolina. He was paroled April 26, 1865 in North Carolina.

She is in destitute circumstances and our citizens will most likely be called upon for assistance to enable her to reach her people in Mississippi. She is a lady of fine accomplishments, and it would be cruel in the extreme to place her in the poor house where she could have no association. We hope her wealthy relatives will come to her aid right soon.

A Distressing Casualty. Our community was greatly shocked last evening by a telephone message stating that our fellow townsman, Mr. Thomas W. Lynch, who left here yesterday morning with a wagon load of cotton for Decatur, had driven into the back waters of the Tennessee River and was drowned. His body had not been recovered up to 7 o'clock this morning. We have no particulars. The sympathies of our people go out to his distressed family.

ORPHANS COURT MINUTES, 1824 - 1830 (Part Nine)

1828

All persons mentioned in these minutes were residents of Limestone County unless so stated. Daniel Coleman was the Judge from the beginning of the minutes through May 2, 1829 and on May 26, 1829 William J. Mason became the presiding judge. This is not the earliest Orphans Court Minute book in Limestone County; at least one book prior to this time is in the Limestone County Archives.

To fully understand these minutes there are some facts the reader should know. When an estate was ready to be appraised the judge usually appointed five men as appraisers, or commissioners. It was only necessary that a majority, or three, of these commissioners do the actual appraisal.

When an estate or guardianship was ready for final settlement the administrator or guardian submitted his final accounts and vouchers to the judge and asked that the case be settled. The law required that a notice of this intent be published for a certain length of time in a local newspaper. The judge set the date of the hearing on the settlement and at that time anyone interested in the case in any manner could appear and let his wishes or complaints be heard. In these abstracts we have not always stated that the judge ordered publication in the newspaper, however, it should be understood that such was the case.

This Bible record was contributed by Mrs. Lewis Robinson (nee Lucy Chennault) of Huntsville, Alabama. The Bible is very fragile and was photocopied only once. Morris Chennault was a graduate of William and Mary College and his Bible was kept contemporarily. Please note how the name "Chennault" dropped one "n" in later years. This Bible was published in New York in 1816.

A. H. BAYLESS LETTER

The following letter was found in the attic of the old A. H. Bayless home near Madison Cross Roads before it was torn down. It has been gracously loaned to TVGS for publication by Mrs. Mary (Jones) Little of Madison County. The letter was a rough-draft copy of one sent to General Joseph Wheeler when he was in the national House of Representatives.

Madison Cross Roads, Alabama March 3rd 1897

Hon. Jos. Wheeler

Sir:

Your letter of the 27th of Feb. recd. yesterday and contents noted. I will now explain the whole matter. Mr. Jos[eph] F. Ellis was Postmaster at this place [Madison Cross Roads] and on the 4th day of last January he died, and I as one of his bondsmen was appointed as acting Post Master untill a Post Master could be appointed. When I taken charge of the office Mr. D. E. McCants, another bondsman, and my Self recommended J. C. Carpenter as a Suitable person for PM and he was the onley person that applied at the time. We didn't know that Mrs. Toney wanted the office. So She Sent in a petition I am toled with about 50 names. Mr. J. C. Carpenter Sent in a petition with 115 names [on] it. Seames the Depr't paid no attention to the letter McCant and my Self wrote nor the petition Mr. Carpenter Sent in; after waiting Something like a month and there was no PM appointed I Sent in my resignation and asked that this office be discontinued if they could not appoint a PM. So there were two petitions Sent in before I resigned. The PM General did not grant me my request. I am Still acting PM and there are no PM appointed yet. I don't know that there are any Serious objections to Mrs. Toney as PM but there is objections to moving the office. The people will be as well off without the office as they will if the office is moved. Will you please suggest Some plan for me to get out of the affair. It is very illconvenient for me to attend to it.

CAPT. JAMES CRAIG'S MUSTER ROLL

The following was found in the Alabama Department of Archives and History in Montgomery. It is a list of Capt. James Craig's Company mustered into service at Fayetteville, Tennessee on 20 September 1814. Captain Craig commanded a company of Tennessee volunteers in the 'War of 1814' and kept a list of his men in a book.

James Craig's company was composed of approximately 109 men which were recruited from Tennessee and mustered into service at Fayetteville in 1814. This company gave service in the campaigns of Andrew Jackson's Army on the Coosa, the lower Alabama and Mobile Rivers.

Even though this is a Tennessee Company we have chosen to carry it in 'Valley Leaves' because so many of the men whose names appear here did settle in Madison County and other North Alabama counties.

HUNTSVILLE DAILY CONFEDERATE

During the occupation of Huntsville by Federal trooks during the Civil War no newspaper was printed in the county, however, the "Huntsville Daily Confederate" was published in Georgia and brought back to Huntsville. Very few copies of this newspaper survived. The following article was taken from Page 2, Column 1 of the 6 February 1864 issue.

LATER FROM HUNTSVILLE

Our latest dates from Huntsville are in Jan.

We learn that the Methodist Church near the Public Square in Huntsville, was burnt in the early part of December. Some Yankees were occupying the basement of the Church at the time. It is not known whether it was the result of accident or design, but is supposed to have been the former.

Of the twelve citizens who were arrested and required to take the oath of allegiance to the Lincoln Government or leave the Yankee lines, we have heard of Messrs. George P. Beirne and Stephen W. Harris and Dr. Anthony having arrive "in Dixie."

Of many family residences in which the Yankees have quartered, we learn that Gen. Sherman and Staff have taken full possession of Mr. Beirne's with the furniture, pictures &C, occuping it as headquarters, and the portion of Mr. B's family at home being thus compelled to seek a home with friends—General Smith has made Gov. Clay's residence his Headquarters leaving but two rooms for the use of the family—and a portion of J. W. Clay's house is similarly occupied.

1'In Dixie" meant across the Tennessee River, the normal crossing being at Whitesburg

JOHN RHEA ESTATE

The following document was found misfiled in Theophilus Lacy's estate file. Theophilus Lacy was the administrator of Hopkins Lacy and Hopkins Lacy was the administrator of John Rhea Sr. This document is dated 13 May 1833:

'Recd. of Theophilus Lacy, admr. of Hopkins Lacy, decd. (admr. of John Rhea Sr., decd.) the following sums of money, Viz:

For William Rhea's heirs - \$33.37-1/2

All the above named persons being heirs of John Rhea Senr., deceased, and these amounts are coming to them from the sale of land belonging to the Estate of said John Rhea [Senr.] Given under my hand and seal this 13th day of May, 1833."

John Rhea Sr. may have died in late 1814 or in early January, 1815 since the following entry was found in the Orphans Court Minutes of 10 January 1815:

"Whereas it has been Suggested to the Court that John Rhea, late a citizen of this County, has died entestate with a considerable personal Estate in possession and that no person is willing or will come forward to administer on said Estate, therefore, it is ordered by the Court [that] Hopkins Lacy and William Simpson be appointed administrators with power to collect the goods and Chattels, Rights and Credits of John Rhea, Deceased, with full power and authority to Dispose by private Sale or public, as they may see proper, of such parts of said personal Estate as they may in their discretion deem in danger of immediate waste & injury and that they make return at the next Term of this Court of an inventory of said property together with their proceedings therein.

PROBATE FILES

The following are abstracts of the original papers in probate files housed in the Madison County Courthouse. Some of these files have only one paper in them and others are quite complete while others are missing entirely. The saving factor is that even if a file is missing the important documents, in most cases, will have been recorded in the ledgers on the third floor in the records room.

WILLIAM A. FOWLKES ESTATE

File No. 3.

John P. Harrison appointed Administrator 2 December 1833. An Inventory of this estate showed seven slaves. There was a statement from William W. Johnson of Winchester, Tennessee dated 9 November 1833 for \$15.00 for a coffin. There was also a statement from Dr. Estel of Winchester, Tennessee dated 10 November 1833 for \$24.50 for medical services rendered. Apparently William A. Fowlkes died on November 9, 1833 in Winchester. The file mentions "John P. Harrison in right of his wife, Martha A. Harrison, formerly Martha A. Fowlkes" as the only one entitled to distribution of this estate.

Note: This file was far from complete and not all the receipts and statements have been abstracted here. For more information on this family see "The Old Free State, A History of Lunenburg County, Virginia and Southside Virginia" Volume II, Page 368 for a genealogy of this family. This was a wealthy and influential family of Madison County. The tombstones, located in the family graveyard on the plantation, were knocked to pieces by a sledgehammer by the current owner, then carried off to use as a landfill. The inscriptions were:

1907 CONFEDERATE CENSUS

The Alabama Legislature passed an act requiring that a sensus of all Confederate Soldiers be taken in 1907. This was to include all veterans of the Civil War who had fought for the Confederacy and who were presently living in the state of Alabama regardless of where they had served or from what state they had served. It was the duty of the Probate Judge in each county to secure the information and to send a copy of it to the state.


Each veteran was to fill out an Affidavit stating his residence, date and place of birth, and to give a brief statement as to his military service. This information was transferred from the original affidavit to ledgers in alphabetical, or semi-alphabetical, order by the soldier's last name. Some of the affidavits were returned after the ledger was made up and those will be found at the end of the ledger out of alphabetical order. The original ledgers are housed in the Probate Judge's office in each county and the copies are now in the Alabama Department of Archives and History, Military Division. The material used in "Valley Leaves" was taken from microfilm copies of the ledgers in the Archives and was abstracted by Dorothy Scott Johnson. The number preceeding each name is the number of that person as it appears in the ledger.





1921 CONFEDERATE CENSUS

In 1921 the Alabama Legislature passed an Act requiring that a permanent roll of Civil War pensioners be prepared and kept by the Pension Commission. Questionnaires were prepared and sent to all known pensioners, both veterans and widows of veterans. These original, completed questionnaires are now housed in the Military Branch of the Alabama State Department of Archives and History in Montgomery, Alabama. They not only give a brief military history of the veteran but they also give personal information such as when and where married and the age of the wife if she is still living. Unfortunately, they did not ask the name of the wife but did ask for a list of living children, their addresses, and occupations. Abstracted by Dorothy Scott Johnson.

William Ward RFD #2 Joppa, Ala. William Ward was born in Jackson County, Georgia on May 25, 1834. He enlisted at Falkville (Morgan Co.) in August, 1862 in the Weston branch of service. He was an ordnance sergeant in Company "E of the 12th Alabama Regiment under Capt. Donlason and Col. Reese.

Mr. Ward participated in the Battle of Murfreesboro, the Battle of Chickamauga, and the Battle of Atlanta but he was not captured or imprisoned although he was in the service 3-1/2 years. He left the service at Greensboro, North Carolina at the surrender in May, 1865 and paroled at Huntsville, Alabama.

Ward is a registered voter in Baleyton precinct of Cullman County. He is a farmer. His wife, now dead, was born in Blount County, Alabama and they were married August 19, 1857 in Blount County. He is presently living with James Ward. The names, addresses, and occupations of his living children are:

He enlisted in 1861 at Falkville in the Western branch of service serving as a second Lt. in Company "E" of the 12th Alabama Regiment under Capt. Donalson and Col Reed. He was in the battles of Murfreesboro, Atlanta, and Knoxville but was not wounded, captured or imprisoned. He was in the service four years and left the service in 1865 when he surrendered to the enemy. He is a registered voter in the 18th precinct in Morgan County. He is a farmer and is presently living with his wife. His children, their addresses, and oppucations are:

Mr. Youngblood entered service in July, 1861 at Troy, Alabama as a private in the Infantry in Company 'I'' of the 15th Alabama regiment under Captain Benjamin Gardiner and Col. James Cantoy. This Company was also called the Quitman Guards. He was in the battles of Fredericksburg, Gettysburg, Wilderness, Cross Keys, Port Republic, Chickamauga and the Attack on Knoxville, the battle at Beans Station and the Second Manasas. He was not wounded, captured or imprisoned. He was detailed to Longstreet's staff in July, 1863.

He was discharged by parole at Appomattox by Grant after the surrender of Lee and had been with Lee at the surrender in 1865.

Mr. Youngblood is presently living with his family. His living children are:

Mr. Millican entered service in 1862 at Old Falkville in Company "D" of the 5th Alabama Regiment under Capt. Taylor. He was in the battles of Murfreesboro, Cedar Ridge and his last battle was at Selma, Alabama. He was never wounded, captured, or imprisoned. He later transferred to Company L of the 5th Alabama Regiment under Capt. Andy Paterson and Col. Joe Paterson and was in the service a total of three years.

He was honorably discharged at the close of war in June, 1865 at Danville, Alabama. His parole was burned when his house burned. He was a farmer, is not a registered voter, and lives with his wife. His living children and their residences are:
