

Remote Access to Library of Congress

I thought members may be interested to know about a computerized service from the federal government.

Computerized access to the catalogs of the world's largest library is now as close as your modem. More than 26 million Library of Congress records in 35 different files have been available to the public through the Internet since April 1993. Previously, such access was available only to researchers at the Library, Library staff, congressional offices and selected institutions and agencies involved in cooperative programs with the Library of Congress.

The Internet is a non-profit collection of computer networks toast links an estimated 20 million computer users in more than 100 countries. The Library of Congress charges no fees to search its files. In the last year, more than 100 companies offering Internet access for a fee have been started.

The host address for telnet access to the Library of Congress Information System (LOCIS) is locis.loc.gov or 140.147.254.3. LOCIS includes more that 15 million catalog records for books, microforms, music, audiovisuals, manuscripts, microcomputer software, serials, maps, name and subject references, and in-process items. LOCIS also has a listing of 13,000 organization that provide information, arranged by subject.

Except for national holidays, LOCIS is available for searching at the following times (Eastern time):

6:30 A. M. to 9:30 P. M.

Saturday

8:00 A. M. to 5:00 P. M.

Sunday

1:00 P. M. to 5:00 P. M.

Documentation on the system is available from the Library of Congress. The *LOCIS Reference Manual* is a 200-page spiral-bound book with file descriptions, command reference and search points. It costs \$30.00, including postage.

The LOCIS Quick Search Guide is also spiral-bound, and has 30 pages of brief, clearly formatted instruction for searching the Library of Congress files. It describes the content of the files, shows how to construct search queries, and has user tips and examples.

I desire my son Robert Benjamin Wilson should live with the said James W. Wilson and attend school 3 months each year and work the remainder of the time. And James W. William Petty* Pension Application

Editor's Note: the name of Richard B. Purdoms, the Clerk of Madison County Court, is spelled in the documents in various ways, which are all reproduced here.

State of Alabama) Madison County)

On this 29th day of October 1832 personally appeared in open court before the Judge of the Circuit Court now sitting, William Petty, a resident of the county of Madison and state of Alabama, aged sixty-eight years, who being duly sworn according to law, doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7th, 1832:

That he entered the service of the United States under General Rutherford, Colonel Armstrong, and Captain Absolom Bostick who was his immediate commander. He marched from Surrey County, North Carolina as a drafted militiaman through Salisbury from there to Cheraw Hills and somewhere in the neighborhood of Rugby's Mills. He joined General Gates army with which he remained until a few days before the engagement in which Gates was defeated.3 He was detached with about 300 men under the command of Major Elisha Isaacs to reinforce General Sumpter whom he joined in the neighborhood of Camden and remained until his defeat in this campaign.

He was in service three months after the close of which he was engaged in scouting parties until he again entered the service as a substitute for a man whose name he has entirely forgotten. He however recollects that the was commanded by Major Francis Hargrave and Captain Pendleton Isbell. After the close of the last campaign he was engaged in guarding legislature of North Carolina. He was almost continually engaged in scouting parties which at that time was considered a very partisan service. He served more than six months but how long he does not know. During the first campaign he thinks Major Micajah Lewis and Major John Armstrong were in the same town and in the regular service. He further states that he was frequently sent on express. He has no documentary evidence of his service. He hereby relinquishes every claim whatsoever to a pension or annuity except the present and declares that his name is not on the pension rolls of the agency of any state. Sworn and subscribed the day and year aforesaid in open court.

Intg. 1st When and in what year were you born?

Ans. I was born in the county of Fauquier or Stafford state of Virginia, I do not know which, on the 13th day of March 1764.

2nd Have you any record of your age and if so where is it?

Ans. I have a record in my family Bible which

I made myself from what my parents have told me.

3rd Where were you living when called into service, where have you lived since the revolutionary war and where do you live now?

Ans. I lived in Surrey County, North Carolina when I entered the service and continued to live there until the close of the Revolutionary War. I then moved to Wilkes County, North Carolina and lived there until the year 1817 when I moved to Madison County, Alabama Territory, now state of Alabama and have lived there ever since and still do.

4th How were you called into service; were you drafted, did you volunteer, or were you a substitute, and if a substitute, for whom?

Ans. I was once drafted and once a substitute but have entirely forgotten for whom. He was a stranger to me when I engaged as his substitute. I knew him afterward but cannot recollect his name. I was at that time 16 years of age.

5th State the names of some of the regular officers who were with the troops whom you served, such continental and militia regiments as you can recollect, and the general circumstances of your service.

Ans. I cannot state more particularly than I have done in my declaration to which I refer in answer to this interrogation.

6th Did you ever receive a discharge from the service, and if so by whom was it given, and what has become of it?

Ans. I never did receive any discharge. It was at that time considered of no value.

7th State the names of persons to whom you are known in your present neighborhood, and who can testify as to your character for veracity and their belief of your services as a soldier of the Revolution.

Ans. Drury Allen and Samuel Chapman are present; any others to whom I am known I believe will do the same.

To be considered for publication, manuscripts submitted must have a reliable reference and cannot be based entirely on family legend. We also cannot accept material copied verbatim from books still in print; such references are welcome, however, in footnotes included for clarification of the text. Fair use practice of the copyright laws must be followed.

Valley Leaves is primarily interested in publishing the following types of material:

- Family Bible records. These must include the title page, and if available, the date of publication page [usually the reverse of title page]. Cemetery readings. These must include cemetery location, directions to find it, and whether the listing is complete, or a certain section.
