

Witnesseth that the undersigned Leroy Pope and Thomas Bibb of the Territory of Alabama, John Coffee, James Jackson, and John Childress of the State of Tennessee Dabney Moore of the State of Virginia and John McKinley of the State of Kentucky have in consideration of the premises promised covenanted and agreed, and do by these presents for themselves and their heirs respectively promises and covenants and agreed with the several members of said company for themselves their assigns and representatives to hold and possess and stand seized of all and singular the sections quarter sections and fractional sections of land as before described in trust and for the common benefit of the members of the said Cypress Land Company, their assigns and representatives in proportion to their several interests and for the purposes before expressed hereby agreeing covenanting and engaging well and truly to perform to the best of their judgement and ability all and singular the acts matters and things necessary and proper by them to be done as Trustee for the purposes aforesaid and more particular to execute, fulfill and perform the following articles of association.

The Land Company shall be called The Cypress Land Company.

The joint interest in said lands or capital stock of said company shall be divided into four hundred and eighty shares. Each associate or member of the company shall be entitled to a number of shares equal to the proportion of the purchase money of said lands paid by him according to the agreement and understanding of the parties Interest for each a certificate shall be signed and sealed by the land Trustees. The certificate shall be in evidence of the title to the share which it describes by its number. The shares shall be regularly numbered: and the trustees shall cause the same and the several certificates by them issued, to be fairly registered, in the books of the company. The said certificates shall be registered in the like manner when executed

with the certificate for that purpose to the proper agent for the company having charge of the books. The evidence of the assignment of a certificate shall be the signature of the owner acknowledged before and witnessed by such agent or proven or acknowledged in the manner required by law in cases of the payment of certificate of the Register of the land office for lands sold by the United States.

Art. 3 The assignment of a certificate duly executed and acknowledged shall pay the entire interest of the assignor and vest all of his title and claim in the assignee or assignees and the representative of such share holders as may die before the business of the company shall be closed shall be entitled to all the rights & privileges and advantages in all respects of the original associates and share holders.

Art. 4 The trustee shall have the entire directions and management of the company interests in trust and for the benefit of the whole. They shall have power to rent, lease, sell and convey all or any part of the company lands to establish one or more ferries on said lands and the same to occupy rent or sell.

Art. 5 The trustees shall as early as may be lay out on such part of the company land as they may deem most eligible a town to be called Florence on such lands and in such manner as they may deem most advantageous to the Company interests and to the growth prosperity and importance of said town: conveying titles to persons purchasing lots making such appropriations of grounds for streets, allies, squares public walks public buildings school houses churches, etc. as they may think proper and make all conveyances necessary to effect the purposes aforesaid, the trustees shall give at least three months notice by public advertisement in as many newspapers not less than three as they think properly of the sale of lots in the said town of Florence and shall determine the condition of the sale and the terms of credit.

Art. 6 The said Trustees may by written power under (seals) and revocable at pleasure, con-

stitute and appoint out of their own body or otherwise an agent or agent authorizing him and them under such restrictions limitations and conditions as shall be deemed proper and necessary to make contracts in their behalf and to rent lease sell and convey lands town lots and ferries and to receive all moneys of the Company, the said agent shall enter into bond in such penalty and with such security as the trustees may require conditional for the faithful and honest discharge of the duties of his agency.

Art. 7 The trustees shall be entitled to retain small moneys rec'd from the sale of lands & rent of lands lots and ferries a commission of five per centum in full compensation of their own services and those of their agents.

Art. 8 All expenses incurred by the trustees for laying out and clearing said town making plats and advertising registering conveyances and shall be borne by the share holders in proportion to their respective interests and the trustees may call for and demand such proportions when necessary.

Art. 9 The certificate of the Register of the land office at Huntsville for said sections quarter sections & fractional sections as aforesaid purchased by the Company shall issue in the name of the said trustees who shall out of the joint funds of the Company pay the remaining installments as they become due or sooner if the moneys in their hands arising from the sales and rents shall be sufficient for that purpose and they deem it advisable, when final payments are made, they shall take out patents in their own names.

Art. 10 The share holders shall pay to the trustees the several sums which may become due on each share for the second third and fourth installments on the lands at or before the time specified in their several certificates. Any share holder failing or refusing to pay all or any of said sums as they respectively become due shall forfeit his interest in any share so held by him and unpaid, and the same shall be sold at public auction giving at least one hundred and twenty days notice of the time

and place of sale; and new certificates reciting the facts shall be issued to the purchaser of purchasers which shall entitle the holder thereof to all the rights benefits and advantages of an original associate or regular assignee but in case in any share or shares on which payments are not made when they become due respectively should happen to belong to an infant the excess on the sale of such shares over the sums necessary to cover the payment and the expenses consequent on the delinquency, shall be paid over when demanded, to each infant or his guardian or representative and it is hereby further provided that any delinquent shareholder may present a forfeiture of any share so advertised for non-payment and maintain his title to the benefits of the Company by coming forward at or before the time of sale and paying up the sum due with averages and the expenses of advertising.

Art. 11 If any shareholder claims a certificate of stock to be issued in lieu of one lost or mislaid or destroyed he shall make an affidavit of the fact and state the circumstances of the loss or destruction and he shall advertise in one of the newspapers of Huntsville and Nashville respectively for the space of six months on account of the loss or destruction describing the certificate and its number; calling on all persons to show cause why a new certificate should not issue in lieu of that lost or destroyed and he shall deposit with the trustee or their agent his affidavit and advertisement before mentioned and give the trustee a bond of indemnity with two or more sureties and in such penalty as they may require against any damage which may arise to the trustee or the Company from issuing the new certificate whereupon the trustees shall three months after the notice aforesaid, issue a new certificate of the same number and tenure of that said to be lost or destroyed, and specifying that it is in lieu thereof; which new certificate shall give all the right and advantage of this one lost or destroyed.

Art. 12 The said trustees shall keep a journal of all their acts to proceedings and regular accounts of all sales, leases and rents, receipts and expenditures and disbursements which

journal and accounts as well the book of the Company shall be open at all times to the inspection and examination of any share-holder and one in each year they shall submit statements of all the accounts cost and proceedings and the general state of the common trust fund to a meeting of the shareholders which shall be convened in said town of Florence by the public advertisement in the most convenient newspaper giving ninety days notice thereof.

Art. 13 The said Trustees shall from time to time and at least once a year at the annual meeting of the shareholders before provided for, declare and make dividends among the shareholders in proportion to their respective interests of all moneys of the Company collected and remaining in their hands, once and above the sums necessary to pay for the Company lands and appropriated to that purpose and when the whole property is sold, they shall make a fair and final discovery of proceeds and profits among the several shareholders in proportion to their respective claims.

Art. 14 At the expiration of five years from the day of the first public sale of lots in said town of Florence the land trustees shall proceed to sell at public auction in said town on a credit of at least twelve months all of the unsold real property of the company having first laid out the same in such parcels (?) and in such manner as they may deem most advantageous to the parties in interest: of which sale they shall give at least six months notice in not less than four newspapers.

Art. 15 As soon as practicable after the expiration of the term of credit in the sale provided for in the last article, the trustee shall make a fair and final settlement of the affairs of the Company, shall pay over to the several stockholders their respective proportions of the balance in their hands and close the concern.

Art. 16 The consent of all the trustees shall be necessary to constitute and appoint the agent. They convey titles on sales made with the consent of the majority, that is to say, of your

members of the board except when a trustee shall be a purchaser in which case all the rest must concur.

Art. 17 If any of the trustees die before the close of this association the survivor or survivors shall act with the same full power of the whole board. In case a trustee should resign he shall convey full title to those remaining in the trust. Absent trustees shall by power under seal authorize some person to sign seal and deliver conveyances and do all other necessary acts and things to which a majority concur and shall as well as the trust be as completely and effectively bound thereby as if acting in person.

Art. 18 If all the trustees should die before the business of the association [is] complete[d] and final fulfillment of the trust, any two or more shareholders may by public advertisement in some newspaper most convenient to said town of Florence and giving six weeks notice call a meeting of the shareholders for the purpose of choosing new trustees to close the business of the Company at such meeting absent shareholders may vote by proxy, a majority of shares must be represented. Each share shall be entitled to a vote; and the decision of a majority of the shares present shall bind the whole company.

Art. 19 The heirs and representatives of each trustee or trustees as may die before the completion and termination of the trust, shall convey to the surviving trustees (or their successors in case of the death of all) the legal estate in the undivided interest in the saidlands which may at the time of the death of such trustee or trustees remain unsold and shall give in the necessary conveyances of the legal estate to purchasers of said lands and lots and shall be bound to perform at all other acts necessary to convey clear legal title in pursuance of this trust.

Art. 20 This instrument within three months be recorded according to law in the county of Lauderdale, the Territory of Alabama; and a plan of said town on or before the day of the public of its lots and the said Leroy Pope and Thomas Bibb of the Territory of Alabama

Book Reviews

THE PRESS FAMILY HISTORY - The German Ancestors and American Descendants of Johann Gottlob Press. 1581-1993. Compiled by Don Press, 125 Kensington Drive, Madison, AL 35758, Phone (205) 772-8062. Paperback, comb binding, 120 pages plus Bibliography and index. \$30.00 from the author. The author begins with a map and description of Germany and the Baden-Wurttenmberg and Oberndorf areas with pictures of both towns. He shows pictures as early as 1600 and pictures of the same town today. Mr. Press explains his numbering system in his introduction so that one can easily find your own line in the book. He follows both the paternal and maternal lines of the Press family in Germany and the children of the American progenitor, Johann Gottlob Press. There are many nice pictures that would make the book very interesting to anybody of this line. In America the areas where the Press families lived are OH, IL, WI, and MO.

TAILORS AND TATES OF THE SOUTH By Ann K. Blomquist. The book is 7" by 10", 976 pages, hardcover, Symth-sewn, and was printed by Gateway Press of Baltimore MD The every name index of 56 pages of 3 columns. George Taylor (1759-1843) settled in Madison Co, AL in 1812 and lived here until his death. A chapter is included about him beginning on page 68. Many of his descendants still live in Alabama. The author begins by sorting out three William Taylors in VA and bringing the line down through TN. GA, and AL. She explains her numbering system and gives a relationship chart. The book is extremely well done and would be a prize in any Taylor - Tate researcher's library as well as an excellent tool for research as no genealogy is ever "finished".

LOGAN COUNTY, KENTUCKY DEED ABSTRACTS 1792 - 1813 by Joyce Martin Murray. 2921 Daniel, Dallas, TX. Softcover. \$30.00. 147 pages plus 48 pages of 3 columns index and 2 page slave index.

Logan County, KY was created in 1792 from a part of Lincoln County and was the 13th county created in that state. Originally it covered a very large portion of Southwestern KY. Christian and Warren counties were created from the area in 1797, Muhlenberg in 1799, and Livingston and Henderson Counties were formed out of parts of the original Logan County. Other counties formed from Logan Co, KY are Allen in 1815 Simpson County, 1819, and Todd county in 1820. Most of the settlers came from the parent state of VA, but many many others came from NC, SC, MD, PA and other states and the IL, IN, LA and Miss Territories. Many RW Veterans came for the granting of VA lands in the area set apart for the VA Continental Line. This book covers deed books D,E,F, and G. of Logan Co., KY.

A product of an extremely hearty family (his father lived to by 87, his grandfather 87 and his great-grandfather 88), Samuel W. Wallace (1795-1886) himself lived to be 91. The genealogy traces 1673 descendants of this singular man, with information on his siblings's families and additional information on Kirby, Hodges and Davis families. The book is filled with extracts from documents that support the suppositions, a d the author has avoided including any questionable data from vague or unknown sources. The area cover is the Southeast, NC, SC, TN, GA, AL and on to the West.

The descendants of Robert Bean and Martha Womack are recorded in this book. Robert Bean was born in Virginia, fought in the Indian Wars, was a companion of Daniel Boone, was a Tennessee Volunteer, a Hero of Kings Mountain and an intrepid Pioneer- Patriot. So says his tombstone. This family spread across Tennessee, down into Georgia, Alabama, Mississippi, Louisiana and Texas. There are many deeds, some maps and military

records. This was a prolific family and Mrs. Rankin has done a remarkable job of recording them in an interesting way. It is a good tool for researchers interested in the Beane name and their allied families.

The compiler follows nine of the eleven children of Robert Beane and Martha Womack plus the Womack lineage to Martha. They were early settlers of Tennessee, moving across the state and early down into Mississippi in the 1820s. Some of the other names are Foster, Selman and Owens.

The book is divided into three sections: The descendants list, personal histories and allied families.

Ezekiel Craft 1762-1843 was b. in Duplin County, NC and served in the Revolutionary War. He married Sally—?—, and with a group of pioneers moved to east Tennessee, settled in what became Claibourne County, TN. about 1799. He migrated to Madison County, Mississippi Territory and settled in Madison Co, AL by 1810 when he appears on tax lists with his brother Archealous. Ezekiel settled near Big Cove and bought land on Aldridge Creek too.

Ezekiel's descendants eventually moved to Texas. Allied families are Grayson, Glover, Vann, Jackson Strayhorn, and Lanier. The states covered are Georgia, KY TN AL and TX.

Included are many copies of original documents, deeds, marriage records, pictures, and military records.

Some of the names of the homeowners are Berry, Payne, Walker, Cockran Kilpatrick, Dale Gary, Dodson, Horton, Jones, Rodgers and many more. There is a picture of most of the homes in the book. The identity of the house printed on the picture would have been helpful. For a volunteer project and a labor of love it is a nice book.

Unusual genealogical information for the neighboring counties will be considered. *Valley Leaves* focuses on the years before the turn of the century.

Typed submissions are a must; we prefer sumissions be in ASCII format on an IBM-readable diskette, which can be returned to you on request.

To be considered for publication, manuscripts submitted must have a reliable reference and cannot be based entirely on family legend. We also cannot accept material copied verbatim from books still in print; such references are welcome, however, in footnotes included for clarification of the text. Fair use practice of the copyright laws must be followed.

Valley Leaves is primarily interested in publishing the following types of material:

- Family Bible records. These must include the title page, and if available, the date of publication page [usually the reverse of title page]. Cemetery readings. These must include cemetery location, directions to find it, and whether the listing is complete, or a certain section.
- Southern Claims Commission Records courthouse records diaries church records
- military records minister's records newspaper items, etc.
