

The "New Market Rebels" Part One

"NEW MARKET REBELS"-This is the name of a company of twelve month volunteers, raised by Dr. M. P. Roberts, under Governor Moore's Proclamation of November 22. It numbers about 70 men, and organized on Saturday last, with the following officers: M. P. Roberts, Capt.; William H. Word, 1st Lieut.; William C. Criner, 2d Lieut.; J. M. Rice, 3d Lieut.; A. H. C. McCoy, O[orderly]. S[ergeant]. Dr. R. and his company deserve much credit for the energy and promptitude they have displayed. It argues well for their efficiency in the service. This is the first company in this county to report itself for duty, under the last call. Dr. R. requests us to say that he wants more recruits."

So reported the *Huntsville Democrat* on Wednesday, December 11, 1861. The New Market Rebels were destined to see all the action they could want in the brutal War Between the States, serving in the heroic 27th Alabama Infantry Regiment. At least eleven of the men from New Market (and probably more) would lose their lives in the war, while others would be permanently disabled.

The New Market Rebels were mustered into the Confederate Army on December 24, 1861. They then were sent by rail to Nashville, Tennessee, where the 27th Alabama Infantry Regiment was formed. The 27th Regiment was unusual in that it was composed entirely of men from

North Alabama. Of its nine companies, three were from Franklin County, three from Lauderdale, and one each from Madison, Morgan, and Lawrence Counties.

The 27th Alabama was soon sent to Fort Henry, on the Tennessee River. When a Union army under General Grant marched on the fort in early February, the 27th Alabama was ordered to nearby Fort Donelson, a stronger post on the Cumberland River. There the regiment saw its first combat, taking an active part in the battle for the strategic fort. Unfortunately, Donelson's inept commanders decided to surrender the fort on February 16, 1862. Almost the entire 27th Regiment thus became prisoners of war.

The soldiers from New Market, along with the rest of the 27th, were sent to Camp Douglas, a hastily built Union prison stockade on the shore of Lake Michigan at Chicago, Illinois. This occurred during an unusually harsh winter, and many of the prisoners soon fell ill. Six of the New Market Rebels died of disease at Camp Douglas, most of them from pneumonia.

Enough of the 27th's officers and men had been sick or otherwise absent to form two companies, and new recruits were added in February and March. These companies were temporarily assigned to the 33d Mississippi Infantry

Battalion, and served with the Mississippians—fighting with them in the Battle of Perryville, Kentucky—until the prisoners were exchanged at Vicksburg in September 1862. The 27th Regiment then was reorganized.

Since the men had enlisted for only 12 months, they were given the choice of reenlisting for another three years or being discharged. Most chose to remain in the army, though some of the men understandably took their discharge and returned home.

The New Market Rebels now elected new company officers, since Captain Roberts had resigned in June and 1st Lieutenant Word had been killed at Perryville. Lieutenant Criner also disappears from the records at this time and presumably did not reenlist. Lieutenant John B. Corn was chosen to replace Captain Roberts, and John H. Jacks and John B. Crutcher were elected lieutenants.

The reorganized 27th Alabama Regiment spent the winter of 1862 as part of the garrison of Port Hudson, Louisiana. They then fought against Grant's army once again in the contest for Vicksburg. The regiment took an active part in the Battle of Baker's Creek, Mississippi, on May 16, 1863, losing many men. However, the 27th was fortunate enough to leave Vicksburg before the city was surrounded and besieged, and spent the winter of 1863 in camp at Canton, Mississippi.

In the spring of 1864 the 27th Alabama was sent to recruit near Tuscumbia, Alabama. While there, a detachment staged a daring raid across the Tennessee River and captured an entire Union army camp. Despite its recruiting, the 27th was still understrength and during the Atlanta

campaign it was consolidated with 35th and 49th Alabama Infantry Regiments. The 27th was singled out for praise for its conduct at the Battle of Peach Tree Creek, Georgia, where it captured the flag of the 33d New Jersey Infantry Regiment and also an artillery battery. The 27th Regiment next marched with Hood's Army into Tennessee, suffering very heavy losses at both Franklin and the Battle of Nashville.

Following Nashville, the 27th Alabama Regiment was so decimated that it almost ceased to exist. Even before this, the New Market Rebels were hardly an effective fighting force. "My company owing to death and desertion now only numbers fourteen men," Lieutenant Jacks had written on Dec. 9, 1864, and most of the 14 apparently were captured or straggled during the fighting Tennessee. Lieutenant Jacks was himself allowed to resign in February 1865, and Captain Corn was captured in Madison County at the beginning the same month. Captain Corn may already have resigned by that time, since Colonel Lemuel Mead listed him as one of his cavalry officers. If so, Corn's resignation has been lost.

By the spring of 1865, what remained of the 27th Alabama Regiment was in North Carolina with the Army of Tennessee, vainly attempting to stop Sherman's march up the coast. On April 9, 1865—the day that Lee surrendered—the 27th was consolidated again, this time with the remnants of the 55th and 57th Alabama Infantry Regiments. Just two weeks later, the Army of Tennessee surrendered and the war was finally over for the 27th Alabama. However, only one of the New Market Rebels was still there to see it end: Pvt. W. Y. Derrick. All the others who surrendered as Company F

had been members of Company A of the 57th Alabama until the final consolidation of the shattered Alabama units.

Unfortunately, as is usual with the Army of Tennessee, the muster rolls of the 27th Alabama are largely missing. The earliest muster rolls of the New Market Rebels were lost at Fort Henry in February 1862, and one has to rely largely on Union prison records for this period. In fact, no muster rolls have survived before July 1863 and none after December 1863. The records of a few men who served from New Market thus may be completely lost, as seems to be the case with PVT. Hiram Jacks. For many men, the only record of their service is to be found in the Union prisoner of war rolls.

What follows, then, is necessarily an incomplete record of the New Market Rebels. But it is probably the best that can be done from the limited information still available.

(Note: Since the men from the 57th Alabama Regiment did surrender as Company F, 27th Alabama, I have included their names. They are marked with an asterisk for identification. These men had enlisted at Troy, Alabama, in March 1863. Their regiment had been badly cut up at Peach Tree Creek and at the final Battle of Bentonville, North Carolina. The 27th Alabama must have been proud to welcome such veterans into its ranks.)

Commissioned officers:

Corn, John B., 2LT/CPT.

Enlisted 24 Dec 1861 at New Market. Elected brevet 2LT Feb 1862 (replaced 2LT Rice). Captured at Fort Donelson. Sent to Johnson's Island 24 Apr 1862. Exchanged Sep 1862 and replaced M. P.

Roberts as CPT.. Captured 1 Feb 1865 in Madison Co., Ala. Released on oath from Camp Chase 13 June 1865 (dark complexion, dark hair, blue eyes, 5' 4 ½", age 33. res. Madison Co., Ala.). [Cpt. Corn was murdered at Hazel Green about a dozen years after the war.]

Criner, William C., 2LT

Mustered in 24 Dec 1861 as 2LT. Captured at Fort Donelson. Sent to Johnson's Island, Ohio, 24 Apr 1862. Exchanged 4 Sep 1862 for a Union officer captured in Kentucky. No further information. [Presumably discharged at reorganization.]

Crutcher, John B., PVT./2LT/1LT

Enlisted 24 Mar 1862 at New Market as PVT.. Appointed 2LT on 24 Sep 1862. Appears July-Aug 1863 as 1LT. Reported 19 Aug 1864 as sick at East Point, Ga. Admitted to St. Mary's Hospital, Union Springs, Ga. 3 Sep 1864 for diarrhea. "Transferred" 6 Nov 1864. No other information. [Memorial tombstone placed in Mount Perhan Cemetery, by his wife, says he fell at Battle of Nashville, Dec 1865, age 37.]

*Hamil, John M., 2LT

Enlisted 12 Feb 1863 at Greenville, Ala. as PVT. in Co. A, 57th Alabama Infantry. Promoted to CPL 9 July 1863. Commissioned 2LT 16 Feb 1864. Wounded at Peachtree Creek. Paroled 26 Apr 1865 at Greensboro, N. C. as 2LT. (res. Pike Co., Ala.)

Jacks, John H., PVT./2LT

Enlisted 24 Dec 1861 at New Market as PVT.. Captured at Fort Donelson and sent to Camp Douglas. Exchanged Sep

1862. Appointed 2LT on 24 Sep 1862. Wounded (foot) 15 Sep 1864 at Lovejoy, Ga. Requested to resign 9 Dec 1864. ("My company owing to death and desertion now only numbers only fourteen men, and I think I can be of more benefit to my country as a private. And I earnestly ask that my resignation be accepted and that I be allowed to join Col. Russell's 4th Ala. Cav., Gen. Wheeler's Command.") Resignation approved by Gen. Hood "to resign but not join the cavalry." Discharged 11 Feb 1865. [On 1907 Confederate Veteran Census as Jonathan Haynes Jacks.]

Rice, J. M., 2LT

Mustered in 24 Dec 1861 at New Market as brevet 2LT. Resigned 18 Jan 1862 ("In consequence of a fall from my horse thereby entirely incapacitating me from military duty I respectfully resign my office of 3LT in New Market Rebels.") Surgeon George D. Norris, 3d Alabama Infantry, confirmed disability. On 10 Mar 1862 CPT. M. P. Roberts wrote: "J. B. Corn of the same company was regularly elected to fill his vacancy about the 10th of February last and all the papers were lost at the bombardment of Fort Henry, where I was stationed at the time."

Roberts, Martin Patrick, CPT.

Mustered in 24 Dec 1861 as CPT.. Not present at Fort Donelson and thus escaped capture. Resigned commission on 15 June 1862. Appears 8 Mar 1864 on receipt collecting 1864 "Tax in Kind," Holmesville, Ala. (References to Dr. M. P. Roberts noted as appearing in the personal papers of William P. Jacks, Company K, Forrest's 3d Tennessee Cavalry, 14 Nov 1861.)

Word, William H., 1LT

Mustered in 24 Dec 1861 at New Market as 1LT. Killed 8 Oct 62 at Battle of Perryville, Kentucky, while temporarily commanding a company of 33d Mississippi Infantry.

Enlisted men and NCOs:

Adams, John S., PVT.

Appears only in Union records: captured in Madison County, Ala. (no date). Took oath of allegiance 29 Aug 1864 (light complexion, sandy hair, grey eyes, 5' 9" tall); sent north of Ohio River to remain until end of war

Adams, Thomas T., SGT/PVT.

Enlisted 24 Dec 1861 at New Market as 2d SGT. Captured at Fort Donelson and sent to Camp Douglas. Exchanged Sep 1862. As PVT. "Taken prisoner at Vicksburg, Miss., paroled July 6, 1863." "Furloughed from paroled camp, never returned. Deserted since Aug 23, 1863."

Beard, James A., PVT.

Captured at Fort Donelson and sent to Camp Douglas. Admitted to hospital 16 Apr 1862 with pneumonia and diarrhoea. Died 9 May 1862 and buried at Camp Douglas.

Bell, Jesse, PVT.

Captured 25 Nov 1863 at Missionary Ridge. Released from Rock Island on oath 20 June 1865 (fresh complexion, brown hair, hazel eyes, 5' 4 1/2" tall, age 29. res. Troy, Ala.).

The Franklin Times, Russellville, Alabama Part 3

- P. 2. Married. Chenault-Osborn. Married at the residence of the bride's father near Beeson, Franklin Co., Ala., Dr. C. S. Chenault of Mt. Hope and Miss Ellen Osborn of Birmingham. The writer officiating. The Doctor is up to date in his profession and enjoys the full confidence of the public. Miss. Ellen is in the front ranks with the accomplished ladies of North Alabama. J. R. NeSmith.
- 2. Teachers. Superintendant McRight has handed us a list of teachers to whom have been issued license to teach as a result of the examinations recently held here. It is something out of common that license to teach be issued to a boy of 17 and his grandfather of 70 on the same day but such is the case as to two of the teachers named below, viz: Judge J. M. Jordan, Ex Probate Judge of Franklin County and his grandson Elbert Jordan, son of Tax Assessor, Price Jordan. Elbert is a bright promising boy and has been receiving the congratulations of his friends on winning the much coveted license. FIRST GRADE. Miss Maud Forbes, L. S. McRight. SECOND GRADE. Seab H. 



Hugh and Samuel Henry agree to furnish Andrew whiskey for the purpose of retailing during the term of 5 years and is to be rated at its wholesale cash value at the time of delivery and is also to constitute a part of the capital stock. It was agreed that Andrew Moore give his exclusive attention to the management of the business during the term of 5 years. Afterward to close & settle the affairs of the same. To pay the boarding expenses of a clerk, to furnish a good & respectable store and necessary number of hours free from rent to do all the buying settling collection, settling all matters of contract connected with the business. Not requiring Samuel & Hugh Henry to do any part of it. Andrew Moore further agrees to settle the remaining unsettled business connected to the firm at Gunters Landing when required being subject to their instructions in the settlement of same paying the expenses which may occur therein. Andrew Moore also agrees to receive, store up, and sell all East Tenn. produce as Hugh & Samuel Henry may from time to time assign him during the 5 year term free from storage and commission Samuel & Hugh paying all other expenses. Eventually every genealogist/family historian encounters a need to preserve some sort of evidence, whether it is an original document, photograph, or perhaps even an audio or video tape or a computer disk.

A Preservation Guide: Saving the Past and the Present for the Future is a practical and inexpensive reference which fulfills the genealogist's requirements for obtaining instruction on the preservation of materials. This guide contains a Chapter, "General Guidelines for Storing Materials," and then subsequent chapters on the maintenance of paper, books, photographs, motion picture videotape, sound recordings (phonograph records and audiotapes), computer disks. and textiles. Additionally, a helpful chapter, "Disaster Recovery," gives advice first on the selection of an archival site, and secondly on the recovery of materials mostly from the ravages of water. Importantly, A Preservation Guide: Saving the Past and Present for the Future does not overlook the importance of the fact that a trained a conservator should handle complex preservations, and this guide provides insight into the selection of a professional for conservation purposes. Finally, a three page list of suppliers and sources of pertinent materials is provided along with a bibliography, glossary, and a brief biography of the author.
