

#### A Request for Information

TVGS member Ms **Judy Wills** in the process of writing a book about the 45th Alabama Infantry Regiment. It was organized in May 1862 at Auburn Alabama. It was made up of companies from the counties of Barbour, Randolph, Lowndes, Macon, and Russell. It was immediately sent to Mississippi and at Tupelo suffered from camp diseases. Later it moved to Kentucky, fought at Perryville, then was assigned to General Wood's, Lowrey's, and Shelley's Brigade, Army of Tennessee. The 45th participated in the difficult campaigns of the army from Murfreesboro to Atlanta, was with Hood in Tennessee, and ended the war in North Carolina. It was organized with 750 men, reported 91 casualties at Murfreesboro and 117 at Chickamauga. In December, 1863, it reported a total of 366 men and 309 weapons. The regiment lost 27 killed, 72 wounded, and 32 missing at the Battle of Atlanta and was almost annihilated at Franklin Tennessee. Only a remnant surrendered on April 26, 1865. ## Special Feature

#### Halbert's Inc. - Publishers

Editor's Note: This is a compilation of three articles which appeared in two genealogical periodicals concerning this company, its products and its marketing practises. Most items stated in the articles are self-explanatory; however, one needs to be stressed. There is no such thing as a "Family" Coat of Arms or "Family Shield." A legitimate coat of arms is awarded to an individual and after his death is usually inherited through the line of the oldest male child. The system is intentionally complex, time intensive to understand and can be very expensive (involving thousands of dollars). If in the future Halbert's should change the orientation of their products, genealogical neophytes will still have a need to know how the genealogical community felt about their earlier products

### HAVE YOU HEARD FROM HALBERT'S?

On 23 March 1995, the National Genealogical Society, in cooperation with the Federation of Genealogical Societies, submitted a report to the U.S. Postal Service. The report supports a request that the Postal Service investigate the mail order business known as Halbert's, Inc. Halbert's produces books whose main feature is a list of addresses for others who share the addressee's last name. It markets these books in ways that lead possible customers to assume they contain material about their own family histories.

#### The Products

Halbert's promotes six titles:

- (1) The World Book of [Addressee's surname] lists addresses and reports immigration records drawn from P. William Filby and Mary K. Meyer's Passenger and Immigration Lists Index.
- (2) Burke's Peerage World Book of [Addressee's surname] is the same book; however, readers should know that, contrary to the advertising, the company once known as "Burke's Peerage" did not publish this book. That firm ceased business in 1987.
- (3) [Addressee's surname] Since the Civil War lists addresses and gives names and dates of deceased Social Security recipients. These come from the Social Security Death Index.
- (4) [Addressee's surname] Since 1791 and
- (5) [Addressee's surname] Since 1620 repeat chapters taken from The World Book and from Since the Civil War. They contain no new data.
- (6) Who's Who of [Addressee's surname] in the United States includes details drawn from questionnaires completed by addressees.
- The report evaluates two books purchased for review: *The World Book of Hinchliffs* and *The Joslyns Since the Civil War*. It concludes that a customer cannot expect to learn anything about his or her own family from these books.

- Halbert's also markets "clan reunion tours" of Scotland. Brochures show that tourists follow a standard route through Scotland no matter where their own ancestors might have lived.
- Finally, Halbert's sells coats of arms. Although its literature calls them "ancestral," these arms are created by Halbert's own artists. They have nothing to do with the ancestry of those who purchase them.
- Dr. Helen Hinchliff, chairman of the Ethics Committee, prepared the report. She was helped by committee members, Erma Miller Angevine, Birdie Monk Holsclaw, Anita Anderson Lustenberger, and Milton Rubincam. An eight-page summary of the report is available from the Federation of Genealogical Societies or the National Genealogical Society.

Sales Technique

Halbert's letters suggest to purchasers that a book on their name will give them facts about their roots. The name of a person who shares the addressee's last name is on the letterhead. The letter states that this person is the "director" of a project that resulted in the book on his or her name. The envelope includes a "family" snapshot and many addressees assume that this is the "director's" family. However, all envelopes contain the same photograph. Further, the so-called directors did not work on Halbert's books. Instead, they sold the use of their names to Halbert's in return for a two percent cut on book sales. This sales pitch works. Halbert's sold 500,000 surname books in 1993 and projected sales of over 780,000 for 1994.

Failure to Abide by Consent Order

Halbert's does business by mail order. Title 39 U.S.C. § 3005 forbids the conduct of schemes or devices for obtaining money through the mail by means of false representation. The U.S. Postal Service has investigated Halbert's before. In 1988, that firm's representatives signed a Consent Order promising to cease and desist from falsely representing their products. Nevertheless, the report concludes that Halbert's advertising disregards both the letter and the spirit of the 1988 Order.

#### What You Can Do!

Over the past year almost 100 genealogists have contributed comments and complaints about Halbert's books and/or its advertising methods. Dr. Hinchliff included them in the report. However, comments and complaints have continued to pour in. She has analyzed these and forwarded summaries to the postal authorities. Now, the time has come for you to write to the postal service directly. ### Halbert's Under Cease and Desist Order

Halbert's, Inc., of Bath, Ohio, a mail order firm that markets surname products, has agreed to the provisions of a cease and desist order issued by the United States Postal Service (USPS) in November 1995. "Halbert's," "Family Book Offer," and "Historic Book Offer" are trade names used by Numa Corporation of Akron, Ohio.

On 23 March 1995, the National Genealogical Society (NGS), with the support of the Federation of Genealogical Societies (FGS), submitted to the United States Postal Service's Chief Counsel, Consumer Protection, a 120-page report on Halbert's marketing practices with the request that these practices be investigated.

NGS and FGS also launched a "grass roots" campaign to encourage the participation and cooperation of genealogists nationwide. A brochure and companion flyer entitled "PSST! Wanna Buy Your Name?" were mailed to genealogical societies and libraries. Societies were asked to reprint the cartoon and brochure text in their newsletters. Librarians were asked to post the flyer on their bulletin boards. As a result, many people wrote to NGS and its Ethics Committee about the solicitation materials they had received from Halbert's, and others wrote directly to the US. Postal Inspection Service.

On 21 November 1995, the Postal Service issued a supplemental cease and desist order prohibiting Halbert's from further use of certain misleading marketing practices, which included a consent agreement signed by Halbert's. Previous cease and desist orders issued against Halbert's in 1985 and 1988 remain in effect.

The supplemental order issued in November 1995 includes the following provisions:

Halbert's was ordered to cease and desist from falsely representing "... that (1) a solicitation for a surname related product was sent by a relative of the solicitee; (2) a relative of a solicitee was involved in preparing a surname-related publication; or that (3) a relative of a solicitee endorses a surname-related product." The Postal Service contended that the company's solicitations, which advertised books such as The World Book of [surname] and The [surname] Since the Civil War, violated the 1988 consent agreement, because they appeared to be letters from relatives of the addressees urging them to purchase a recently completed book on their family.

Halbert's was ordered to begin displaying prominently the following disclaimer on any advertising for surname related publications: "No direct genealogical connection to your family or ancestry is implied or intended."

Halbert's was ordered to cease and desist from"... representing, directly or indirectly, that advertising has been approved by the United States Postal Service."

The consent agreement entered into by Halbert's in November 1995 contains several other provisions. Halbert's may submit proposed advertising to the USPS General Counsel not more than three times per calendar year to obtain an opinion on whether the advertising violates cease and desist orders. Halbert's must pay \$2,000 for each submission to defray investigative, administrative, and legal costs incurred by the Postal Service.

For a period of one year from the date of execution of the consent agreement, Halbert's must, "... within ten (10) days after written request therefor, pay full and unconditional double cash refunds, including postage, handling, and deposits, to all consumers who have previously requested in writing to [Halbert's], and not received within thirty (30) days after the receipt of the written request therefor, refunds in connection with any and all surname-related solicitations in use prior to the date of [the consent agreement]." Halbert's must also accept and honor refund requests from the Better Business Bureau, the Postal Inspection Service, the Ohio Attorney General's Office, and any other duly constituted governmental entity which has received complaints from consumers about its promotions.

Under the 1988 cease and desist order, the following conduct by Halbert's is prohibited:

- Representing that a book is principally about a particular family name and the history of this family name
- · Representing that a book contains information about someone's forebears and their emigration

from Europe

- Representing that a book contains information about the heraldry and family crest of a particular family
- Representing that a book explains how a particular family got its surname
- Representing that a book explains why someone's forebears immigrated to the New World (the United States, Canada, and Australia)
- Representing that a book explains why persons with a particular surname immigrated to the New World
- Representing that a book is the result of research through numerous sources by themselves, or someone acting in their behalf, to compile information on persons with the addressee's surname who immigrated to the New World

The Postal Service has advised NGS that Halbert's is a member of the Direct Marketing Association and participates in the Mail Preference Service. Anyone who does not wish to receive future mailings from Halbert's can have their name deleted from the company's mailing lists by writing to: Direct Marketing Association, Mail Preference Service, P.O. ## NGS Consumer Protection Committee Update

Dozens of NGS members have written to ask whether Halbert's is violating a U.S. Postal Service Cease and Desist Order by continuing to solicit orders for its World Book series. Others have asked about the meeting that representatives of the NGS Council and the NGS Consumer Protection Committee held with a delegation from Halbert's, Inc. Here's an update!

On 21 November 1995 the US Postal Service and Halbert's signed a consent agreement under which Halbert's agreed to cease and desist from, among other things, falsely representing "... that (1) a solicitation for a surname related product was sent by a relative of the solicitee; (2) a relative of solicitee was involved in preparing a surname-related publication; or that (3) a relative of a solicitee endorses a surname-related product." The prohibitions of the 1988 cease and desist order were to remain in effect.

The Postal Service did not consult with NGS about whether its cease and desist order responded adequately to the complaints we made about Halbert's misleading advertising nor did the Postal Service inform NGS when the order was signed. We learned about it early in the new year when Halbert's initiated a new solicitation letter.

In January 1996, Halbert's ceased using letters signed by a so-called director when it solicited orders for its world Book; instead, the letters were signed by *Sharon Taylor* or *William Forman*. The letters were revised to eliminate the chummy, folksy language that formerly had suggested a relationship between the person who had supposedly directed the project and the addressee, both of whom had the same surname. The package included a revised order form with a disclaimer that "No direct genealogical connection to your family or ancestry is implied or intended."

The issue is whether the US Postal Service is properly enforcing the 1988 cease and desist order by allowing Halbert's to continue to send letters that appear to violate it directly.

On 10-11 May 1996 representatives of Halbert's registered for the NGS conference in Nashville and attended the banquet during which Consumer Protection Chair Helen Hinchliff gave a talk entitled "Scams, Suckers, and Megabucks: the Shady, Shaky Side of Genealogy." Among other things she addressed the subject of Halbert's sale of phony coats of arms. The following morning NGS representatives met with a delegation from Halbert's, at the latter's request.

The purpose of the meeting from Halbert's point of view was to inform us that they were making efforts to publish materials that would be useful to genealogists. The purpose of the meeting from the NGS point of view was to discuss our continuing concerns with Halbert's products and advertising Mr. Ludwig A. Huck, Halbert's newly-appointed Vice Chairman and General Manager, chaired his delegation and Mr. Curt B. Witcher, then NGS First Vice President, and Manager of the Genealogical Library of Allen County (Fort Wayne), Indiana, chaired the NGS delegation.

Mr. Huck informed NGS that (1) Halbert's is considering dropping the promotion and sale of coats of arms, a practice that NGS has long shown as deceptive and false; (2) Halbert's has appointed an Advisory Board whose purpose is to provide advice on how to gain the approval of the genealogical community; (3) the firm has plans to bring out additional products; and (4) its representatives believe their products are useful for genealogists and they are proud of them.

The NGS delegation (1) expressed gratification that Halbert's is considering the elimination of coats of arms and gave additional examples of the falseness and deception involved in the promotion and sale of coats of arms for surnames, (2) held that Halbert's advertising materials continue to misrepresent and to mislead the public, and (3) argued that their products are not as useful to genealogists as they claim.

Mr. Witcher repeatedly asked, why, if Halbert's is proud of its products, do they not describe them accurately in their promotional materials. Mr. Huck invited NGS to provide detailed analyses of the ways in which its promotional materials mislead the public.

On 24 June 1996, the NGS Consumer Protection Committee prepared the first of several proposed analyses, showing line by line the many ways in which Halbert's new World Book Solicitation letter falsely represents the contents of the World Book and appears in several ways to violate the 1988 Consent Agreement. We directed this analysis to Mr. Ludwig Huck and to the members of Halbert's Advisory Board. We sent a copy to Mr. Daniel Bryant, Consumer Protection Lawyer, US. Postal Service. In the same packages, we sent a compilation of 30 complaints and queries that NGS members and other interested parties had submitted to the Committee about the new solicitation letter. Since then over a dozen new complaints and queries have come in.

Please lighten the burden of the Committee

If you feel strongly that Halbert's letters are misleading and deceptive, you should be writing your letters to Mr. Huck, to the members of his Advisory Board, and to the Postal Service. Here are their addresses:

Transcriber's Note The original will was recorded, in 1851, in Franklin County AL, Will Book "B," pages 61, 62 and 63. Found in Columbia County, Arkansas, Will Book "A," Page 1. Thomas' widow, Peggy Moss, was the following Will in this book.

Page 1 The State of Alabama Franklin County

I Thomas Moss of the county and state aforesaid do

I also in like manner give to my daughter Rachel Newby during her life and at her death to be equally divided amongst her bodily heirs the Negro woman Aney and her child Harriet and the Negro boy Andy also valued by me at seven hundred dollars. I also give and bequeath in like manner to my daughter Sarah Reed and her bodily heirs the Negro

I also give and bequeath to; my daughter Peggy Mil\_??? for her sole use and then to her bodily heirs, the Negro woman Cinda and her child Adalin valued by me at seven hundred dollars. I also give and bequeath to Nancy Cook for her sole use at her death to her bodily heirs the Negro woman Eliza valued by me at six hundred dollars . I also give and bequeath unto my son Jackson a certain Negro boy Henry valued by me at three hundred dollars to pay a certain debt due by Samuel Cook to Elijah McCullock and for the Payment of which debt my son Jackson stands bound being nearly three hundred dollars now should Samud Cook will and truly pay the above debt to my son Jackson the boy Henry shall be the property of my daughter Nancy Cook and her heirs forever.

Also I desire the Negro boy Julius to be sold and the proceeds divided equally amongst my daughters --folly Lewis, Pheby McCullock, Peggy Milone???

<u>Editors Note:</u> This is the fifth installment of extractions from this newspaper. The first installment appeared in Volume 30, Number 3 (March 1966) and has appeared continuously since then. We have set aside our normal rule of not accepting 20th Century information because of the lack of 19th Century records for Franklin County - the results of a 1890 courthouse fire.

Fly & Hobson vs H. E. and H. F. Plaxco, jury failed to agree on verdict.

The above two cases brought out probably the hardest legal fights during last term of court. Rollins was charged with burning storehouse of W. R. Petree at Belgreen three or four years ago. In the other case Fly & Hobson vs H. E. and H. F. Plaxco the fight turned on a effort of the plaintiffs to prove the existence of a partnership between the defendants. The case was strongly fought by Messrs. Carmichael and Sargent for plaintiffs, Almon and Bullock for the defense, resulting in a "dog fall."

Wesley Miles goes to the mines for 128 days for procuring money under false pretense. Ed. Harris (col) Grand Larceny gets one year in the penitentiary. Both men will be carried off this week.

Like the golden ray of a spring morning sun, suddenly obscured by a drifting cloud; like the hushing of the sweetest music, or like the plucking of the most fragrant rose, was the passing of little Annie Myrtle, the youngest child of Mr. and Mrs. J. ### Madison County Will Book 1, 1852 - 1856, Pages 61 to 81

Abstracted by Eulalia Yancey Wellden Assisted by Carolyn Tribble Nogues

Editor's Note: This is a continuation of the Second Series of Madison County Wills which began in Volume 15, Number 1 (September 1980) and is continued from Volume 31, Number 2 (December 1996).

For this series, Ms. Wellden, not only abstracted information from the Madison County Will Book, but has also included additional information, abstracted from other sources, which, she believes, pertains to the family involved in the estate. The reader is cautioned that such a connection may or may not prove to be correct after a more detailed search. For this reason, this information appears at the back of the article and is marked Supplemental Information (Endnotes).

Will of John P. Johnson Will Book 1, Pages 61, 62 and 63 Dated: 1 December 1854

My body be buried in the burying ground near the Baptist Brick Church on Flint River by the side of my father and mother on the north side nearest the fence according to the rites of the Masonic Usage. My bay mare is to be sold at auction. To my sister Martha Byrn I give all my household furniture and a note I hold on W. B. Tabor for \$240.00 due 1 March 1854. To my two sisters Sarah Sibley and Elizabeth Sibley I give three Negroes, a boy, Lewis, and two women. Delila and Finely Ann. and \$300.00 to be divided between them as follows. The boy Lewis and \$350.00 is to be lot number one. Delila and Fenely Ann are both to be lot number two. My two sisters Sarah and Elizabeth Sibly are to draw lots. In case any or one of the Negroes may object or refuse to go then he is to be sold and the money is to go to the one who may have drawn that Negro. Also to my two sisters Sarah and Elizabeth my two colts to be divided in like manner as the Negroes. And after all expenses are paid the balance of money to be divided equally between my three sisters Martha Byrne, Sarah and Elizabeth Sibley. I appoint my friend John W. Weaver as executor.

My wife Eliza Ann and daughters Ellen and Susan continue in our present residence until the estate is divided. My daughters be given liberal and comfortable support as Susan's education completed. My son Angelo given a liberal allowance until the division of the estate. My son John F. should he desire, be given any financial assistance, executors pay heirs annually, \$600.00, until the division of the estate and the sum be charged against him. John C. M. Glover, nephew of my wife, shall continue at school and be supported until he has acquired sufficient education to fit him for business an allowance for this purpose be made out of the estate. When debts are paid, the estate must be divided. To my wife Eliza Ann my plantation known as "Oak Place" containing 320 acres together with the Mountain Tract known as the Fagan Place 200 acres, also 20 acres lying on the N. E. Corner of the Fagan Place, during her natural life. At her death the land be equally divided between my heirs at law. Also to my wife Eliza Ann one-fifth part of the slaves except a family to be specifically dispose of. Eliza Ann to select Richmond as her one-fifth share. To her all my household and kitchen furniture, also the carriage and horses. All the stock and farming equipment necessary to cultivate the farm. All other property not disposed of be devised to

my children equally divided between them. In making the division equal the portions which either of them have received is to be charged to them. My son Matthew W. Allowed the interest on \$5,000.00 from 1st September 1850 until the division of the estate, in addition to his general share in the estate. For any old and decrepit servants proper provision for their care and comfort. A family of Negroes to be set free, viz: Bet or Elizabeth aged 23 a mulatto woman, a mulatto boy Ellis, a mulatto boy John Brahan, a boy Charley, a mulatto girl Emma, children of Bet or Elizabeth. These servants are to be removed to a free State either Ohio, Illinois or Michigan. Settle them on a small farm and be stocked as necessary. To Bet or Elizabeth and her children \$1,500.00 and invested in land and stock. The expense of moving them to a free state be taken from my estate. Additional \$120.00 to be for a year of provisions for the family after they arrive in the free state. Until Bet or Elizabeth and the children are removed they are to continue to live at the Fagan Place where they now are and be well treated. My son Matthew W. Steele executor without giving bond.

After taking out my youngest sons share the other slaves be returned to the bulk of my estate and divided as follows: To my wife Ann W. Nimmo during her natural life five slaves and at her death returned to the bulk of my estate. Also to my executors in trust for the use and benefit of my wife Ann W. Nimmo \$1,000.00 to be put out at interest and the interest be paid to her annually and to cease at her death. The \$1,000.00 be returned to my estate for distribution. Also to my wife Ann N. Nimmo two of my horses, three good cows and calves and all my household and kitchen furniture. At the death of my wife Ann M. Nimmo all the properties and monies in her possession be divided among my children and the Lineal heirs equally share and share alike. When my youngest son reaches the age of 21, all the slaves bequeathed to my wife in trust and which are not taken to make his share of \$1,000.00 be equally divided as above stated to my children and lineal heirs. If any of my children should die without children then their share be equally divided among my children and lineal heirs. My sons Amos N. and James P. Nimmo executors.

## Book Reviews

#### COMPTON AND ALLIED FAMILIES

The principal author of this book is Ms Freda Adams who was assisted by TVGS member and *Valley Leaves*' Morgan County Correspondent, "Dene" Walls.

The book identifies the descendants of Aquilla Compton and wife Elizabeth Norris who entered Frederick County Maryland from England about 1724. They then link the Comptons to Orange County, North Carolina in the 1780's.

The book traces the descendants of each of the Compton's fourteen children, some into the fourth generation, but its main emphasis is on the descendants of their sixth child, Norris.

Norris was born in 1773 in Orange County, North Carolina and moved to Spartanburg and Greenville Counties, South Carolina. Norris had three wives and it was his immediate descendants who moved into Marshall County, Alabama around 1852. While the authors have covered most of Norris's children, they spent their greatest effort on his thirteenth child, Monroe, and his immediate descendants. This book also covers the Flack and Hughes families who intermarried with the Compton family in Marshall and Morgan Counties Alabama.

This is a very serious, well researched, and well laid out book. There are well written narratives on the history of the family, the meanings of various items of documentation as well as a brief history of migration movements in the United States.

The authors appear to use first and second hand information for biographies of the

most recent generations. One author stated that "over 650 letters were mailed out in the February" [preceding publication] to update information and correct errors and omissions. The biographies for recent generations contain the person's name (in bold upper case letters); date and place of birth; marriage date, location and spouse's name; date and place of death and place of burial. Children's names and birth dates are also listed. Occasionally cause of death may be listed.

In addition to the brief biographical information for recent generations there are identified good quality photographs and photocopies of obituaries. Unfortunately, none of these are dated nor are sources or locations identified, but since this is a family genealogy, this may be considered a minor defect since persons and dates can be identified by a detailed search through the text.

The information on the earlier generations is well documented with sources identified. The authors have included transcribed text of wills, deeds, church minutes, estate records, military records and census information. There is a photocopy of a very old Family Bible and throughout the book there are photocopies of various legal documents which are connected with the family. In addition to this "hard information" there are copies of family members' letters, most of which date from the late 1800's to very early 1900's. These letters contain information about family members and traditions.

The only puzzling item in this book is a Compton Coat of Arms, which is referenced as taken from *Burke's Peerage*. There then follows a detailed description as to whom the arms were awarded. The description makes it very clear that the arms could not have been awarded to a direct ancestor of this line. Since coats of arms are not awarded to families, but to specific individuals, I am puzzled as to why this coat-of-arms appears in this otherwise fine book.

This book is in three sections, or chapters. The first chapter deals with the physical history of the church. Researcher Charles R. Wells traces the evolution of the church from 1808 when the congregation met in the home of a member. The final deed was dated September 1884 and the final mortgage was satisfied in 1943.

There has long been confusion about the names and locations of the very early churches in the northeastern part of Madison County.

Mr. Wells has traced the evolution of this church through the minutes and recorded deeds and even included maps to aid the reader in pinpointing the location[s] of the church through the years. He adeptly clarifies and explains the differences between the early Baptist churches, especially Enon Baptist Church of Christ which was organized a year after the Flint River Primitive Baptist Church. He also shows when and where other Baptist churches were organized.

The second section, or chapter, of this book is entitled, "Early entries from the church minute book," and begins in 1808. There is no notation made that the "minutes" consist of selected entries and are very incomplete. For instance, they jump from February 1810 to August 1821 omitting all entries in between. Subsequent entries, through 1868, are so few in number that they were either selected at random or were intentionally confined to those dealing, solely, with Negro membership. The author does not state what his criteria was.

This reviewer has a complete copy of these minutes and feels a great opportunity was lost in not publishing them in their entirety thus making a major genealogical and historical contribution. There are names in the original minutes that appear nowhere else in Madison County records, and had they been included they would have been a great genealogical resource tool.

The third section is a "partial listing of the Constituting Members and other early members." Again, no introduction was given and no basis was shown for selecting some names and omitting others. There are approximately 375 persons listed in the original minutes (with some duplication of names) but the author of this book chose to use only 152 names. At least the names they chose to use are listed in alphabetical order.

The fact that this book was done as a history for present church members as opposed to developing it as a genealogical tool is probably a factor in why various items were omitted.

Despite the book's shortcomings, the material included in its first section justifies the price of the book.

This book describes the descendants of Allen Gipson who, at age 10, came to Franklin County, Tennessee from Laurens County, South Carolina with his father. Mrs. Phillips has been unable to positively identify the father of Allen from among the other Gipson/Gibson men living in Franklin County.

There is a wealth of information in this book and seldom have I seen as much good documentation in a family history.

No numbering system is used. This is probably due to the fact that the author has

been unable to find the immigrant ancestor. However, the lack of a numbering system makes it extremely difficult to follow lineages, even though, parents' names are supplied within each person's historical sketch.

Each Gipson/Gibson is listed in alphabetical order. If parents, are known, they are enclosed within parenthesis and then the subject's vital information is given. If a spouse or spouses are known, their name, vital information and parentage are listed. Any children are identified along with their date of birth and their spouses' names. Documentation and sources are identified at the end of each individual's biography.

In the prologue to this work the author discussed her extensive research in Laurens County, SC to prove the father of her Allen Gipson. Brief biographies of all located Gipson/Gibsons are included even though they may not be in her direct line.

The book identifies the descendants of Revolutionary War soldier and patriots who were members of the Alabama Society of the SAR. Entries are listed according to the membership number assigned by the Alabama Society. Therefore the full name Index is very important. Since this book is essentially nothing but a list of names, the Index is 98 pages thick. There are two important omissions in

this book. The first omission - in 38 out of the 44 earliest submissions dates are given only for the Revolutionary ancestor and the Alabama Society member. This was unavoidable as the

early membership applications did not contain

this information.

The second omission - for all entries. there are no birth or death locations listed for anyone between the Revolutionary Ancestor and the Alabama Society member. This was an unfortunate editorial decision as it reduces the research potential of the book. Still, this book is valuable, it just means that other sources will have to be used to confirm lineages.

The book identifies the descendants of John Morris of Worchester County Maryland who later migrated to Missouri.

The author appears to have spent a great deal of time in research, but the book suffers from uneven presentation.

One the best and notable feature of this book is that all proper names are shown in bold upper and lower case letters.

The author appeared to use first and second hand information for biographies of the most recent generations and sources are given. Unfortunately, the sources' identifications are usually so vague that a researcher would have trouble trying to verify or continue research. The biographies, for recent generations, contain the minimum of; the person's name, their spouse's name and their children's names. Pass this point, there is so much variation as to what else is included that no other general remarks can be made.

In addition to the brief biographical information for recent generations there are 79 identified photographs of widely varying quality. Many of these photographs are dated and some have location and sources listed. There is a separate Table listing photographic subjects in the order that they appear in the book.

There are testimonials, anecdotes, and poems written by and about various family members scattered throughout the book which adds a personal touch.

The author uses a Modified Register System to show generations and family groupings. He discusses the different systems and explains, in detail, how his system works. This is a nice touch.

The documentation on the earlier generations consists primarily of brief abstracts of wills and, to a lesser degree, from the book *They Lived in Somerset* (author's name not given). I am surprised by the use of single sources as proof of relationships between generations.

The author's notation of sources deserves comment. The Maryland sources show the County's name followed by letters and numbers and then letters, none of which are explained. A case in point is the reference to "Worchester County MD, Will book JW4 17691783 F249 Dryden." If you are familiar with Maryland records then you will have little problem. If you are not familiar with these records, you will be lost. The code is explained as follows: The "JW" are the initials of the name of the Orphan's Court Clerk. The "4" means that the book (Libra) is the fourth book he recorded since beginning his term of office. "17691783" should have been written as 1769-1783, the years that the book covers. "F249" is Folio (page) number 249. I have no idea what "Dryden" refers to.

There is a "Morris Family Shield" included in the book and on its front cover the author credits its existence to a previous work on the Morris family and includes a definition of "Heraldry" from the Columbia Encyclopedia. The author, correctly, states that many books display such family shields and he expresses confusion that there are so many different designs for the surname "Morris." Flatly stated,

people need to be made aware of the fact that there is no such thing as a "Family Coat of Arms" or "Family Shield." Coats of Arms were and are still awarded to specific individuals, with a proven right to display or "bear coat armor." In most cases, this right is then passed through the male line.

In summation, this is not a "bad" book. It is, in fact, a good first effort. The book reads well and there appears to be information in this book which has probably not ever been recorded before. However, technical errors and lapses (such as faulty proofreading) do detract from its overall worth. Further, the lack of firm and complete information for recent generations will limit its usefulness for future generations to make their family connection.

This is the second volume of marriage records of Jackson County Alabama produced by these two members of the Tennessee Valley Genealogical Society. The marriage record information was meticulously copied and proofread to aid genealogists and historians researching in that county.

The page number of the original book on which each marriage is found is included which aids a researcher when requesting copies from the courthouse. All information in each entry has been included such as the name of the bride and groom, bondsman, officiating officer along with the date the license was issued and date of solemnization.

The Probate Office, where marriage records are housed, caused the original marriage books to be photocopied and reduced in size. Unfortunately, they did not photocopy

the parental permission slips or information on places of marriage which were attached to the original books. Once the photocopying was completed, the large original marriage books were then "retired" leaving only the smaller easily handled photocopies available for public use. Ms Shaver and Ms Hinman copied the marriage information from the old original books so all permissions and places of marriage are retained in this published work.

The first volume of Jackson County Alabama Marriage Records (1851-1856 and 1859-1871) is still in print and sells for \$15 plus \$3 postage and handling from the same compiler at the same address.

This book contains one each of 55 different genealogical forms along with instructions on how to use them for maximum benefit. Mr. Vredevelt generously allows you to photocopy or reproduce any or all of these master forms as many times as you like provided it is for YOUR USE ONLY. They are not to be reproduced and sold or even given away - a reasonable request.

Some of the forms included are unique. Some would be especially helpful as a reminder to get ALL the information needed from a particular document. For instance, the "Census Analysis Sheet" gives an overview of what information you have and what information you yet need to find. The "Census Index & Soundex Guide" could be a big time saver. Since the census returns prior to 1850 show only age brackets, Mr. Vredevelt has added the span of years that correlate with the age brackets - a tremendous aid. Another clever form is the "Census Visitation/Land Ownership" which allows the compiler to correlate census returns

with land records. A nine-section block of a township plat is provided for this purpose thus allowing you to see not only your ancestor but all his close neighbors.

The two-page "Family Group Sheet" has room for fifteen children and three spouses, but has no space for any details or vital information on these spouses. Space is provided to cite your sources, but the spaces provided are very small, so persons with large handwriting will have a problem.

The "Henry" numbering system is explained by Mr. Vredevelt and space is provided on each form to mark the generation - a real aid for those persons inexperienced at compiling a genealogy using a numerical system.

Wedding, funeral, vacation, school, church, hospital and athletic record forms are provided along with Land Index Surveys. Some of these forms you will never use and some you will use constantly.

**CONTRIBUTIONS** - TVGS does not pay for contributions, but we welcome genealogical material pertaining to the nine North Alabama Tennessee Valley counties. Unusual genealogical information for the neighboring counties will be considered. *Valley Leaves* focuses on the years before the 20th Century.

To be considered for publication, manuscripts submitted must have a reliable reference and cannot be based on unsubstantiated family legend. Information submitted should include references to time, persons and places. If the manuscript itself does not contain these elements, additional information should accompany it which will help identify these elements. We also cannot accept material copied verbatim from books still in print; such references are welcomed as footnotes for clarification of the text. All Copyright laws must be followed.

<u>ALL submissions must be typed</u>. Handwritten materials can only serve as a backup to typed submissions. Photocopies of the submitted documents are desirable and are required as backup for personal letters, Family bible information, and for other personal and unpublished documents. Typed submissions be accompanied by a 3 1/2" floppy disk with at least one copy of the information saved as ASCII text, in either IBM or Macintosh format. All floppy disks are returnable upon request.

Valley Leaves<sup>©</sup> is primarily interested in publishing the following types of material:
• Family Bible records. - These must include the title page, and if available, the

date of publication page [usually the reverse side of title page].

• Cemetery readings. - These must include the cemetery location, directions to find it, and whether the listing is of the complete cemetery, or only of a certain section.

• Southern Claims Commission Records • Courthouse records • Diaries • Church records • Military records • Minister's records • Newspaper items • Personal letters, etc.
