

Major Long- Term Projects:

- 1.) With this issue of the Valley Leaves we begin our First Families of the Tennessee Valley. In the center of this Quarterly is an official Application with instructions. In case someone has gotten to yours first, contact us at our Society's address, listed on the inside of the front cover, and we will send you one. What does it take to qualify? Just that one of your direct linear ancestors was living in one of the nine counties of Alabama, covered by TVGS, before 14 December 1819. The ancestor didn't have to stay here, he just had to have been here. See our instructions for more details.
  - You will start seeing other examples of our publicity beginning this month. You will be informed of our full Calender of Events, real soon, but for starters, we have all ready planned for a formal kickoff celebration on 17 January 1998.

As for now, we have Registrars and Verifiers who are ready to process your application, so we hope to hear from you soon.

- 2.) Our Annual Spring Seminar as undergone a massive face-lift. For **this** Seminar, you will need to reserved the days of April 3 **and** 4, 1998. That's right, a two day Regional Seminar with 8 speakers and dual sessions. The theme is "Our 19th Century Ancestors and The Records They Left." Individual speaker's subjects will have a wide range of appeal. You will soon see more publicity on this.

As you see, an exciting year, we hope you will take an active part in it.



## Franklin County

### The Franklin Times, Russellville, Alabama

Extracted by Oscar L. Glover

<u>Editors Note:</u> This is the seventh installment of extractions from this newspaper. The first installment appeared in Volume 30, Number 3 (March 1966) and has appeared continuously since then. We have set aside our normal rule of not accepting 20th Century information because of the lack of 19th Century records for Franklin County - the results of a 1890 courthouse fire.

In Memoriam. John E. Hooper, second son of Edward W. and Louise Hooper, was born March the 21st 1860, died Aug. 3, 1900. John was always a good and obedient son, and on the death of his father fourteen years ago, he although still a boy, manfully stepped into that dead fathers place, and was father and brother to his younger sister, a stay indeed to his aged mother. He said on his death bed that he had promised his father to care and look after his mother and baby sister, that he had done his best, and if they had ever wanted for anything it was their own fault as he was always ready, gladly and willingly to share with them his last dollar. Such sons, such brothers are scarce indeed, and only his dear ones know how hard it was for him to give up. He was the sixth one of the family to be laid to rest in the same burial ground in ten years, two in the last ten months. He leaves a wife and two little girls, a mother, four sisters and one brother. His friends were all who knew him.

He had been a member of the Baptist Church for 15 years, was a member of the I. O. O. F. Truly in his death the world, his family and his friends have lost a man of the noblest and best type, a man ever ready to do his duty by all. May the Good God rest his soul and brush away the tears from the eyes that looked always in love and longing for his coming.

Item 8th. I further give and bequeath unto my said Daughter Belinda Anna Louisa Cason, to her and to her alone, the following slaves "to wit" Jane and Juliet.

- No application will be considered if a valid check is not included with the submitted package.
- You are solely responsible for making sure that all submitted information is easily readable and all necessary information is included as part of the package. Unreadable submittals will be returned without consideration.
- Dates are to be written as dd mmm yyyy. Examples: 14 Dec 1819 or 06 Jul 1996.
- Locations (places) are to be shown as City/County/State/Country (if other than America). Examples: Huntsville/Madison/AL or Blairlogie/Stirlingshire/Scotland/UK.
- Do not enter a name, date or location which you cannot substantiate with documentation. If you cannot find documentation for an entry, mark it with "n/a." Mark estimated dates with a "ca."
- Preponderance of Evidence Arguments are accepted.
- No verbal or hearsay evidence will be considered. All claims have to be substantiated by documentation.
- Do not send any original documents. All documentation must be photocopies or certified transcripts.
- Do not submit any copyrighted material without identifying the author and source.
- No accepted information will be returned. All accepted information will become the property of the Tennessee Valley Genealogical Society, Inc. and will, eventually, be permanently stored in publicly assessable files in the Huntsville Public Library or its successor. These files will always be open to researchers.
- Any and all retained information will be considered public information and may be used in various articles and publications, on a variety of subjects, and written by any number of authors without further notification.

What standards will be used to judge an Application and documentation? Generally, those used by reputable lineage societies, such as the DAR and SAR. (None of these societies are a part of this Certification process.)

What is involved in the approval process? Once your information and check are received, one of our Registrars reviews your application and documentation. Any or all of your documentation may be checked by one or more Verifiers to determine accuracy. In difficult cases, submitted information may be reviewed by more than one Registrar. If your application is approved you will receive your certificate. If your application is not approved you will be informed of the reason and permitted to submit more documentation to substantiate your claim. Appeals must be made in writing to the Tennessee Valley Genealogical Society Executive Board.

If I do not have complete information about my ancestry, can I send what I have and have you all complete what is needed? No. To be considered for one of our Certificates, you will have to submit all necessary documentation to prove your case. Incomplete applications will be returned without any other review.

#### Examples of accepted proof and evidence which can be used for documentation:

Birth and Death Certificates showing the names and birth location of parents.

Wills, estate records, deeds, and other court records where parties are named and their relationship stated.

1850 to 1920 U.S. Census returns.

Photocopies of Lineage Societies's applications are permitted if the National and State numbers are identified and you include full documentation for the qualified ancestor and Generation #1.

Family Bibles can be used if the information recorded was contemporary to the event. Family relationships must be explicitly stated. Certified transcripts or photocopies of the information and the title page must be sent.

Family genealogies and histories and parts of copyrighted books can be used, but they must be properly annotated using reliable sources. Published sources must include a title page.

Marriage licenses, census records or estate records showing that a marriage was implied.

<u>Editor's Note</u>: This is a continuation of the Second Series of Madison County Wills which began in Volume 15, Number 1 (September 1980) and this article is immediately continued from Volume 31, Number 3 (March 1997).

For this series, Ms. Wellden, not only abstracted information from the Madison County Will Book, but has also included additional information, abstracted from other sources, which, she believes, pertains to the family involved in the estate. The reader is cautioned that such a connection may or may not prove to be correct after a more detailed search. For this reason, this information appears at the back of the article and is marked Supplemental Information (Endnotes).

Sophia Walker to raise and educate my two grandchildren Joseph and Elizabeth. In the event of the death of either of them without issue then his or her portion go to the surviving one.

To my wife Delilah Walker and my children, John H., Polly Ann, Margaret A., Samuel L, William A. and Reede Walker all of my estate except bequest heretofore made. My wife Delilah to have full control of my children until they become of age or marry and that she raise and educate them and when they become of age give them so much of my estate as she thinks proper not to exceed \$1,500.00. And to take their receipts for the amount. In the event of the death or marriage of my wife that there be given to my children such property to the

amount of \$1,500.00 by 3 disinterested free holders. If my wife marries she to have an equal amount set apart to her with the balance of my children last named. I have given my daughter Sarah J. Routt a Negro Woman named Tobby and a boy child named Houston valued \$750.00. Also a horse, saddle and bridle, bed and furniture, and other outfits value \$200.00, a wagon \$10.00 which amounts to \$1,020.00. To Sarah \$180.00 which amounts to \$1,200.00 which I will to Sarah.

My remaining daughters to have a good education equal to those who are grown, and Negroes and property amounting to \$1,200.00 each to be given them when they marry or become of age.

To my sons be made to work one half of their time and go to school the other one-half from the time they are 8 years old until they are 16.

Then to be sent to a religious College until they are 21 years of age then I will them \$1,000.00 each from my estate.

To my daughter-in-law Susan Scruggs widow of my dec'd son Gross Scruggs Jr. the tract of land where she now lives in Madison County. Also the slaves now in her possession. After her death to belong to her children. To my grandchildren the full share of their fathers bequest after whatever property and whatever money I have heretofore given or paid for him since his death.

To my son Edmond L. Scruggs one equal share in my estate with the property he received from me in his lifetime deducted and what property my grandchildren received from me since their fathers death.

To the children of my dec'd daughter Mary Tate wife of Waddy Tate, one equal share in my estate from which is to be deducted what her sons Frederick Tate and William Tate received from me since their Mothers death, I mean what all the children have received from To my daughter Sarah Scruggs wife of Henry F. Scruggs of Morgan County, Alabama one equal share in my estate deducting what she has already received from me. To Sarah the share of my estate that went to my dec'd daughter Julia S. Driver. This bequest made at the request of Julia S. Driver dec'd before her death. Which is deducted all she has already received from me.

I sold my land to my son John W. Scruggs while land was at \$15.00 per acre. But after the railroad went through my plantation the value of my land greatly increased. I became very dissatisfied with my contract and wanted John W. Scruggs my son to alter it. He finally agreed to do so.

My executors to sell my land and all that the lands bring \$25.00 per acre or above to be divided equally among all my legatees including John Waddy Scruggs.

To my son John W. Sruggs one equal part of my estate deducting what he has already received from me. In case my son John W. refuses my wishes concerning my land then I give him \$2,200.00 which he has already received and nothing more from my estate.

To my son James H. Scruggs one equal share of my estate deducting what he has already received.

To my daughter Margaret Philpot wife of Benjamin Philpot of Texas, one equal share deducting what she has already received from me.

To my daughter Elvira Sanders widow of William J. Sanders dec'd one equal share deducting what she has already received fro me.

To my wife Edith Scruggs my Carriage and horses. Place over her grave a neat and substantial marble monument not to exceed in cost more than \$150.00.

The slaves that have been allotted to the several legatees that children under ten years of age shall not be separated from their mothers. Husbands and wives are not to be separated.

Accounts which are correct of all the advancements made to my children and grandchildren my legatees are to settle (by these) with my executors.



This book, originally published in 1882, lists epitaphs from approximately 2500 tombstones in nineteen graveyards in and around Old Bridgewater, Massachusetts.

According to the book's Preface, it was the author's intent to "present a complete list of all epitaphs in all old public grave-yards commenced before 1800, with plans and with some account of the old grave-yards of the three towns of West Bridgewater, Bridgewater and East Bridgewater, including all monuments in those yards, down to the present time, and also, most of the epitaphs in private and small pox-yards." And that it does.

For eleven of these graveyards there is a complete record of epitaphs. Ten of these have maps of the grave plots. Some entries have additional information added. Each cemetery is individually indexed. Reviewed by Richard A. Smallwood

This is the second Deed Abstract book published for Greene County by this author. The first was reviewed in the December 1996 issue of the *Valley Leaves*. This book covers Greene County Deeds Volumes 9 through 12.

Like all the books by this author, the lay out is efficient. While the lettering is small, it does contain enough "white spaces" to make reading by the light of a microfilm reader possible.

The book does not contain lengthy land descriptions, if acreage is mentioned in the deed, then it is mentioned here as well as the price paid and what waterway the land is located near. Each deed's page number is listed as well as the date when the deed or indenture was recorded.

I have had an opportunity to use several of this authors books and have found them to be super accurate, detailed and efficient deed indexes. Their greatest value is to the researcher who is sitting at a microfilm reader in an Archive or at the Greene County courthouse trying to locate properties and thereby, perhaps locate extended family members through the use of deed records.

What is now Greene County, Tennessee was formed in April 1783 out of Washington District North Carolina. In 1792, parts of Greene County were given to Knox and Jefferson Counties. In the County's deed books it is referred to as: Greene County NC, in the State of Franklin, Washington County TN, Greene County Territory South of the Ohio as well as Greene County TN. It was one of those counties which are broadly spoken of as "a crossroads of migration."

Other indexes published by this author are for White, Williamson and Sumner Counties TN as well as Logan and Warren Counties KY and Ellis, Washington, Austin and Red River Counties TX.

This company offers some of their index books in microfiche format for \$7.00. This is, of course, an apparently significant initial savings, but if you consider how these books are best used (at an archive or the courthouse), where would you expect to find a microfiche reader available at the same that time you are using microfilm or original records? My advice is, if you had ancestors in any of the counties covered, go ahead and buy the book(s) and don't waste money on the films. The books provide the greatest help while you are actually researching. The combination of these books, the original (or microfilmed) deed records and detailed maps make for a powerful research

Chapter one begins with a fascinating

history of Bloucher's Ford, the area in which Reuben Stone settled. In its scope, it is the most detailed genealogical-historical narrative this reviewer has seen on that particular area of Madison County. Mrs. Brakefield's extensive research, fully footnoted, includes biographical sketches on people from her own genealogical line, as well as from fifteen other long term resident families in the community. Specifically noted, is an interesting biography of Joshua Boucher, a circuit riding Methodist minister, for whom the area is believed to be named.

Chapter two begins with Reuben Stone's Application for Pension for Revolutionary Service. The author then traces his movements and shows detailed pictures and maps chronicling where Reuben fought or was stationed during his war service. She also includes a biography and a picture of Governor Thomas Pickney, who issued Reuben's 200 acre land grant in South Carolina in 1787.

Chapter three contains a brief chronological historical review of Reuben Stone's life beginning with his 1775 birth in Fauquier County VA. The author then lists in chronological order significant events which would have affected life in the Bloucher Ford Community. To give the reader a sense of history, she included events of national importance (the War of 1812), events of regional importance, down to local events, such as: "1809. Richard Shackelford bought the land where Patterson's Mill would later stand."

Chapter four is a compilation of Reuben Stone's genealogy starting with John Stone, Reuben's father who died in 1787, in Laurens County SC, to the present generation. Following an established numbering system, this genealogical chapter contains photographs of some family members, which is always a welcomed addition to any genealogy.

This is a well written book, the product of 20 years of intensive research by the author with additional input from well over a hundred individuals (the *Acknowledgment* alone is over three pages long).

Note: The profits from this book go the Tennessee Valley Genealogical Society for the purchase of microfilm reels of the Applications for Pension for Revolutionary Service - a worthwhile project.

ALL submissions must be typed. Handwritten materials can only serve as a backup to typed submissions. Photocopies of the submitted documents are desirable and are required as backup for personal letters, Family bible information, and for other personal and unpublished documents. Typed submissions be accompanied by a 3 1/2" floppy disk with at least one copy of the information saved as ASCII text, in either IBM or Macintosh format. All floppy disks are returnable upon request.
