

<u>Editors Note:</u> This is the seventh installment of extractions from this newspaper. The first installment appeared in Volume 30, Number 3 (March 1966) and has appeared continuously since then. We have set aside our normal rule of not accepting 20th Century information because of the lack of 19th Century records for Franklin County - the results of a 1890 courthouse fire.

Researchers Note: Jayhue Beason and Larkin Poteet are shown living near each other in the 1840 census of Jackson County. Later, they both moved to Arkansas.

ELIZA COX Estate

Before Judge L. C. Coulson, Judge of the Probate Court, Jesse W. Brown in right of his wife, Eliza; all of whom are of full age; Mary Cox, who is a minor child of W. R. Cox, over the age of fourteen years; Hopkins Cox, Texas Cox, James Cox, Thomas Cox and Jesse Cox, all minors under the age of fourteen years, children of William Reid Cox, a distributee by law of Eliza Cox, and who live with Melvina Cox in Jackson County for whom a Guardian Ad Litem is requested. The petition is signed by Jesse W. Brown, 5 Sep 1865.

ELIZA COX - Last Will and Testament

...being of sound mind and disposing memory ... 1st, I bequeath my spirit to God who gave it, and my body to the earth from whence it came.

2nd, That my lands be sold and also my Negro property and the proceeds of both land and Negroes to be equally divided or distributed among my children consisting of Jesse C. Cox, William Reid Cox, Elizabeth Price, Mary Pogue, Leanah Cawlfield, Sarah Amanda Long, Nancy Caroline Grider and Eliza Brown.

3rd, I bequeath all my ready cash with notes and accounts that are due me to be equally distributed among the above named children of my body.

4th I bequeath the live stock, household and kitchen furniture to be distributed among the above named children.

I hereby appoint Jesse W. Brown, my executor, to attend to the interest of my estate. Signed by Eliza Cox, 6 July 1859. Witnessed by T. T. Cotnam and Elizabeth Jenkins. Certified by Lawson C.

SAMUEL C. DAVIDSON - Last Will and Testament

...being of sound mind and memory. After my lawful debts are paid the residue of my property that I have not this day, deeded away, be equally divided among my heirs right of my daughter, Sarah M. Edds [The name of her husband was not written but he was probably the John C. Edds with wife Sarah listed in the 1850 Census of Jackson County, compiled by Rhonda Cooper. LR] Whose portion is to be equally divided between him and his son, William C. Edds, also, my son, Matthew M. Davidson. I will to him thirty six acres provided he comes forward by the twenty fifth of December 1863 and pays me or the Administrator of my estate the sum of Four hundred thirty six dollars and forty three cents with interest from the sales which amount I have already paid him. Now if the said Matthew M. Davidson complies with the above requisition, the said thirty six acres of land are to be his. If not, it is to be sold and divided equally between him and if I have to pay any more debts for the said Matthew M. Davidson between this and the 25th of December 1863, he is to make full settlement with me or my Administrator. I also make, constitute and appoint my son, William C. Davidson, Executor Signed 6 Aug 1862 by Samuel C. Davidson. Witnesses: Hensley Grubbs, W. D. Ward and I. C. Selby.

Wilbourn who is of full age and William S. Wilbourn, who is of full age, James L. Wilbourn, who is of full age and reside in Jackson County, these last two were mentioned as Executors.

3rd, your petitioner charges that the said Will was executed in the presence of David D. Langston, Rice Hillion and W. W. McCutcheon. Signed 17 October 1865 by Wm. S. Wilbourn.

Wilbourn Guardianships:

John W. Parks consents to serve as guardian ad litem for Martha Jane, Melvina, and Sarah Ann Beadles, Eliza, Mary and Elvira Wilbourn, who are minors under the age of 21 years on the application to probate the Will of Elias Wilbourn in Probate Court, November 25, 1865.

ELIAS WILBOURN - Last Will and Testament

... that I, Elias Wilbourn of the County of Jackson, State of Alabama, do make this my last will and testament. I do hereby will and bequeath unto my granddaughter, Sarah Reynolds, daughter of Margaret Mitchell, the sum of Two hundred and fifty dollars currency.

I hereby give and will unto Margaret Mitchell the sum of Twenty dollars to be paid in common currency and no more.

I further will and give unto my daughter Tabitha Sublett the sum of Five hundred dollars in good common currency and unto my grandchildren the heirs of Ida Beadles I give the sum of Five hundred dollars of good common currency.

And unto my daughter Vina Maples and her heirs I give all that tract of land known as the Broadway Tract together with the Reddfield[?] forty acres, my daughter to have the land until her marriage or death then the heirs of her by John B. Maples to have the benefits of said land exclusively.

To my son William S. Wilbourn, the sum of Ten dollars in common currency.

...and to my son, James L. Wilbourn, all that tract of land known as the Cap Vaughn tract. ...and to my son, George W. Wilbourn, all my house tract of land, one hundred and eighty acres to have for his life time and then unto his heirs.

...unto all my heirs equally, Frances Mitchell excepted, all that river tract of land together with all the other land that I now hold as my own. At my death together with all the slaves that I now have or may die possessed of together with all other property ...and Geneva effects that I may own at my death

And I hereby appoint my sons William S. and James L. Wilbourn, executors of this my last will and testament, who after times shall become so settled that fair sales and a sound currency can be had, will sell all of said property or other ways so divided equally between all of my heirs, my granddaughter Frances Mitchell excepted, who has had her full share in this my last will and testament. Signed 4 December 1864. Witnessed by D. D. Langston, Rice Hillion, W. W. McCutcheon.

ELIAS WILBOURN - Last Will and Testament (continued)

Recorded by Judge Coulson on 25 November 1865.

An Executor's Bond of Eight thousand dollars is posted by William S. Wilbourn, D. D. Langston, J. L. Wilbourn and T. B. R. Hillion, 25 November 1865. Letters of Testamentary are then granted to William S. Wilbourn to probate the Will of Elias Wilbourn.

ROBERT T. SCOTT Estate

[Robert Thomas Scott came from North Carolina and settled in Madison County in 1817. He lived in Bellefonte and ran an inn. He owned the land on which the town of Scottsboro was developed and the town was named for him. LR]

On 20 September 1865, Elizabeth Ann Scott comes before Probate Court to apply for Letters Testamentary for the Estate of Robert T. Scott. 2nd, Prior to his death Robert T. Scott prepared a codicil to his will. 3rd, She believes that the codicil was intended by him as his Last Will and Testament and that he was fully capable and competent to make a will and that she was nominated Executrix, that the instrument was witnessed by L. B. Evans, who has since died, A. Moore, F. F. Privett and William H. Dicus.

The heirs of Robert T. Scott are the petitioner, Elizabeth Ann Scott, who is the widow, Mary Jane Parks, wife of James M. Parks, James T. Skelton in right of his wife, Charlotte C. Skelton, Robert T. Scott, all are of full age and reside in Jackson County, Alabama, and Walter Scott, who is of full age and resides in Oden, Marion Co., Illinois. Also, Lucy H. Scott, who is a minor under the age of 21 years and resides with the petitioner.

The petition asks for a date to be set for a hearing. Signed by W. H. Robinson for the petitioner. Subscribed before Judge Coulson 20 September 1865.

A. P. Moore and William H. Dicus comes before the Probate Court to say that the instrument purported to be the Will of Robert T. Scott was signed 28 Dec 1859 and attested by L. B. Evans and that at that time Robert T. Scott was of sound mind and memory, over the full age of 21 years and fully capable of making a will.

ROBERT T. SCOTT - Last Will and Testament

... whereas I Robert T. Scott, being in good health and sound mind ... this codicil to my last will and testament now in the possession of my friend H. Caldwell for safekeeping ... It is my anxious desire to will my property equally among my children, Mary Jane Scott, Charlotte T. Scott, Robert T. Scott, Walker Scott and Lucy H. Scott after the death of my wife if she shall survive me.

I will that the whole of my estate both neat and personal remain in the possession of my wife, Elizabeth Ann Scott until her death and then to be equally divided among my heirs as hereafter directed: James M. Parks, who married Mary Jane Scott is justly indebted to me for goods, etc. to a large amount but as there is little to show for it I have concluded to charge his wife only with the sum of Five hundred dollars without interest, to be deducted from Mary Jane Parks share of my estate, which will be one fifth as her husband has received the sum in advance.

I further will by this condicil that my Nigra [sic] girl Mary with her increase, which Nigra [sic] has been in possession of my daughter Mary Jane Parks from the time of her marriage belong to said Mary Jane Parks and on her death to the heirs of her body, or in other words, her children. I value said Nigra girl Mary and her children at One thousand dollars. In addition to this I have given said Mary Jane Parks a house, household furniture, etc. which I value at One hundred and fifty dollars making with the \$500.00 first mentioned, Sixteen hundred and fifty dollars, this sum \$1550.00 is in advance to my daughter Mary Jane Parks and is to be taken from or deducted from her part or share which is one fifth of my estate after the death of my wife if she survives me.

To James T. Skelton, who married my second daughter, Charlotte C. Scott, I have given Negro girl, Rose and her increase except Martha and Ceedy, who was born before I donated this Negro girl. I now give to my daughter Charlotte, the said Negro girl, Rose, who was entailed to my wife Elizabeth Ann Scott. I value Rose and her increase now at Eleven hundred dollars. I gave to the said Charlotte

C. Shelton a house and household furniture, etc. which valued at \$150.00, making Twelve hundred and fifty dollars which I have advance my daughter Charlotte which sum is to be taken from or deducted from her share of my estate.

I have advanced to my son Robert T. Scott, one mare at One hundred and fifty dollars which sum must be deducted from his share of my estate.

I have advanced Walter Scott, one mule, valued at Eighty dollars which sum is to be deducted from his share of my estate.

Against Lucy H. Scott, I have made no charges as her expenses so far have only been for educational purposes, etc. At the death of my wife, if she survives me, I do hereby will that my estate both real and personal be equally divided among my children or their heirs subject to the deductions above. I do hereby at my death or the death of my wife give, grant and convey from natural affection, all my estate real and personal to Mary Jane Parks, Charlotte C. Skelton, Robert T. Scott, Walter Scott and Lucy H. Scott and at their death to their children.

I do hereby appoint and constitute my wife, Elizabeth Ann Scott, my sole Executrix to convey into execution this my last will and testament with the fullest confidence in her prudence ... I do not require that she shall give bond ...my estate is altogether solvent and has the means to meet all demands against it without the sale of property ... it is my wish and will that the property be kept together during the life of my wife as it will give more value without division and I do hereby grant my Executrix full and ample power to contract and manage the same during her life time. But my said Executrix has full permission to permit our children to enjoy and use so much of said property as she may think right before the final division takes place. Signed December 27, 1859, R. T. Scott Since writing this codicil to my last will and testament, I have concluded to enlarge it and do hereby further authorize and require my Executrix to sell lots in Scotsborough [sic] either at public or private sale and to donate lots for public purposes if it should be deemed necessary to grow up said Town. As to the amount of said donation I leave to the sound direction of my said Executrix, Elizabeth Ann Scott and I do hereby empower my said Executrix to make good and perfect deeds in fee simple for the same when paid for and not before. Also to make deeds to such lots as may be donated as aforesaid. Signed R. T. Scott, December 28, 1859

Witnessed by L. B. Evans, A. Moore, F. F. Privett and Wm. H. Dicus.

The will is recorded by Judge Coulson, 28 Oct 1865.

Letters of Testamentary are also issued to Elizabeth A. Scott, to act as Executrix on 28 October 1865.

Researcher's Note: This is a settlers' petition against being removal from the lands of Double Head Reserve. The date it was signed was not given, however the date it was received in Washington DC was December 1810. These petitioners seem to have been located in present day Lauderdale Co. Alabama, near the cities of Muscle Shoals, Tuscumbia, Florence and Sheffield. The petition information was published in the National Genealogical Society Quarterly; Volume 35, December 1947.

<u>Editor's Note</u>: This is a continuation of the Second Series of Madison County Wills which began in Volume 15, Number 1 (September 1980) and this article is continued from Volume 32, Number 1 (September 1997).

For this series, Ms. Wellden, not only abstracted information from the Madison County Will Book, but has also included additional information, abstracted from other sources, which, she believes, pertains to the family involved in the estate. The reader is cautioned that such a connection may or may not prove to be correct after a more detailed search. For this reason, this information appears at the back of the article and is marked Supplemental Information (Endnotes).

Will of John Stapler Will Book 1, Pages 109 and 110 Dated: 23 August 1856

Pay lawful debts. To my wife Ann Stapler a negro boy named Oliver and my land and home where I now reside and at her death the land and negro boy to my son John Stapler, Jr. except 20 acres which I give to my son Joseph N. Stapler - the 20 acres taken from the 40 acres joining Joseph N. Stapler. To my son John Stapler, Jr. a young sorrel mare. To my son Thomas L. Stapler a negro woman named Franck, 2 negro girls named Morring and Frances, and a negro boy named Jack. To my son William N. Stapler 1 negro boy named Jerry. To my daughter Rutha Davis, heirs of her body \$500.00 to be divided between them. To my daughter Elizabeth Whitacar and her heirs \$500.00. Which money is to be made from the sale of a Negro boy named Ellis and divided between Elizabeth and her heirs and Rutha Davis and her heirs. To my son and his heirs Amos Stapler and his heirs a negro boy named Martin. To my son Joseph N. Stapler a negro boy named Frank. If after selling the land and all other property owned in copartnership there should not be plenty to pay my debts then sell the copartnership negroes or any other negroes [no names listed. CN] that did not come by my wife. My securities from loss or pressure on my account any time.

My executors to buy a place near Huntsville either up or down the railroad that my wife and children might get their supplies.

To given my son William who is now no more \$1,500.00. \$1400.00 which he put into the mercantile business with William Stewart and William M. Derrick after paying his debts the law will divide the balance equally between his wife and child. If this child shall reach the age of eleven yrs old, that my executor will advance him 50 dollars yearly toward paying his expenses of schooling and clothing and if he reaches years of manhood then pay him \$500.00. And in case of death the estate be

released from paying the five hundred dollars. This is all that he would inherit since I believe it to be portion.

When all debts are paid then my son Albert shall have \$2,000.00 and until he receives the same he is to be paid \$200.00 yearly to defray his expenses and is not to pay any rent if he remains with his mother.

As my children shall marry or become of age that they each receive \$2,000.00 in money or property provided my estate is in a situation pay it off. Otherwise to receive \$200.00 yearly under same condition as Albert.

All my property except such as has already been bequeathed shall be sold and special legacies to be kept together. My wife to have all that is made to raise and educate our children. In case of the death of my wife that all of the property, after giving to each child that allotted to Albert be equally divided between the children then living. If my wife marries again the property to be divides as follows: My wife to have the house and lot bought from [?] and Lemberg together with all the household and kitchen furniture, her Rockaway and horse, 1/3 of all the negroes that I got from her father's estate [no names listed. CN], the balance to be divides as has already been specified.

To my son Albert my buggie. To my brother Leroy H. Jones my saddle horse crocket. With the request to treat him ever kindly and bury him when he dies.

My wife Executrix and my brother Leroy H. Jones and my friend Dr. Henry A. Binford executors with no securities.

Then the executors are to hire out the negroes except the house servants [no names listed. CN] and when sufficient funds are at hand to buy a plantation in Arkansas and the slaves are to be removed to that state under the control of my son Albert and for his services be paid a reasonable compensation in addition to legacy of the will. My son Albert be appointed co-executor with those appointed by the will. He is to be exempted from giving bond or security.

If any balance against me as the adm'r of my dec'd brother James S. Jones there is money on hand to pay. I believe that John, Thomas, William Mc — and the estate of Robert Brandon dec'd, my brother Leroy H. Jones and his wife legatees William Brandon dec'd. will all be indebted to me as the executor of William's estate. If they come forward and settle with Probate Court without litigation then the amount which John, Thomas, William Mc and the estate of Robert shall owe shall be divided into 3 equal annual payments and that the notes and securities shall be taken from each, for the proper amounts, the first payment to be without interest, but if they are litigious then the settlement to take its course. My brother Leroy H. Jones not to be charged more than \$500.00 and allowed two years to pay and without interest and if he is indebted for a larger amount I give it to him.

I have settled with my wards the children of Samuel Hughes except the youngest. Papers on file in the Probate Court of Madison County. I revoke the gift of my saddle horse to my brother Leroy H. Jones and give the horse to my son Albert H. To my brother Leroy H. I give him his choice of my walking canes my desire is he should take the gold headed one left me by William Brandon.

Researcher's Note: The first part of this book was used as a pre-Civil War Circuit Court Docket Book. The remainder was used for indigent records. It is an accounting book to record people paying their way out of debt through their labors, their children's labors, or with money or salt payments made by friends or family members. This book was restored by C. C. Porch, Probate Judge in 1966. Some page numbers were missing in the original, substitute numbers have been added. These numbers are made bold for clarity. This installment of the book begins with Bristers Cove Precinct #4 and continues into the Jay Bird Precinct #5.

Even though this book is written as a personal history, it is a very interesting and well written book. The author doesn't pull any punches in what stories she has picked about her subject, so the reader gets to see him and his family as persons, warts and all.

Despite the book's small size, the author successfully conveys some of the spirit of the exciting times in which John Hemphill lived in South Carolina and Texas. She was consistently good at tying events to places and times so the reader is always aware of the correct sequence of events in the Judge's life.

There is a coat of arms shown at the front of the book. It is marked Hemphill. It is not described, the source is not given, it just sits there - a small smudge in an otherwise fine book.

As you may guess, this series represents a very serious research effort.

The first two volumes should be purchased as a set because the indexes to Volume One are in Volume Two and Volume Two contains additions and corrections to Volume One.

The first thing that the careful reader will note is that the first volume possesses two unique features. The first unique feature is, the author identifies a British professional genealogist whose services he used in the course of this research. Many authors acknowledge persons who contributed to a book or assisted in research, but until now, no author I have reviewed, acknowledged using a professional researcher.

The second unique feature is that there are coats of arms shown in the book <u>and</u> the author identifies how each was awarded <u>and</u> traces how each was passed on to descendants.

Okay, so what's the significance of these

two features? The fact that a professional genealogist was used means that the author understood his limitations and hired a qualified professional to do what he knew he could not do. That is to say, that this author did not attempt to learn Latin and Early and Middle English and French. Nor did he spend huge blocks of time trying to understand the prevailing laws, customs and systems of a country and age with which he was unfamiliar. Some researchers appear to feel that if they do not do all the work themselves they are somehow "cheating," when the fact is, their work suffers because they do not have a solid grasp on what their research may uncover. So a writer/researcher who is aware of his/her limitations and compensates for it will, all things being equal, be more likely to turn out a quality product than one who believe that he/she can learn all things for all time periods.

The coat of arms information shows how lines of descent can be proven by how arms' designs were passed. This doesn't make the discussion any more interesting, quite the opposite, but it does illustrate another means by which a family line can be traced.

Both books in Volume One have lineage and family group charts along with verbal descriptions so that a line can be easily followed.

Volumes Two and Three contain information about other American Massey lines. The author attempted to connect every Massey family possible, state by state, up to the 1880 Census. While this could be considered a naive effort and does "date" the work, considering when the volumes were published, you can understand that the author was doing a big favor for the genealogical community.

After having written all these good things about the book, I have to say that the work is marred by a lack of definite references and footnotes. While this lack is typical for books of its day, good scholarship always requires it. Reviewed by Richard A. Smallwood

The author stated that he had spent twenty-five years of research on this book. The book is well written, easily read and flows well.

In the initial chapters, for each family line, the author discusses previous published works. In his argument and discussion, the author references his statements with endnotes at the end of each chapter (as he does through out the book). Original source materials appear to have been used in the writing of this book, but the Bibliography only lists the previously published works which were consulted and quoted in the work. If secondary sources were the only ones used, the footnote references should be changed to reflect this. If original source material was used, the Bibliography should be upgraded to reflect this.

While previous published sources are quoted and some items are refuted, the author does not appear to judge whether time has proven these authors' assumptions as valid. I feel that this should have been done so the beginning researcher would know whether to bother looking up these other works or not.

The author does include one really interesting feature - for each family he has designated sections for "tall tales" so the reader can compare his unsupported family traditions with what others have stated. Some of these are really interesting if for no other reason than the naivete of some of the stories.

A puzzling feature of this book is that there are three coats of arms shown for the various families. The first is clearly listed as extinct (the last bearer died without heir), the second

is clearly labelled as not belonging to the family where it is shown and, lastly, the third is clearly identified as never officially registered and then later became extinct. In addition to all this, Appendix "A" has a short discussion about the awarding of arms which pretty much sums up that none of the included arms belong(ed) to the family. No explanation is given as to why the author then went to the expense and trouble to include these arms in his book.

There are standardized lineage charts at the back of the book for those who want to skip the verbiage and get straight into the lineage information. Each entry contains consistent information and the layout is efficient and effective.

There are human interest stories and photographs throughout the book. The stories add a personal touch, but all the photographs are noticeably out of focus, some worse than others. However, all illustrations, throughout the book, are sharp and clear.

The author stated that he had spent twenty-two years researching his family. The book shows a great deal of research effort.

This is the second book that the author has written on the Lloyd family. The first was

on the descendants of Jacob B. Lloyd, a native of Wayne County KY who moved to Putnam County MO about 1850. This book starts with Jacob's great grandfather, Thomas Loyd, who was born, before 1745, in New Jersey and moved first to Washington County VA and later to Greene County TN. The author then follows the next three generations of the family, including, the line of one of Thomas' sons, Nicholas, born in New Jersey about 1768. Nicholas lives for a while in Lawrence County AL and dies, after 1850, in Jackson County AL.

The first part of the book consists of narratives based around a lineage chart. The last part is presented much like a researcher's notebook (albeit much neater and better arranged).

I did not find the book confusing and there are ample notes, footnotes and references. An unique feature is that the author lists all sources he consulted regardless of whether he found appropriate information in the source.

There are interesting and complete narratives concerning the older generations, the more recent generations just contain birth, marriage and death dates and locations. Whenever information was furnished by a third party, the complete name and address is listed for the person who supplied the information, so the reader always knows who gets the credit (or where to place the blame).

"Between ten o'clock and midnight on 15 August 1891, two men died under circumstances that still leave people wondering." With that tantalizing sentence, Alabama native Ben Bradford commences his tale of the life and violent times of William Monroe Evans, a terror in North Alabama in the late 1800's. On that brutal August night 106 years ago, Monroe Evans and his son John strangled to death at the end of a rope provided by a Baileyton lynch mob. The story of "Mun" Evans has been touched on briefly in several recent publications, but Bradford has ferreted out the details of Evans life and gruesome end. This was no easy task, since many people along the Morgan and Cullman County line had done their best to obliterate the trail.

Now a resident of Michigan, Bradford grew up hearing tales of Monroe Evans and his dastardly deeds. Fortunately for history, Bradford has fleshed them out and produced a very readable book for us to enjoy. He has also tried to track down Evans' family and untangle the sometimes complicated threads of their family relationships.

William Monroe Evans was born near Cottonville, Marshall County, in 1845. He was the son of 51 year old William Evans and his wife Mary, 37. "Mun" Evans first attracted attention as a teenager by joining the Union scout company of the notorious "Captain" John Wesley Dickey. Dickey's men were provided uniforms, horses, and pistols by the Union Army, but were never really considered soldiers. (Some of their widows found this out the hard way when they applied for Union veteran's pensions.) The scouts were paid by the day, and when not actually working for the army would amuse themselves by getting into devilment. As Bradford puts it, "John Dickey recruited the most bizarre collection of depraved humanity ever seen in that part of the country. They were composed of known outlaws, Confederate deserters, traitors to the Union, conscription dodgers, and other riffraff that quickly was attracted by the thrills and profits of such a gang." Murders, rapes, and robberies were all credited to Dickey's men, and in such rough company Monroe Evans cut his teeth.

Despite current claims to the contrary, Mun Evans was always a small scale outlaw. No bank robberies or train holdups have ever

been credited to him. Mun was more into moonshining, cattle stealing, and just plain devilishness, although a few murders may have been committed by him. The most famous incident involving Evans took place in 1869 in Wild Goat Cove, in Northwestern Marshall County not far from New Hope. A shoot-out took place between Evans and his followers and a local posse. Mun Evans was wounded and several black Alabamians killed in the gun battle. Evans tried to claim the Ku Klux Klan was out to get him, but the affair actually was over a woman. In fact, the posse was led by another of Dickey's men, Willis C. Stephens. Possibly the posse was inspired by Evans' threats to blow up the town of New Hope and his alleged attempt to blow up the Paint Rock Methodist Church during a crowded Sunday service. Ironically, a group of Confederate veterans sent a petition to the occupying Federal troops requesting protection against ex-Union scout Monroe Evans.

Evans escaped capture and made his home thereafter in the Eva area, near the county lines of Marshall, Morgan and Cullman. Bradford speculates that Evans chose the location so that he could easily slip out of the jurisdiction of whichever county sheriff came after him. But Evans' wild ways eventually caught up with him that brutal night in 1891 in Baileyton. Bradford chronicles the events that finally drove the citizens to take the law into their own hands.

He also describes the difficulties of discovering just who the "white cap" vigilantes actually were. Most likely, some of them were Bradford's own ancestors.

There is genealogical content in the book as names are mentioned both in the active sense and as the author attempts to "follow up" on the "white caps" and their families; describing their lives and where they later move to. Unfortunately with no index, the reader must scan the book to determine if any family members are mentioned. That's not all bad, for a readable and enjoyable trip back into the Tennessee Valley's past, get yourself a copy of Bradford's book. The title itself is a delightful descent into black humor.

Typed submissions be accompanied by a 3 1/2" floppy disk with at least one copy of the information saved as ASCII text, in either IBM or Macintosh format. All floppy disks are returnable upon request.
