

Dear Friends,

This is the first edition of our 33rd Year. It is our Anniversary and we celebrate it as we move towards the last year of this century! Family Alcoholism Research Study

The University of California, San Francisco (UCSF) Family Alcoholism Study is reaching out to those with an interest in genealogy to help us find large families that have been affected by alcoholism to participate in a research study. The aim of this study is to locate the genes that may contribute to the development of alcoholism.

Do drinking problems seem to run in your family? If so, you may be just what we are looking for. We are seeking large families in which more than one member has had a problem with alcohol, and would like as many family members as possible to participate. At minimum, we need one alcoholic (past or present) and at least one of their siblings or both of their parents. The study can be completed by telephone and mail and takes about 4 hours of time. Each participant receives a financial compensation of \$30.00 - \$50.00 depending upon time and effort required to complete the study.

Tennessee Valley Genealogical Society's Newest Lineage Certification Program • Pioneers of the Tennessee Valley •

The Society now enters its second phase in honoring those persons who entered the Tennessee Valley early in the 19th Century. As with the First Families of the Tennessee Valley, an eligible ancestor did not have to remain here all their lives, they did not have to own land, they did not have to be white or of Western European ancestry, you just have to document that they were here.

"Here" is any of the nine (9) counties of North Alabama which are served by TVGS, and they had to be here before 31 December 1834. That's right, 1834, not 1819, but 1834.

The **Pioneers** program acknowledges those people who came here during the first 15 years of Alabama statehood. Documentation submitted must be of an equal quality with and be of the same type as that required for the First Families Certification program. In the event an application is designated as being submitted for the **Pioneers** program and the ancestor really qualifies for the First Families program, the applicant will be so notified and the appropriate First Families Certificate will be awarded.

The Application Fee is still \$25.00 for the initial submittal in either program, but a Supplemental Application (as for a wife) is \$15.00, in either program. The fee for a Certificate for a child of an accepted First Family ancestor, who would qualify as a **Pioneer**, is \$15.00. Any official First Families application form can be used for a **Pioneer** Application.

Editor's Note: For those who don't know the story. Ms Walls is a nationally known genealogical speaker and author. She also appeared in the PBS series Ancestry. Ms Walls was a scheduled speaker for the TVGS 1998 Spring Genealogical Seminar at the Von Braun Center. About three weeks before the Seminar, Ms. Walls was diagnosed with leukemia and had to undergo the highest level of treatment. The treatment killed her bone marrow (an expected result) but the doctors were not successful in transplanting her own bone marrow back into her body. When a plea went out for possible bone marrow donors, several of the Society's members responded, with the results as described above.

Editor's Comment and Call for Comments

Probably the most dramatic change to have taken place in genealogical research has occurred in the past three years. This change has been the increase in the use and the resources available on the Internet. One side effect of the Internet is that membership numbers and activities have been reduced in traditional genealogical societies. Objectively, there should be no incompatibility between the Internet and traditional genealogical societies, as participants in both should be searching for the truth and facts about ancestors.

But the Internet sings a Siren's song. With very little effort, in the comfort of your own home, and in a short period of time, a person can search vast databases, in many locations, for the names of ancestors. When answers are found, they magically appear on your computer screen and can be downloaded to your printer. Now, what could be simpler than that?

Well, what tends to be forgotten is that the Internet is nothing more than a communications tool. It takes a person to place the information into those databases. It also takes checks and verification to place accurate and truthful information into those databases. Being just a communication tool, the most absolute of truths and the most blatant of lies are all the same to the Internet, as there is no built-in truth check and, under the present setup, there never will be.

The Internet is a very fluid environment and is a comparatively low cost means of doing business. People set up and close down websites, daily. Good private sites and governmental sites tend to stay at one website address and that seems to be a good indicator of the quality of material they offer. But a word of caution is required here, just as the Mormon Church (LDS) makes no claims about the accuracy of the information patrons submit to its IGI or FamilySearchtm databases, even the best non-governmental websites cannot guarantee that all the information in their databases are valid.

For this reason, reputable lineage societies, Indian tribes and courts of law do not accept Family Group sheets, Family Tree charts, LDS IGI or FamilySearchtm records, Broderbund's World Family Tree records, or Internet abstracts as anything other than unsubstantiated hearsay.

So even though the Internet has drastically changed the potential as to how we can search for information, it has not changed what is considered reliable documentation, or, for the most part, how we search through the actual records.

TVGS has been computer aware for many years. *Valley Leaves* has been edited on a computer for the past seven years. We also have been transferring our articles by e-mail on the Internet for the past year. Yet with the exception of announcing our website address and placing e-mail addresses in our Queries, our Quarterly has not addressed any aspect of the Internet. From a limited poll of members, we know that our Society's Internet use is increasing. Should there not be a reliable clearinghouse, for our members to use to determine good search sites and techniques as well as what equipment and software seems to be the best for genealogical use and research?

To be dynamic and viable the Quarterly has to be a reflection of the wishes of our membership/readership. The question to the readership is- do you wish the Quarterly to reflect the impact of the Internet? If so, what subjects do you want covered?

Segments on website addresses (such as Cyndi's List, with 55,150 links to search sites http://www.CyndisList.com/), updates on additions (such as Ancestry presently digitizing NSDAR records http://www.ancestry.com), governmental sites such as the Bureau of Land Management (http://www.glorecords.blm.gov/), or Search Sites (http://cpcug.org/user/jlacombe/search.html), or big database such as the LDS FamilySearch website (http://www.familysearch.org/).

Perhaps comparisons on the best genealogical computer software:

- 1.) PAF for its low cost (free in the Windows version). Compatible with all Macintosh's, most PC's, and mainframe computers. Sold by the LDS church or download at their site. This program set the standard for GEDCOM and is the only one which works 100% with GEDCOM.
- 2.) Broderbund Family Tree. This program is compatible between Power Macintoshes and PC's and Broderbund's main frame. Cost \$59.95, but subject to sales and special deals. It is not needed on PC's to read Broderbund's CD-ROMs, but is needed for Power Macs to read them.
- 3.) Master Genealogist for PC's and Reunion for Macintosh. Each more expensive than the previous two programs, but both have a good reputation for being powerful. Both require translation to GEDCOM to communicate between platforms Macs to PC's and vice versa.

The first installment appeared in Volume 30, Number 3 (March 1996) and has appeared continuously since then. We have set aside our normal rule of not accepting 20th Century information because of the lack of 19th Century records for Franklin County - the results of a 1890 courthouse fire.

One of the survivors of the Seminole war of 1838 lives at Centre Star, this county. He is Dennis Holden, and is ninety one years of age. The suggestion of the Courier for the re-union of these veterans is a good one.--Herald Florence.

Mrs. Cobb was stricken with paralysis some time Saturday morning and died about 2 p.m. that day. She made her home with her daughter Mrs. A. C. Davis of this city. A Sad Accident.

The little child of Marion Pace living about four miles from town was killed last week under peculiar distressing circumstances. The father and mother were both in the field leaving the children, aged about 18 months three and five years each at the house. By some means the youngest seems to have fallen from the porch and getting its head hung in the banister was choked to death before the other children could get it loose. Mrs. Pace started to the house and when near, one of the children called that something was the matter with the baby. Getting to the house she found the little one lying on the floor dead and the children unable to tell just how it happened. Black marks on the child's neck showed that it had been choked and the little fellows told as well as they could of the fall and of pulling the baby back on the porch.

County Court.

Is the Grand Jury in session? Seemed a pertinent question Monday to one coming by the Court House and looking at the crowd of witnesses in and around Temple of Justice.

The first case was George Harris (col.) charged with assaulting Callie Harris, his 14 year old niece with a stick while he was trying to make her go home. The Judge thought Geo. ought to put up a five and so decreed Geo. appealed to the Circuit Court.

The next case was Jasper Taylor charged with abusive language, Plea of guilty. \$1 and cost.

Next Case Callie East and Fillis Love charged with meeting together to commit a breach of the peace which is law talk for getting up a mob.---Not guilty.

Willie Woods assault with a rock was next, the Court decided he didn't do it.

Henry Williamson alias Henry Hamilton, charged with stealing a hog. His Honor thought the hog and the way Henry got it was worth \$25 and six months in the Coal mines. Henry is also in trouble about stealing Mrs. Suggs cow last winter.

Jesse Smith a Negro lad 15 or 16 years old, was next tried on a charge of attempted criminal assault, a Negro girl 12 or 14 years old being the alleged victim. The case was hotly fought and ended with Court binding the boy over to await the action of the Grand Jury. Attorneys for the defendant Almon & Bullock appealed from this decision by suing out a writ of Habeas Corpus before Judge Almon who is now at Fern Quarry and to whom the written evidence has been submitted.

Through the courtesy of Mr. G. L. Cleere we were permitted to look over and old copy of the North Alabamian recently found among the papers of his father the late Geo. D. Cleere. The paper a 6 column folio was printed Dec. 17, 1836. Asa Massenger, Editor, subscription price \$4.00, ad \$1.00 per square. In the news columns the paper tells with regret that Van Buren had been elected President, that two decisive battles had just been fought between the whites and the Florida Indians. The news from Texas was that the Congress had just passed a resolution authorizing negotiations for the annexation of that State. All this news was about a month old. Late proceeding of the Alabama legislature of date Nov. 29 were given, the body electing Thos. B. Tunstull, Sec. of State, and transacted other business. Cotton is quoted in Mobile at 17 cts. The T. C. & D Railroad notifies patrons that it will not carry naked kegs of powder, as their only motive power is steam and also notifies patrons that accounts must be paid monthly, that no more than 15 bales of cotton must be put on a car, that on request cars will be left at most convenient turnouts for loading. P. N. Bolin advertised his farm for sale 9 miles east of Russellville on the Moulton road (where Newburgh is now.) W. J. Bullock has letters of administration on estate of Francis Bullock decd and Temple Sargent and Fred K. Lester have a land suit against the administrator to enable him to make them title. This publication comes from the Orphans Court of which Michael Dickson was Clerk. His is the only county officials name that appears in the paper. Th Minott Peters publishes prospectus of Moulton News which he says he will soon begin at Moulton. Tuscumbia was then in Franklin county, Frankfort the County seat. About one half the paper was advertisements.







Cotaco County Superior Court Record November 1819 - 29 February 1820

Abstracted by Dorothy Scott Johnson

Editor's Note: This is the second installment of this series. In the last issue, the first installment was identified as part one of a six part series. Work is still in progress on this series, so the final number of parts is not yet known.

Author's Notes: This transcription was made from a photocopy obtained by Gay Campbell from the Alabama Archives. Cotaco County was established by an Act of the Legislature in 1818 with Somerville as its county seat. Then the county's name was changed to Morgan and the county seat became Decatur. All legal definitions are from Black's Law Dictionary, Fifth Edition and will hereafter be referred to as Black's.

Cotaco Co. Superior Court Record

First Monday in November 1819.

Pages 50 - 55

Benjamin Patteson &, Assignees, vs. Nathaniel W. Dandridge.

Benjamin Patteson and Co. filed a Capias ad respondendum¹ against Nathaniel W. Dandridge.

The sheriff was ordered to "take the body of Nathaniel W. Dandridge wherever he may be found in your county and him safely keep so that you have his body before the judge of our next Superior Court" to be held at Somerville on the first Monday in November next [1819] to answer Benjamin Patteson and Brice M. Garner, merchants and partners trading under the name of Benjamin Patteson & Co., assignees of Archibald B. Dandridge.

Patteson requested Dandridge render to them the \$100 he owes them plus \$50 damages from him for not paying the debt. Witness: Edward Richardson, Esq., Clerk of said Court, on the 3rd Monday in February 1819 and of American Independence the 43rd year.

The debt was incurred on 13 June 1818 by a note signed by Dandridge to Patteson in the amount of \$100 due 1 January 1819. Said note was assigned by Archibald Dandridge on 25 Dec 1818 to the plaintiffs and defendant was so notified. Said sum was due and unpaid in its entirety. Plaintiffs' claim debt plus \$50 damages.

The writ was served on defendant 5 July 1819 by A. Miller, deputy sheriff, and Dandridge was taken into custody.

Defendant failed to appear in court at the appointed time at the November 1819 term of court as ordered. Plaintiff appeared by his attorney, Clay.

Judgment was that plaintiffs recover \$100 debt plus \$6.66 damages occasioned by reason of the detention of said debt plus their costs in this case.

Page 55 - 59

Knowles Green vs. Joel H. Goode & David Ballew

The sheriff was commanded to bring Joel H. Goode and David Ballew into custody if they can be found and them safely keep to ensure their presence before the judge at the next Superior Court in Somerville on the first Monday in November 1819. Bail required.

The suit is founded on a \$527 (plus interest) note dated 29 October 1818 and due in six months. No part of the debt has been paid although plaintiffs have often asked for payment. Plaintiffs also ask for \$100 damages as a result of the debt not being paid.

A document commanding the sheriff to take the defendant, and him safely keep, so that he may have the defendant in court on a certain day to answer the plaintiff's suit. [Black's]

Mead & Titus, attorneys for plaintiff.

At the November 1819 term of Superior Court the defendants failed to appear as ordered. The court ordered that the plaintiffs recover of defendants \$427 debt plus \$21.80 damages plus costs of this suit.

Pages 60 - 63

William Cruse and Samuel Cruse, merchants trading under the firm name and style of W. & S. Cruse vs. William Vaughan and Milkijah Vaughan, merchants trading under the firm name of Wm. & M. Vaughan.

The Cruses filed a *Capias ad respondendum* against defendants. The sheriff was commanded to "take the bodies of Wm. Vaughan and Milkijah Vaughn" wherever "they may be found in your county and them safely keep so that you have their bodies before the judge of our next Superior Court to be held for the County of [blank] at the Court House in the town of Somerville on the first Monday in November next to answer Wm. Cruse & Samuel Cruse." The Cruses ask that the Vaughans give them \$181.28 debt plus \$50 damages. Witness: Edward Richardson, Esq., Clerk of the Superior Court, on the 3rd Monday in February 1819. Writ issued 7 July 1819. Sheriff W. Gray served the writ on defendants 20 July 1819. Bail requested.

Suit is brought to recover \$181.28 promissory note for value received and dated 28 April 1818, due in 6 months. No part of debt has been paid. J. Boardman is attorney for plaintiffs.

At a court held in the November 1819 term the plaintiffs appeared in court by their attorney and the defendants, being solemnly called to court did not appear.

The Court ruled that plaintiffs recover the \$181.28 debt plus \$13.28 damage plus their costs in this case.

Pages 64 - 65

William Cruse and Samuel Cruse vs. William Vaughan and Milkijah Vaughan.

The sheriff of said Territory was "commanded to take the bodies of William Vaughan and Milkijah Vaughan, trading under the first name and style of Wm. & M. Vaughan, wherever they may be found in your County and them safely keep so that you will have their bodies before the judge of our next Superior Court to be held for the County of Cotaco at the Court House in the town of Somerville on the first Monday in November next [1819] to answer William Cruse and Samuel Cruse, trading under the firm and style of Wm. & S. Cruse, in a Plea of Trespass on the case to their damages of \$600. Herein fail not." Witness: Edward Richardson, Esq., and clerk of the Superior Court, on the 3rd Monday in Feb. 1819. Writ issued 6 July 1819.

The suit was brought to recover from defendants, \$366.98 "as indorsers", with interest, executed by one James Thomason to the defendants on the 23rd June 1818. Payment was due in 12 months from date of note and by them assigned to the Cruses by "an endorsement in blank²."

Pages 66 - 70

William Cruse and Samuel Cruse merchants trading under the name of Wm. & S. Cruse vs. William Vaughan and Milkijah Vaughan, merchants trading under the name of Wm. & M. Vaughan.

To the sheriff of Cotaco County: "Greetings. You are hereby commanded to take the bodies of William Vaughan & Milkijah Vaughan ... wherever they may be found in your county, and them safely keep so that you have their bodies before the judge of our next Superior Court to be held for the County of Cotaco, at the Court House in the town of Somerville on the first Monday in November next to answer William Cruse and Samuel Cruse, Merchants." Defendants served 20 July 1819 by W. Gray, Sheriff.

Suit is brought to recover a \$181.29 note signed by the Vaughans on 28 April 1818 and due 12 months from date. No part of debt has been paid.

The court date was set in November term of Court 1819 but the defendants failed to appear. The court ruled plaintiffs recover of defendants \$181.29 debt plus \$7.25 damages plus their costs of this suit.

² "In blank" is an endorsement of a bill or note where it consists merely of the endorser's name, without restriction to any particular endorsee [Black's]

Pages 70 - 71

William Ryan vs. Archelaus Craft & Richard Holly

On 11 November 1818 it was ordered that Archelaus Craft and Richard Holly be summoned to "appear before me or other Justice of the Peace" for

Cotaco County by 11:00 o clock at the house of Horatio Philpot [Justice of Peace] on Saturday 14 November 1818 to answer the complaint of William Ryan in a plea of debt not exceeding \$50.

Defendant appealed.

At the November term of court 1819 the defendants came into court and confessed [agreed to] judgment for the debt, interest and cost with a stay of execution [delay] of six weeks before monies due.

The court ruled that plaintiff recover \$26.50 debt plus \$2.04_ damages and costs in the case.

Pages 71 - 76

William Cruse and Samuel Cruse vs. James Thomason.

A Writ of Capias ad respondendum was filed by William Cruse and Samuel Cruse as follows: The Sheriff was commanded "to take the body of James Thomason wherever he may be found in your County and him safely keep so that you have his body before the judge of our next Superior Court" to be held on the first Monday in November 1819 to answer William and Samuel Cruse, merchants trading under the firm name of W. & S. Cruse. The warrant was executed by Sheriff W. Gray on 20 July 1819. Defendant Thomason was taken into custody. "Take Bail."

Suit was brought by the Cruses for the sum of \$366.98 debt plus \$100 damages. The Cruses were

assignees of the Vaughans. J. Boardman was attorney for plaintiffs.

William and Milkijah Vaughn were merchants and copartners trading under the firm name of

Wm. & M. Vaughan.

The Declaration was heard at the November term of court 1819. Originally, the \$366.98 note, for value received, was executed by William Ryan to the Vaughans on 23 June 1818 and due in 12 months. This note was assigned to the Cruses by the Vaughans by endorsement. The Cruses now sue Ryan for the money plus damages. No part of the debt has been paid.

Defendant Ryan failed to appear in Court at the designated time. The Court decreed that the

Cruses recover of Ryan the sum of \$366.98 debt plus \$7.00 damages and costs of this action.

Pages 76 - 81

William Cruse and Samuel Cruse vs. William Vaughan and Milkijah Vaughan.

The sheriff was commanded to "take the bodies of William Vaughan and Milkijah Vaughan, merchants trading under the name, firm and style of Wm. & M. Vaughan, wherever they may be found in your County and them safely keep so that you have their bodies before the judge of our next Supreme Court to be held for the County of Cotaco, at the Court House in the town of Somerville on the first Monday in November next, to answer William Cruse and Samuel Cruse, Merchants trading under the name, firm and Style of W. & S. Cruse."

The Cruses file suit and ask that the Vaughans pay them \$730.43 debt plus \$200 damages for having withheld said payment. Case filed on the third Monday in February. Witnessed by Edward

Richardson, Clerk of the Superior Court.

Suit is brought to recover the amount of a promissory note executed by the Vaughans on 28 April 1818 for \$730.43 and due 12 months after date and which amount the Vaughans unjustly detain. No part of the debt has been paid.

The hearing was set at the November term of Court 1819 but the defendants did not appear. The Court ruled that the Cruses recover \$730.43 debt plus \$29.00 damages and costs of this action.

Pages 81 - 86

William Cruse and Samuel Cruse vs. William Vaughan and Milkijah Vaughan.

A writ of capias ad respondendum was filed against the Vaughans. The sheriff was commanded "to take the bodies of William Vaughan and Milkijah Vaughan, merchants trading under the name, firm and Style of Wm. & M. Vaughan and them safely keep so that you have their bodies before the judge of our superior court to be held for the County of Cotaco, at the Court House in the town of Summerville on the first Monday in November, next [1819] to answer William Cruse and Samuel Cruse, merchants trading under the name, firm & Style of W. & S. Cruse in a plea that they render to them" the sum of \$147.07 which the Vaughans owe the Cruses and unjustly detain to the damages of the Cruses of \$50.00. The writ was served on defendants on 20 July 1819 by Sheriff W. Gray who took the Vaughans into custody. "Take Bail."

The suit is brought to recover the amount of a note executed by the Vaughans to the Cruses on 23 June 1818 at Somerville for \$147.07 for value received, payable 12 months after date. No part of the debt has been paid.

At the November 1819 term of court came plaintiffs by their attorney but defendants failed to appear. The court rules defendants pay plaintiffs \$147.07 debt plus \$4.24 damages plus costs.

Pages 86 - 89

John Brahan vs. Reuben L. Bayles.

"To the Sheriff of said County, Greetings. You are hereby commanded to take the body of Reuben L. Bayles, wherever he may be found in your County and him safely keep so that you have his body before the judge of our next Superior Court to be held for the County of Cotaco, at the Court House in the town of Somerville, on the first Monday in November next, to answer John Brahan of a plea that Bayles render unto him \$98.00 which he owes Brahan plus \$50.00 damages."

Case filed the 3rd Monday in February 1819. Warrant for arrest of Bayles issued 15 July 1819. Witness: Edward Richardson, Clerk of the Superior Court. Warrant served on Bayles by Sheriff W. Gray on 21 August 1819.

Case: On 16 July 1818 in Cotaco County, Reuben L. Bayles signed his promissory note to John Brahan in the amount of \$98 and due one day after date. Bayles has paid no part of said debt even though Brahan has repeatedly asked for payment, to the damage of Brahan in the amount of \$50.

Case came to court in November term 1819 but Bayles failed to appear. The Court ruled that Brahan recover against Bayles \$98.00 debt plus \$10.12 damages and the costs of this suit.

Pages 89 - 93

John Brahan vs. Jesse Couch

The sheriff was commanded to "take the body of Jesse Couch wherever he may be found in your County, and him safely keep, so that you have his body before the judge of our next Superior Court to be held for the County of Cotaco in the Court House in Somerville on the first Monday in November next, to answer John Brahan of a plea that Couch render to him" \$640 with interest from 21 November 1818 plus \$100 damages.

Case filed on the 3rd Monday in February 1819. Warrant to Couch issued 15 July 1819 and served on him on 23 August 1819 by Sheriff W. Gray who took Couch into custody. Bail required.

Suit: On 21 Nov 1818, in Cotaco County, Jesse Couch signed a promissory note to Brahan in the amount of \$640 due on or before 1 May 1819, plus interest thereon until paid. No part of debt has been paid although often requested to do so resulting in Brahan's damage of \$100.

At the November term in 1819 a court was held to hear the case. Brahan was represented in Court by his attorney, C. C. Clay, but Couch failed to appear.

The Court ruled that Brahan recover \$640 debt plus \$48.36 damages plus costs in this case from Couch.

First Monday in November 1819

Pages 94 - 98

John Brahan vs. Jesse Couch

The Sheriff "commanded to take the body of Jesse Couch, wherever he may be found in your County, and him safely keep so that you have his body before the judge of our next Superior Court to be held for the County of Cotaco at the Court House in Somerville on the first Monday in November next, to answer John Brahan of a plea" that Couch render him \$603.58 plus interest from the 21st day of November 1818. Couch has failed to pay this debt to the damage of Brahan in the sum of \$100. Warrant witnessed by Edward Richardson, Esq., clerk of the Superior Court, on the 3rd Monday in February 1819. Warrant issued 15 July 1819 and served 23 August 1819 by Sheriff W. Gray. Bail requested.

On 21 Nov 1828 Couch gave Brahan a \$603.58 promissory note due on or before 1 April 1819 with legal interest thereon from the date of the note. No part of the note has been paid although Brahan has often asked Couch to do so.

At the November term 1819 of Court the case was called for hearing. John Brahan appeared by his attorney, C. C. Clay, but the defendant, although solemnly called, came not.

The Court ordered that Brahan recover from Couch the sum of \$603.58 debt plus \$47.90 damages sustained by reason of detention of the debt, plus costs of this case.

This is not a book review so much as an announcement that the transcribed version of Dr. Alfred Davis Henkel's notebook exists.

First of all, the work done by the Maulsby is up to their usual, very high, standards. They transcribed all information from the doctor's handwritten records.

Dr. Henkel kept his 287 page journal from 1915 to 1946. But what he records dates back in some cases to 1713.

Dr. Henkel moved to Winchester VA in 1887 and remained there until his death. Much of the genealogical information in the journal is of his own family, but other families are represented.

He interviewed local inhabitants and conducted research at the Frederick County Courthouse on many persons having roots in Frederick and surrounding counties.

There is a depth of details in personal descriptions, occupations and the location of

homes and businesses.

It is the Maulsbys' opinion that the notebook makes a perfect companion volume to the book, What I Know About Winchester; Recollections of William Greenway Russell, 1800-1891; edited by Garland R. Quarles and Lewis N. Barton.

This book starts with the statement "Garlinghouse is a long name and a strong name' so starts the newspaper clipping from an unknown source dated 21 October 1849." From what I can gather, the family started out in this country in Pennsylvania, in 1746, and have generally stayed in the mid-Atlantic states since then.

The whole book is, for all practical purposes, an index or, hopefully, an outline for a book yet to be written.

Individuals are listed in alphabetical order, each with a one paragraph biographical description. There are no footnotes, no endnotes, no bibliography and no references to any kind of documentation. Further, there is no overall view, chart or description describing family relationships. To assemble a family unit, the reader is required to read every biography to record what parents, siblings or children are named.

I don't have the faintest idea why the publisher would submit this book for review because it is an example of what not to do. With no sources listed, a researcher has no idea what is belief and what is cold hard fact.

This book is a annotated Index to Dr. As Fitch's manuscript *History of Washington County, New York* the originals of which are owned by the New York Genealogical and Biographical Society of New York City and Saratoga National Historical Park; Stillwater NY

From 1847 to 1878, Dr. Fitch collected a series of articles which were oriented towards the history and genealogy of Washington County which included "the date of the first settlement of the towns and from whence the settlers came."

In collecting his data, Dr. Fitch personally interview settlers and included primary source material such as family records, wills, unrecorded deeds, cemetery records, court proceedings and newspaper accounts.

The area was settled by the Scots-Irish and persons who moved in from the States of Connecticut, Massachusetts, and Rhode island.

The original document is only available on microfilm and is divided into seven parts. This author has combined them into a 4 part index.

Volume three covers Articles 1101 through 1150 which Dr. Fitch compiled between October 1862 and October 1873.

Definitely an interesting book, though some of the entries contain nothing more than direct references to the original manuscript, others give real insight into life in that area and era. If your ancestors were ever in contact with Washington County NY, this book should be considered a "must" read book.

This book is very well written and researched. It begins with the family in Amsterdam Holland in the 1600's and covers the immigrant coming to America, in 1652, and the family's life in America thereafter.

The book goes into the history of the Dutch settlement in New York and the author weaves the family's history into this historical background. To support both the historical and genealogical elements of the book, appropriate photographs and copies of specific documents are placed through the book. Such supporting documents include photographs of tombstone, deeds, family Bible pages and probate records. All photographs and documents are sharp and clear.

The book does not contain footnotes or endnotes as such, but specific references are made in a coded style similar to that used in the PERSI catalogs (Periodical Source Index published by the Allen County Indiana Public Library). That is to say, that a referenced book or document is given an unique abbreviation and then the volume and page number are listed. This is not an academically "approved" method of annotating; however, it doesn't interrupt the flow of this book and it does give the reader enough information to determine the source(s) of any statement.

This book starts with the German immigrant, Hans Martin Mosser, his wife Margaretha Kungel, and their one year son, Frederick, aboard the ship *James Goodwill*, which arrived in Philadelphia, from Rotterdam, 17 September 1728. The family settled in the Perkiomen Valley at New Goshenhoppen; Philadelphia County Pennsylvania.

The author has spent a great deal of time in her research and she puts in a lot of effort to explain her research within the context of the German and colonial cultures. I found her background information to be most readable and educational, but for some reason, she did not cover the somewhat confusing German naming practises which boils down to - a child's baptized first name isn't his/her real or commonly used first name and women had the suffixes "in" or "en" appended on the ends of their maiden surnames.

While the author didn't use footnotes, she usually incorporated reference source within her narrative. All individuals were arranged in family groups, whenever possible and "stray" individuals were noted and discussed. As one would expect, biographical information varies amongst individuals, but as one would not expect, the sources for biographical information are not always stated for all individuals.

Overall, this book is very readable and good effort.

These two books are part of a series on early Maryland and Virginia families. I had chosen to address them together because they possess to same virtues and failings.

They books are well researched, but the presentation is uneven. There are no footnotes or endnotes used in either book. Further, the references in the Bibliography are listed in whole, that is to say, that there are no references to page numbers which would help you determine what the source(s) of any information might be.

Page viii of the White Families book has the statement: "We have not confirmed all of the date by personal examination of contemporary records, and can not [sic], therefore, vouch for its accuracy in all cases. Others are, of course, just as prone to making mistakes as we are, but the information reported is as accurate as we could make it from the records studied." [The book begins a new paragraph:] "We recognize that it is virtually impossible to report such an extensive amount of data without an error creeping in some place."

[Further on, at the end of the next paragraph, at the bottom of the page, these two sentences:] "The serious researcher should verify the material with independent research. Good luck,

and please forgive our occasional error."

Yes, well, and good luck on knowing where to look for it.

The Bibliography lists mainly secondary works, but they reputable authors. The references to original records such those in the Maryland Hall of Records (State Archives) are very broad so there is no way of knowing what information was or was not reviewed.

The author claimed that the book was intended for the "casual reader who wanted insight into his/her family history." I'm not sure what is meant by that statement so I can't judge whether that goal was obtained. I'm just uneasy with facts being stated and me not knowing the source of those facts.

Well, be that as it may, the Miles Families book cover the descendants of Charles Miles who died in Montgomery County MD in 1842. The White Families book begins with the first Guy White who died about 1676 in Calvert County MD, but whose descendants lived, mainly, in Montgomery and Frederick Counties MD.

Other family names with books in this series are:

Fry, Walker, Fulks, Watkins, King, Burdette, Soper, Brandenburg, Purdum, Perry, Stottlemyer, Browning, Lewis, Warfield, and Maddox.

The information Col. Green transcribed from the 46 columns which appeared on these schedules are: name of owner acres of improved land, acres of unimproved land, cash value of farm, value of farm implements and machinery and value of livestock.

As any researcher knows, accurate indexes are a big help in research. A sampling check of this book against the actual census records indicates perfect accuracy. Col. This book covers the descendants of Robert and Mary Kent of Goochland Virginia from 1747 to 1999. While the author states that the work covers the period 1715 to 1999, the first documentation on Robert appears in 1747. He follows family members as they moved into Tennessee, Alabama and Mississippi.

The earlier part of the book is well documented containing many appropriate footnotes. Many individuals in the later generations (late 19th Century and the 20th Century) are not so well documented, but in those instances he does list the name and location of who supplied the information so the reader will know who to thank (or blame).

The author also make an effort to educate the reader on the historical aspects of the period he is covering. He also discusses how the prevailing law affected the family's lives and fortunes.

There are appropriate personal stories and photographs of family members throughout the book. The photograph are all soft focus, but the overwhelming majority are readable. There are also copies of support documents which are sharp and clear.

Typed submissions be accompanied by a 3 1/2" floppy disk with at least one copy of the information saved as ASCII text, in either IBM or Macintosh format. All floppy disks are returnable upon request.
