

Esq. Hugh Graham moved out of District 34 and leaves it without a J. P. 1

Major William M. King Sir:

We are requested as a committee appointed by the Battalion of Jackson County (Ala.) Volunteers to respond to your note of yesterday. It is the unanimous desire of the officers and privates of this Battalion that you do not resign your seat in the State Legislature.

Strays taken up in Jackson County by George Frazier - Estill Fork.²

Jackson Union News,

12 Aug 1908

Mr. Will Vandiver, former resident of Paint Rock Valley, but now a resident of Chicatah, Oklahoma, and Miss Pearl Sanders of Milan, Ala. were quietly married last Friday in the office of Circuit Clerk J. M. Swaim, Esquire. W. I. Kirk officiated. Owing to objections on the part of the father of the bride, Mr. William Sanders, it became necessary for the young couple to elope, which they did. Coming to Scottsboro, where the license was secured by friends, Esquire Kirk doing the rest. It is said that the watchful father was led to believe that the couple were going to Winchester, Tennessee, the haven for all north Alabama eloping couples and he

¹ Hugh F. Graham was the son of James F. Graham and second wife, "Jenny" Russ. Hugh married Eugenia Tate Jackson Feb. 28, 1891. They are both buried in the Clay Cemetery at Princeton.

² This George Frazier was a brother to the first wife of Moses Swaim - Elizabeth Frazier. He eventually left here and went to Mississippi near the Arkansas line and is buried in Arkansas just over the line.

headed for that point with the intention of stopping the marriage but in this, the father was misled.

Messieurs Anderson Howell, Hershel Henshaw and Will Vandiver, a relative to the groom, and Mrs. Pearl and ...Sisk accompanied the happy couple and saw them safely through. Mr. and Mrs. Vandiver at once left for their home in Oklahoma and their young friends to their respective homes in Paint Rock Valley.³

George Henshaw of Estill died of typhoid fever and flux one day last week.⁴

Mr. Wilkerson Gifford, commonly known as "Uncle Wilke," who resided near Gray's Chapel, died last week at the age of 100 years.⁵

³ Addie Shaver did not know what happened, but the marriage was dissolved soon. Later Pearl married Woodville Swaim, Addie's uncle. They went to Texas and lived there for several years. They had three children, two boys and a girl. Pearl Swaim died in Grapeview, Texas and is buried there. After a while Woodville Swaim and the children moved back to Alabama.

G. W. N. Stovall. We learn that the case of State vs. G. W. N. Stovall, charged with the murder of Benj. Snodgrass, Jr., tried at the recent term of the Circuit Court, resulted in a conviction of the defendant of manslaughter in the second degree, and in a sentence to twelve months imprisonment in the county jail. It is also stated that the judgment was set aside and a new trial granted.

⁴ This was George Henshaw, son of George Washington Henshaw and Elizabeth Jane Robertson. He was born August 10, 1856 and died Oct. 19, 1893. He is buried in the Old Bostick Hill Cemetery beside his parents.

Estill Fork

July 9, 1872

To the Editor of the Herald:

On Saturday night, the 6th inst., about 9 p.m., John Bishop's dwelling house, kitchen and smoke house, with the entire contents except two beds and three quilts and one side of meat, were burnt together with his entire wheat crop just threshed out and put upstairs.

Also on Friday night, the 5th on the same creek, Hurricane Fork - Ambler Grubbs, aged sixty four years, fell from a window of a mill thirty-one feet perpendicular onto a solid rock and was killed, bursting his skull, breaking his neck and back.⁸

12 Dec 1872

Married

On the evening of the 19th of Nov., 1872, at the residence of the bride's mother, by S. G. Grimmett, Esq., Mr. Joseph B. Reid and Miss Susan C. Hinshaw, all of the county.

Scottsboro Citizen, Fri. 15 Oct 1880 Death of a Pioneer

Died in Paint Rock Valley, Oct. 7, 1880, Mr. Moses Swaim. He was an old and respected citizen having moved to the Valley in 1823. Consequently, he was one of Jackson's pioneers. Mr. Swaim was the father of twenty-five

children, thirteen of whom are now living. He has sixty-five great-grandchildren. He had been married three times, his last wife surviving him. He was universally esteemed by his neighbors and his death is generally regretted.⁹

Progressive Age, 2 April 1892

Drowned at Paint Rock on Sunday of this week, Charles Hannah, the 12 year old son of A. T. Hannah of Paint Rock. He and two other boys were playing on some floating mill logs in the river. Young Hannah fell into deep water and was drowned. Mr. McCulley, the Paint Rock druggist, was a witness to the scene but too far away to reach to boy in time to keep him from drowning. ¹⁰

9 April 1891

Young Married Woman Kills Herself with a Pistol

Mrs. Macon shot herself on the 5th inst. at her father-in-law's residence twelve miles north of Huntsville, with suicidal intents, and will die but the course is unknown. She is the daughter of San Francisco Rice and has been married six months and is a member of one of the most prominent families in the county.

Mrs. Margaret Eustace, mother of W. T. Eustace of Hollytree, died at her

⁸ Addie Shaver could not identify this Ambler Grubbs as he was not a Valley man. There were some people by that name in Jackson County, however. Perhaps he was working at a mill. It does not fit the description of a sawmill, but there was a pencil mill at Estill Fork some time around 1915. Could it have been there in 1872?

⁹ In 1998, Addie Shaver was able to find all 25 children of Moses Swaim and locate were all went. At the time of his death the whereabouts of several were unknown. Descendants are many more than was known and numbers today would reach the thousands.

There appears to be no marked grave anywhere in the Valley for this boy and there is no 1890 census. For these reasons I have been unable to gather more information on him.

"I need to know the place and date of George Wilson, born about 1790 according to the 1850 Jackson Co., Alabama census. He married Rebecca Camp (or Kemp). Their children:

"Joseph, b. 1815 in Kentucky; had wife Ferraby.

"Washington Cooper Wilson, b. 1815 in Ky [Ed: Must have been twins], married Lucinda Cook, died Gray's Chapel, Jackson Co., Al in 1864.

"Bird (Byrd) Claborn Wilson, b. 1827 in Ala.

"Carroll married Rhoda Ann Money [who was] b. 1835 (Moneys from Paint Rock Valley also);

"George Wilson [Jr.] went to Texas never heard from again.

Mr. Granville Bridges, died at his home in Larkinsville Tuesday, August 17, 1903, aged 75 years.

The death of Mr. Bridges removes one of the oldest and most respected citizens of our county. For a number of years he lived in Paint Rock Valley but moved to Larkinsville a few years ago, he and his son having bought the Gabe Smith farm near that place. deceased was a gentleman of the old school and was rated for his many excellent traits of character. His wife, who died a few years ago, was a sister of Dr. McCord of Section. Two children survive him, Will S. and Miss Cardea. Mr. Bridges was a consistent member of the Cumberland Presbyterian Church and died - stronger in the faith and a good Christian.

Mr. Swaim is competent for the office he seeks and if elected would make a good Clerk.

Paint Rock Valley Data

Paint Rock reports the coldest weather since 1877. The thermometer registered two degrees below zero this morning of the 10th.

A new post office has been established on the mail route from Scottsboro to Gray's Chapel called Cato. George W. Dolberry is postmaster.

Tried for Murder (Thurs. March 4, 1875)

James Bingham was arraigned for killing his uncle, John Bingham. Trial before magistrates Gormely, Padgett, Peters and Beavers. Prosecutor, W. H. Robinson; and [for] Defendants, L. G. Meade and L. H. Lewis. Bail was a bond of \$2500. Trial at Paint Rock Magistrate Court.

Warney Robertson was killed by lightning last Monday. He was working on a barn at the time he was killed. The deceased was a bachelor and was about 45 years. 13

 Sarah Ann Walker Fanning was the second wife of James W. Fanning. Marriage records show J. W. Fanning married Sarah Ann Walker 25 Dec 1873 by Elish Prince, M. G. The first wife of James W. Fanning was Marion A. Greer.
 Mrs. N. A. Bishop may be Nancy Swearingen who married William Bishop. Her middle initial in the marriage record was not the same, however.

Dots from Milan

Mrs. Sarah Russ, widow of the late Dr. B. S. Russ, died the 20th at the home of her son-in-law, James N. Walker, near Princeton.¹⁷

Prof. Hodges, who taught school at Princeton, has applied for Bostick Hill School.

James Green, a son of G. W. Green of Larkin's Fork, died Friday the 18th. He had been afflicted all his life. ¹⁸

21 June 1894

H. B. Taylor, an old and esteemed citizen of Paint Rock Valley, died at his home near Larkin's Fork one day last week.¹⁹

Bostick Hill High School will begin July 23rd with Prof. P. W. Hodges, principal, and Miss Barbie Collins, Assistant. Parents and friends of education are elated in having secured the services of the able and energetic principal and that of the talented lady assistant.

Thurs. 14 Oct 1875

Mr. Gideon Bouldin, father of James Bouldin, one of the best citizens of Paint Rock Valley in this county, died at his residence in Etowah County on the 26th ult. of typhoid fever. The deceased was 79 years old and much respected and beloved for his many virtues and religious integrity. His friends have the

There is a new Post Office in Paint Rock Valley on the mail route from Larkinsville to Hunt's Station, Tenn., called "Francisco" where the *Herald* has four subscribers and desires – and ought to have a dozen more. M. H. Rich is postmaster and Wm. Green, assistant.

Thurs 15 Mar 1891

Milan News

Sidney Swaim, son of Commissioner Swaim, came home from Greene Academy at Nat on the 10th and returned on the 12th. He reports the school is in a flourishing condition.²⁰

Prof. W. W. Reed is teaching a private school at Hollytree.

Thurs. 29 Mar 1894

In an affray near Francisco between James Mason and Zav Myers on the 19th, Mason struck Myers in the road with a rock or some deadly weapon, knocking Myers insensible in which state he remained until his death on the 21st. Mason is now having his preliminary trial before Justice E. J. D. Kennedy. Myers was a peaceable and inoffensive citizen.²¹

Milan News

Mrs. Catherine Anderson, one of the old settlers, died at M. Cooper's near Wallston on the 19th and was buried near the old Anderson homestead.²²

Hiram Langston, a young man about 17 years of age, son of a widow lady, shot and killed himself on the 14th inst. Early in the spring he was bitten by a mad dog and it is supposed that had something to do with it as no other cause is known.²³

An I. O. O. F. Lodge No. 147 has been installed at Trenton with the following officers: William Cobb, N. G.; Dr. J. M. Brewer, V. G. S.; H. Summers, Secretary; J. T. Welborne, Treasurer.

Paint Rock Lodge I. O. O. F. at Bostick Hill installed their officers some weeks ago for the ensuing term: Robert A. Reed, N. G.; Dr. J. O. Robertson, V. G.; G. W. Green, Treasurer; and J. R. Austell, Secretary.

Addie Shaver did not know where Myers was buried, possibly at Beech Grove Cemetery in an unmarked grave. Other Myers are there and it

Two white men by the names of Bice and Brentfield were brought over from Paint Rock Valley last Monday and lodged in jail on the charge of breaking into and robbing the store of Mrs. Taylor on Larkin's Fork. It is said that some of the goods were found in their possession and the state has a good case against them.

27 Sept 1894

The post office at Larkin's Fork has been changed to Larkin. A.C. Thompson of Milan died the 23rd of flux and was buried today at Bostick Hill.²⁴

Married at Trenton, Oct. 3, 1894, Mr. John Webb and Miss Rebecca Finney.

Died in Paint Rock Valley

Mrs. John G. Enochs died at her home near Hollytree last week. The deceased had been totally blind for years and she bore her long affliction with Christian fortitude. Her husband and children have the sympathy of that community in their bereavement.²⁵

Thurs. 18 Oct 1894

William Gifford, who so cruelly murdered his aged father on the mountain near Francisco last week, is

still at large. He was heard of the other day at Town Creek, Ala. where he stayed all night at his sister's, a Mrs. Nicholls. He left early next morning and stole his sister's horse.

It is said that Gifford has a brother living at Patrick, Leman County, Texas, and it is supposed that the fiend is going in that direction.²⁶

Thurs. 22 Nov 1894.

Agnes, the sprightly daughter of J. T. Anderson, about eight years of age, died on the 14th inst. after a protracted spell of malaria fever. She was a girl of unusual promise, and no pains had been spared by her parents in her education and training.²⁷

This indenture made this 12th day of October, 1837 between William C. Thomas and Clarisa Thomas, his wife, of the first part and James W. Barton of the other part. Wherewith the said William C. Thomas and his wife for and in consideration of the sum of \$450.00 to them in hand paid hath this day bargained and sold a certain tract of land lying at the NW quarter of Section 5 of Township 7, Range 4 East and containing 160 acres.

Signed by W. C. Thomas and Clarisa Thomas (her mark).

- Richard S. Randles, Clerk of the County Court certified the above was recorded in his office the 12th day of June, 1838.

Editor's Note: For reasons unknown there were sometimes long delays from the date of a transaction until it was presented to the Clerk of the Court for recording purposes. The preceding transaction happened in October of 1837 and was not recorded until June 1838.

Cemetery Treks

An open posting in a recent issue of Family Tree Magazine had some important hints for those of us who enjoy traipsing through old cemeteries:

- 1. Never go alone to a cemetery.
- 2. Carry a cell phone with you.
- Know your surroundings in case you have to leave in a hurry.
- Try to get a map of the cemetery you are visiting in order to save time.
- Carry a first aid kit with you in case of snake bite, animal attack, poison ivy, etc.

- Pay attention to the weather in case of a severe storm.
- Carry a whistle at all times. If you
 have a dog and there are no posted
 restrictions for bringing one, bring
 your dog.
- 8. Carry mace.
- Take drinking water, snacks, and any medications you may have to have in case you get lost.
- Plan ahead and allow plenty of time for your visit. Let someone know where you are going in case a search party has to be called.
- 11. Never be afraid to ask questions if a stranger approaches. If possible, ask for I.D., especially if they claim to live in the area. Never give out your phone number or e-mail address. If necessary, get their phone number and tell them you will call them.
- Wear proper clothing and especially no high heels. The ground is usually uneven; there are sunken graves and critter holes.
- If you go into tall grassy areas, wear tall boots in case of snake bite. Carry insect repellent and work gloves.

It is especially important to follow these rules when going through old family cemeteries that are off the beaten path. One writer to the forum told of being watched by a strange man when she visited her father's grave. She quickly got back into her car and drove off. He got into his car and followed her as well, until she lost him at a red light. Be aware of your surroundings, not only when visiting cemeteries.

Archaic Medical Terms

Does it worry you that the death certificates of your grandparents or great-grandparents list cause of death as senility? Are you afraid it may be genetic and perhaps you will have it too? You should hope so! It simply means that they died of old age. This is one of those curious old-fashioned terms that are no longer in use today.

We've all seen those strange terms, which mean nothing to us really, until now. Your editor has come across a fascinating website that lists descriptions of those terms. Be prepared to spend long chunks of time looking them up and laughing! See www.antiquusmorbus.com for hours of fun.

In this issue of *Valley Leaves*, the Madison County section is full of these unusual terms in the Death Certificates. Your editor has looked up as many as possible and you may enjoy comparing them as you read the cause of death notations. For example:

General Debility – is the state of being weak and frail and a general wasting away.

Dysentery – the inflammation of mucous membranes of the bowel. This was a common malady of the Civil War soldier, caused by infections and by drinking bad water.

Sarcoma – a malignant tumor.

Myocarditis – inflammation of the muscle tissue of the heart.

Bright's Disease - kidney disease.

Bellyharm or Bellywark - colic

Bilius Fever – copious amounts of bile either during evacuation or vomiting, usually associated with summer or fall months. This was also common among Civil War soldiers. If jaundice is evident in the patient, it is usually called Typhoid Fever.

Endocarditis – inflamed endocardium and heart valves.

Paralysis Agitans – known today as Parkinson's Disease.

Marasmus – wasting away of flesh, atrophy with no apparent cause. This is especially common in young children due to

an inability to absorb nutrients or digest food

Pellagra – lack of niacin or inability to absorb niacin, a B vitamin, which causes scaly skin sores and mental confusion. It can also be aggravated by chronic diarrhea and alcoholism.

Catarrh of bowels – an inflammation and swelling of the bowels. The word Catarrh was used frequently and usually applied to inflammation of nasal passages, usually caused by cold, flu, and hay fever.

Phthisis Pulmonary - tuberculosis.

Dropsy - kidney disease.

Apoplexy – seizure caused by stroke or brain hemorrhage.

Scours – this is actually a Scottish term for diarrhea. This is also an old-fashioned term used by farmers and ranchers in America. Scours in their cattle was the term for diarrhea.

Other terms related to early medicine:

Lazaretto – a hospital to house people with contagious diseases. In other words, a quarantined building.

Panacea – a pretended remedy for every disease. In today's world, we use the word panacea to mean a cure-all solution, not necessarily related to medicine.

Pest house – similar to lazaretto. Most used in the South to identify a place for people with tuberculosis or plague.

Plugging – using lint or other substance to stop bleeding at the wound site.

Blisters – a skin irritant is applied to raise skin filled with serous substance. This was oftentimes used as a counter-irritant to whatever the ailment was internally, just below the skin surface. Flying blisters were a series of raised blisters thought to be a more aggressive treatment.

Nostrum - a quack medicine, or homemade remedy.

Shucks – used commonly in the South to treat chronic malaria, a strong tea is made from corn shucks.

Venesection – opening a vein with a lancet for blood-letting.

Contributions

We prefer typewritten material but if you have a legible hand, handwritten information is acceptable. Please do not send computer discs.

Courthouse records, diaries, church records, military records, minister's records, newspaper items, personal letters, tombstone inscriptions, etc. are of special interest to our readers.

Tombstone Inscriptions

If you send tombstone inscriptions, please give the location of the cemetery, how to get to it, and if you copied all the stones or only a portion of them. Other genealogical material concerning the persons enumerated is encouraged but not necessary.

Do NOT put the inscriptions in alphabetical order but leave them in the order in which are buried. By putting them in alphabetical order, important relationships can be lost.

Bible Records

If you send a Bible record, we would like to have a photocopy of it plus your interpretation of each name. We

like to include a photocopy of the Bible in *Valley Leaves* as this is helpful to persons proving their lineage for membership in DAR, etc. If there is a *title page* and *date of publication* in the Bible it is imperative that you include them when you submit the record.

Queries

We no longer have a "queries section," however, if you have a query pertaining to Jackson, Madison or Marshall Counties, we will work it into the main body of the appropriate chapter.

Book Reviews

Books will be reviewed in *Valley Leaves* if the author donates a copy to TVGS. After the review, the book is given to the Heritage Room of the Huntsville- Madison County Public Library.

Quarterlies will be reviewed *only* upon receipt of a *full volume*.
