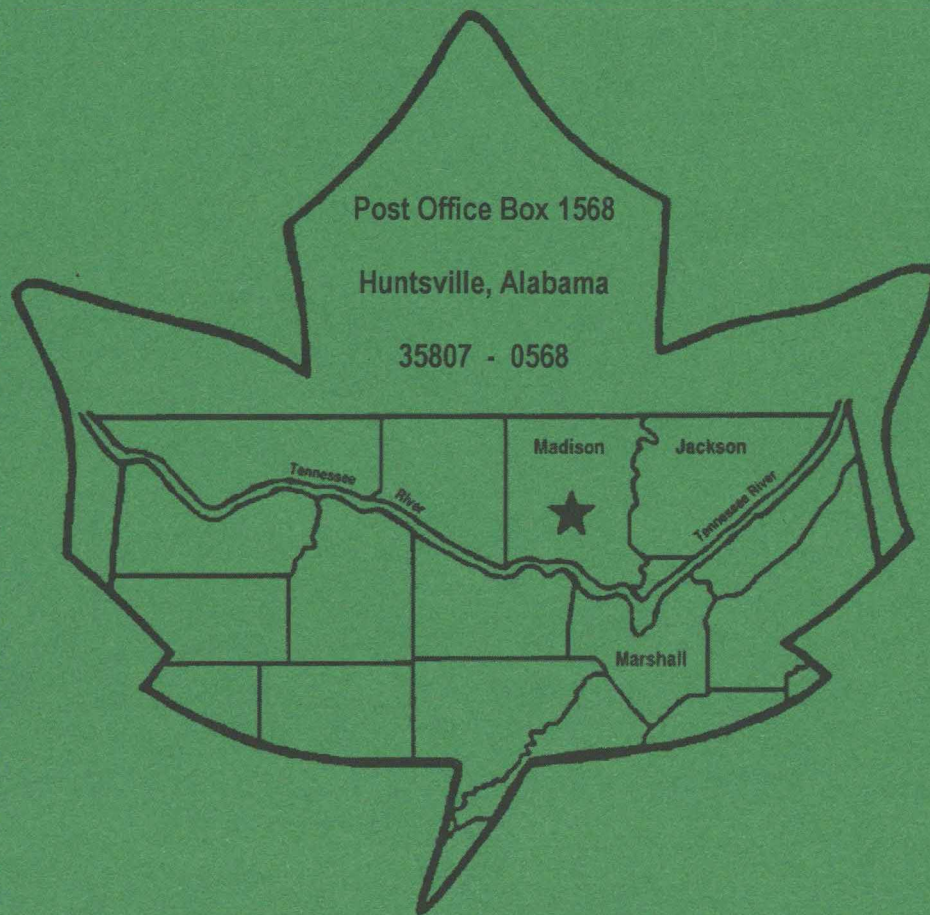

The following records were recorded in the Probate Minutes, Book TT, dated 1897 to 1900 at the Jackson County Courthouse in Scottsboro.

G. W. Thomas, et al
Tenants in Common
Order Setting Day
June 2, 1899
Page 333

This day comes G. W. Thomas and files his application in writing and under oath representing among other things that he is a joint owner or tenant in common with W. R. W. C. Keys, C. L. Keys and others of a certain piece or tract of land lying in this county which cannot be equitably divided or partitioned among said joint tenants.

He prays for an order of this court to sell said real estate for partition and division among those justly entitled.

It appearing to the Court that all of said joint tenants are non residents except the petitioner, it is ordered that the 3rd day of July be appointed a day to hear said petition and the proof submitted, in support of the same.

It is further ordered that due notice of the nature of said application and of the time above set for hearing the same be given at least 30 days before the said day of hearing by publication in the *Stevenson Chronicle*, a newspaper published in said county for three successive weeks, for all persons

interested to appear and contest said application if they think proper. It is further ordered that G. W. Thomas have notice of this proceeding and of the day set for hearing the same by citation to be served personally on him 10 days before said day of hearing.

It is further ordered that G. W. Tate be and he is hereby appointed guardian ad litem to represent and protect the interest of the two children of T. S. Keys, deceased, who are under 21 years of age, and all other minors interested in this petition, said S. W. Tate being neither of counsel nor of kin to said petitioner and is considered in every way a suitable person to act as such guardian ad litem.

Eliza L. Kirby, Deceased

This day comes T. S. Kirby and files his petition in writing and under oath representing among other things that Eliza L. Kirby, departed this life in Jackson County, Alabama on or about the 4th day of November 1896, leaving

no last will or testament so far as he knows or believes, and that her death was known more than fifteen days before this day.

That the said Eliza L. Kirby was, at the time of her death, an inhabitant of this county, and that she died seized and possessed of personal property situated in this county consisting chiefly of one mare worth about \$25.00 and probably not more, that the names, residences, and ages of the heirs and distributees of the estate are as follows to wit: Elma, Mabel, Alberta, and Albert Kirby, all minors under fourteen years of age.

It appearing to the Court that said T. S. Kirby is the husband of said decedent and is considered in every way worthy to administer said estate, and he, the said T. S. Kirby, having bond in the sum of \$50.00, with J. L. Burgess as his surety thereon which said bond has been taken and approved as good and sufficient by the Judge of this Court.

It is ordered, adjudged, and decreed that said Thos. S. Kirby be, and he is hereby appointed administrator of said estate, and that proper letters of administration issue to him forthwith. It is further ordered that said petition be recorded.

W. H. Norwood who was heretofore duly appointed by the Court to act as ? administrator ad litem to represent and protect the interest of the estate of Sarah J. It is therefore ordered that he have and receive nothing further from said administrator.

It is ordered, adjudged, and decreed that Caroline Gambol have and receive of the assets of said estate the sum of \$175.99 and receipted in full for her said interest. It is therefore considered by the Court that said Caroline Gambol have and receive nothing further from said administrator on said estate.

It is ordered that Madison Arnold have and receive of the assets of said estate the sum of \$175.99. But it appears that he has received of said Administrator the sum of \$175.99 on his said distribution interest of said estate. It is decreed that he have and receive nothing further from said estate.

It is ordered, adjudged, and decreed that the estate of Sarah Jane Arnold have and receive of the assets of said estate the sum of \$175.99; which said sum of \$175.99 has been paid into court for said estate.

It further appearing to the court that said administrator has fully accounted for all of the assets of said estate and has paid out the amount due each heir of said estate on according to each distributive interest therein and has fully discharged his duties as such administrator of said estate. It is ordered that said administrator be discharged from further duties therein.

He moves the Court to confirm his report made in writing and under oath more than ten days since, setting forth, among other things, that on the 27th day of May 1899 within the legal hours of sale in pursuance of law in such cases made and in strict accordance with all and singular the terms and requirements of the former order and decree of this Court granted and entered in the premises on the 3rd day of May 1899, he proceeded and sold at public outcry in front of the residence of said George Walker on said premises in the County, the real estate and personal property set forth and particularly described in said form in order and decree and that said land was purchased at said sale by Andrew J. Hicks for the sum of \$600. The personal property was purchased by several different parties named herein.

And it appearing to the Court that said report was filed more than ten days before this day and no exceptions to the same has been filed. 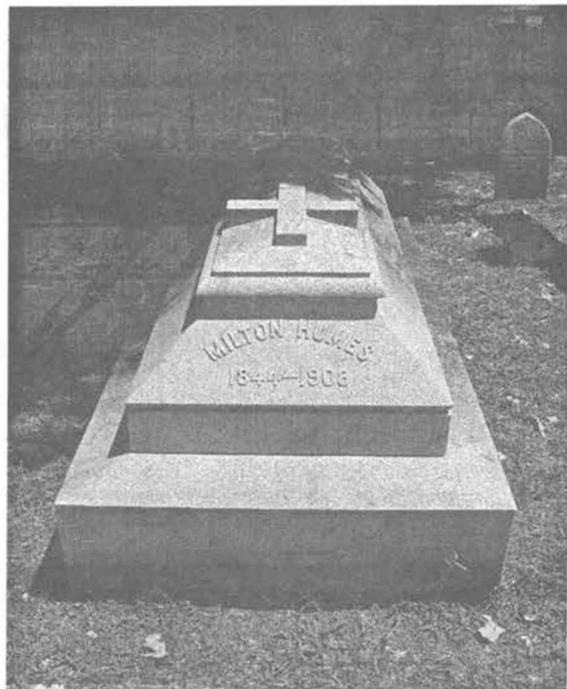

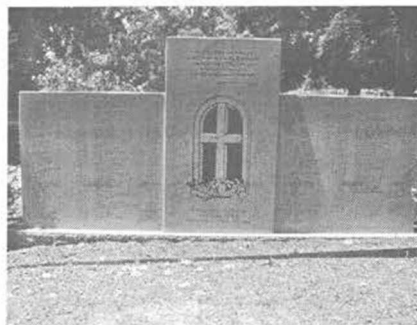

Andrew Burnside and John Burnside
to Manning & Kin??

This indenture made this October 2, 1838 between Andrew Burnside and John Burnside of the first part and R.C. Newman of the second part and Thomas Manning and David Ricketts ?, merchants under the firm name of Manning & Ricketts ?.

Whereas the said Andrew Burnside and John Burnside are indebted to the firm of Manning and Ricketts ? in the sum of \$76.63 due by four seasonal notes making in all that amount this indenture for and in consideration of the sum of one dollar in hand to the said Andrew Burnside and John Burnside by the said R. C. Newman, trustee, have given, bargained and sold to R. C. Newman, trustee, the following described property: the SE fourth of the NE fourth of Section 3 in Township 7 of Range 5 East.

The said R. C. Newman shall permit Andrew Burnside and John Burnside to remain in peaceable possession and use of above described property. The said R. C. Newman shall on December 25, 1839, after giving 20 days notice by announcement at three or more public places, sell the above described property

to satisfy the debt of \$76.63 plus interest and costs.

Signed by Andrew Burnside, John C. Burnside, R. C. Newman and Manning & Rickets ? with signatures witnessed by George Lay ?, Justice of the Peace on October 9, 1838.

R. S. Randles, Clerk of the Court, certified the recording of the above document in Book A on pages 202 and 203.

Deed of Trust
Johnson A. Paris to Hugh Henry
Pages 204, 205

This indenture made and entered into by and between Johnson A. Paris of the first part and John M. Scott of the second part and Hugh Henry and son of the third part. Whereas the said Johnson A. Paris is justly indebted to the said Hugh Henry in the sum of \$147 due by note bearing date of August 4, 1838 and the said Johnson A. Paris is willing and desirous to secure payment unto Hugh Henry.

This indenture for and in consideration of the sum of one dollar paid to the said Johnson A. Paris by John M. Scott and this day Johnson A. Paris has bargained, granted and sold to the

said John M. Scott all the following described property: one field of corn growing and standing in the field about one and a half miles from Gunter's Landing and on the South side of the Tennessee River generally known to be the field Johnson A. Paris has cultivated this year, one yoke of oxen, one steer about two years old, one clock, three sows, one gray mare, one bay mare, two bedsteads, two ovens, two skillets, and one large kettle.

Upon trust the said John M. Scott will allow Johnson A. Paris to remain in peaceable possession of the above-described property. The said John M. Scott shall on the second Monday in November next after giving 20 days notice in three of the most places in the neighborhood of the said Johnson A. Paris, proceed to sell all or so much thereof to satisfy the debt and interest plus costs.

Signed by Johnson A. Paris, his mark, John M. Scott and Hugh Henry. Richard S. Randles witnessed the signatures in his office in Claysville on August 2, 1838 and recorded the indenture in Book A on pages 204 and 205.

Things You Should Know

Civil War Sesquicentennial 2011-2015

Many of our readers are old enough to remember the centennial years of the Civil War (1961-1965). It is hard to believe that fifty years later – 150 years after the event itself - we are still obsessed with finding out more information on the Civil War and the exact movements of our ancestors in blue and gray. Although it may seem a little early to hear about the Sesquicentennial, believe it or not, lots of people are getting ready for it. A new website by the National Park Service, U.S. Department of the Interior, is having information added on a constant basis to identify the more than 70 parks under the care of the National Park Service that have either a direct or indirect association with the American Civil War. Their website is:

A list of the parks, with their own links, is available, though some are still “under construction.” A visit to the Alcatraz Island website tells readers that it was occupied by several Indian tribes from 1969 to 1971 to protest the U.S. treatment of Indians (many of us still remember that event). Ironically, American Indian prisoners were held there in the 1800s. Alcatraz was a military prison from 1859-1934, federal penitentiary from 1934 to 1963, and is now a popular tourist site.

For those of you looking for ancestral links to any of these events, there are many names listed and further links to help you get more information on possible family connections.

Another interesting part of this website is the National Geographic Map Machine: Civil War Edition. The website is:

This lists the day by day events of the Civil War. For example, On September 4, 1864, Huntsville native John Hunt Morgan was killed in Greeneville, Tennessee. On September 23, 1864, there was a skirmish at Athens, Alabama. A little farther from home, the citizens of San Francisco contributed

\$100,000 for relief of Federal wounded soldiers on September 21, 1862.

In the future, these will be fleshed out to reveal many more details.

British Parish Records

According to Family Tree Magazine, more than 15 million burial records and memorial inscriptions from the United Kingdom are now available on FindMyPast.com for a fee of \$178 per year (thanks to the current low value of the dollar). These records date back to 1538, before civil registration was required beginning in 1837. The biggest plus is that if you know your ancestor's surname, you can find records without knowing where they lived. Later this year, baptism, marriage, and probate records will also be available.

Easy Money for Non-Profits

As the price of gasoline goes up and up and it becomes easier to buy items on-line, many of us are spending our time in front of the computer shopping with our fuzzy slippers on.

Family Tree Magazine has some great new information on ways to earn extra money for non-profit organizations, including genealogy groups such as ours. By registering your charity or school, spreading the information on to your friends, every time you/they order something on-line, the participating company you order from is donating a percentage of your purchase.

If that isn't enough to convince you, the Association for the Prevention of Cruelty to Animals has earned \$16,800 through your shopping!

First, you need to see if your charity has already been registered before you try to register them again. Go to:

<http://www.goodsearch.com/charityList> and follow the instructions. You can also look by state. For example, here in Huntsville, some of the registered charities are: Ars Nova, Aids Coalition, Therapy Partners, Act Family Worship, and University of Alabama at Huntsville. Nearby is Athens Bible School, Auburn University, Autism Society of Alabama, and the list goes on.

The organizations you can have money sent to are in categories such as: animals, art and culture, youth and children, crime, disabled, disaster relief, educational, elderly, environment, fraternal clubs, global relief, government, health and disease, homeless, human rights, hunger and poverty, military, religion, politics, sports, women, substance abuse, and trade associations.

And who can you shop with? For example, you can shop on ebay and have 25% to 37.5% of your cost donated to the charity of your choice. Gap gives 2.8%; 1-800-Flowers gives 7%; Barnes & Noble gives 2.5%; Coldwater Creek gives 1-3%; Land's End gives 3%; L.L. Bean gives 2%; PetSmart gives 4-7.5%; Kohls gives 2%; Home Depot gives 2%; Toys R Us gives 1.5%; Wal-Mart gives .5-2%; Williams-Sonoma gives 2%; Sears gives 1%; Staples gives 2%; Old Navy gives 2.8%; Macy's gives 3%; Office Depot gives up to 4%, and again, the list goes on.

Even easier, you can shop by category on the Good Shop website and narrow your shopping and time spent searching even further.

Tombstone Inscriptions

If you send tombstone inscriptions, please give the location of the cemetery, how to get to it, and if you copied all the stones or only a portion of them. Other genealogical material concerning the persons enumerated is encouraged but not necessary.

Do NOT put the inscriptions in alphabetical order but leave them in the order in which are buried. By putting them in alphabetical order, important relationships can be lost.

Bible Records

If you send a Bible record, we would like to have a photocopy of it plus your interpretation of each name. We

like to include a photocopy of the Bible in *Valley Leaves* as this is helpful to persons proving their lineage for membership in DAR, etc. If there is a *title page* and *date of publication* in the Bible it is imperative that you include them when you submit the record.

Queries

We no longer have a "queries section," however, if you have a query pertaining to Jackson, Madison or Marshall Counties, we will work it into the main body of the appropriate chapter.

Book Reviews

Books will be reviewed in *Valley Leaves* if the author donates a copy to TVGS. After the review, the book is given to the Heritage Room of the Huntsville- Madison County Public Library.

Quarterlies will be reviewed *only* upon receipt of a *full volume*.
