

# **Jackson County**

#### Probate Court Records

Part 5 - Continued from Volume 43, Issue 1

Copied, Abstracted, and Contributed by Jacquelyn Procter Reeves

The following records were recorded in the Probate Minutes, Book TT, dated 1897 to 1900 at the Jackson County Courthouse in Scottsboro.

Charles W. Wallace, Deceased Estate of Exceptions to Exemptions June 17, 1899 Page 340

This day comes Nannie Wallace, the widow of Charles W. Wallace, deceased, for herself and in behalf of the minor children to wit: Walter, Edgar, Eastmon, Marion, and Bessie Wallace, and files her petition in writing and under oath praying to an order of this court setting aside the report of the Commissioners allotting a homestead to them out of the lands of said decedent. Alleging in her exceptions among other things that said Commissioners allotted this and worn out land which is unproductive that the widow and minor children cannot make support thereon. that Commissioners failed to give them the cleared land that was fertile and productive. That said Commissioners did not permit the widow to make a selection.

Whereupon it is ordered by the Court that the 29<sup>th</sup> day of June be a day set to hear said exceptions and the proof submitted in support of the same. It is further ordered that notice be given the administrator according to law of the

time and nature of said exceptions and of the day set to hear the same.

Willie Fridell, Et al, minors Tenants in Common Order of Continuance June 19, 1899 Page 340

This day coming on to be heard the petition of Sallie E. Marshall to sell certain lands of said estate for division among said joint tenants. It is ordered that this cause be continued till the 24<sup>th</sup> day of June 1899 and that all matters pertaining thereto be deferred till that day.

W. B. Keeble, Deceased Estate of Setting aside sale of land June 19, 1899 Page 340

Whereas on the 8<sup>th</sup> day of June 1899 John H. Vaught, administrator in this Court of the estate of W. B. Keeble, deceased, filed his report in writing and under oath, setting forth therein among other things, that in pursuance of an order to said Court made and entered in the premises on the 24<sup>th</sup> day of April 1899, which was an order authorizing him as such administrator to sell certain real estate belonging to the estate of W. B. Keeble, deceased, for the purpose of paying the debts of said estate and for distribution.

Which land is particularly described in said order of sale and in said report of sale. He did, as such administrator, proceed and sell at ? and cry to the highest bidder at the Court house in the town of Scottsboro in this County, on the 22nd day of May, 1899 the said real estate, and at said sale, J. C. Brandon became purchaser in the sum of \$150.

And the Court being satisfied from the proof that said land sold for an amount less than and greatly disproportionate to its real value, it is ordered, adjudged, and decreed that the sale of said lands to J. C. Brandon be, and the same is hereby vacated, annulled, and set aside.

It is further ordered by the Court that said Administrator be and he is hereby directed to make another sale of said lands. Such re-sale to be made, conducted, and concluded in all respects in accordance with the previous decree directing the sale of said lands in the first instance.

Thomas D. Starnes, Deceased Estate of Petition to sell lands for division June 20, 1899 Page 341

This day comes M. P. Brown, the administrator or said estate and files in this Court his petition in writing and under oath alleging therein that said T. D. Starnes, at the time of his death, was the owner of an undivided one-half interest in all the lands hereinafter

described, and that W. D. Parks was then, and is now, the owner of the other undivided one-half interest of said lands.

He prays for an order of this Court to sell the following described lands owned by the heirs at law of the estate of Thomas D. Starnes, deceased and W. D. Parks, as tenants in common or joint tenants, for the purpose of partition and distribution to wit: SW ¼ of Sec 23, T3, R6 East, and NW ¼ of NW ¼ of Sec 20, T3, R6, East, and the SE triangular half of the E ½ of the NE ¼ of Sec 27, T3, R6, East, known as the Thos. J. Gulatt (?) land. Also ¼ undivided interest in the N ½ of NE ¼ Sec 2 E, T6, S of R ? East and known as the J. T. Butler lands.

Also the S ½ of NE ¼ of Sec 12, T5, R5 containing 37 70/100 acres, and being a part of the Feeney tract. Also the E ¼ of the N ½ of NE ¼, Sec 12, T5, R6 and known as the Moon land. Also SE ¼ of NE ¼ of NW ¼, Sec 25, T 5, R 5 containing 10 acres known as the Mary J. McKay land. Also the E ½ of SW ¼ Sec 7, T 4, R 6 known as the J. S. Thorp land, all in Jackson County, Alabama, except that part known as the Butler lands.

It appearing to the Court that the heirs at law of the estate of Thos. D. Starnes are Eliza J. Starnes, the widow of said decedent Beulah Flag, Lucinda Baydston, Kate Higgins, Thomas Dupree Starnes, and Nellie G. Starnes, children of said decedent and of full age, and George Carter, a minor grandchild of decedent.

It is ordered by the Court that the 21<sup>st</sup> day of July 1899 be appointed a day to hear and determine the matter of said petition and the proof submitted in support of the same. It is further ordered that W. D. Parks, Mrs. Eliza J. Starnes, and Nellie Starnes have notice of the nature of said petition and the time set to

hear the same by citation to be served on them personally, ten days before the day of hearing, and by publication for three successive weeks in the *Progressive Age* a newspaper published in this County. It is further ordered, that S. W. Tate, who is deemed a suitable and competent person not of kin or of counsel to the petitioners be, and he is hereby appointed, guardian ad litem to represent and protect the interest of George Carter, the only minor interested in this proceeding. It is further ordered that said Guardian ad litem have notice of his appointment.

Thomas Frasier, Deceased Estate of Petition for Allotment of Dower June 21, 1899 Page 342

This day comes Nancy J. Frasier and files her petition in writing and under oath alleging among other things that the said Thomas Frasier departed this life intestate on the 24<sup>th</sup> day of December 1898, and that his estate is now being administered by James P. Williams who is a resident of this county as the administrator thereof.

And that in the opinion of the petitioner the said estate is solvent, that the petitioner is the widow of the said decedent and that she resides in said county, and that the heirs at law and distributes of said estate and their respective residences are as follows to wit: Mary L. Carden, the wife of Bully (Billy?) Carden, Willie A. Austin, wife of George O. Austin, Martha C. Frasier, wife of J. G. Frasier, Currie C. Brewer, wife of J.M. Brewer, Nancy E. Cochran, wife of Richard Cochran, and Genevieve E. Cobb, wife of Wm. Cobb, all of whom are of full age and that they all

reside in Trenton, Jackson County, Ala. except Genevive E. Cobb who resides at Tullahoma in the state of Tennessee. Also Nellie K. Frasier, and Thomas F., John W., and James P. Jones, all of whom are minors over 14 years of age and reside at Trenton in said County, and James F. Dameron is a minor over 14 years of age and William H. and Henry E. Dameron both of whom are minors under 14 years of age and all of whom reside at Varendale, Cross County in the state of Arkansas.

That said decedent died seized and possessed of the following real estate situated in Jackson County, Alabama to wit: The SE ¼ and E ½ of SW ¼ Section 17 and S ½ of SE ¼ Section 18 and E ½ of NE ¼ Sec 19 and NW ¼ and W ½ of NE ¼ and N ½ of NW ¼ of SW ¼ SW 20 all in township 2 R 4 East.

Petitioner further alleges that she never at any time relinquished her right to dower in any portion of said land and that she is entitled to be endowed of a life estate in one third of said land, which dower she alleges can be duly and justly assigned to her by metes and bounds and the said petitioner prays that dower in accordance therewith be allotted and assigned to her, and for all such orders as may be necessary to that end.

It is therefore ordered by the Court that the 20<sup>th</sup> day of July 1899 be appointed a day to hear said petition, and that notice of the time of hearing, and of the nature of said application be given to the heirs at law who are shown to be in this state and to said James P. Williams as administrator aforesaid to be served upon them 10 days before the day of hearing said petition.

It is further ordered that those who are shown to be non-residents be given notice of the nature and time of hearing said petition by publication in the Scottsboro Citizen, a newspaper published in said County once a week for three successive weeks. It is further ordered that John B. Tally be and he is hereby appointed guardian at litem to represent said minors and protect their interest on the hearing of said petition. It is further ordered that said Tally have notice of said appointment.

Willie Fridell, et al, Minors Tenants in Common Decree to Sell for Removal June 24, 1899 Page 343

This brings the day to which was continued for hearing the petition heretofore filed by Sallie E. Marshall and J. W. Marshall the guardian of the estate of Willie and Pearl Fridell and the Chattanooga Savings Bank, guardian of the estate of Lizzie Katie Graham and Ella Fridell minor heirs of James A. Fridell deceased, to which petition is attached for the inspection and judgment of this Court, a transcript from the records of the county court of Hamilton County, Tennessee, a court of competent jurisdiction in that state, certified in accordance with the requirements of Congress showing that they have been duly appointed guardians by said Court of said estate in the state of Tennessee, praying an order and proceeding of this Court authorizing the proceeding to sell certain real estate belonging to said minors and which real estate is herein after described for the purpose of removing said estate to the state of Tennessee.

Now comes the said guardians and move the Court that their said petition be granted. Also comes W. H. Norwood who is not of him or counsel to said

guardian and was heretofore regularly appointed by an order of this Court entered of record in this proceeding and who has filed in this Court his consent in writing to act as such guardian ad litem. and who has put in issue the facts stated in said petition as required by law. And it now being shown to the satisfaction of the Court that said guardian and their said wards are non residents, residing in the County of Hamilton in the State of Tennessee, and that due notice of the filing and the nature of said petition and of the day set for hearing the same have been given according to statute in such cases made and provided and strictly and in all respects according to the former order of this Court made and entered in this proceeding on the 18th day of May 1899 when said petition was filed; whereupon the Court proceeds to hear the matter of said petition and the proof submitted in support of the same.

It having been proven to the satisfaction of the Court by the oaths of M. E. Looney and W. J. Hallworth who are disinterested witnesses and whose testimony has been taken in this cause by deposition upon direct and cross interrogations Chancery as in proceedings and which testimony has been filed of record in this Court that it will be to the interest of said minors to sell said estate for removal that said estate can be removed to another state without conflict with any restrictions or limitations and without impairing the right of said wards thereto.

It is therefore ordered, adjudged, and decreed by the Court that said application be and the same is hereby granted and the following described real estate is hereby authorized to be sold at public outcry in front of the post office at Stevenson in this County after first giving notice of the day place and terms

of such sale with a description of said land for three successive weeks by publication in the *Stevenson Chronicle*, a newspaper published in this County, for cash, on the 20<sup>th</sup> day of July 1899 to the highest and best responsible bidder.

The W 1/2 of the E 1/2 of the NW 1/4 of Sec. 4 T2, R8 E and 27 and 27/100 acres described as follows: begin at SW corner of fractional, Sec 33 T1, R8, Thence N4 E, 6 chains and 28 links, thence S 88 degrees 20 East 15 chains and 15 links. Thence S 22 chains 14 links. Thence 8? 30 feet west 19 chains. Thence N4 degrees E 16 chains 85 links to beginning. Said? described land lies in NW 1/4 of S? T2, R8 and in SW? of SW 1/4 Sec ? T1, R8 and a small piece adjoining Benjer Reservation on east, in NE 1/4 NW 1/4 Sec 5, T2, R8. All of said land amounting to 76 and 19/100 over more or less.

It is further ordered that J. H. Gregory be and he is hereby appointed Commissioner to make said sale, and to convey by profora deed to the purchaser thereof the above described real estate. It is further ordered that a commission issue to him forthwith directing him to make said sale.

Marie M. Oneal, Minor Estate of Order Confirming Sale of Land June the 26<sup>th</sup>, 1899 Page 345

This day comes W. P. Oneal, the guardian of said estate, and moves the Court to confirm his report made in writing and under oath more than ten days since, setting forth among other things, that on the 10<sup>th</sup> day of June 1899 within the legal hours of sale, in pursuance of law in such cases made, and in strict accordance with all and

singular the terms and requirements of the former order and decree of this Court granted and entered in the premises on the 16<sup>th</sup> day of May 1899 he proceeded and sold in front of the Court house door in this County the lands set forth and particularly described in said former order and decree and that said land was purchased at said sale by H. K. Lyda for the sum of \$390.

And it appearing to the Court that said report was filed more than ten days before this day and no exceptions to the same have been filed, and it further appearing from the report and from the evidence therewith submitted that said amount so bid for said land by said H. K. Lyda was the highest and best bid for the same that said sum so bid was not greatly less or disproportionate to its real value, that said sale was legally and fairly made, conducted, and concluded and that the proportion of the purchase money so bid which was required to be paid in cash by said former order and decree has been duly paid and that the balances of such purchase money has been secured sufficiently, and according to law and said decree of sales.

It is ordered, adjudged and decreed that said sale be and the same is hereby approved and in all things ratified and confirmed. It is further ordered that said report and all other papers on file relating to this case, except the depositions, be recorded.

W. R. Larkin, Deceased Estate of Order Appointing Administrator June 26, 1899 Page 345

This day comes W. Rutlege Larkin and files his application in writing and under oath praying to be appointed to the

administration of the estate of W. R. Larkin, deceased, alleging in his petition among other things that said W. R. Larkin departed this life intestate at Larkinsville in this County, and that his death was known more than fifteen days before this day, that he was at the time of his death an inhabitant of this County, that he died seized and possessed of real estate of the annual rental value of \$2,000, and personal estate of this value of about five thousand dollars and probably not more, that the heirs of said estate are Lizzie Larkin the widow of the deceased, who is over the age of twenty one years and resides at Larkinsville, Alabama, Mamie Larkin and Rutlege Larkin, both children of the deceased, over the age of twenty one years and reside with their mother at Larkinsville, Ala. That said petitioner W. Rutlege Larkin is the only son of said decedent and that the widow has declined to administer said estate.

And it being shown to the Court that the allegations of said petition are substantially true, and that said W. Rutlege Larkin having given bond in the sum of \$12,000 with Lizzie Larkin and Maymie Larkin as his sureties thereon, which bond with such sureties thereon has been duly taken and approved as good and sufficient by the Judge of this Court. It is ordered, adjudged, and decreed that said W. Rutlege Larkin be and he is hereby appointed to administer said estate, and that the proper letters of administration do issue to him. It is further ordered that an appraisement of said estate be made, that Wiley Cotton, W. D. Selby, and J. P. Barclay be and they are hereby appointed and authorized to appraise said estate, and that they have due notice of this appointment. It is further ordered that said petition be recorded. It is further

ordered that said appraisers allot to the widow the personal exemptions allowed hereby law to be exempt from administration.

William Woosley, Deceased Estate of Decree on Final Settlement June 29, 1899 Page 346-349

This day having been set to hear and determine all matters as to the accounts heretofore filed by Thomas B. Woosley as the administrator for a final settlement of said estate. Now comes the said Thos. B. Woosley and moves the Court that his said account may be ? and allowed as the same has been stated by him.

And it appearing to the Court that due notice of the nature of and of the time set to make such settlement has been given in all respects according to law and strictly in pursuance of the order of this Court made and entered on the 7th day of June 1899. And W. H. Norwood who was heretofore duly appointed by the Court to act as guardian ad litem to represent and protect the interest of Sarah and Brice Woosley the only minors interested in this settlement, having heretofore filed his written consent to act and proceeded to contest the same. The Court proceeds to hear the matter pertaining to said accounts and to consider the evidence submitted relating thereto. Whereupon it is shown to the satisfaction of the Court that said administrator has received of the assets of said estate the sum of \$1,382.80 and that he has justly expended in and about the costs and charges necessary and incident to said administration and in the payment of the just debts of said estate the sum of \$498.35, leaving a balance of

\$884.45 for distribution among those entitled.

And said account appearing to be full and correct it is ordered, adjudged, and decreed by the Court that said account be and the same is hereby in all things passed and allowed as above stated. And it further appearing that said decedent left surviving him his three sons who are over 21 years of age to wit, (1) Thomas B. Woosley, (2) Aaron W. Woosley, (3) Brice M. Woosley, and her heirs of (4) Elizabeth Lindsay who was a daughter of decedent. J. W. Lindsay, Wm. E. Wright, Lindsay, Belle Cornelia Davidson, who is a daughter of Martha Womack, deceased, who was a daughter of said Elizabeth Lindsay, deceased. (5) the heirs of Sarah B. Brewer deceased, who was a daughter of decedent - Mary Brewer, James T. Brewer, Wm. W. Brewer, Wiley Brewer, John Brewer, and Onil V. Thompson. (6) the heirs of Mary Davidson, who was a daughter of decedent, W. H. Davidson, Samuel Amanda Burrow/Brewer, Davidson, Robert B. Davidson. (7) The heirs of Onie Proby deceased, who was a daughter of decedent Mary Brewer, William Proby. (8) The heirs of Wm. A. Woosley, deceased, who was a son of decedent, Wm. H. Woosley, Mary Selby, Sarah Woosley, and Brice M. Woosley, Jr., all of full age except Sarah and Brice Woosley who are minors and reside with their mother Sarah Woosley in this County. All of whom are entitled to share the personal estate of said deceased so that said balance of \$884.45 must be divided into eight equal parts or shares, and that each son and daughter is entitled to have the sum of \$110.55, distributed equally among them.

It is ordered, adjudged, and decreed that Thomas B. Woosley have and receive of the assets of said estate the sum of \$110.55 cents, which said sum has been retained by him as such distributes.

It is ordered adjudged and decreed that Aaron W. Woosley have and receive of the assets of said estate the sum of \$110.5 which said sum has been paid to him by said administration.

It is ordered, adjudged, and decreed that Brice M. Woosley have and receive of the assets of said estate the sum of \$110.55, which said sum has been retained by said administrator as his agent for him.

It is ordered, adjudged, and decreed that J. W. Lindsay have and receive of the assets of said estate the sum of \$27.63 which said sum has been paid into Court for him.

It is ordered, adjudged, and decreed, that W. E. Lindsay have and receive of the assets of said estate the sum of \$27.63 which said sum has been paid to him by said administrator.

It is ordered, adjudged, and decreed that Belle Wright have and receive of the assets of said estate the sum of \$27.63, which said sum has been deposited in Court for her.

It is ordered, adjudged, and decreed that Cornelia Davidson have and receive of the assets of said estate the sum of \$27.63, which said sum has been paid to her husband for her by said administrator.

It is ordered, adjudged, and decreed that Mary E. Brewer have and receive of the assets of said estate the sum of \$18.42 which said sum has been paid her agent John Brewer for her.

It is ordered, adjudged, and decreed that James T. Brewer have and receive of the assets of said estate the sum of \$18.42, which said sum has been paid him by said administrator.

It is ordered, adjudged, and decreed that Wm. W. Brewer have and receive of the assets of said estate the sum of \$18.42, which said sum has been retained by said administrator as his agent for him.

It is ordered, adjudged, and decreed that Wiley Brewer have and receive of the assets of said estate the sum of \$18.42, which said sum has been paid for him to his agent John Brewer.

It is ordered, adjudged, and decreed that Onie V. Thompson have and receive of the assets of said estate the sum of \$18.42, which said sum has been paid for her to her agent John Brewer.

It is ordered, adjudged, and decreed that John Brewer have and receive of the assets of said estate the sum of \$18.42, which said sum has been paid to him by said administrator.

It is ordered, adjudged, and decreed that Wm. W. Davidson have and receive of the assets of said estate the sum of \$27.63, which said sum has been paid to him by said administrator.

Most of the deed books now are replaced by electronic duplication and printed to letter sized paper and placed in small books. Unfortunately these recent copies are much more difficult to read. Question marks will be place after names that cannot be readily interpreted.

#### Deed of Trust Jack Smith to Thomas Price Pages 215-216

This indenture made and entered into this November 17, 1838 between Jack Smith of the first part and Thomas Price of the second part and to A. H. Price of the third part. Whereas the said Jack Smith is justly indebted to the said A. H. Price in the sum of \$67.50 to be paid on the 7th day of September 1838 as by note bearing date of 7th day of September 1839 more fully appears which debt with legal interest the said Jack Smith is willing to secure. This indenture wherewith that for and in consideration of one dollar to the said Jack Smith in hand paid by the said Thomas Price and A. H. Price the said Jack Smith hath bargained, sold and released to Thomas Price and A. H. Price one sorrel horse, one cow and one yearling.

This indenture made and entered into January 10, 1839 between William L. Fry of the first part, Peter C. Starnes of the second part and Andrew Moore of the third part. Whereas the said William L. Fry is justly indebted to the said Andrew Moore in the following sums of money to wit: one dated October 19, 1835 and due December 25, 183? for \$105.00, one note due for \$14.25 making the total due \$119.25 and the said William L. Fry being willing and desirous to secure to the said Andrew Moore.

Now this indenture witness that in consideration of the sum of one dollar in hand paid by the said Peter C. Starnes to the said William L. Fry hath granted, bargained and sold unto the said Peter C. Starnes the following personal property: one wooden clock, one side and one (illegible), 500 bundles fodder?, 200 bushels of corn, five cows, one yearling, one bed with furniture, 300 pounds of pickled pork to have and to hold all the above personal property to the said Peter C. Starnes. The said Peter C. Starnes shall allow the said William L. Fry to remain in peaceable possession of the said property unless default of the said

If default, then the property will be sold at public auction to the highest bidder after giving 10 days notice and after placing advertising at the three most public places in the neighborhood.

R. Starnes, Trustee.

Starnes shall allow the said Josiah Tidwell to remain in peaceable possession of land and other property until default be made by the said Josiah Tidwell in any of the above mentioned payments. Upon default the land and property will be sold at public auction after giving 30 days notice by advertisement in three or more public places in said county of the time and place of sale.

Logan as Trustee the following tract or parcel of land lying and being in the County of Marshall known as the NW part of A of fractional section six in Township seven of Range three East containing 120 acres. Whereas the said William S. Logan as Trustee upon the request of the said James Birdwell and by and with consent of the said Edmund Bridges the tract of land was sold May 10, 1839 at Claysville to the highest bidder. Martin B. Bridges was the highest bidder.

Deed of Trust Johnson A. Paris, John Watson, Richard S. Randles, and Curtis Herrin Pages 103-105

This indenture made and entered into January 23, 1841 between Johnson A. Paris of the first part, John A. Watson of the second part and Richard S. Randles and Curtis Herrin of the third part, all of Marshall County. Witness that the said Johnson A. Paris is justly indebted to (illegible) in the sum of \$40 by notes of dates to wit: one note for \$20 due December 25, 1841 and the other note due December 25, 1842 and the said Richard S. Randles and Curtis Herrin having endorsed their names as the security on said notes and the said Johnson A. Paris being willing and desirous to release Richard S. Randles and Curtis Herrin from all liabilities on their part as his securities.

Now this indenture for and in consideration of one dollar in hand paid to the said Johnson A. Paris by the said John Watson the said Johnson A. Paris has this day given, bargained and sold and delivered to the said John Watson the following described property to wit: one lot of blacksmith tools consisting of bellows, anvil, hammers and all other tools pertaining to a blacksmith shop. Nevertheless the said John Watson shall permit Johnson A. Paris to remain in

peaceable possession of above stated property until default is made in payment of above stated notes.

If default in payment the above stated property will be sold at public auction after giving 20 days advertisement at three public places in Marshall County.

There is further agreement that the above stated property shall remain where it is at Gunters' Landing until the aforesaid sums of money are paid off.

Signed by Johnson A. Paris (his mark), John Watson, R. S. Randles and Curtis Herrin. Richard S. Randles certified that he recorded this indenture January 25, 1841 in Book B on pages 103, 104 and 105.

#### Original Land Acquisition by John Walker Page 106

The United States of America:

Greetings: Whereas John Walker of Madison County, Alabama has deposited in the General Land Office of the United States a certificate of the register of the Land Office at Huntsville whereby it appears that full payment has been made by the said John Walker according to the provisions of the act of Congress of the 24th of April 1820. Further provisions for the sale of public lands for the West half of the SW quarter of Section 25 in Township six of Range two East in the described of lands subject to sale at Huntsville, Alabama containing 80 and 75/100 acres. According to official records these lands were previously returned to General Land Office by the Surveyor General and now acquired by the said John Walker.

In testimony whereof I, Andrew Jackson, President of the United Stated

of America have (illegible) to be made Patent and the seal of the Tennessee Land office.

Given under my hand at the City of Washington the first day of July in the year of our Lord 1831 and of the Independence of the United States the fifty-fifth.

By the President, signed Andrew Jackson by A. J. Donelson.

Richard S. Randles certified the above document was filed in his office in Book B on page 106. (The date was not imprinted)

(Editor's Note: In 1817, John W. Walker was nominated as U.S. Attorney for the Alabama Territory and then Territorial Secretary, but turned both positions down because of his health – he suffered from tuberculosis. Andrew Jackson recommended him as Governor of the Alabama Territory, but that honor went to William Wyatt Bibb. Walker was elected unanimously as Speaker of the House of Representatives in 1818, and when the Enabling Act was passed, Walker was appointed as a judge to the territory.

Walker was elected president of the Constitutional Convention held in Huntsville in 1819 and in October 1819, he became one of Alabama's first senators. In December 1822, he resigned his seat in the Senate due to failing health. He died in Huntsville in the spring of 1823 at age 40. Walker County was named in his honor. Andrew Jackson, later President Jackson, had been a close personal friend of his.)

Deed of Trust George C. Armstrong to Reuben Henson Pages 107-108 This indenture made and entered into February 8, 1841 between George C. Armstrong of the first part, Reuben Henson of the second part, and George R. Henson of the third part. Witness that whereas the said George C. Armstrong is justly indebted to the said George R. Henson in the sum of \$600.00 due by note bearing the due date of December 1, 1840 which debt the said George C. Armstrong is willing and desirous to secure to the said George R. Henson.

Now this indenture for and in consideration of the sum of one dollar to the said George C. Armstrong paid by the said Reuben Henson, the said George C. Armstrong had this day given, bargained and sold unto the said Reuben Henson the following property to wit: one Negro boy named Tony aged about 12 years, and one black mare aged about nine years. The said George C. Armstrong shall remain in peaceable possession of the above stated property unless default in payment of above stated note to be made by February 8, 1843. If upon default of the note the above described property will be sold at public auction for ready money after having fixed the time and place by advertisement at three public places at least 20 days prior to the date of the sale.

Signed by George C. Armstrong, Reuben Henson and George R. Henson. Richard S. Randles, Clerk of the Court, witnessed the above signatures and recorded the above document February 8, 1841 in Book B on pages 107 and 108.

John Freeland to Joshua Johnson Pages 109-110

This indenture made and entered into January 23, 1841 between John Freeland and Ann Freeland, his wife, of the first part and Joshua Johnson of the second part. Wherewith the said John Freeland and Ann Freeland, his wife, for and in consideration of the sum of \$102.50 to them in hand paid, hath this day bargained, sold and conveyed to the said Joshua Johnson all that certain tract or parcel of land lying in the county and known as the South half of the West half of the NW quarter of Section 34 in Township six of Range three East containing forty acres and 50/100 of an acre.

Signed by John Freeland and Ann Freeland (her mark). Richard S. Randles witnessed the above signatures and recorded the above document February 9, 1841 in Book B on pages 109 and 110.

#### Deed George Morrow to Elizabeth A. Hill Pages 110-111

This indenture made November 7, 1840 between George Morrow of the first part and Elizabeth A. Hill of the second part. Wherewith the said George Morrow for and in consideration of the sum of \$550.00 to him in hand paid has this day bargained sold and conveyed to Elizabeth A. Hill a certain parcel of land known and described as the West half of the NE quarter of Section 19 in Township six in Range 5 East containing

80 acres, also the East half of the NE quarter of Section 19 in Township 6 Range 5 East containing 80 acres more or less.

Signed by George Morrow and Martha Morrow (her mark). Richard S. Randles, Clerk of the Court, recorded the above document February 10, 1841 in Book B on pages 110 and 111.

#### Deed Burgess McGaha to William Hill Pages 111-112

This indenture made and entered into February 1, 1840 between Burgess McGaha and his wife, Anna, of the first part and William Hill of the other part. Wherewith the said Burgess McGaha and his wife, Anna, for and in consideration of the sum of \$500 to them in hand paid and have this day bargained, sold and delivered the following tracts or parcels of land to wit: a part of fractional Section 13 on the North side of the Paint Rock River in the County of Madison in Township six in Range two East containing half an acre. (Further length land descriptions not transcribed).

Signed by Burgess McGaha and Anna McGaha. Richard S. Randles recorded this document February 10, 1841 in Book B on pages 111 and 112.

# Things You Should Know

#### Voting - Whys and Why Nots

I believe I can safely say that we are all happy that the election is over, no matter how you feel about the outcome. Lest you forget the misery of political advertisements, David Fryxell of *Family Tree Magazine* researched the history of voting and came up with some interesting trivia.

In Athens, Greece, circa 508 BC, politicians were voted *against* when their names were written on shards of broken pots, or ostrakas. Anyone who received 6,000 or more votes against him was exiled for 10 years. An interesting sidenote is that the word ostracize comes from the Greek word ostrakas.

Centuries later in Venice, colored balls indicated the voters' choice. These ballotas (Italian for balls) is where we get the word ballots.

In many places, voters gave their votes orally in the presence of an election clerk.

In 1600s America, paper ballots were used and eventually politicians supplied their own pre-printed ballots to the voters. If this wasn't your candidate of choice, a voter could draw a line through the pre-printed name and write in another name. Politicians, getting ever wiser, cut the paper into smaller strips so there was no room to write anyone else's name.

Thanks to an Australian, we now use pre-printed ballots. In 1858, the open box next to a name would be marked with an "x" to indicate one's candidate of choice. In 1892, America's Grover

Cleveland was elected with this kind of ballot.

Some of us remember our first votes cast on a lever machine, standard in most cities by 1930 but out of style by 1982.

There are still different versions out there. Here in Alabama we connect an open arrow, and who can forget the "hanging chad incident" of the 2000 election?

Readers may also be surprised to learn that in 1789, only white male property owners aged 21 and older were allowed to vote. In 1870, African-American men were allowed to vote under the 15<sup>th</sup> Amendment. In 1920, women were given the right to vote, but it wasn't until 1947 that American Indians were given that same right.

#### **Identifying Old Photographs**

Coy Michael recently sent me some information that will help us all pinpoint the timeframe of old photographs. This information comes from Willis Photo Lab in Mountain View, California, and I will provide the highlights:

Daguerreotypes were popular from about 1830 to about 1870. The cost was an astounding \$5.00, which was more than one week's pay for most folks. The image is on a copper sheet, and shows up in silver and attached to glass. It was sealed into a case and padded with fabric. The silver image tended to tarnish in the same manner as silverware.

Calotypes existed in the proximity of 1845 to 1855. A negative image was made onto light-sensitive paper, then a second sheet of paper was placed over it to make a positive likeness. Over time, the image faded and changed colors, leaving only a few faded calotypes in existence today.

Ambrotypes were popular from about 1854 through 1865. A negative image on glass appeared as a positive when placed against a black background. It required a 20 second exposure and the glass was fragile and easily broken. The finished product was sometimes tinted (rouge on cheeks and lips) and it was put into a decorative case, oftentimes with a cover that closed over the picture itself. Although daguerreotypes had more advantages, the ambrotype cost only about 25 cents.

Tintypes were manufactured from 1856 until the 1940s. Apparently they look enough like ambrotypes and daguerreotypes, that they are easily confused. For dating purposes, a small magnet placed over a tintype will attach.

Tintypes were much cheaper to manufacture, the camera was lighter, and best of all, it was printed on paper. Because a protective case was not necessary, they were varnished by the photographer to protect tints added to the picture and put into a cardboard "envelope" or frame. These were especially popular with Civil War soldiers who had pictures made of themselves in their uniforms, oftentimes holding their weapons.

Tintypes bearing the stamp "Neff's Melainotype Pat 19 Feb 56" along one edge can be dated to pre-1861.

From 1861 to 1865, most tintypes were put into paper holders with stars and emblems and bearing the Potter's Patent.

After 1863, the paper holders were embossed instead of printed. Cancelled tax stamps on the back narrow the date further, from September 1, 1864 to August, 1866.

From 1870 to about 1885, The Phenix Plate Company introduced what we call sepia brown today, or tinted photographs. The popularity of the sepia tinted photographs swept all over the country for some reason, and at this time, painted studio backgrounds and fake props became popular as well. As a side-note, the sepia tone is still popular in places where tourists dress in old fashioned costumes and pose in novelty or themed studios. One can even buy film that will produce wonderful oldfashioned sepia photographs.

Gem portraits, common between 1863 and 1890, were tiny photos that could easily be placed inside a locket, ring, or other piece of jewelry.

In the 19<sup>th</sup> Century, it became popular to have portraits made of people on their deathbed, or even worse, after death.

With so many innovations in photography, new problems arose. When photographs were made larger, blemishes and imperfections became larger as well, leading photographers to touch up photographs or use diffusers which blurred the photograph as well as imperfections.

As the prices went down, the popularity of photographs led to a booming business. Many of us have, in our old photograph collection, postcards with family members on one side, which were then sent out to friends and relatives. It was an ingenious idea of the photographer to encourage someone to buy photographs in larger quantities.

Hopefully, with this information, you may be able to narrow down your unidentified pictures to the right era and perhaps attach a name to your historic photographs.

#### **Tombstone Inscriptions**

If you send tombstone inscriptions, please give the location of the cemetery, how to get to it, and if you copied all the stones or only a portion of them. Other genealogical material concerning the persons enumerated is encouraged but not necessary.

Do NOT put the inscriptions in alphabetical order but leave them in the order in which are buried. By putting them in alphabetical order, important relationships can be lost.

#### Bible Records

If you send a Bible record, we would like to have a photocopy of it plus your interpretation of each name. We

like to include a photocopy of the Bible in *Valley Leaves* as this is helpful to persons proving their lineage for membership in DAR, etc. If there is a *title page* and *date of publication* in the Bible it is imperative that you include them when you submit the record.

#### Queries

We no longer have a "queries section," however, if you have a query pertaining to Jackson, Madison or Marshall Counties, we will work it into the main body of the appropriate chapter.

#### **Book Reviews**

Books will be reviewed in *Valley Leaves* if the author donates a copy to TVGS. After the review, the book is given to the Heritage Room of the Huntsville- Madison County Public Library.
