Pension Application on Service of Jones Bishop

Copied, Abstracted, and Contributed by Jacquelyn Procter Reeves

The following records were compiled by the late Addie Stovall Shaver. They are all stamped with the words "Reproduced at National Archives" and some bear the stamp of the U.S. Pension Office and the Old War & Navy Files. These documents represent the difficulty in trying to prove marriage by witnesses, long after the fact, as Louisa Bishop tried to apply for a widow's pension on the service of her deceased husband, Jones Bishop, some 60 years after his service. Mrs. Bishop did not wait long after the 1892 act was passed, allowing widows to receive a pension. Note also that his bounty warrant was awarded to Jones Bishop nearly 20 years after his service.

Readers will also take note that some of the records were from Texas, indicating that Jones and Louisa Bishop moved there at some point and both later died there. These records are located in the filing cabinets in the Heritage Room, 3rd floor of Huntsville/Madison County Library, dedicated to the records of Addie Shaver.

Personally appeared before me, a Justice of the Peace, in and for said county, duly authorized to administer on this Frances F. Collins age 69 years, whose post office is Milan in the County of Jackson, State of Alabama, who being by me duly sworn declares and says in relation to aforesaid claim as follows:

Affiant was present at the marriage of Jones Bishop to Louiza J. Fraisure and that said marriage occurred in aforesaid County and State near Milan, Ala. and sometime in early part of year but affiant can't remember the month nor exact date of the month.

Why affiant thinks it was then, said marriage followed a few months after affiant's own marriage which was in latter part of 1846. Affiant and her husband, A. W. Collins and Sarah F. Martin now Sarah F. McCullough, Amanda M. McCullough, George S. Counts, and others, this is why affiant can and does remember of her personal knowledge of the facts

This statement was all written out by John R. Austell in her presence and only from her oral statements then made; and was written on 21st day of Sept. 1894 at Milan and in making the same she did not use and was not aided or prompted by any written or printed statement or recital prepared or dictated by anyone. Affiant further states that she has no interest in said case nor is not concerned in its prosecution.

Personally appeared before me, a Justice of the Peace, in and for said County, duly authorized to administer on this Sarah H. McCullough whose age is 61 years, post office address is Milan in the County of Jackson, State of Alabama, who being duly sworn declares and says as follows, to wit:

Affiant states that she was present at the wedding of Jones Bishop to Claimant and that said wedding occurred on or about March 1847, but exact date affiant cannot remember.

One fact affiant remembers is that Oma Bishop, who was a waiter on the bride and sister of bridegroom, had to go home and Miss Amanda McCullough, now Amanda Trice, [took] the place of Oma Bishop and I further remember that my mother went and superintended the cooking of wedding dinner.

I fürther remember that A. W. Collins, who was then an aged man and married. took a leading part in the play, he being a Deacon in the Primitive Baptist Church. Affiant further states that she made the statement to John R. Austell who reduced the same to writing and in making the statement she was not aided or abetted by any written or printed matter or by any verbal statement from any person or persons but makes the same from her own recollection of the facts and circumstances. Affiant further states that she is not interested in said case nor is not concerned in its prosecution.

Affiant was present and saw the claimant and Jones Bishop married and said marriage occurred near Milan in the County of Jackson and State of Alabama and Furman Fowler officiated at said marriage and it occurred in early part of 1847 – but the date I don't remember. Why I do remember about the marriage so well is that Oma Bishop, sister to bridegroom was a waiter and had to go home to fix the table at home for the reception the day following – and affiant took the place of said waiter.

I can also call to mind George Counts and Sarah McCullough, nee Martin being present at said marriage.

Affiant made this statement verbally to John R. Austell who reduced it to writing and she further states that she was not aided or prompted by any writing or printed matter or by any verbal statement but from the facts as affiant remembers them.

Affiant further states that he is not interested in said case nor am not concerned in its prosecution

Grimmett who reduced it to writing and that he was not aided or prompted by any person or persons, nor any printed or written matter of any kind, but makes it from his personal knowledge and affiant further states he has no interest in said cause nor is not concerned in its prosecution.

Young) and further states that she was personally acquainted with Jones Bishop's mother, sisters, and brothers and that the said Jones Bishop was born and raised in the neighborhood that he and my sister Lou J. Bishop were married. They were married in Alabama, Jackson County, in A.D., 1847.

And at the same time personally appeared Lousinda Day, known to me who after being by me duly sworn upon oath, says that she is the mother of Louisa J. Bishop, wife of Jones Bishop, deceased, that she knows from her personal knowledge that Louisa J. Bishop and Jones Bishop were never married previous to their marriage.

I first got acquainted with Jones Bishop about the year 1845 in Jackson County, Alabama where he was born and raised. He was living neighbor to me when he married my daughter Louisa J. Bishop in the year 1847.

I hereby certify that the above testimony was all written in his presence and he only from this oral statement was made Oct. 13, 1894 at Winchester, Texas to A. Ramsay, and that in making the ? they did not ? and was not aided or practiced by any written or present statement or recital prepared as dictated by any other person.

T. J. Hargiss, Deceased Estate of Order setting day for Final Settlement August 22, 1899 Page 377

This day comes N. H. Snodgrass the administrator of the estate of T. J. Hargiss, deceased, and files his accounts vouchers and evidences of debt for a final settlement of said estate. It is ordered that the above cause be continued till the 1<sup>st</sup> day of September 1899 and that all matter pertaining thereto be over till that day.

Thomas Frazier, Deceased Estate of Order setting day to Hear Petition August 23, 1899 Page 377-378

James P. Williams, as the administrator of the estate of Thomas Frazier, deceased, having this day filed his application in writing and under oath, alleging that at the time of his death, the said decedent owned the following described real estate situated in said state and county to wit: the SE  $\frac{1}{4}$  and the E  $\frac{1}{2}$  of SW  $\frac{1}{4}$  Sec. 17 and NW  $\frac{1}{4}$  of Sec. 20 except a small strip on the west side

thereof so as to include one half of the Frazier Spring.

That all of said heirs are of sound mind and Martha C. Frazier one of said adult heirs, requests the petitioner to sell said land as administrator aforesaid for division among said heir, and said petitioner prays for an order and proceeding to see the said land for the purposes aforesaid. It is therefore ordered by the Court that the 3<sup>rd</sup> day of Oct. 1899 be appointed a day to hear said application and the ? submitted in support of the same, which said day fixed for hearing is more than 40 days from this day.

It is further ordered that John B. Tally, who is a proper person, and who is not of counsel or kin to petitioner, be and he is hereby appointed as guardian ad litem to represent the said minors and to protect their interest in the hearing of said application.

It is further ordered that citation issue to all of said heirs who are shown to be of full age and residing in the state, notifying them of the said petition and of the day appointed for hearing the same, which must be served on them 10 days before the day appointed for the hearing thereof.

It is further ordered that the nature of said petition and of the time set for hearing the same be given by publication once a week for three successive weeks in the *Scottsboro Citizen*, a newspaper published in such county and that a copy of said paper containing said notice be sent to the said Gemima E. Cobb by mail to Tullahoma, Tenn.

W. R. Larkin, Deceased Estate of Order to record report of Appraisers August 26, 1899 Page 378

This day comes W. Rutledge Larkin, the administrator in the court of the estate of W. R. Larkin, deceased, and filed his inventory of the personalty of said estate. At the same time, comes the appraisers, J. P. Barclay, W. D. Selby, and Wiley Cotton, who were heretofore appointed and commissioned to appraise said estate and to set apart to the widow the personal exemptions allowed to her and file their report in writing and under oath showing how they have executed said demands of said commission.

# Estate Files of Martha Patton and Thomas Percy

Copied, Abstracted, and Contributed by Jacquelyn Procter Reeves

It is always interesting to go through the estate packets of some of Huntsville/Madison County's earliest residents, for much can be revealed about their personal lives and information that seldom makes its way into the history books. These names should be familiar to most people from this area. This information is housed in the records room of the third floor of the Huntsville/Madison County Public Library and they are available for anyone who wishes to go through them.

### Martha L. Patton

Martha Harrison was the second wife of early pioneer David Moore. (See *Valley Leaves* Volume 45, Issue No. 2, December 2010.) She married David Moore in 1834, after the death of his first wife, Harriet Haywood Moore, who died in 1831 at age 41.

Martha was the daughter of Benjamin Harrison of Brunswick County, Virginia and a cousin to President Harrison. She and Dr. Moore had six children. Dr. Moore died in September, 1845, and she then married Dr. Charles A. Patton. Martha died November 6, 1881, one day after her 70<sup>th</sup> birthday. Dr. Patton had apparently pre-deceased her. Only three of Martha's children were still surviving at her death.

A look at the 1880 census indicates that Martha was born about 1813 and in 1880, she was listed as the widowed head of household. Among the people listed on the census as living in her household were her son, 37-year-old Samuel H. Moore, a mulatto servant, 38year-old Zena Pruitt who was born about 1842, and 12-year-old Addie Pruitt, also listed as mulatto and assumed to be the daughter of Zena. Addie was listed as a student.

As most people know, Samuel Moore was part owner of the famous Jersey cow named Lily Flagg.

Zena Pruitt was known as the cook who prepared many dishes made from butter, cream, and milk of Lily Flagg to celebrate her entry in the Chicago World's Fair for producing the most cream/milk.

Last Will of Martha L. Patton Dated July 27, 1878 Date of Death: November 6, 1881 Filed December 13, 1881 Estate Case File #2877 and 3655

In the name of God, Amen. I, Martha L. Patton, at present residing in Huntsville, Alabama, do make, publish, and declare this to be my last will and testament.

I give, devise, and bequeath all of my estate, real, personal, and mixed of whatever name or nature and wheresoever situated to my beloved son Samuel H. Moore and to his heirs forever.

I nominate, constitute, and appoint my said son, Samuel H. Moore the sole

executor of this my last will and testament, and it is my will that under no circumstances, and in no event shall he be required to give any security whatever as such Executor.

I hereby revoke all wills heretofore made by me.

In witness whereof, I have hereunto set my hand and seal at the City of Huntsville, this 27<sup>th</sup> day of July, A.D. 1878. Signed by Martha L. Patton.

Signed and sealed by the said Martha L. Patton, the testatrix above named in our presence, and at the same time declared by her to us to be her last will and testament and thereupon we at her request and in her presence and in the presence of each other have signed our names thereto as witnesses at Huntsville, this 27<sup>th</sup> day of July, A.D. 1878.

**Editor's Note**: David Leslie Moore, listed as non compos mentis in these records, is buried at Maple Hill Cemetery. He died shortly after his 50<sup>th</sup> birthday. Incidentally, a CSA marker, No. 78, was once assigned to his grave.

Samuel Moore is known to be buried in the same plot, however there has never been a marker placed over his grave. Speculation is that anger at him for acquiring his mother's estate was the reason his next-of-kin did not mark his grave.

Martha Patton is also buried in the Moore plot.

**Editor's Note**: The following information is a continuation of Estate Case File #493 in the name of Thomas G. Percy, held in the records room (3<sup>rd</sup> floor) of the Huntsville/Madison County Public Library. This is a follow-up of information published in the Volume 45, Issue No. 3, March 11 *Valley Leaves*.

Obituary of Thomas George Percy Died September 30, 1841 *The Democrat* Saturday, October 9, 1841

DIED - At his residence, in this place on Thursday morning, the 30<sup>th</sup> ult. Col. Thomas G. Percy, on the 55<sup>th</sup> year of his age, after an illness of 11 days. The subject of this notice was born near Natchez, Miss. then Louisiana. The advantages of a polished education were afforded at the College of Princeton, New Jersey, where he graduated in the year 1807. Whilst at this institution, he contracted an intimate friendship with our lamented John W. Walker, which was continued with increased ardor to the death of the latter. About the year 1815, he first visited this country, and in the year following, having married the sister-in-law of his bosom friend, the daughter of Col. LeRoy Pope, came to reside amongst us. The empty bubble of popular applause, so ardently sought after my many, was never coveted by him, but, with a fondness for polite literature and devoting himself to the peaceful and honorable pursuits of agriculture, he cultivated those social qualities for which he at all times was so

distinguished. Endowed naturally with an amiable and benevolent disposition, his manners were bland and courteous; affable and polite to all; ardent and devoted to his friends; kind and humane to his domestics; most tender and his family affectionate to and discharging with connexions: conscientious solicitude all his relative emphatically duties. he was the exemplification of an intelligent, polite "Southern accomplished and gentleman."

Col. Percy had complained of slight indisposition for several days, and had forebodings of severe illness; but in the early part of the day of his attack, he was quite cheerful, and engaged in his usual avocations, when he was suddenly stricken down by Apoplexy. And times. afterwards. although at sufficiently conscious to recognize and speak to his family and friends, he never again recovered the full exercise of his faculties. He lived without reproach and died without an enemy, deeply regretted by all who knew him, leaving a distressed widow and six children to mourn their melancholy bereavement.

Editor's Note: At the time of his death, he was survived by his wife Maria, and sons: John W., Charles B., Robert H., LeRoy P., William A., and Ellis W. He also owned the following slaves: Spencer, age 38; Tim, age 43; Milly, age 36; Clara, age 58; Albert, age 16; and Luisa, age 11.

Maria Pope and Thomas George Percy were married July 16, 1816 in Madison County, Alabama.

Thomas Percy and his wife lived in the Joshua Cox home, known locally as the Spite House, after it was discovered that LeRoy Pope owned title to the property. His family also lived in a plantation home known as Belfield, adjacent to Oakdale, the plantation of his good friend, John Williams Walker. Apparently, after the death of his friend, Percy intended to move back to Natchez, Mississippi, but died before he could continue on. Some records indicate his widow moved to Mississippi after the several years it took to settle his estate locally.

The Percy family contributed politicians, writers, and a descendant of Thomas Percy's sister, Sarah, was the woman who left her final home to ex-Confederate President Jefferson Davis. It is known by the name Beauvoir.

# 1841-1843 Bankruptcy Exceptions

### Copied, abstracted, and contributed by Dorothy Scott Johnson

In the early 1840s, when a person declared bankruptcy, the courts allowed that person to keep property that would allow him to continue to make a living; all other property, whether livestock or table settings, that was declared unnecessary was exposed to sale. Monies from the sale were applied against the debtor's obligations. The most interesting part of the bankruptcy proceedings was the list of items the courts allowed the person to keep. It gives us a glimpse into his life-style and occupation.

These records are from the 1841 - 1843 personal ledger of Septimus Cabaniss, a lawyer, and was kept in his role as assignee of Bankruptcy Court of Northern Alabama. Mr. Cabaniss was the ancestor of Dr. Frances Cabaniss Roberts who inherited the ledger then willed it to the University of Alabama, Huntsville campus. The original ledger is now in possession of that University and can be viewed there in its entirety. The number after the debtor's name is the page number in the original ledger. Please see "Historical Note" at the end of this chapter.

### Historical Note

There are many more bankruptcies in Madison County than in Jackson or Marshall. Madison's population was greater which accounts for part of it but the economy was a prime cause of financial stress.

In 1818, cotton sold from  $20\notin$  to  $25\notin$  per pound. By 1830 it was  $9\notin$  but went upward to  $14\notin$  in 1835. Failure to fully rebound caused the panic and depression of 1837. Cotton prices fell to  $6\notin$  in 1840 but the planter's expenses remained high and they still had to feed their families, livestock and slaves. Cotton prices bottomed out in 1845 at  $5\notin$  per pound.

The frugal farmer/planter who had paid his expenses "as he went" and did not rely on credit or make foolish purchases was the one who went to bankruptcy <u>sales</u> and bought items at a fraction of their value.

Too, then as now, people were buried in a sea of credit expecting higher cotton prices that did not arrive until the Mexican War. By 1850, cotton was selling for 11¢ per pound then dropped to 8¢ by the mid-1850s. After that, a strong recovery lasted into the 1860s.

We have lost a great lady but her works will live forever. On May 22, 2011 Margaret (Matthews) Cowart (Mrs. Eugene) died at Huntsville Hospital of a massive stroke, leaving an outstanding family and countless researchers who have benefited from her contributions. Her first love was her family and the second was genealogy.

Her contributions to genealogy began in June, 1966 when she became one of the charter members of the Tennessee Valley Genealogical Society (TVGS). From that time forward she served in nearly every office and was almost constantly on the Board of Directors until her final illness. She was honored by the Society when she was awarded the prestigious *Lifetime Achievement Award*. She was also on the Board of the Friends of the Alabama Department of Archives & History and other groups.

Margaret was president when, in 1970, her husband was transferred to Seattle. Everyone rejoiced when the Cowart family returned to Huntsville and in 1975 she became editor of *Valley Leaves* after serving two years as apprentice under Helen McKnight.

After her term as editor expired she continued to make substantial contributions to Valley Leaves, including the 1855 Alabama State Census of Colbert-Franklin Counties, Madison County's Big Cove Church Minutes, and many others. Her stamp was on most issues of that publication until her energies went to meticulously compiling her Old Land Records series on each county of north Alabama. Margaret's forte was her devotion to accuracy.

To compile the *Old Land Records* series, Margaret worked from microfilm or photocopies but not trusting them she travelled to each county to verify the information from the originals. She also travelled to Montgomery to check the records in the Alabama Dept. of Archives & History and to the National Archives in Washington, D. C. Her work was so lauded that she was asked to lecture on land records at regional and national genealogical conferences.

One time a hot-shot young lawyer called to gleefully say he had found an error in Margaret's *Old Land Records of Madison County*. As it turned out, he was wrong and Margaret was right. He didn't know her obsessions were accuracy and honesty.

The remainder of her inventory of the *Old Land Records* has been donated by

the family to TVGS and to the Heritage Room of the Huntsville-Madison Co. Public Library. Except for Jackson County (out of print) these books may be ordered from the Society or picked up in person in the Heritage Room.

In 1946 Margaret met and married the love of her life, Eugene (Gene) Cowart, a marriage that lasted 65 years. Gene flew B-26 Marauders in the 9th Air Force during WWII. A few months after the war ended he entered the University of Alabama where he studied Engineering and where Margaret was an Art major. It was love at first sight. During Margaret's Junior-Senior year Gene got his degree in Engineering and Margaret traded in her Art studies for an MRS.

Gene went into private industry where he excelled in management. Margaret became a housewife and together they raised two outstanding children. Their son, David, earned his Ph.D from Rutgers University in New Brunswick, N. J. and now teaches at the University of South Carolina in Columbia, South Carolina.

Jan (Cowart) Potter, their daughter, is equally talented and successful. She received her degree from the University of Alabama (Huntsville campus) and is a computer guru. David and Jan each have children who are also talented and successful in their chosen fields. They have blessed Margaret and Gene with six grandchildren and eight greatgrandchildren.

We miss you, Margaret.

An effort will be made to balance material among the three counties to broaden researcher interest. Materials prior to mid-20th Century are preferred. Family histories should be sufficiently comprehensive to possible connection to ancestors. In compiling submissions, all source references should be cited, including locations where known. The 15th Edition of the Chicago Manual of Style should be used. While attempts are made to check submission for accuracy and originality, The Society, Editorial Board, and the TVGS Valley Leaves Editor shall not be held responsible for any such errors by contributors. Correction of proven errors will appear in subsequent issues of
