Orphans Court Minutes Book 8, page 52: WALL, Mary applied for Letters of Guardianship for Sarah WALL, over 14, child of Alexander G. WALL; of James T. WALL, Alfred A. WALL and Helen G. WALL, under 14, infants of Alexander G. WALL dec'd. Alfred Howell and Asa Shelton, securities. 9 March 1840.

Probate Record Book 11, pages 513-517: WALL, Mary makes final settlement of her guardianship of Sarah C. WALL, and annual settlement for Alfred A., Helen G., and James T. WALL, all infants of Alexander G. WALL dec'd. 14 Dec. 1844.

Probate Record Book 13, page 279: WALL, Mary makes final settlement of her guardianship of Alexander A. WALL, and annual settlement of accounts with Helen G. and James T. WALL. 14 June 1847.

Probate Record Book 33, page 60: WALL, Mary dec'd. Petition to sell the land. Kennon H. Steger, Administrator. She died about the 13th of February 1869 and was the Widow of Alexander WALL dec'd. During her marriage she had the following Children by her said husband: Mary Steger, Wife of Kennon H. Steger (applicant); Alfred A. WALL; Sally C. Lacy, Widow of Alexander Lacy dec'd; James T. WALL who died in the lifetime of the intestate and left surviving only one child named William WALL, who is over 14 and Helen G. WALL who died in the lifetime of the intestate, under 21, and unmarried. Mary Steger, Alfred A. WALL and Sally C. Lacy are over 21, William WALL is an infant over 14, with no parent in life and is now under the care of his Grandfather Thomas H. Cawthon; all reside in Madison Co., Ala. 19 Nov. 1870.

Probate Record Book 33, page 173: WALL, Mary dec'd. Petition to probate the will. Kennon H. Steger and Alexander A. WALL show that Mrs. Mary WALL died the 1st day of March 1869 in Madison County, leaving a will in which the petitioners are named as executors. The next of kin are: Sarah C. Lacy, unmarried, over 21, Madison Co., Ala.; William A. WALL, Son of James T. WALL, a minor over 14 residing with Thomas H. Cothran, Madison Co., Ala.; Mary E. Steger, Wife of Kennon H. Steger, of age, Madison Co., Ala. Alfred C. WALL and Helen G. WALL, over 14 and residing with their Father A.A. WALL, Madison Co., Ala., William R. WALL, James S. WALL, Robert Lee WALL, Alexander Lacy WALL and John A. WALL, minors over 14, residing with their Father A.A. WALL in said county of Madison. Alfred A. WALL who is of age and resides in Madison County. 3 Apr. 1871.
