September 15, 1831

Died on Monday, 5th of September, MAJOR WILLIAM M. MARR, at Blount Springs. Highly respected citizen and one of early settlers in this town. He was born in Pittsylvania County, Virginia, was educated as a physician, emigrated to Tennessee in 1798 and from thence to this place in January 1819. He was 49 in May last. Volunteer officer in the Creek War of 1813, 1814. Left a wife and eleven children (From Spirit of the Age, Tuscaloosa).
