Died near Intercourse in this county on 17 November last, WILLIS THORN in 29th year. (In 1850, he was 27 b. N.C.)

December 13, 1851

Died in Montgomery on December 2, 1851, Mrs. GEORGENA R. RIGGS, wife of JOEL RIGGS in 29th year. (In 1850 Census Montgomery Co. she was 26 b. N.C.)

December 20, 1851

Died at Downieville, Forks of the Yuba, California, October 14th, MAJ. JEREMIAH MANASCO of Alabama aged 39...Mason. (m. Miss PHOEBE HILL 11 Feb. 1846, Sumter County.) (Mrs. Guttery writes, 1962, "Our Jeremiah Manasco went to Sutter's Mill California with his nephew, CALTON MANASCO in 1849. This was JOHN's bro. as CALTON W. was his son.)

January 10, 1852

Died at Mrs. BINGHAM's near Gaston on the 5th, REV. ROBERT W(ILSON) HADDEN in 28th year of his life and 3rd year of his ministry...(Note: He married 1850 LOUISA JANE BINGHAM, daughter of Mrs. MARY BINGHAM.) (Received his education at Nassau Hall (now Princeton) and his theological education at Columbia, S.C.)

January 17, 1852

Married in this county on 7th by REV. D.P. BESTOR, Mr. ANDREW MILLER to Miss MARY M. daughter of JUDGE BOOTH of Louisville, Mississippi. Died on 1st after a lingering illness, Mr. GEORGE M. MALLORY, native of Virginia and for many years past a highly respected merchant. (Mobile Herald)

January 24, 1852

Married on the 15th in Greene County by REV. Mr. MITCHELL, Mr. PHILLIP P. MAY of this county to Miss JANE TINDALE.

On 15th January by REV. GEORGE W. BOGGS, Mr. JNO. T. SMITH to Miss CORNELIA E. daughter of M.C. HOUSTON, all of this county.

In this county on 21st by REV. Mr. CLEMENT, Mr. THOMAS M. HILL, to Miss MARY MAY, daughter of R(ICHARD) B. MAY, Esq.

In the Parish of Caddo, Louisiana on 17th December last by REV. WILLIAM SCALL, of the Episcopal Church, DR. R.T. GIVVS, of Mansfield, to Miss EMILY C., daughter of FLABEL FOSTER, Esq.

February 21, 1852

February 28, 1852

WATSON aged 25 years 12 days, second daughter of PLEASANT and FRANCIS WHITE. She was born near Greensboro, Greene County, Alabama February 7, 1827. Baptist. Married November 22, 1847...

Died at Capan Grey, Missouri (Mrs. JENKINS copied at Miss) on 31 December last, Mrs. SOPHIA H. consort of TULLY R. CORNICK, Esq. formerly of this place, aged about 30 years. Well known.
