Died near Brewersville Feb. 16, MARY E., daughter of FELIX and DORA MCMILLAN...

The wife of Mr. HENRY MCDANIEL (48NC, wife in 1850 was DELILAH 44T) died last Friday at Sumterville of paralytic stroke.

Mr. G.W. ROGERS aged about 30 died at the residence of his father in law, Mr. D(AVID) W. HOODS (29SC) on the 9th. (Married to MARY S. HOODS (1848-71))

CAPT. JESSE A GIBBS (37V) who took a prominent part in movement to establish a city court at Gainesville is writing a history of his evenful life. Extracts: "I was born in Prince Edward Co. Va. May 29, 1812... My mother was a RANDY and married my father in Prince Edward Co. near Burksfield, 40 miles west of Richmond. I left there with my uncle when he came there to draw his legacy from his grandfather. My uncle lived in Kentucky. I went with him home. I was 7 years old when I left my parents' house..."
