Died at the residence of her son-in-law, DR. JOHN H. JOHNSON in Navarro County, Texas, Mrs. NANCEY MITCHELL (37 SC), widow of BENJ. J. MITCHELL (41 SC), deceased in her 56th year. She was born December 2d, 1812 and died May 1st, 1868. Native of Newbery District, South Carolina. In early childhood, her parents moved to what was then Greene County, Alabama, now Hale County. While young, she connected herself with Mount Zion Presbyterian Church then under the care of REV. ISAAC HADDEN. In 1832, she married Mr. BENJ. J(AMES) MITCHELL with whom she lived and raised a large family of children; her companion was taken away April 1st, 1859... (Mrs. JENKINS book has his tombstone, died April 1857.) For a number of years before her death, she was afflicted with a lingering and painful disease from which she never expected to recover...
