MAY (29 A), and daughter of the late WILLIAM H(ARVEY) (59 G) and CAROLINE TALBOT aged 44 years 3 months and 14 days, native of Jones County, Georgia but removed at an early age with her parents to this state. At the age of 17, she professed religion, joining the Missionary Baptist Church. She married July 9, 1843, her husband becoming a member of the Primitive Baptist Church...She talked to her husband and children at the last...(MARY was born May 18, 1824, daughter of WM. HARVEY TALBOT and first wife CAROLINE (TALBOT). See marginal note in Vol. 94. WILLIAM H(ARVEY) was born Washington County, Ga., Sept. 5, 1790, died Sumter County, Ala. Jan. 3, 1863.)
