SKETCH OF JOHN ANTHONY WINSTON (37 A), EX-GOVERNOR OF ALABAMA.

Tribute to his Memory. Born in Madison Co. Alabama about 1811. Oldest child of WILLIAM and MARY WINSTON. His mother was MARY COOPER (15 A), a sister of WILLIAM COOPER and L. B. COOPER, distinguished lawyers of North Alabama. ANTHONY WINSTON, grandfather of GOVERNOR WINSTON was born in Hanover Co. Va., and was a captain in the Revolutionary War. He moved from Va. to Tennessee and settled about 1 mile from the Hermitage. JOHN ANTHONY WINSTON married in early manhood, MARY JONES of Madison County, Ala. a sister of his partner, JOEL W. JONES. She was mother of GOVERNOR WINSTON'S only child, Mrs. AGNES W. GOLDSBY, now of Mobile; but she died when her daughter was only a few years old. GOVERNOR WINSTON married again, but had no children. In 1834 he moved from Franklin County to Sumter Co. near Gainesville (gives political record in detail). Was COLONEL of 8th Alabama regiment and served in campaign of peninsula of Williamsburg and Seven Pines...He will be buried beside the mother of his child.
