August 22, 1873

Death of CHANCELLOR JAMES B. CLARK. A primitive letter from Blount Springs brings information that HON. JAMES B. CLARK died at that place on Sunday morning of cholera. He filled a prominent place in the Judiciary of the State for many years and the records of the Chancery and Supreme Courts bear testimony of his worth and ability. He was a native of Pa. Bedford County 1796 and was 77 years old at the time he died. Came to Alabama in 1822, having been licensed to practice law a short time previously and settled in Bibb Co. He subsequently settled in Cahaba after having filled one term in the Legislature from Bibb. Engaged in practice of law in Cahaba 8 years and met with great success. From Cahaba he moved to Eutaw, of which place he continued to his death a citizen. In 1863, CHANCELLOR CLARK resigned his office and became a private citizen and after the close of the war, engaged in the practice of law with his son,
