Native of Edgecomb (now Wilson) Co. N. C. and moved to this county in 1834. Some 25 years ago, he removed to East Miss. where he resided up to time of his death. He was a man of great probity of character and enjoyed the respect of all who knew him.

JUDGE (illeg) L. B. STRANGE (38 SC; m in Mtgy Co. 1840 Hemutial Westmoreland) died suddenly near Tuskegee a few days ago.
