Died near Blount Springs, Ala. on 28 Jan. 1876 CAPT. VICTOR M. RANDOLPH (MRS. SUE WATSON, Chattanooga, in 1954 says VICTOR M. RANDOLPH was son of EDW'D BRETT RANDOLPH). Born in Culpepper Co. Va. July 24, 1797, was commissioned from that state a midshipman in U.S. Navy in the year 1814 and sailed under CAPT. STEPHEN DECATUR. He served with great credit during the fierce conflicts with the Algerine pirates that ended in their extermination. He was with the late CAPT. JOSIAH TATTNALL at the bombardment of Vera Cruz and caught the latter in his arms when he fell dangerously wounded by a Mexican missile. . . . For more than 40 yrs a member of Episcopal Church. His remains sent to Columbus, Miss. and interred by side of his beloved wife.
