Departed this life at late residence in this place on Sunday morning 30 ult. after lingering illness, MRS. HANNAH FEW, formerly of the state of Georgia; embraced religion at early age of 13, Methodist Episcopal; left family of several children.

Died in Pickens County in 25th year after prolonged illness, DR. HARRIS BREWTON, late of South Caroline (communicated).
