PEYTON R. TUNSTALL. Note: This is the noted MRS. VIRGINIA CLAY-CLOPTON, a famous belle of the fifties.

Death of THOMAS W. WHITE

Founder and Editor of "Southern Literary Messenger" Died Tuesday morning in his 55th year. He was several weeks since attacked with paralysis in the city of New York (From the Richmond Enquirer Jan. 21st)

March 22, 1843

Died at Centreville on the 10th of March 1843 JOHN HENRY in his 48th year.

April 5, 1843

Married on Monday, the 3d instant by REV. DR. MANLY, PROFESSOR JAMES C(OVINGTON) DOCKERY of the University of Alabama to MISS MARY A. WHITFIELD of this place. Note: He d. Nov. 3, 1863 in DeSoto Co. Miss. (tombstone) b. Richmond Co. NC. She probably d. ab 1854-5 dau of BENJ. & MATHILDA WHITFIELD.

April 19, 1843

Died in DeKalb County, Alabama on the 1st instant, MR. PALMER CLAYTON, eldest son of MR. SAMPSON CLAYTON aged about 18 years.

April 26, 1843

Married in Tuscaloosa on the evening of the 20th instant by REV. J. H. THOMASON, MR. LUCIUS N. HOLBERT of Aberdeen, Mississippi to MISS M. E. SHORTRIDGE of the former place. (A genealogist in Aberdeen says his name was really HALBERT not HOLBERT. He was made gdn of minor heirs of JOSHUA HALBERT, 1844, Monroe Co. Miss. MARY HALBERT.)

Married on the 25th instant by REV. J. P. McMULLEN, MR. ROBERT G. MARTIN to MISS EMMA J. McCLARY, both of this co. (a genealogist thinks they moved to Oktibbeha Co. Miss.)
