February 3, 1836

February 10, 1836

February 17, 1836

JAMES C. MARTIN, being about to remove from Huntsville.

Died at Seneca Agency west of Mississippi on 31st of December, 1835 in his 50th year, CAPTAIN GEORGE VASHON, Sub-Agent to Western Cherokee Nation; native of Virginia and distinguished officer of the late war; was a Captain of the 7th Regiment of Infantry in 1815 and served as much with that Regiment until 1819 when he resigned command. Remains brought to Fort Gibson on 5th instant.

February 24, 1836
