Died on March 28th at the residence of her mother MRS. HANNAH McBROOM in Ash Cove, Madison County, Ala. MRS. NANCY M. SPINEY who leaves a large family to mourn her loss. (Bible record shows NANCY M. SPIVEY (28 A) (daughter of STEPHEN and HANNAH McBROOM) died March 28, 1860, K. P. J.)
