August 5, 1875

Died, LUKE MATTHEWS, one of the oldest citizens of Huntsville at his residence in this city Monday evening last in his 79th year.

August 12, 1875

Golden wedding of ELLIS MURPHREE (48 in Alabama) and wife JINNIE MURPHREE (45 in South Carolina) July 20 in Murphree's Vallen, Blount County, Alabama. Among those present were REV. DeFOREST ALLGOOD and JEREMIAH ELLIS and MRS. PATSEY ELLIS, who were witnesses of their marriage. MRS. ALLGOOD, who is their step-mother, who is 93 was present with them together with 18 children, sons, sons-in-law, daughters-in-law, 40 grandchildren and 11 great grandchildren. All grandchildren present except 3 who are in Texas.

August 19, 1875

August 26, 1875

September 2, 1875

September 16, 1875

JAMES Q(UINN) DILLARD (34 in Tennessee), father of our respected citizen, HENRY DILLARD (14 in Alabama) died at his residence in Aberdeen, Mississippi on the 4th in his 60th year. MR.
