RATHBONE,

Esq of this county. Native of Warren County, North Carolina and resided for many years in Kershaw District, South Carolina. Note: In 1835 he married ELIZ. MASON. He died 1842 in 62 or 67th year and she married 1843 ELI DEAN. In 1843 ELIZ. DEAN and RATHBONE children were in Monroe County, Mississippi. See our volume 76.

June 23, 1832 Died Thursday last in this place after lingering illness, THOMAS J. SUMNER, Esq., Senior Editor of the "Democrat." Left wife and one child. Died on 27th of May in Sullivan County, Tennessee HON. JOHN RHEA, aged 79.
