On 2 by REV. BETHEL BRYAN, MR. JOHN VARNEL (22 in Tennessee) of Lauderdale County, Alabama (1850 Lauderdale County) to MISS ELIZABETH KATHARINE (20 in Tennessee), daughter of REV. SAMUEL EDMONSON of Limestone County (ancestor of SAML D. F. CANAGAN, Athens, Alabama 1966-- he says SAML married REBECCA HICKS, daughter of JAS. HINSON HICKS and ---- (KNIGHT)).

On 14th instant by REV. MR. HUSBANDS, MR. H(ENRY) A. SKEGGS to MISS MARY J. HUNT, all of this place.

December 22, 1848

Married on 28th instant, MR. JOHN W(ESLEY) DICKEY (27 in Alabama) of Marshall County to MISS SALINA NEAL (22 in Alabama) of Madison (ancestors of MRS. ROBERT RICKETTS, Jefferson City).

Died on 17 at residence of her father in Huntsville, MISS MARY ANN TABLER aged 17 years 10 months. (she was daughter of WM. TABLER and grand-daughter of MICHAEL TABLER).

Died in Nashville on 9 in 29th year of her age, MARY JANE HENRIETT wife of MR. CHARLES C. PERCY, formerly of this place.

December 29, 1848

Died in Florence on 17th, MRS. ELIZABETH WALKER, wife of GEN. L. P. WALKER in 28th year of her age.

January 5, 1849

Married at Buzzard Roost on 21st instant by REV. W. D. F. SAWRIE, MR. JOHN L(EWIS) MALONE (23 in Alabama; Franklin County) to MISS MARY JANE (20 in Alabama), daughter of the late ARMSTEAD BARTON.

January 19, 1849

Married on 16th day of January, 1849 by REV. B. C. CHAPMAN, MR. JESSE J. SHEID of Franklin County, Tennessee to MRS. CYNTHIA WILKINSON of Madison County, Alabama. (She was daughter of ROBT. HAMLET and married 3 times in Madison County, Alabama. 1. JOHN C. FINLAY--March 29, 1826, 2. JOHN M. WILKINSON--May 6, 1839, 3. JESSE J. SHEID; see will of one JESSE J. SHEID in Sumter County 1861; 2nd wife CYNTHIA--In 1850 he was 38 born in Tennessee; CYNTHIA was 40 born in North Carolina; see volume 158, page 65; and volume 146, page 54 for tombstone of CYNTHIA HAMLETT, born 1810--buried in Jackson County)

January 26, 1849

February 9, 1849

Died in Tuscumbia on 1st REV. J. B. GALLAGHER.
