

February 23, 1849

Died in Tuscaloosa the 7th instant DR. JNO. OWEN for many years a resident of Tuscaloosa. DR. OWEN was a minister of the Gospel of Protestant Methodist Church.

March 2, 1849

Departed this life on the 21st at his residence near Somerville, Morgan County, Alabama COL. JAMES B. GRAHAM in the 55th year of his age. Born in Bath County, Virginia on 15th September 1795 and removed to this county nearly 30 years since. Elected clerk of Circuit Court 1824 and continued in office with the exception of 4 years until October 1847....

March 23, 1849

March 30, 1849

Died in Limestone County on 19th, MR. SAMUEL LENTZ, an old and much respected citizen.
