May 11, 1849

May 25, 1849

August 3, 1849

Departed this life on Wednesday 25 July MR. ROBERT GRAHAM aged about 50 years. Born in Monaghan, North of Ireland and for the last 25 years a resident of Huntsville.... Kind husband and father.

Died in Somerville, Morgan County, Alabama on Monday the 16th of July, HARRIET EUGENIA, daughter of WILLIAM P. (40 in Virginia) and MARY LOU (32 in Virginia) TERRY aged 5-2-6.

At Sherwood, Lunenburg County, Virginia, on the morning of July 18, ROGER ATKINSON, son of HENRY C. and ELIZA W. LAY of this place aged nearly 14 months.

Suddenly on 25, MR. WM. BEALE of this place aged about 23.
