Married in Athens on the 29th instant, FOUNTAIN E. OGLESBY (19 in Tennessee, son of W. H.; H in census, H in marriage record) to MISS LUCINDA E. LEWIS.

Married in the Circuit Clerk's Office on the 11th instant by REV. WILLIAM GREEN, MR. JAMES GILES to MISS ELIZABETH GRIFFIN, all of this county (volume 127, page 26).

Died in Tuscumbia on the 13th instant CAPT. WM. C. FRANCIS, a well known steamboat captain on the Tennessee River.

December 24, 1851

Married on the 19th instant by REV. J. H. ZIVELY, WILLIAM S. BAR-(hole punched in paper), Esq. of Mississippi to MISS SARAH L. FEARN, daughter of DR. THOMAS FEARN of Huntsville (volume 100, page 15).

(note: We have checked with the marriage records in Madison County and the name should be WILLIAM S. "BARRY")

December 30, 1851

Married on the 26th instant MR. BYRD HAMLET to MISS ELIZABETH E. VAN HOOK, both of this county (volume 147, page -64 which says married December 24).

Married on the 11th instant (son REV. DANIEL K), by REV. G. A. COLLIER, MR. J(AMES) A. M. HUNTER to MISS MARY C. McGAH(A?), all of Madison County (volume 147, page 64).

Married on the 2nd instant (son of WILSON) by REV. G. A. COLLIER, MR. FLEMING PUTMAN (18 in Alabama) to MISS ELIZABETH JENKINS of Madison County.

Married on the 16th instant by REV. WILLIAM EGGLETON, MR. PHILIP P. GILCHRIST of Alabama to MISS ELLEN A. PHILIPS, youngest daughter of HON. JOSEPH PHILIPS of Rutherford County, Tennessee.
