Married on 10 by REV. WILLBORN MOONEY, MR. JOHN E. DONLEY (20 in Alabama; son of JAS.) to MISS MARTHA J. M. ATKISSON, all of Franklin County, Alabama.

Married on 10 by WM. J. BULLOCK, Esq., MR. GEORGE M. GHOLSON to MISS MARY E. PATTON (14 in Alabama; daughter of AARON), all of Franklin County, Alabama.

February 1, 1854

Died at his residence in this county, CAPT. STEPHEN McBROOM, one of the first settlers of the country. He came to this county in 1804 and was born in Hawkins County, East Tennessee the 26th March 1784. He bore his last illness with a firm mind and was willing to die, and retained his mind to the last. (Bible record states he died January 6, 1854. He was son of THOMAS and ---- (CRINER) McBROOM, and grandson of JOHN CRINER, who died in Hawkins County, Tennessee before 1808.)

February 8, 1854

Married on 23rd by JOHN W. IRBY, Esq., MR. JASON G. HAMBRICK to MISS MARY CAMPBELL, all of this county.

Married in Wetumpka on 24th by REV. OTIS SAXTON (M. E.), DR. M. G. MOORE, one of the Lessees of the Alabama Penitentiary to MISS GEORGIA SPRATLIN (16 in Georgia) of Wetumpka.
