February 25, 1880 Died at his residence in this city Sunday, February 22, THOMAS S. McCALLEY, native of Spotsylvania County, Virginia. Born February 13, 1807. Removed when quite a young man to Huntsville. Successful merchant and planter. Member of Episcopal Church.

June 9, 1880 Died in this city at the residence of her mother, MRS. CARUTHERS on Tuesday afternoon, MRS. COLTART, widow of the late ROBERT W. COLTART after a long illness.

June 23, 1880 Died the 17th instant at her husband's in Moulton (Lawrence County), MRS. NAOMI SOPHIA PETERS (28 in Alabama), wife of JUDGE THOMAS M. PETERS (39 in Tennessee) of that place. The deceased was born in Lawrence County and was the daughter of WILLIAM and NAOMI LEETCH (73 in North Carolina). Her mother was the aunt of PRESIDENT POLK.
